

Viva! God's Own State is 32

he geographical entity called Abia, God's Own State, was created on August 27, 1991 by the retired Gen. Ibrahim Babangida Administration, alongside seven other states - Enugu, Delta, Taraba, Kogi, Kebbi, Osun and Adamawa.

Abia was carved out from Imo State, which was created in 1976 by the late Gen. Murtala Muhammed administration. Abia derives its name from the acronym formed from the initials of then four existing constituent groups - Aba, Bende, Isuikwuato and Afikpo.

In 1996, the name Abia still stood, though Afikpo is now part of Ebonyi. Abia is also mentioned in the Bible. For the avoidance of doubt, Abia is properly located in Matthew 1: 17 and Luke 1:5, hence the state adopted God's Own State, as its slogan.

Against the peculiar circumstance in which Abia was created, it represents several things. It has special significance for the founding fathers, fallen heroes and valiants who toiled, fought from the sweat of their brows for the creation of the state. And for those heroes - most of them now quiet in their graves - the creation of Abia State remains a crowning glory and consummation of life-long ambition to have a place for a people who share same cultural and historical affinity.

Here such names as the late Dr. M. I. Okpara ("M.I. Power'), Dr. M.O. Agbara, Chief Ugorji Eke, Chief Nnanna Kalu, Ezeogo Dr. Anagha Ezikpe and Eze Abel Egesi ,Chief S.N.Okpi,Dr Nwakanma Okoro,Chief K.O.Onyioha,Sen Simon Ojukwu etc, all of blessed memory among others, readily call to mind.

And for those of them who are still alive, they deserve nothing less than honour and gratitude. To Ndigbo one of the dominant ethnic groups in Nigeria, the creation of Abia represents and symbolizes righting an historical wrong, perpetrated by past Nigerian leaders. It was part of a redress of proverbial Igbo marginalization in the nation's dispensation,

indeed an issue that is yet to be properly and comprehensively addressed by the Federal Government.

The creation of Ebonyi State in 1996, did nothing to bring the South-East nay Ndigbo at par with other five geopolitical zones in the country with six states each. And to the entire citizenry of the state, the existence of Abia remains a dream come true and a daunting challenge on ways to make her to compete favorably with other states. Here we recall that the Founding Fathers' dream was that the state should be developed rapidly and run on the basis of Onye Aghala Nwanneya (Be Your Brother's Keeper).

From crevices to dawn of a new era

Great men and great philosophers grow from the pressing frustrations of their epoch."-Victor Kalu

Abia State is a complex and complicated story of failed leadership. The people of the state have demonstrated high resilience and survival instinct. A great people, known for their individual exploits and personal achievements, but were somehow unlucky to be visited by leadership vicissitudes. Abia State is a wonderful community of excellent men, women and youths. They were known for their vibrancy in all fields of human endeavours.

As Abia State celebrates the 32 years of the creation of the state by Gen. Ibrahim Badamasi Babangida, we cannot but engage in some measure of stock taking. We must go down memory lane to inquire into our past, to fathom where the rain began to beat

Abia State was governed by five military administrators since it was created on August 27, 1991.

The first Military Administrator, Frank Ajobena was barely in office for about four months, starting from 28 August, 1991 to January 2, 1992.

The first civilian governor was Dr. Ogbonnaya Onu, a Chemical Engineer trained, at the University of Lagos and University of California in Berkely USA.

Other military leaders who held sway were: Col. Ike Nwosu(Dec.9, 1993 to Sept. 14, 1994), Navy Commander Temi Ejoor(14th Sept.1994 to 22nd August, 1996. The next was Moses Fasanya (22nd August, 1996 to August, 1998 while the last military helmsman was Anthony Obi(August, 1998 to 29th May, 1999.

Then the second civilian governor came in the wake of the return to civil rule in 1999. He was Chief Orji Uzor Kalu(1999 to 2007). After Chief Kalu came Chief Theodore Amaefule Oji(2007 to 2015), while Dr. Okezie Ikpeazu took over in 2015 and left in 2023, paving way for the incumbent, Gov. Alex Otti. The crisis of governance in Abia State reached its nadir during the period when Chief T. A. Oji held sway. A hitherto unknown civil servant, he was brought into political relevance by his predecessor, Chief Orji Uzor Kalu. Chief T.A. Orji tightened the nooze on the neck of the citizens, squeezed up the entire state and castrated the civil society. There are those who equally blame Orji Uzor Kalu for the sorry state of affairs in Abia. Yes, his endorsement of T.A. Oji in the first instance marked the beginning of the Abia conundrum.

The prospects of Abia State as an oil producing state were frittered away because of greed and avarice. Even the Chief T.A.Orji's successor in office Dr Okezie Ikpeazu proved not to be better than his master.

He could not rise above the cult of mediocrity in power circles in Umuahia. He inherited and continued with Orji's politics of exclusion and the transactional culture of sharing the common patrimony amongst the cliques in government. The Abia citizens

were subjected to monumental degradation. The civil service was bastardized and became an eye sore. The local government councils were not spared by the greedy state officials who used the joint allocation



semantics to loot the resources of autonomous council authorities in their brazen disregard for decency.

The political class in Abia operated as mercenaries in their own land. They became pompous, vicious, uncontrollable, meretricious, majestic and full of perfidy while the masses groaned and yelled for a change to the status quo ante. Social amenities and road infrastructure collapsed in Abia, while the political mandarins looked the

In the midst of all these, it became clear that Abia State could not replicate what was happening in Anambra State where Peter Obi had cleaned up Onitsha and the state was acknowledged in the South-East as one with the best urban and rural networks. It was within the context of the pervading crisis of leadership that Chief Alex Otti emerged after a long drawn titanic struggle for power as the new Governor of Abia State on 18th March, 2023.Infact Dr Alex Otti defied all odds to secure a landslide victory in that governorship election.

Dr Alex Otti represents a cumulation of nascent political forces that are hell-bent on salvaging Abia State from the decadence of the past. However, the real challenge is about to begin. The crisis of development in Abia State had reached a boiling point.

The crisis in itself represented a boilingover conflict. According to Festus Iyayi, "the essence of a crisis is that it reflects an unresolved, ongoing and critical contradiction. The critical element in the contradiction means that its resolution is significant in the development of a phenomenon and unless it takes place, the phenomenon is flawed".





Abia @ 32: An overview

Abia State was created on August 27, 1991, by General Ibrahim Babangida (Rtd), alongside Enugu, Jigawa, Kebbi, Kogi, Osun, Taraba and Yobe states. The state was carved out from Imo State.

Abia was coined from the first alphabets in the name of four constituents areas of the state, viz: Aba, Bende, Isuikwuato and Afikpo (Afikpo is now part of Ebonyi state).

Abia is mentioned in the Bible, which explains why it adopted God's Own State, as the state's slogan.

Abia, located in the South-East geographical zone, is strategically located as it shares boundaries in the north with Enugu State, north-east with Ebonyi and in the west with Imo

Abia also has common boundaries in the east with Cross River State, south-east with Akwa Ibom and Rivers State in the south.

In addition to Umuahia as the capital city, and Aba as the commercial nerve centre of the state, Abia has other emerging towns, such as Arochukwu, Uzuakoli, Isuikwuato, Mbawsi, Item, Ohafia, Igbere, Abiriba, among others.

Abia occupies a land mass of 5,833.7km² and ranks 27th out of 36 states in Nigeria. In terms of land mass, Abia is one of the smallest states in Nigeria.

Abia, according to the 2006 official census figure, has a population of 2,843,380.

With a projected annual growth rate of 3.2%, the estimated population for 2020 was put at 4,183,359 and 4,808,498 by the end of 2023.

The Abia State Long Term Development Plan, 2020-2050 (ABSLTDP) prepared by the Abia State Planning Commission, gave further details of the projected population.

It projected the male and female population to be 2,417,106 and 2,391,392 respectively by the end of 2023. The state also ranks as the 27th most populated state in the country.

Abia has 17 local government areas, while 10 chief executives, comprising five 5 military administrators and five executive governors have governed the state. Retired Group Captain Frank Ajobena was the pioneer military administrator, while Dr. Alex Otti is current executive governor.

Abia, located within the rainforest zone is rich in mineral and forest resources.

Official statistics listed the resources as: crude oil, natural gas, lead, zinc, copper, limestone, industrial sand, gypsum, etc

As a result of abundant arable land, cultivation of crops like cassava, yam, cocoa-yam, maize, plantain, oil palm, rubber, cocoa, among others thrive very well in the state.

According to a 2020 data, obtained from the Forestry Department, Abia State Ministry of Environment, the state has 8,244.24 hectares of forest reserves, while only about 2,056.06 hectare (25%) have been developed.

The two main rivers, the Aba and Imo rivers, that transverse many communities in the state encourage fishing. Animal husbandry also thrive in the state.

On the education sector, Abia ranks as one of the educationally advantaged states in the country. The literacy level is put at 94.24 %, making it one of the States with the highest literacy level in the country.

Some of the tertiary institutions in the state are: Michael Okpara University of Agriculture, Umudike, Abia State University,



Uturu, Rhema University Aba, Abia State Polytechnic, Aba, Clifford University, Ihie, Isiala Ngwa North Local Government Area, (LGA), Gregory University, Uturu, School of Nursing, Amachara, Umuahia etc.

The state also boasts of Research Institutes, like the Root Crops Research Institute, Umudike, Rubber Research Institute of Nigeria, Akwete, among others.

Abia also boasts of health institutions, both government and privately owned located across the state. They include, the Federal Medical Centre, Umuahia, Abia State University Teaching Hospital (ABSUTH), Aba, Abia State Specialist Hospital and Diagnostic Centre, Umuahia, general hospitals, public health centres scattered across the state.

However, with 86 deaths per 100,000 births, Abia State is among the states with high under 5 mortality rate in Nigeria and second in the South-East.

As should be expected, Abia, with Aba as its commercial hub, is home to Medium, Small and Micro Enterprises (MSMEs) in the country.

Aba, popularly called the Japan of Africa, is the epicentre of fabrication, manufacturing, distribution and retailing of goods.

Aba as a city is synonymous with creativity. The commercial city, unarguably, has the largest number of producers and markets of footwears, leather works and garments in sub-sahara Africa.

With a very vibrant MSMEs and indigenous innovations, without doubt, Abia has one of the highest potential for independent and private sector driven economic activity.

This is even evident in the establishment of different companies, including a power plant (geometric power plant) for power generation, presence of almost all the commercial banks in the country within the state.

As a result of high economic activities in the state, there are many markets scattered across the state. They are: Ariaria International Market, Ekeoha Shopping Complex, Ngwa Road Market, Cemetery Market, Asa Nnetu Spare Parts Market, (all in Aba), Timber Industrial Market, Umuahia, Ubani Ibeku Ultra Modern Market, Umuahia and other specialized markets, that attract huge patronage from other African countries.

Further, statistics from 2022 edition of BudgIT, on fiscal performance ranked Abia as 18th out of 36 states and still very dependant on Federal Account Allocation Committee

(FAAC) for its operating cost, as 78.5% of its total recurrent revenue came from FAAC.

It is also the 18th most indebted state in the country, with a total debt of #136.98billion.

Abia is blessed with wonderful tourist sites like the Azumini Blue River, the National Museum of Colonial History, Aba, The Akwete Weaving Cooperative, Akwete, Ukwa East LGA, The National War Museum, Umuahia and the Ojukwu Bunker, Umuahia, Ibom Waterfalls, Arochukwu etc.

The different communities that make up Abia State have different cultures and festivals that are peculiar to them. But then, there are certain festivals that are common to all Abia people, but with a little variation across the communities.

Some of the cultural festivals and dances in Abia State are the iri ji festival (mew yam festival), the ekpe (masquerade) dance, the okonko society, age grade system, traditional retirement (Igboto nma or Ime Uche) and so on.

Abians are predominantly Christians with a handful of Muslims and traditional worshipers. The state draws its strength from being relatively peaceful. Its strategic location, highly educated workforce and a vibrant population, put the state in a vintage position for accelerated development.

With the coming of a new administration under the pragmatic leadership of Dr. Alex Otti, Abians are expectant that it is a New Dawn.

They are optimistic that the visions and dreams of the founding fathers which is to make Abia the first among equals, in the achievement of human development and a state of abundant opportunities for its citizens, will be realized.

32. Because of the importance of education to our agenda, we declared a state of emergency in the sector in the first week of our administration and have since earmarked appropriate funding to match our commitment.

Abians and the struggle for change

bia State was created on August 27 1991, during the military dictatorship of Ibrahim Babangida. There was no dramatic development in the state during the short-lived military administration. Dr. Ogbonnaya Onu was elected the First Executive Governor of the state. He was on the saddle between January 1992 to November 1993, when he was ousted from power.

The subsequent military administrations in the state could not develop the political and physical infrastructure needed to nurture any meaningful development. No matter the shortness of the first civilian administration, and the years of military administration, the state did not witness open and accountable leadership. These periods also witnessed a titanic struggle to restore democracy in Nigeria. Many Abia indigenes were in the forefront of the struggles that dismantled military rule with resultant return to democratic rule on May 1999. Abia has a rich legacy of outstanding political leaders especially in the first and second republic. Abians still remember prominent indigenes who struggled to have the state created in order to boost development at the grassroots.

Abians have good memories of such political leaders as: Dr. Michael Okpara, Dr. Jaja Nwachukwu, Chief O.C. Ememe, Chief Ubani Ukoma, Dr. J.O.J. Okezie, Dr. K.O.K Onyioha, Dr.K.K. Ogba, Senator Simon Ojukwu, Dr. Kalu Ezera, Chief Aguocha, Dr. Alvan Ikoku, Mazi S. G. Ikoku, Chief Smart Ndem Okpi, Dr. O.O. Oreh, etc.

When democratic rule was restored in 1999, it was assumed and taken for granted that the new civilian democratic leaders who inherited power from the departing military will continue the past tradition of good leadership that was established by Igbo nationalists and first republic political Igbo leaders. At the dawn of democratic rule in 1999, it was generally hoped that the new civilian democratic rulers will dismantle the bad governance structure entrenched in the state as a result of military rule in favour of a good governance structure that will enhance the rapid development of the state. Such positive expectation did not materialize, rather the bad governance structure inherited from the departing military was expanded and perpetuated. Most of the democratic norms were observed and practiced mostly in breach.

The consequence was that Abia State from the start 1999. recorded a new round of decline in its development indices Such decline reached a crescendo during the eight years of Dr. Okezie Ikpeazu's administration. It has to be mentioned that the anti-democratic culture and the perpetuation of a bad governance structure which the practice of democracy presented had itself generated an anti-thesis in a struggle for good governance which has taken decades to achieve. Political theorist are not quite agreed on the origins of this struggle for change in Abia.

However, there is a near consensus that it is traceable to Chief Enyi Abaribe's "Otu Onu Movement" which struggled to gain power in the 2003 Governorship Election with Chief Enyinnaya Abaribe as its governorship candidate. They also contend that their insular philosophy as well as their limited political base constrained this early movement from gaining power in 2003.

The struggle for change was to gain further boost amongst many conscientious Abians when they converged around the political aspiration of Chief Onyema Ugochukwu in another big push to bring change to Abia between 2006 to 2007. The defeat of Chief Onyema Ugochukwu in the 2007 Governorship Election by

Chief T. A. Orji who contested the 2007 governorship election under the banner of the Progressive Peoples Alliance (PPA), while still being incarcerated in Kirikiri Prison on corruption allegations, dampened the enthusiasm of the early agitators for change. The situation was made worst when the political crises that occurred within the ruling PPA, led to the defection of then incumbent Governor T.A Orji back to the People's Democratic Party.

Such defection had the unintended consequences of neutralizing the bludgeoning opposition that had for years opposed the bad governance system in the state and held banner of hope for millions of Abians who remained fervent in their positive hope for their future.

On the other hand, the bad governance system was given added impetus after the merger with the PPA elements in the now new PDP. The PPA leaders emerged as senior partners of the alliance, while the former PDP opposition members of the alliance were muscled to become a junior partners in the alliance whose motive was sharing of the spoils of office.

Under this circumstance of the politics of sharing of the spoils of office, not much thought was given to the fundamental essence of politics, which is to improve governance and engender development.

The consequence was that while the political leaders enjoyed the spoils of office, most of the state's development indices nose dived. It was these scenarios that attracted the attention of another group of Abians, that made them to take more than a passing interest in the political developments in their state. Such groups included the Abians in diaspora, the business group, the professionals and the intellectual group.

These groups seemed to be worst bit by the negative development indices that continually oozed out of their state. They were mostly affected by the lack of an enabling environment that could enable them bring or attract investments to their home state.

They were affected by the insecurity that the bad governance structure bred. They felt the pressure of the high poverty rate as they spent more money subsidizing the cost of living of their many dependents. They felt the pressure of the high unemployment figures as their dependents could not secure jobs at home.

They experienced first hand the poor roads, electricity as they returned home. It was these reasons that informed their joining the political fray with a determination to wrestle out political power from the hands of what they considered to be a thieving political elite. These Abians in 2014 organized and queued behind one of their best, Dr. Alex Otti, in a new bid to change the bad governance structure in the state, with a new one that will engage development.

Such bid did not succeed in 2015, leading to another round of a titanic political struggle in 2019 which also failed. Such failures were all thanks to a defective electoral system in Nigeria.

Meanwhile, the bad governance structure in the state got an added boost under the regime of Dr. Okezie Ikpeazu in 2015, which lasted till May 2023. In fact, as at the time of the change of baton on May 29, 2023, Abia State was rated as the worst managed state in Nigeria. Its unemployment rate was 50%. It was higher than the Nigerian average of 33%.

Most of its roads both urban and rural were in various stages of dilapidation. There was no any functional public water scheme in the state, while most of its cities were enveloped by darkness at night. Mountainous of refuse heaps dotted many streets in the urban areas. There was also no functional health care system. In fact by the time of the change of baton on 29th may 2023, most of the medical personnel in the State Hospital System were on strike as a result of a long drawn industrial dispute. The same way that all the offices of the MDAs were under lock and key, due to the strike action embarked upon by the Nigerian Labour Congress. In fact, the offices were opened by the labour unions after May 29 as a mark of good will and respect to the new Governor Dr. Alex Otti after his inauguration. It will be trite to say that Abians under the past bad governance structure that reigned supreme, were an unhappy and gloomy lot. It is within this context that the success of the struggle for change which took several years to achieve can be appreciated. The spectacular and unprecedented frenzy of joy and celebrations which reeted the Labour Party's win in Abia on April 22, 2023 with Dr Alex Otti emerging as the winner of governorship elections was an indication of a sense of great achievement by Abians. The same could be said about the huge number of people that attended the inauguration and banquet which heralded the change of baton on May 29. It is now three months plus or an equivalent of 100 days since this change of baton occurred. This period roughly coincides with the 32nd anniversary of the creation of Abia State. The state government declared the double event a week long affair.

Taken the above scenario into consideration and the fact of the liberation of the State from the strong arms of a notorious thieving elite vis avis the positive indications that is now coming out of the young regime which has only be in office for an equivalent of 100days. Abians have all the right reason to roll out the drums.

It is indeed a birthday celebration like no other. It is a new session of hope and Abians have all the right reasons to celebrate the double event.

Three months plus or an equivalent of 100 days in the life of an administration that has a four-year tenure could be considered too short a time to have any meaningful assessment of how well such a government is faring, but it is a period that could be used to have a glimpse into the direction the government is going and to determine if such direction is right one or not.

More importantly, it is quite enough period to determine if the structures for a good governance system has been put in place or not.

However, an objective assessment of Dr. Otti's outing within the first 100 days can only be arrived through a peep at the sectoral performance of his government.

It is also good to note that Dr. Alex Otti prepared for the challenge of running a very badly mismanaged state, when he started his campaign with a 42-paged manifesto document which he personally authored.

One of the first thing he did when he ascended into office was to operationalize the manifesto document into an implementable programme of action through the constitution of 101 transition council members that sat for one month. The transition council was made up of very brilliant minds and top professionals that were drawn from diverse fields of endeavour. It was this council members that translated and expanded the manifesto document into a workable instrument for public policy

It is also necessary to restate the fact that his inauguration into office on May 29th was overshadowed by a lingering industrial action, embarked upon by the organized labour to protest the rascality

of the last regime over matters concerning wage bills and general fiscal indiscipline. One of the first things, Dr. Alex Otti did on coming into power was to retool the machinery that will ensure that the state public sector workers earn their wages by the 28th of every month as promised during the campaigns.

Three months plus into the tenure, a lot of public sector workers can attest to receiving their pay on the 28th day of the month, though there are still hitches. The

administration is making strenuous the system of appointment of effort to ensure that the challenges which the new system is facing is tackled, so that all the workers would receive their salaries same time. It is also good to mention that the administration is making concerted efforts to ensure that the huge arears of workers' salaries which has been put at over 50 billion naira is cleared before December 2023

REFORM OF THE INSTITUTIONS OF GOVERNANCE

One of the significant things, Dr. Otti did on coming into power was to change

political appointees into the public service. In the past, such appointments were used to reward political loyalists not minding the capacity to do the work. It is in this sense that his careful selection of top professionals and brilliant people with requisite academic and professional experience could be understood. The people who now manage the critical sectors of the state public sector are also people of unquestionable integrity.

The meritocracy selection process has also been accompanied by a vigorous reform of other critical sectors of the public sector as the following examples will depict:

(a) Strengthening the state's Accountant-General office to ensure proper and accurate record keeping as well as audit and ensure publication of the state's financial reports possibly on quarterly basis

(b) Conversion of the state's accounting system

(c) Staff audit, including biometric verification exercise across the state for LGA and state employees

(d) Disengagement of third-party receipts with the development of a centralized direct remittance by market stall and place holders

(e) Plans have been concluded for the September take-off of the Treasury Single Account (TSA) to ensure that all revenues accruable to the state are received into a single/central pool, which can be accessed online by the governor and other authorized persons.

Another notable reform that has been strengthened and made functional is the Due Process Office. Before now the law on public procurement was observed in breach, but now all the relevant mechanisms have been put in place, to ensure that public procurement followed due process requirements.

REFORMS OF THE JUSTICE **SYSTEM**

Another realm in which Dr. Otti's reform agenda has impacted positively is the justice sector as could be glimpsed from the following activities.

(a) Engagement and negotiation with the Judiciary Staff Union of Nigeria, (JUSUN) Abia State chapter, over the industrial action embarked upon, over arears of the consolidated judiciary salary scale, since 2015. Such engagement paid off with an amicable resolution of the dispute, which led to the calling off of the strike action and the opening of the courts for judicial and related activities.

(b) To ensure that administration of civil justice is more efficient and effective, Dr. Alex Otti on the recommendation of the chief judge of Abia State, issued an executive order increasing the monetary civil jurisdiction of magistrate courts in Abia State aimed at reflecting the current realities.

(c) Creation of a desk on genderbased violence cases at the Ministry of Justice as well as the reorganization of workers within the ministry. The process is still ongoing and payments will soon start.

(d) The procurement process is ongoing to update and digitalize the law of Abia State when completed as well as to train law officers on the operations and importance of the data desk.

(e) The Abia State Government has since 2007 failed to pay the retirement benefits of retired judges. These include gratuities, consolidated advances, severance package, pension and

miscellaneous entitlements. These matters had lingered since 2007. The past administrations had made several promises either by way of making authorization for payment of retirement benefits or giving approval to make payments by installments, but none of them fulfilled their promises, compelling the judges to file an action at the National Industrial Court of Nigeria in 2020. Sadly, while the case was pending, some of the judges died without receiving their benefits. The immediate past government of Abia State promised to pay N10 million every month in other to gradually offset these arears, but only did so for one month.

Upon assumption of office, Dr. Otti set up a committee to recalculate these outstanding retirement benefits of the judges with a view to clearing it.





SANITATION AND WASTE DISPOSAL:

One of the first things Dr. Alex Otti did on coming into power was to declare a state of emergency on refuse in Aba and Umuahia. This was soon followed with the setting up of a special task force to tackle the problem. Prior to this time, the cities of Aba and Umuahia were overwhelmed with refuse heaps that dotted many parts of the two cities.

Since the war started, the government has been steadily winning it with massive cleanup and evacuation of accumulated refuse in Aba and Umuahia, which was achieved with the disposal of over 3,000 truckloads of refuse by the end of June.

The Abia State Environmental Protection Agency has been revitalized with its integration with the Special Task force on Refuse Disposal.

The agency has fully deployed its personnel and equipment to ensure that the state is kept clean. It has also been aggressive in acquiring equipment needed for the job. This is coupled with a massive enlightenment campaign and stakeholders' engagements towards better waste management practice.

The agency has also put in place an appropriate mechanism that will ensure modern and sustainable waste management system, through the engagement of contractors, who will help do the job. It is also instructive to note that these contractors were engaged through a

rigorous, open and transparent bid process that was in line with the Public Procurement

SECURITY

Dr Alex Otti had on inauguration made it clear that there shall be zero tolerance for any form of criminality in Abia. Such declaration was in appreciation of the centrality of security as the foundation of any meaningful prosperity. His government walked the talk through the launching of a special security scheme code named "Operation Flush". Operation Flush is a strong and coordinated response to the lingering challenges of security in many parts of the state which had made life very difficult for so many people.

The scheme is a joint task force with membership drawn from the various military formations including operatives of the Nigeria Army, the Nigerian Navy, the Nigerian Police, the Directorate of the State Security Services and the Nigeria Security and Civil Defence Corps.

This special operation has been technically set up to swiftly identify, analyses and respond to security threats from and within any parts of the state. The operation has also been oriented to devote special attention to the flash points around communities within the Isuikwuato and Umunneochi axis as well as Aba,Umuahia and Ohafia.




League (NPFL) title and assured them of support.





Abia was created on August, 27, 1991 during the regime of military President Ibrahim Babangida.


In fact, the newspaper hit the news stand on August 27, 1992, as part of activities to mark the anniversary of the creation of the state.

Later on, other publications like the Abia in Focus Magazine, Abia Who is Who and Abia Tourism Handbook were added to the stable.

Dr. Ogbonnaya Onu, the first civilian governor of the state who established the paper desired for a state-owned newspaper, that would compete with other national newspapers.

Established under Edict 15 of 1995, the newspaper has as its core mandate, the task of publishing the activities and programmes of the state government and galvanizing the populace with adequate information and enlightenment to elicit their participation in the development process. The Edict also empowers it to be a thriving commercial publishing house in the country.

Not only did Gov. Ogbonnaya Onu adequately funded the newspaper. He also put in

until sometime in 2012 when the then incumbent Governor T.A.Orji fell out with his godfather Chief Orji Uzor Kalu and the paper was revived to help him wage the attendant media battle. However, the fortunes of the newspaper further nosedived under the infamous Dr Ikpeazu 8 year-tenure.

The Abia Newspapers and Publishing Corporation which ordinarily should be the intellectual hub of the state suffered a great deal of neglect under the immediate past regime.

Since the incumbent Governor Alex Otti is also a leading intellectual in his own right, it is the expectation of the intellectual community in the country that he should continue on the foundation laid by Dr Ogbonnaya Onu by ensuring that the development of the Abia Newspaper and Publishing Corporation as the intellectual hub of the state is accorded a prime place in his development agenda.
