Gov. Otti Reopens Newly Retrofitted ikiwe State Secretariat

bia State Governor, Dr. Alex Otti, has formally reopened the newly retrofitted Nnamdi Azikiwe State Secretariat in Umuahia after months of retrofitting, remodeling, and external works aimed at restoring the dignity and productivity of the State's Workforce.

The newly retrofitted Nnamdi Azikiwe State Secretariat is set to accommodate close to 1,000 personnel and house four different MDAs on four Ministries temporary

Speaking at the Ceremony held at the Secretariat Complex, Ogurube Layout, Umuahia, Governor Otti described the renovation of the secretariat as another pointer to his administration's determination to change the face of the State's Civil

He recalled that the initiative followed other significant projects, such as the commissioning of the Joint Accounts Allocation

Gender Based Violence: FG Orders Varsities To Set Up Help Centres

he Federal Government (FG) has moved to curb Gender Based Violence (GBV) across institutions of higher learning.

FG directed tertiary institutions in the country to establish Sexual Assault Referral Centres to address cases of students offering lecturers sex in exchange for good grades, harassment and gender-based violence on campuses.

The Minister of Women Affairs, Imaan Suleiman-Ibrahim, affirmed this at the National Summit held in Abuja by Alliances for Africa in collaboration with the Committee on Gender Directors in Nigeria to kickoff the 16 Days of Activism Campaign Against Gender-Based Violence.

The directive comes three days after the Federal University in Oye Ekiti, cleared a female student, Ramota Olahanlove, to graduate following the remarking of her final-year examination scripts.

Olahanloye had alleged that a lecturer, Dr. Anthony Agbegbedia, demanded sexual favours from her, and when she declined, he deliberately failed her in two final-year courses.

But Suleiman-Ibrahim disclosed that for the trend to be curbed, there was a need to introduce timely intervention and survivor support in the centres being recommended.

She said, "I call on university leadership to prioritise the establishment of SARCs to ensure timely intervention and support for survivors within their communities.

"We currently have only 47 Sexual Assault Referral Centres across 22 states and the FCT. This is far from enough."

e disclosed that the State Government leveraged the expertise of the State's Civil Service to execute the projects, significantly reducing costs to N900 million, compared to the estimated N2 billion if outsourced to private contractors.

The Governor highlighted that the direct labour approach not only saved funds but also enhanced the technical capacity of Civil Servants, created employment opportunities, and empowered local businesses that supplied materials for the project.

The Governor assured workers of his administration's dedication to their welfare and urged them to reciprocate by demonstrating professionalism, punctuality, and dedication to

In his address, the Commissioner for Lands and Housing, Mr Chaka Chukwumerije, stated that the re-opening of the Nnamdi Azikiwe Secretariat as part of the present Administration's integrated plan to significantly upgrade the entire Secretariat complex to ensure that Public Buildings are adequately colocated within the same space and in a conducive environment, befitting for its civil servants.

The Commissisoner recalled that the Nnamdi Azikiwe Secretariat, originally constructed in 1993 during the Ibrahim Babangida administration, had deteriorated over the years and eventually abandoned by the previous administration following concerns about its structural integrity.

He lauded Governor Otti's administration for fulfilling its promise to rebuild and modernize Abia's public service infrastructure, noting that the newly retrofitted Secretariat now boasts of restored water

and electricity supply, new furnishings for approximately 150 offices, four newly introduced boardrooms, and a state-of-the-art 240-seater conference hall.

He listed other works in the pipeline as part of the holistic upgrade of the Secretariat to include the building of "a brand new secretariat block to accomodae more MDA's, provision of a creche, opening of the utility area, the completion of the road works, and the provision of alternate energy to serve the

In her remarks onbehalf of the Abia Workforce, the Head of Service, Dr Mrs Ngozi Obioma, described the commissioning of the retrofitted Secretariat Complex as a demonstration of the present administration's commitment to rejigging the Abia Civil Service trajectory which was on a "downward spiral prior to the Governor's assumption of office.

She lauded Governor Otti for recognizing that decent conducive accommodation serves as a motivation for qualitative service delivery and commended the Governor's commitment to transforming the administrative, infrastructural, and social landscape of the State.

Ubah noted that the location where the military personnel mounted the checkpoint initially was a builtup area, which made it difficult for the military to exercise freedom of movement to repel the attack, adding that the traditional ruler of Ezeleke Autonomous Community, Eze Ibeakanma and other community leaders had shown co-operation with the military to enable them to relocate because of the inconvenience the road closure has caused

According to Ubah, the communities in the area had volunteered to start clearing the new location, as well as volunteer information, as security is everybody's

The Commanding Officer, 145 Battalion, Umuahia, Major Martin Domkat and other senior military officers were part of the GOC's entourage.

Health Commissioner Urges Parents To Join In Campaign Against Cancer

Tancer has been described as a silent threat and enemy to human existence, hence the need for parents to join in the campaign against it.

The Commissioner for Health. Prof. Enoch Ogbonna Uche, who made this call while delivering an address on the occasion of Cancer Awareness Day Celebration 2024 in

Umuahia, with a lined-up activities which included Health Walk from Government House to the new JAAC Building, Health Talk, Free Cancer Screening and a lot of other activities, with the theme- The changing face of the enemy, reducing the rising prevalence of cancer in Abia State. He said there is an urgent need for parents to ensure that their daughters, wives, sisters, mothers and female relatives within

the ages of 15-49 to embrace the preventive initiative by going for screening and receiving HPV vaccination, which he described as a sure way of reducing the rising risk of all forms of cancer.

Prof. Uche said "Globally an estimated 1 in 5 people will develop cancer in their lifetime. Also 1 in 8 men and 1 in 11 women will die from cancer. In 2020, there were over 19 worldwide with over 10 million deaths. In Nigeria, cancer is a major health issue. In 2020, over 124000 new cases of cancer were reported and over 78000 died. Every year, over 70,000 cancer deaths are recorded in Nigeria. These estimates are projected to increase by 85% in the next 15 years. The most common cancer types in Nigeria are breast, cervical, prostate, colorectal, and nonHodgkin lymphoma".

The Commissioner expressed sadness over losing his many relative to cancer, and assured that his ministry in collaboration with other stakeholder will work assiduously to stem the prevalence of various incidences of cancer in the

Additionally, he applauded the First Lady of Abia State for her resilience and go-getter spirit in championing the sensitization and awareness programme in the State and pledged unalloyed support.

In their lectures, Dr. Oluchi Izuka and Prof. Rosemary Ogu, advised people to stop lifestyle that can lead to the disease, such as intake of excessive alcohol, exposure to hydration, avoiding highly processed food and the likes.

According to them, Abia State is not immune to cancer and despite all the positive strides in the health sector, we are faced with the rising cases of cancer patients. They said early detection and prevention remains the only approach to eliminating this unfortunate life threatening disease. If detected early, at least 5% cure will be achieved.

A cancer survivor, Mrs Ruth Okeyi, from Nsulu Isiala Ngwa, while sharing her ordeal on how she broke through this deadly disease, she went through six successful sections of chemotherapy, after which she embraced natural ways of eating both vegetables and herbs.

Meanwhile 50 participants received free mammograms courtesy of the office of the Wife of the Governor, Mrs. Priscilia C. Otti ,while she presented a donation of N10million Naria bank cheque to some identified patients to compliment the good work of the Governor in the health sector.

Abia Govt Warns Against Unapproved Healthcare Outreaches

has warned the general public against patronizing unauthorized healthcare outreach.

This was contained in a Press Release signed by the Commissioner for Health, Prof Enoch Ogbonnaya Uche and made available to newsmen, encouraging the public to report any unauthorized or illegal healthcare activity near them to the Ministry of Health.

The release further reads:

women group of the Redeemed Christian Church of God Amafor Isingwu, Umuahia North, Abia State when Prof Mabel Ifeoma Onwuka fulfilled her promise of donating a pyrolysis drum for the production of biochar to them.

In her lecture, she explained that:

"Biochar is an organic and eco-friendly fertilizer produced from waste materials known as feedstocks. These waste materials include agricultural waste such as crop residues, animal wastes, shells, rice husk and saw dust etc. that are nuisances to our environment, if not recycled. They are converted into healthy nutrient for crops growth and vield. Apart from increasing the crop growth, biochar has been found to reduce soil acidity, increase soil nutrients such as phosphorus, calcium, magnesium, potassium and organic carbon, a good remediate of heavy metals and increase soil microorganism.

"Applying biochar to the degraded soils of the Southeast Nigeria, which are mostly acidic have resulted to increase crop yields and management of the soil. Prof Onwuka stated this while demonstrating to the women how to produce biochar using the pyrolysis drum. The drum according to her works on the principle of charring the waste materials under intense heat and limited oxygen.

"The limited oxygen eliminates the production of carbon dioxide (a greenhouse gas), which is not one of the gaseous products of the pyrolysis unit.

Mabel Onwuka who is

t was all joy for the founder of Hope for Farmer, Women and Girls Initiative (HOFWGI) and the Director, Center for Gender, Youth and Child Development (CGYCD), emphasized that the smallholder women farmers play significant roles in crop production in Nigeria and Africa, hence they must be encouraged especially now that mineral or inorganic fertilizers are very costly and out of the reach of the resource-poor farmers.

> Commenting on the effectiveness of the biochar fertilizer, Mrs. Ijeoma Ehiogu of Amafor Isingwu said that the biochar that was freely given to them by Prof Mabel, during the 2023 International Day of Rural Women, was utilized by her to plant ginger. She testified that the yield, she got was about 300 per cent more than the previous years' yields, she normally get. She further stated that after taking the much ginger her family needed for the year, she sold the surplus and made a profit of N15,000.00k which she has never made from ginger ever since she started growing ginger years ago.

> In her remarks, the leader of the group Mrs. Sarah Ndubuisi-Nmerifo thanked Prof. Onwuka and her team for visiting their group. She praised her for keeping to her promise of donating a pyrolysis drum to them after she won the 2023 Prize for Women's Creativity in Rural Life by Women's World Summit Foundation, Geneva, Switzerland. The communique further recommended that "The media should be integrated into the state's information and data gathering mechanism, with regular interface and press briefings on updates in HCD activities in Abia.


"The Abia State Government should ensure sustained trainings and workshops at a pace convenient to it, to enhance efficient participation of journalists in the operations of HCD coverage areas.



163 Graduands Bag First-Class, As MOUAU VC Unveils Milestones

he Vice-Chancellor of Michael Okpara University of Agriculture, Umudike (MOUAU), Prof. Maduebibisi Ofo Iwe, has unveiled the university's academic excellence, as 163 graduands bagged first-class honours at the institution's 12th convocation ceremony.

This, he said, highlighted the university's unrelenting pursuit of excellence, solidifying its reputation as a hub for exceptional academic achievement.

Prof. Iwe who disclosed this at the Pre-Convocation Press briefing, held at the institution recently, expressed pride in the students' achievements, emphasizing that the record number of first-class graduates is a proof of the institution's dedication to academic rigor and quality education.

Iwe said the feat reflects the unwavering commitment of the students, faculty, and administration to excellence, adding that the institution is proud to celebrate the efforts of these outstanding individuals who have demonstrated exceptional discipline and resilience in their academic journey.

According to him, the convocation ceremony which would witness the graduation of 4,743 Bachelor Degree graduands, 49 Postgraduate Diploma, 252 Master's Degree and 164 Doctorate Degree as well, with a breakdown of 163 first Class graduation in first degree, 1,710 second class upper, 2,114 second class lower and 734 graduands with third class, while nine, recorded a pass.

The Vice-Chancellor, however, reiterated the university's commitment to fostering an environment that nurtures academic brilliance and innovation, producing high caliber graduates.

According to the University Don, the Convocation ceremony would begin with an inter-Denominational Convocation thanksgiving service, followed by a novelty football match, and Juma'at prayer at the MOUAU central mosque.

Gov. Otti Approves Health Insurance Scheme For Civil Servants

bia State Governor, Dr. Alex Otti, has an nounced a groundbreaking initiative with the approval of \$500 million as counterpart funding for the launch of the Abia State Health Insurance Scheme, specifically for civil servants. This significant development is aimed at enhancing the healthcare services available to state employees.

Under the new health insurance scheme, civil servants are required to contribute 5% of their basic monthly salaries to access a range of medical services from approved health service providers. To encourage enrollment, the governor has graciously subsidized 2.5% of the

workers' contributions for Hospital (ABSUTH) in Aba, the first three months.

During a briefing at Government House, Umuahia, on the outcome of the recent Executive Council meeting, the Commissioner for Information, Prince Okey Kanu, emphasised the importance of civil servants participating in the scheme.

He stated, "By this development, all State Civil Servants are encouraged to enroll in the scheme." The arrangement will enable workers to enjoy medical services that would otherwise be unaffordable if accessed directly".

In addition to the health insurance scheme, Governor Otti has approved comprehensive upgrades and renovations of the Abia State University Teaching Hospital (ABSUTH) in Aba, to meet world-class standards. This initiative a ligns with the administration's broader healthcare transformation agenda.

Furthermore, the Abia Specialist Hospital, has regained its accreditation from the Medical and Dental Council of Nigeria, for the training of medical interns, increasing its annual training quota from 24 to 36 interns.

The Commissioner described this accomplishment as a major milestone, with the Federal Minister of Health commending Governor Otti for his forward-thinking initiatives in the healthcare sector.

In response to questions

regarding the Health Insurance Scheme, the Commissioner for Health, Professor Enoch Ogbonnaya, stated that Civil Servants, once they begin contributing, will have access to the services within three months.

Employees can include four dependents plus their spouses in the scheme, and efforts are being made to extend coverage to individuals in the informal sector.

Governor Otti's initiatives reflect a strong commitment to improving healthcare access and quality for Abia State's Civil Servants and the broader community, especially for vulnerable populations, he stated.

Gov. Otti Commissions N750m Dozie Way, Pledges Massive Road Projects In Umuahia

overnor Alex Otti of Abia State has commissioned the newly rehabilitated 1.3-kilometer Dozie Way, a key infrastructure project designed to enhance the economic development of Umuahia and its environs.

Speaking at the Commissioning Ceremony, he disclosed that the N750 Million Project was executed through direct labor by the Abia State Ministry of Works, thereby saving the State Government significant costs compared to the N2.2 billion quoted by external contractors.

The Governor, Dr. Otti described the road as a s y m b o l o f h i s a d m i n i s t r a t i o n ' s commitment to transforming Umuahia into a modern urban hub and added that the project demonstrates his dedication to enhancing economic activities and decongesting traffic in the State Capital.

This road also serves to decongest traffic on the Ikot

Ekpene Road when there is gridlock. It is also very useful in supporting the economic activities in several communities markets within Lodu, Ahiaeke, Umuana all in Umuahia corridor.

"This road will not just boost economic progress beyond the immediate precinct of the area but will also lead to new investments in real estate, agriculture, hospitality and retail trading.

"This project ultimately will spur up economic activities and improve the value of property holdings around here".

Governor Otti disclosed that the State Government plans to embark on expansive road development projects over the next 12 months, including ongoing works along IBB Way and the Ahiaeke-Lodu corridor.

"As you may be aware, preliminary stages of extensive Civil Engineering works are already ongoing along the IBB Way and on the stretch of road leading to Ahiaeke and Lodu.

"My promise to you is that

there would be multiple reconstruction activity along this corridor over the entire length of the present dry season window", he said.

In his speech, the Deputy Speaker of the Abia State House of Assembly, Mr. Austin Mmeregini, described the project as evidence of the a d m i n i s t r a t i o n 's commitment to improving the welfare of Abians and urged residents to support the Government's rebuilding agenda and fulfill their civic duties, including paying their taxes.

In his address earlier, the Commissioner for Works, Mr. Otumchere Oti, noted that Dozie Way was initially intended as a strategic by pass to ease traffic congestion from Ikot Ekpene Road to the Timber Market.

He however noted that years of neglect by previous administrations left the road in a deplorable state, necessitated the comprehensive rehabilitation of the road.

Oti while highlighting that the road would enhance

social and economic activities in the area, urged residents to desist from any act that would jeopardise the efforts of government in reconstructing the road.

reconstructing the road.
Also, the Chairman of Umuahia North Local Government Area, Chief Smart Iheoma, expressed gratitude to the Governor for alleviating the suffering of residents through the road rehabilitation and appealed for similar interventions in other parts of the Local Government.

In their separate remarks, Leaders of Umuana-Ndume Community, including Mr. Friday Ohaeri and Chief John Onyiro, commended the Governor for completing the project and called for the rehabilitation of connecting roads to further enhance the movement of goods and people.

They urged residents to protect the newly constructed road and desist from activities that could undermine the State Government's efforts.

e understand from Scriptures that our settlement as believers is crucial to God. That's why the Bible says: But the God of all grace, who hath called us unto his eternal glory by Christ Jesus, after that ye have suffered a while, make you perfect, establish, strengthen, settle you (1Peter 5:10). Every prophetic word from God is designed for fulfilment. As it is written: And blessed is she that believed: for there shall be a performance of those things which were told her from the Lord (Luke 1:45). This is because prophecies are not psychological predictions, but the unveiling of divine plans. We must understand that God speaks according to His resources and not our scarcity. He speaks according to His integrity and not our fallibility. He also speaks according to His size and His unlimited capacity to make it happen (Isaiah 55:11; Numbers 23:19; Deuteronomy 18:22; Haggai 2:8; Psalm 50:9-11). In addition, it is important to know that only God's hand can perform whatever He says. However, without our faith, we cannot take delivery. It is written: The Lord of hosts hath sworn, saying, Surely as I have thought, so shall it come to pass; and as I have purposed, so shall it stand (Isaiah 14:24).

What, Then, is Faith?

into Divinity Thereby Commanding Supernatural Feats: For instance, when the woman with the issue of blood grafted herself to Jesus Christ through her faith, she tapped into His virtue and the flow of blood ceased. Similarly, when we engage our faith, we are grafted into God and become partakers of His divine nature, thereby commanding divine authority over the issues of life (Romans 11:19-23).

We must recognise that the Bible is a book of covenants and God's covenant with man in Scriptures is binding as long as the earth remains (Jeremiah 33:20-22; Psalm 89:34). However, we must understand that it is our faith in the settled Word of God that guarantees our settlement in life (1 Peter 5:8-10; Psalm 119:89).

Having established that faith is the covenant force that guarantees our settlement, we must also know that God's covenant is based on well defined terms and sealed with an oath to deliver. As such, we must believe and engage these terms to commit God's integrity to perform (Isaiah 34:16).


What are the Terms of the Covenant of Settlement?

We Must Fully Return to God: Until we return to our covenant walk with God, it is not our turn to be settled

(Malachi 3:7). For instance, 12:22-24; Psalm 84:4-7;

Also, until Judah returned in the days of King Asa, she was not settled. However, upon return, God gave Judah all-round rest (Luke 15:17-24; 2Chronicles 15:3-6; 11-15). In addition, we must

132:13-18). Again, when we are planted in the house of God, we are ordained to flourish in all areas. However, it is important to note that God has an appointed place of worship for every believer and until we locate and abide there, our settlement is not guaranteed (Psalm 92:12-15; 2 Samuel 7:10;

understand that being away from God is a curse (Psalm 16:4). This is because we serve a jealous God, Who cannot stand double dealings (Exodus 34:13; James 1:6-8).

We Must be Planted in the House of the Lord: Zion is the Church of Christ and our covenant place of settlement (Obadiah 1:17; Hebrews

Deuteronomy 12:13-14).

We Must Make a Covenant to Serve God: Serving God indeed and in truth commits Him to our settlement. It is when we serve God and the interest of His Kingdom that He adds to us what others are dying to get (Matthew 6:33; 2 Chronicles 15:1-4/12-15;

Joshua 24:15; Deuteronomy 10:46-52; Matthew 36:11). Remember, only workers are entitled to wages. Therefore, we should not just watch others serve God but engage wholeheartedly and excitedly in Kingdom service, and watch God deliver our settlement testimonies (Matthew 10:10; Luke 10:7; 1 Timothy 5: 18).

We Must Pray for our Desired Settlement as Men and Women Did in Bible Days: From several scriptural references, we understand that God established the altar of prayer as the altar of settlement. For instance, when Jacob, Jabez, Hannah, Blind Bartimaeus and the Canaanite Woman prayed in faith for their settlement, the Bible says that God heard and settled them immediately. This simply means that we are only entitled to receive what we ask for in faith (James 4:2; Genesis 32:24-28; 1 Chronicles 4:9-10; 1 Samuel 1:13-19; Mark

Raise an Altar of Sacrifice: We can also enforce our settlement by rearing an altar of sacrifice as prompted by the Spirit of God. For instance, when Noah offered a sacrifice to God after the flood, God averted the curse and settled humanity. Again, when David reared an altar of sacrifice as instructed by God, the plague ceased (Psalm 126:1-6; Genesis 8:20-22; 2 Samuel 24:18-25). Therefore, whenever we receive a prompting of the Holy Spirit to rear an altar of sacrifice, we should dive into it in faith, because therein lies our settlement.

In conclusion, God has an agenda of settlement for us but without our faith, we can never access it; and faith cannot be exercised unless we are born again. Are you born again? If you are not, this is an opportunity to do so. Simply say the following prayer: Lord Jesus, I come to You today. I am a sinner. Forgive me my sins. Cleanse me with Your precious Blood. US Recognizes Venezuelan Opposition Leader Edmundo **Gonzalez As President-elect**



he United States has formally recognized Venezuelan opposition leader Edmundo Gonzalez as the country's president-elect following the disputed July 28 presidential election, Secretary of State Antony Blinken announced on X.

The Venezuelan people spoke resoundingly on July 28 and made Edmundo Gonzalez the presidentelect. Democracy demands respect for the will of the voters," the top US diplomat posted while participating in the G20 summit in Rio de Janeiro.

The announcement marks a significant change

in US policy towards Venezuela: up until now, the US and other countries said Gonzalez had won more votes than incumbent leader Nicolas Maduro in July but stopped short of recognizing him as 'president-elect.

"It is clear to the United States, to democratic nations around the world, and to independent international organizations that observed the July 28 elections that opposition candidate Edmundo González Urrutia won the most votes. That makes him the president-elect," a State Department spokesperson told CNN.

Global Plastics Summit Starts As Cop29 Ends

Nations-sponsored COP29 climate talks ended in Baku, Azerbaijan, Sunday with approval of a deal to provide \$300 billion a year to fight climate change, focused on helping poorer countries manage the rise in global temperatures. Negotiators gather Monday in Busan, South Korea, to work on harmoning out of work on hammering out a landmark deal to manage the world's plastics crisis.

Australia Approves Social Media Ban On Under-16s

ustralia will ban children under 16 from using social media, after its parliament approved the world's strictest laws.

The ban, which will not take effect for at least 12 months, could see tech companies fined up to A\$50m (\$32.5m; £25.7m) if they don't comply.

Prime Minister Anthony Albanese says the legislation is needed to protect young people from the "harms" of social media, something many parent groups have echoed.

But critics say questions over how the ban will work - and its impact on privacy and social connection - have been

This is not the first attempt globally to restrict children's social media use, but the minimum age of 16 is the highest set by any country. Unlike other attempts, it also does not include exemptions for existing users or those with parental consent.

Having passed the Senate by 34 votes to 19 late on Thursday, the bill returned to the House of Representatives where it passed early on

"We want our kids to have a childhood and parents to know we have their backs," Albanese told reporters afterwards.

Meanwhile, the legislation does not specify which platforms will be banned. Those decisions will be made later by Australia's communications minister, who will seek advice from the eSafety Commissioner - an internet regulator that will enforce the rules.

However, the minister, Michelle Rowland, has said

the ban will include Australian parents and Snapchat, TikTok, Facebook, Instagram and X. Gaming and messaging platforms are exempt, as are sites that can be accessed without an account meaning YouTube account, meaning YouTube, for instance, is likely to be

The government says will it rely on some form of ageverification technology to implement the restrictions, and options will be tested in the coming months. The onus will be on the social media platforms to add these processes themselves

However digital researchers have warned there are no guarantees the unspecified technology - which could rely on biometrics or identity information - will work. Critics have also sought assurances that privacy will be protected.

They have also warned that restrictions could easily be circumvented through tools like a VPN - which can disguise a user's location and make them appear to be logging on from another country.

Children who find ways to flout the rules will not face penalties, however.

Polling on the reforms, though limited, suggests it is supported by a majority of

caregivers.

"For too long parents have had this impossible choice between giving in and getting their child an addictive device or seeing their child isolated and feeling left out," Amy Friedlander, who was among those lobbying for the ban, recently told the BBC.

"We've been trapped in a norm that no one wants to be a part of.

But many experts say the ban is "too blunt an instrument" to effectively address the risks associated with social media use and have warned it could end up pushing children into less regulated corners of the internet

During a short consultation period before the bill passed, Google and Snap criticised the legislation for not providing more detail, and Meta said the bill would be "ineffective" and not most its "ineffective" and not meet its stated aim of making kids

In its submission, TikTok said the government's definition of a social media platform was so "broad and unclear" that "almost every online service could fall within [it]".

X questioned the "lawfulness" of the bill -

saying it may not be compatible with international regulations and human rights treaties which Australia has signed.

Some youth advocates also accused the government of not fully understanding the role social media plays in their lives and locking them out of the debate.

"We understand we are vulnerable to the risks and negative impacts of social media... but we need to be involved in developing solutions," wrote the eSafety Youth Council, which advises the regulator.

Albanese has acknowledged the debate is complex but steadfastly defended the bill.


'We don't argue that its implementation will be perfect, just like the alcohol ban for [children] under 18 doesn't mean that someone under 18 never has access but we know that it's the right thing to do," he said on

Last year, France introduced legislation to block social media access for children under 15 without parental consent, though research indicates almost half of users were able to avoid the ban using a VPN.

A law in the US state of Utah which was similar to Australia's - was overturned by a federal judge who found it unconstitutional.



"Yeah. You're from


Africa, aren't you?"

Vincent Chukwuemeka Ike

incent Chukwuemeka Ike was a Nigerian monarch, academic and writer known for a mixture of lampoon, humour and satire.

Ike was born into a royal family in Ndikelionwu in Anambra State, in the southeastern region of Nigeria. He attended Government College Umuahia.

He started writing at Umuahia for the school magazine, The Umuahian and he was also influenced by teachers that included Saburi Biobaku, who had honours in English from Cambridge. After completing his secondary education, he studied at the University of Ibadan. While at the college, he was invited by Chinua Achebe to join the magazine club. He earned a Bachelor of Arts degree in History, English, and Religious Studies from the University of Ibadan in 1955 and got married in 1959 to Adebimpe Olurinsola Abimbolu. In 1965, he published his first novel, Toads for Supper. He earned a master's degree from Stamford University in 1966.

In 1971, became chief executive of West African Examinations Council.

In 2008, he became king of Ndikelionwu. He was an Igwe, Eze Ndikelionwu of the Ndikelionwu in Eastern Nigeria, with the title "Ikelionwu XI" in his hometown of Ndikelionwu in Anambra State.


Ike served as a teacher in a primary school at Amichi from 1950 to 1951 and in a secondary school at Nkwerre from 1955 to 1956. Between 1957 and 1960, he worked as an administrative assistant at University College,

He joined the University of Nigeria, Nsukka, where he worked as the Deputy Registrar from 1960 to 1963 and Registrar and Secretary to the Council from 1963 to 1971.

Ike had served in Biafra as the Provincial Refugee Officer in charge of Umuahia Province from 1968 to 1969 and Headquarters Scout Commander in Nsukka Province from 1970 to 1971. After the Nigerian Civil War, he was appointed Chairman, Planning and Management Committee of the University of Nigeria, Nsukka. He was responsible for reopening and managing the institution as the interim Chief Executive immediately after the war. He served as the Registrar of West African Examination Council from 1971 to 1979 as the first Nigerian Chief Executive of the organization.

He had also worked with Daily Times and University Press Plc as a Director in both organizations. He retired from public service in 1979 and became a visiting professor of English Language and Literature at University of Jos from 1983 to 1985. Between 1990 and 1991, he was the Pro-Chancellor And Chairman Of Council, University of Benin, Benin-City. He was the President of the Nigerian Book Foundation from 1991 until his death in 2020. Here are some of his works:

Toads for Supper, 1965; The Naked Gods, 1970; The Potter's Wheel, 1973; Sunset at Dawn, 1976; Expo '77, 1980: The Chicken Chasers, 1980; The Bottled Leopard 1985; Our Children Are Coming, 1990; and Conspiracy of Silence, 2001.

MOROCCO 2025 AFCON: 24 Gladiators Emerge

he 24 gladiators that will battle for glory in the 2025 AFCON slated for Morocco have emerged following the conclusion of the qualifiers. It was tears of joy for some teams and tears of heart break for others.

In Group A, the Coelacanths of Comoros shocked the continent by qualifying ahead of the Carthage Eagles of Tunisia. They topped the group with 12 points after winning three and drawing three of their matches. Their greatest performance in the qualifiers came on match day three when they went, saw and conquered the 2004 champions, Tunisia, 1-0 in Tunis.

Tunisia joined the Islanders in qualifying for next year's AFCON after finishing second with 10 points. They were able to win only three matches and got a draw against the group winners.

Ironically, the best team of the qualifiers was the Atlas Lions of Morocco, who had already qualified as host before the commencement of the qualifiers. They have emerged favourites to win the AFCON as they garnered the maximum 18 points after winning all their matches. They are the only team to achieve this feat.

The Panthers of Gabon took the second ticket with 10 points, eight behind Morocco.

The most successful side of the AFCON, the Pharaohs of Egypt and the Zebras of Botswana took Group C's tickets.

Seven time AFCON champions, Egypt won the group with 14 points as they did not lose any match after winning four and drawing two matches. Botswana pulled through



with eight points.

In Group D, the Super Eagles of Nigeria won the group with 11 points despite putting up a woeful performance during the qualifiers which saw them lose to Rwanda at home and failed to win any away match. Their qualification was boosted by the three points and three goals they were awarded against Libya.

Squirrels of Benin Republic coached by former Super Eagles coach, Gernot Rohr, took the second ticket on goal difference as they were tied on eight points with the

Amavubi of Rwanda.

The 1990 and 2019 champions the Dessert Warriors of Algeria will be in Morocco after winning Group E with 16 points. They won all their matches except their 0-0 draw with Equatorial Guinea, who clinched the second ticket with only eight points.

It was tears of heartbreak for fourtime champions, the Black Stars of Ghana as they surprisingly finished last in Group F which comprises of Angola, Sudan and Niger. They failed to win any match, drawing three and losing as much.

While tears of heartbreak rain in Accra, it was tears of joy in Luanda and Khartoum as Angola and Sudan booked their tickets to the AFCON. Angola won the group without losing any match, winning four and drawing two while Sudan won, drew and lost two matches respectively to garner eight points. The 2012 champions, the Copper Bullets of Zambia and the AFCON reigning champions, the Elephants of Cote d'Ivoire qualified from Group G. Zambia garnered 13 points, one more than Cote d'Ivoire as both sides secure a place in

In Group H, The Leopards of Congo qualified for next year's AFCON with 12 points after winning four and losing two matches. Similarly, Taifa Stars of Tanzania will be in Morocco as they came second in the group after winning three, drawing one and losing two matches to garner 10 points.

Morocco 2025.

Eagles of Mali qualified for their 14th AFCON with 14 points after winning four and drawing two of their matches in Group I. the Mambas of Mozambique also qualified with eleven points.

Five time champions, the Indomitable Lions of Cameroon won Group J with 14 points after winning four and drawing two matches. The 2021 AFCON hosts will be in Morocco to fight for their sixth title.

The Warriors of Zimbabwe qualified for their sixth AFCON after finishing second in the group despite winning only two and drawing three matches. They have

never gone beyond the group stage of the AFCON and will be vying to break the jinx in Morocco.

1996 champions, the Bafana Bafana of South Africa will be in Morocco as they continue their search for a second African title. They qualified from Group K without losing any match. They garnered 14 points after winning four and drawing two matches.

Cranes of Uganda will also be in Morocco after coming second in the group with one point adrift of South Africa. Their 2-0 home loss to South Africa was the only match they lost in the qualifiers. They will hope to repeat their 1978 AFCON performance, in Morocco, where they got to the final.

The two West African countries in Group L subdued the Swallows of Burundi and the Flames of Malawi as the Teranga Lions of Senegal and the Stallions of Burkina Faso booked their places in next vear's AFCON.

The 2021 champions, Senegal won the group without losing a match. They won five and drew one match to garner 16 points, while Burkina Faso got 10 points.

Meanwhile, Brahim Diaz led the qualifiers scorers' chart with seven goals.

The 2025 AFCON will take place in Morocco between December 21, 2025 and January 18, 2026.

rsenal will continue their bid to win the English Premier League title for the first time in two decades when they welcome Ruben Amorim's Manchester United to the Emirate Stadium this Wednesday.

Under Erik ten Hag, the Gunners have mastered the act of disuniting Manchester United, evidently, it will be a different outing this mid-week with the arrival of Ruben Amorim.

Blast From The Past: Nwankwo Kanu **Destroy Chelsea**

anu Nwankwo c a m e Highbury after signing a contract worth around £4.15million in February 1999. He hit the ground running almost immediately scoring seven goals in 17 games.

On October 23, 1999 Arsenal took on Chelsea in a fierce London Derby. One player stood out. Guess who? Papilo.

Chelsea started the game like a house on fire. On the hour mark, they were already two goals up courtesy of headers from Tore Andre Flo and Dan Petrescu. There was no hope for Chelsea to bounce back as Chelsea were at the top of their game and their goalkeeper Ed De Goey had not conceded a Premier League goal at Stamford Bridge at that

Nigerian striker Kanu, the current chairman of Envimba International Football Club of Aba, had other ideas, though.

With 15 minutes left Kanu Nwankwo as a goal predator, who knows where to be at the right time intercepted a Marc Overmars shot and toe poked it into the bottom corner to make it 2-1. Goey's record was broken, but can Arsenal restore parity?

Overmars was instrumental again as the Gunners equalized. He fired a cross into the box Kanu Nwankwo controlled the ball into space with remarkable aplomb and fired into the net with seven minutes left.

Chelsea have restored parity, can they snatch victory from the jaws of defeat? Kanu Nwankwo had the answer. Kanu won the ball back on the touchline and for some inexplicable reason, Chelsea goalkeeper, De Goey came racing out to try and tackle the Arsenal man. Papilo calmly rounded the goalkeeper but was faced with an impossible angle and four Chelsea defenders between himself and the goal.

Undeterred, he smashed the ball into the top corner over the heads of Frank Leboeuf and Marcel Desailly to seal the 3-2 win.

It was not surprising that he was named African Footballer of the Year for the second time in 1999 and he went ahead to score 16 goals in all competitions that season.

Chelsea fans have never forgotten that painful defeat as Arsenal fans still tastes the sweetness of that victory in their mouths.
