8. The Institution Of A Direct Labour Mechanism

One other unique structure which Governor Alex Otti established that has enhanced the quick delivery of services at the most cost-effective way is the establishment of direct labour mechanism in some agencies that deal directly with the provision of physical infrastructure. Such unique mechanism has resulted in the efficient, fast and costeffective delivery of goods

Physical Manifestations Of The Good Governance System In Abia

Abia State is now regarded as a huge construction site. Most government officials are now known by their busy schedules and haste to deliver quality goods and services. Indeed, numerous projects have been delivered since the coming into power of Dr. Alex Otti on May 29th 2023.

Governor Otti appreciates the overriding importance of health-care in the human development index, hence its inclusion in the list of emergencies when he was inaugurated into office. It will be recalled that the health sector in Abia prior to May 29th, May 2023, was in a deplorable state.

Earlier in his tenure, Governor Alex Otti had enabled the Abia Teaching Hospital to regain its accreditation thereby restoring the teaching of medical officers by the institution. This is in addition to a massive investment in its infrastructure which is aimed at transforming it into a first-class health facility. The same gesture was extended to the Abia State Specialist Hospital, Umuahia and Amachara General Hospital, all of which were renovated and

General Hospital as well as the General Hospital Umuahia.

The renovations included the equipping of various department such as the Eye Clinic, now comparable to the best facilities anywhere in the country, General Outpatient Department, Accident and Emergency Departments etc.

The equipment of these tertiary, secondary and Primary health facilities continue to be an ongoing concern enabling them in the process to perform complex tasks like Bone Marrow transplant as well as other complex surgeries.

Ending The Baby Factory Menace In Nigeria

ear Editor,

What has now become a public issue is the sale of babies - a menace which has been on for some time – as teenage girls become victims of unwanted pregnancies and the children produced are sold out for adoption to couples who want babies at all cost

At the baby making factory, young girls are encouraged or forced to become pregnant and after delivery, the newborn babies are sold out, usually between N500,000 or more, depending on the sex of the child. The main concern of this piece is how to eliminate or reduce to the barest minimum, the continued demand and supply of these babies under the guise of lucrative 'business'. Who patronize the baby factory?

The answer is simple - it is either couples who badly need children, which they cannot get biologically or mischievous persons who require human parts for other reasons. There is no where that selling of human beings both adult and children not a concern, world over. Nowhere is selling of adult human beings or children not a concerned the world over.

For instance, Article 3 of the United Nations Protocol to Prevent, Suppress and Punish Trafficking in Persons especially women and children, Section 50 of the Trafficking in Persons (Prohibition) Law Enforcement and Administration Act, 2003 of Nigeria defines trafficking as including "all acts and attempted acts involved in the recruitment, transportation within or across Nigerian borders, purchase, sale, transfer, receipt or harbouring of a person involving the use of deception, coercion or debt bondage for the purpose of placing or holding the person whether for or not involving servitude in force or bonded labour, or in slavery-like conditions" while the Childs Rights Act (Cap 198) Laws of the Federation of Nigeria also criminalises exploitative child labour and other forms of child abuse hitherto left unpunished by the Criminal Codes.

In many African countries, a couple's inability to give birth to children few years after marriage is often frowned at by family members and even the extended family members, culminating into family members trading blames and pointing accusing fingers at wives for the inability to bear children.

This social problem will continue to fester unless drastic steps are taken to address the contending issues surrounding the spread of baby factories. To begin with, our adoption laws should be reviewed without further delay as this will give those who seek after having children -when they cannot produce biologically, the clean option.

Apart from the fact that married people still contend with the challenge of covering up the tracks of the origin of the children who should necessarily be integrated into the family, some establishments and government institutions reel-out age limits for the needy couples and for those who are more than 50 years, their applications may not be treated at all.

Another obstacle is that the adopting couples are usually inundated with rigorous demands by child-adoption agencies. Again, official adoption procedure that is managed by state governments, are excessively bureaucratic such that the adoptive parents are expected to meet and fulfil the basic rights and duties of the adopted child. And in the process of disbursing of wills and settlements, the adopted child must be treated as a lawful child of the adoptive parents, the same way as the biological child and not as a stranger.

Usually, when a couple wants to adopt a child, they are first expected to have obtained a temporary custody of the child. The child would then have to live with them for a couple of months on a trial basis to ascertain if they are fit to take care of the prospective adopted child.

Next, if the couple meets with the requirements, then the court allows adoption to take place, although it reserves the right to revoke any adoption process if it receives reports of any foul play along the line. A single parent too is not permitted to adopt a child of opposite sex, except in an extreme circumstance. Genuine adoptions should, therefore, be simplified to curb buying of babies.

Another factor that still encourages the booming trade, is the huge cost required in seeking medical assistance to have children. Whereas there is great advancement in medical sciences for barren couples to be assisted through the InVitro Fertilization, IVF, the process is usually out of reach of the ordinary. Going by the prevailing economic situation, it is a reality that only a few couple can afford the cost, which is not less than N1million for each attempt. Government should provide the leeway by coming in and seek ways of helping needy couples. Another point of concern is the need for effective monitoring of several organisations that engage in nefarious activities that are largely unknown to the government. It is surprising that virtually all the organizations involved in the baby factory saga claimed to be duly registered. These 'factories' were found to have been registered as non-governmental organizations, which allows them to carry out their unofficial activities through the back door. A suspected operator of one of the factories was reported to have taken the police to court for daring to challenge him. Unfortunately, he later obtained a court judgment by restraining the police from prosecuting him. In the light of this, government should tighten its registration and monitoring of the NGOs. More importantly, not many culprits have been caught and punished. We only get to read about what transpired without any mention of what sanctions were meted-out to the offenders. What resultant effect of such double standards is that some of these suspects will continue to compromise the system and escape punishment.

Nigerians React As Donald Trump Becomes The 47th President Of America

victory as a positive development, others are worried about the potential implications of his presidency.

It's worth noting that Trump's presidency has been a subject of interest globally, as his policies will have far-reaching impacts. As the second President in U.S. history to serve non-consecutive terms, Trump's second Presidency is expected to be significant.

Mr. Christian Isaac Anyalisi, a Chartered Stockbroker/ Securities and Investment Analyst, noted that there are palpable fears about cuts in US grants and supports to protégé countries. According to the expert: "Where this happens, it is expected to affect the flow of funds into the Nigerian economic system and consequently the capital market. "However, such withdrawals could compel countries to develop resistance by adopting initiatives to fill funding gaps. "We expect that policy makers at the center, particularly in the financial system will make necessary adjustments to attract investments from the USA, rather than shy away from capitalizing on the existing relationship with." He also said: "Donald Trump, from experience is an advocate of low interest rate. During his first tenure, the Federal Reserve Bank reduced interest rate to 2.5% and further down. Where this becomes the situation under the new regime, it will result in the outflow of investible funds from the US economy. In this vein, the Nigerian capital market, both the debt and equity segment is expected to benefit from this policy shift.

Low rates in the US economy will

has contributed over \$20 billion annually, thereby mitigating foreign exchange shortfalls.

"A negative shift in the immigration trend could hurt diaspora remittance", he further stated.

The energy sector.

"With a focus on the reduction of energy prices by increasing domestic oil output, there could be global low oil prices which is likely to impact the oil revenue for budget financing in Nigeria, with

a resultant increase in deficit

Experts have continued to react to Donald Trump's victory as the 47th US President, with some congratulating him and others expressing concern. President Bola Tinubu was among the first to congratulate Trump, expressing hopes for continued strong US-Nigeria relations and economic cooperation.

Some have also continued to share their thoughts, with opinions divided between support for Trump and his opponent, Kamala Harris. While some Nigerians see Trump's also lead to an increase in the flow of foreign exchange into Nigeria and as result, an increase in the value of the domestic currency. Anyalisi opined that the "America First" stance of President Donald Trump, if carried through, may lead to a reduction in diaspora remittances.

However, he maintained that it is reasonable to expect that, the US economy has so much in connection with foreign nationals, that the idea of mass deportation could prove difficult. "Data from Nairametrics and other sources has confirmed that diaspora remittances into Nigeria budget financing through increased domestic borrowing. "This development, when combined with elevated interest rates, (High Monetary Policy Rate), will create a crowding-out effect on the equities segment of the Nigerian capital market", he noted.

Another aspect of Donald Trump's policy which could affect the Nigerian economy and the capital market, according to the expert is the anticipated trade restriction through the imposition of high tariffs on imported goods, with China having to pay 60% on goods imported into the US.





Abia Govt Unveils Plans To Boost STEM Education

he Abia State Government has announced plans to launch an online platform aimed at promoting Science, Technology, Engineering, and Mathematics (STEM) education, among secondary school students in the state.

The Commissioner for Science and Technology, Mr. David Kalu, disclosed this during a press briefing on the outcome of the recent State Executive Council meeting presided over by Governor Alex Otti.

According to Kalu, the initiative is designed to enhance the teaching and learning of STEM subjects in secondary schools, with the aim of

preparing students for careers in science, engineering, technology and mathematics.

"We are investing in the future to produce more Scientists, Engineers, Technicians a n d Technologists in Abia.

"So with this online platform we would be able to reach out to students across the State.It would be accessible on personal computers, smart phones and all technologies", he said

In addition to the STEM initiative, the Commissioner revealed plans by the State government to domesticate the Federal Start-Up Act to

support technology-based start-ups in the State.

He said that the move would provide training on business processes, branding, online content creation, and other critical areas for entrepreneurs.

"If it (the start-up) is a very lucrative business, we may be able to offer hosting them to some extent and also where possible, funding would be made available.

"All sort of areas are being explored and with this, we are producing a draft act, which we will be reviewing with stakeholders and eventually passing to the House of Assembly for approval", Kalu explained.

The Commissioner also highlighted the government's readiness to roll out broadband infrastructure to foster technological growth in Abia, adding that a regulation known as the "Right of Way Policy", would be introduced to facilitate the policy.

He said that the regulation would establish guidelines for laying telecommunication cables necessary for broadband deployment.

"For instance, if you dig up a road, you have to restore the road to the exact condition you met it.

"This regulation will make anyone coming to lay cables to do it in a fashion that would be convenient for Abia citizens", he said.

According to Ibelegbu, "Most examinations set by the present administration are done with the computer, and if you are not computer literate, you won't pass the examinations," citing the recently concluded Permanent Secretary examinations as an example.

Impact of Age Grade System In Community Development, A Look Into Abiriba Community

In the Abiriba community, located in Ohafia Local Government Area of Abia State, the traditional age-grade system has been an influential force in driving communal development, with its members taking active roles in various aspects of social and economic growth.

Recently, a significant milestone was achieved as the apex stage of the age-grade system in Abiriba officially retired from its mandatory service. The retirement ceremony, known as "Ime Uche," marked the departure of several esteemed Abiriba sons and daughters from this critical level of service, symbolizing both the honor and the end of their active participation in the age-grade's responsibilities.

In a recent visit to the ancient Abiriba kingdom to explore some of its unique cultural heritage by the Abia Tours, a tourism body in Abia State, highlighted the significant role of the age-grade system, an institution as old as mankind, in driving community development. Reports indicated that no age grade is allowed to advance to the next stage without first initiating and completing a project that benefits the community. This practice has contributed to the rapid development seen in Abiriba and the wider Ohafia region.

Mrs Onyekachi Loveday, the CEO of Abia Tours, shared that the organization's mission is to promote the cultural and tourism potential of Abia State. She explained that the Abia Tours explorers travel to communities across the State to showcase its rich cultural heritage to the world and the team found the Ime Uche ceremony particularly intriguing, due to its unique background and significance.

In Abiriba, the 2024 festive season witnessed a beehive of activities, with the retirement ceremony, which is held every four years, taking center stage throughout the period. Barr Jackson Abba Agbai, one of the retirees, expressed his happiness in participating in the Ime Uche ceremony, describing it as a proud moment, having served the community for over thirty years.

Barr Agbai who provided insight into the Ime Uche ceremony and what it entails, explained that between ages of 18 and 20, an individual is admitted into the age grade system, where you stay and contribute your quota to community development.

grade system plays a crucial role in ensuring the smooth functioning of the community. Just like every other society that is being ruled by the Legislature, Executive and Judiciary, the Abiriba age grade system serves as a law making body, enforcing laws and also acting as adjudicator in disputes.

Barr Jackson Abba Agbai, a successful businessman and legal luminary, shared that through the Okezie age grade, he has dedicated the past thirty years to serving the Abiriba community. He emphasized that his ranging from traditional retirement to celebration of successful completion of a particular stage in the age grade system.

As you may know, once an individual is admitted into an age grade, they remain in that grade for a period of four years, serving the community before advancing to the next stage. The Abiriba community has a total of 13 age grade levels, with members serving in each grade until they reach the retirement stage.

On December 19th, 2024, Abiriba Community

witnessed another celebration of monumental significance. Those who had reached the warrior stage were honored for their courage in going to war and returning unharmed. The phrase "IGWA MANG" holds great weight in the heart of every Abiriba man. Ιt symbolizes strength and manhood, as the warrior stage is reserved for

retirement would not hinder his commitment to continuing in serving his people.

According to the system, retirement from the age grade means stepping down from mandatory community service, where individuals are no longer compelled to serve under the threat of a fine or sanction. As Barr Agbai puts it, "From now on, no one will mandate me to serve. Whatever I choose to do, will be entirely at my discretion".



those who are not faint-hearted, it positioned between the lower ranks and the apex stage. Successfully returning from war marks the transition into the apex stage, where individuals take on roles focused on community decisionmaking.

Reports gathered during the Igwa Mang ceremony, revealed that prior to the colonial era, those in the apex age grade were forbidden from marrying until they returned alive from war.However, with the advent of modernization, the focus has shifted to community development rather than traditional customs.

The Igwa Mang festival is an ancient tradition that showcases the history of bravery. The event is basically to celebrate the victory of the warriors at the war front and members at this level were usually happy to return home victorious from the war.

Celebrants of the Igwa Mang ceremony equally shared their moods, expressing joy to return unhurt as warriors of Abiriba land, pledging their commitment to offer more selfless services to the community.

The Ime Uche ceremony of Barr Jackson Abba Agbai, held in his White House residence in Abiriba, was one that would remain etched in the memories of its sons and daughters for a long time. The atmosphere was filled with excitement and a sense of pride as the community came together to celebrate a grand occasion. Lavishly treated, the guests were welcomed with open arms and pampered in the most sumptuous manner. The setting was nothing short of spectacular, with an array of exquisite food and drinks, including fine wines that flowed generously throughout the event.

"Abiriba remains the only community in Africa that still maintains the unique characteristics of the age grade system. Till date, the grades still govern. When there is an issue, it is being settled through the age grade, this is why we have a very peaceful community",Barr Jackson Agbai explained.

With how impactful the age grade system is, one would literally wonder, if it has any disadvantages. However, as Barr Agbai pointed out, the benefits far outweigh any drawbacks. He further hinted that the age In his parting word, Barr Agbai urged members of other age grades still in active service to dedicate themselves fully, emphasizing the importance of working hard and giving their time to the development of the Abiriba community.

Interacting with some guests at the event, the former Commissioner for Information in Abia State, Chief John Okiyi Kalu, the President, Aba Chamber of Commerce, Industry, Mines and Agriculture (ACCIMA), Chief Jerry O. Kalu (Oshimiri Ndigbo), and Dr Okorafor Ukiwe, congratulated Barr Agbai, wishing him well as he progresses in life, praying for good health upon him and as well, the strength to render more service to his family and community.



Jane Austen was an English novelist, famous for her six novels: Sense and Sensibility(1811), Pride and Prejudice(1813), Mansfield Park(1814), Emma (1816), Northanger Abbey (1818), Persuasion (1818) and Lady Susan (1871) The last three were posthumously published.

She was born in Steventon, Hampshire on Decemaber 16, 1775. It was not until April 5 that she was baptized at the local church and christened Jane.

Her father, Geoge Austen, served as the rector of the Anglican parishes of Steventon and Deane. Her mother was Cassandra Leigh.

In 1783 Austen and her sister Cassandra were sent to Oxford to be educated by Ann Cawley who took them to Southampton later that year. Later, both girls were sent home after catching typhus, of which Jane nearly died. She was from then home-educated, until she attended

boarding school with her sister from early in 1785 at the Reading Abbey Girls' School, ruled by Mrs La Tournelle. The curriculum included French, spelling, needlework, dancing, music and drama. The sisters returned home before December 1786 because the school fees for both girls were too high for the Austen family. From the time


she was 11, Austen wrote poems and stories to amuse herself and her family. She exaggerated mundane details of daily life and parodied common plot devices in stories full of anarchic fantasies of female power, licence, illicit behavior and general high spirits.

When Austen was 17 in August 1792, she started Catharine or the Bower which presaged her mature work, especially Northanger Abbey, but was left unfinished until picked up in Lady Susan.

In the months after Austen's death in July 1817, Cassandra, Henry Austen and Murray arranged for the publication of Persuasion and Northanger Abbey as a set. Henry Austen contributed a Biographical Note dated December 1817, which for the first time identified his sister as the author of the novels.

In 2013, Austen's works featured on a series of UK postage stamps issued by the Royal Mail to mark the




Ex-Athlete Donates Volleyball Equipment To Abia Sports Council

igeria made history when the Dream Team won gold in the football event of the 1996 Atlanta Olympics. The likes of Kanu Nwankwo, Austin Okocha, Emmanuel A m u n i k e, D a n i e l Amokachi, among others, gave the world joy with their soccer artistry.

Nigeria did not participate in the preliminary round of the qualifiers as world champions. So they joined the qualifiers in the first round and they were drawn against Namibia.. The Dream Team 2 did all the work in the first leg, the Namibians 4-0. So when they lost the second leg 3-2, it did not prevent Nigeria from qualifying for the next round on a 6-3 aggregate.

The second round saw Nigeria drawn in Group 1 against Angola, Zimbabwe and Uganda. For a team that won gold in the previous Olympics, this group did not look difficult at all. But, it turned out to be very difficult for the Dream Team 2.

On October 16, 1999, Nigeria defeated Angola 2-0 and were placed second in the group after Zimbabwe thrashed Uganda 3-0. The Zimbabweans maintained their lead after defeating Nigeria 2-1 on match day two while Angola took the third position after defeating Uganda 3-1.

On February 13, 2000, Nigeria bounced back to winning ways by defeating Uganda 3-2 in Kampala, yet Zimbabwe maintained the top spot after defeating Angola 3-2. Match day four took place in February 26, 2000 and Nigeria defeated Uganda by a lone goal, but Zimbabwe lost 4-2 to Angola.

Match day five was

Uganda were already out of contention having lost all their five matches.

The situation was very dicey for Nigeria, though they would host Zimbabwe while Uganda host Angola in the last qualifying matches. It was obvious that Angola would defeat Uganda and move to 12 points. So Nigeria must not only defeat Zimbabwe but must do so, with as much as two goals to have a superior goal difference.

Meanwhile, Zimbabwe's coach was a man who knew Nigerian football like the back of his hand-Clemens Westerhof. At the end of the first 45 minutes of the tension soaked encounter, Nigeria were 2-0 up courtesy of Emmanuel Ebiede's brace. At this point, Nigeria was top of the group, but only a goal by the Zimbabweans will turn everything upside down. So the tension was palpable down to the rooms of Nigerians who were watching the match.

Meanwhile, in Kampala, the score was still goalless, the Angolans needed just a lone goal to leapfrog Nigeria and they were confident that they would do just that in the second 45 minutes. They did that in the 83rd minute through De Almeida Joao Santos. The Angolans can feel Sidney and it was heartbreak for Nigeria.

Nigeria must score twice to leapfrog the Angolans, while Zimbabwe needed just a draw to get unassailable 13 points.

Ticking of every second of the clock was the Sidney Olympics crawling away from Nigeria. But just a minute to full time, Yakubu Aiyegbeni scored a third goal. At this point, Zimbabwe were out because they could not equalise, but another goal is need overcome Angola. It was the last action of the match; the referee was ready to blow the final whistle. Pius Ikedia took the ball and ran into the opponents vital area, he needed to cross the ball but the opponents were poised to clear the ball, then he decided to hit the ball hard with the hope of a deflection and indeed the ball deflected off a Zimbabwean player into the back of the net. At the blast of the final whistle, Nigeria booked their ticket for Sidney, while Angola and Zimbabwe booked their tickets for Luanda and Harare, respectively.

crucial, Nigeria needed to win to leapfrog Zimbabwe ahead of the last round of matches, but the opposite happened. Angola defeated Nigeria 3-1 and Zimbabwe defeated Uganda by a lone goal. At this point, reality dawned on the team and their fans across the country, participating in the 2000 Sidney Olympics could be a mirage.

Zimbabwe were leading the group with 12 points, Angola were second with nine points same as Nigeria but the East Africans had superior goal difference of +3 while Nigeria had +1.
