In May 2001, Dr. Alex Otti joined First Bank of Nigeria as Assistant-General Manager, responsible for growing the Energy Sector. He was later promoted to Deputy General Manager, and then Executive Director for the South Directorate, overseeing over 140 branches in the South-South and South-Eastern political zones.

Diamond Bank:




Honours and Recognition: **Honorary Degrees:**

Political Career:

Dr. Otti first contested the governorship election of Abia State in 2015, under the All Progressives Grand Alliance (APGA) and was declared the winner by the Court of Appeal on December 31, 2015. However, the Supreme Court reversed the decision on February 3, 2016, affirming the incumbent Okezie Ikpeazu as the Governor.

Dr. Alex Otti again in 2019, contested the same office and was under the same party, but was declared the second runner-up.

Dr. Alex Chioma Otti remained undeterred and continued his political journey .In 2023, he contested the Governorship Election under the Labour Party and had a landslide victory with a total vote of 175,467 against his closest rival, Chief Okey Ahiwe, who came a distant second with 88,529.

He was sworn in as the Executive Governor on May 29, 2023.

Nkwonta holds Maiden Ukwa **Town Hall Meeting, Set To** Build Skill Acquisition Centre

he Chairman, House Committee on South-Eas Development Commission (SEDC), Federal House of Representatives Abuja, Hon. Chris Nkwonta, ha held his maiden non-partisan stakeholders meeting with his constituents to address their peculiar challenges in the area.

Speaking at his country home, Akwete Ndoki, Ukwa East Local Government Area, Abia State recently, th lawmaker representing Ukwa-East and Ukwa-West Federa Constituency at the National Assembly, decried the high level of underdevelopment in his constituency in spite being an oil-rich area, insisting that state governments from 1999 ti date have failed to fix critical infrastructure for their people.

He said, "I am not a politician but in politics to interven in the affairs of our people. We have not faired well in Ukwa East and Ukwa-West in terms of politics, from 1999 till 2023 We are not getting our fair share in Abia project. The people of Ukwa-East and Ukwa-West have become endangere species in Abia project from one administration to another".

These and more other reasons informed his decision t unite their people, through nonpartisan stakeholder meeting, maintaining that their survival lies in their unity of purpose

The Ndoki-born Federal Legislator, also proposed to build an ultra-modern skill acquisition centre in Ukwa-Wes to train teeming unemployed youths and women from the constituency on vocational skills before empowering then economically

This, he said, would take away the attention of youth from crime and other social vices, promising to alway embark on projects that would directly touch the lives of th Ukwa people.

According to Hon Nkwonta, the ultra-modern skill acquisition centre, which would require about 50 plots o land, will train interested Ukwa Youths in such skills as Masonry, Carpentry, Plaster of Paris (PoP), Tiling, Painting Electricals, Plumbing, Welding, Fishery, Piggery, Poultry Information and Communication Technology an Footballing among others

Contributing, the President-General, Ndoki Union, Rev Felix Akara, commended the Federal lawmaker for the proposed ultra-modern skill acquisition centre, urging fo the revival of existing ones.

The cleric disclosed that Ukwa people have comparative advantage also in agriculture, calling for more investment in the sector, to boost food security and socio economic development.

In his remark, the former Commissioner for Information and Strategy in Abia State, Chief Don Ubani, explained tha unemployment is a major factor that militates agains development, with chains of negative multiplier effects o any society.

He applauded Nkwonta, adding that the project, whe completed, would curb youth restiveness and looming insecurity in the State and country at large.

Ubani said: "It will be necessary to note that even in th midst of unemployment in Nigeria, youths that have skill are never out of lucrative engagements. They are alway sought for by individuals or corporate bodies that requi their services.

He promised to support the lawmaker in hi determination to address, holistically, the challenges unemployment and development in his constituency.

Meanwhile, the member representing Ukwa-East Stat Constituency in Abia State House of Assembly, Hon, Lew Obianyi and his Ukwa-West counterpart, Hon. Godwi Adiele, lauded Nkwonta for the proposed project, adding that they would continue to collaborate his efforts in the capacities in order to attract democracy dividends to the constituents.

rganization for Women in Science for the Developing World (OWSD) has lamented that despite significant strides in higher education, women remain underrepresented in Science, Technology, Engineering and Mathematics (STEM) fields worldwide.

The Coordinator, OWSD Umudike branch, Prof. Mabel Ifeoma Onwuka who stated this recently during the 2025 International Day of Women, Girls In Science at Awom na Ebo Secondary School, Amawom Oboro, Ikwuano Local Government Area (LGA), Abia State, identified encouraged them to societal stereotypes, limited take up challenges, access to education, and revealing that the lack of mentorship opportunities among others as factors contributing to the negative trend. the 3-kilometer Mgbaga to Otulu Ebem Ohaifia road by the Federal Government of Nigeria has consistently progressed since after its flagoff some weeks ago.

Attracted by the law maker representing Arochukwu/Ohafia Federal House of Representatives, Hon. Ibe Okwara Osonwa, the 3-km road starts at Ebem motor park and passes through Mgbaga community to Otulu.

Performing the flag-off ceremony on February 1st, 2025, on behalf of the Ebemborn Federal Lawmaker, the paramount Ruler of Ebem Ujuruezie, HRM, Ezie Ukoha Kalu Ukoha (JP), expressed the gratitude of Ebem people to God for answering the people's prayers over the years for that road to be constructed, and to Hon. Osonwa for attracting the

"very dear" to Ebem Ohafia Community.

Ezie Ukoha urged the Supervising Engineer to the Construction Company handling the job to avoid anything that will delay the timely completion of the work, stressing that the community will frown seriously at any such delay. He stressed that the road, when completed, will certainly decongest Ohafia-Arochukwu Federal Road that traverses Ebem community – which is usually rendered impassable due to traffic congestion, especially during festive periods - hence the need for its timely completion.

Hon. Ukariwe appealed to citizens of Ebem and residents whose properties may be partly or wholly affected by imminent demolition exercises, to cooperate with the construction company, Ebem community and the Federal Government by showing understanding.

Speaking on behalf of Ebem Ohafia Development Union (E.O.D.U), the first Vice President-General, Hon. Lochi Ngam, disclosed that the Mgbaga-Otulu road issue has, for a long time, been a matter of great concern to the union and eulogized the Ebem son, Hon.

He announced that E.O.D.U will give every needed support to the construction company - including not allowing any person or group of persons in Ebem, to obstruct the company's operations.

Hon. Ngam warned that henceforth EODU will no longer tolerate any illegal structure or building that blocks any road or street in the community.

Assuring Ezie Ebem, the Eze-in-Council and the people of Ebem of the company's preparedness to deliver quality work on the road, the Supervising Engineer to the construction company, Mr. Osita Mbaka, said the 3-km interlock Mgbaga-Otulu, Ebem road will be completed in 16-weeks and called for Cooperation and understanding from the people of Ebem. He reiterated the fact that the road project was very dear to Representative Ibe Okwara Osonwa and that the company cannot disappoint the law maker and Ebem community.

2027: Why Nigerians Must Take Rotimi Amaechi Serious

ormer Rivers State governor, Rotimi Amaechi, has once again stirred up the proverbial hornet's nest by choosing to be politically incorrect in a clime where doublespeak not only walks on all fours but is also seen as an exemplar of political astuteness. But not for the man who was Speaker of the Rivers State House of Assembly, former Governor of Rivers State and former Minister of Transport.

Speaking in Abuja on January 30, at a national conference on strengthening democracy in Nigeria, organized by the African Centre for Leadership, Strategy, and Development, Amaechi, as he is wont to do, bucked the hypocritical trend when he reminded his audience that included former Vice President Atiku Abubakar, former Governor of Kaduna State, Nasir el-Rufai, and Senator Aminu Tambuwal, former Governor of Sokoto State, that the average Nigerian politician will not relinquish power unless compelled by the superior will of the people. Nobody has power and will give it to you - not even me... The politician in Nigeria is there to steal, maim and kill to remain in power. If you think Tinubu will give it to you, you are wasting your time," Amaechi said, stressing the need for vigilance and sacrifice.

the docility of Nigerians and their inability to react to the egregious dishonesty of their leaders for the rascality of politicians.

"Nigerians don't react to anything. Has any politician told you he is not a thief? Which politician told you he went to university, which politician told you he/she served in NYSC, and which politician told you he has his certificate? Nigerians know and still vote for them... Even if you come to a Nigerian's house and kill his mother, the father will continue with his life. So, why should I waste my time," he asked.

But even long before The Niche lecture, he had always taken umbrage at the atrocious conducts of Nigerian politicians and seeming acquiesce of the people. all Nig Speaking on December 15, 2013 at reality. an event organised in Lagos to pay tribute to former South African President Nelson Mandela, he say that Amaechi simply amplified challenged Nigerians to hold their leaders to account, insisting that political office holders steal State funds because Nigerians do not stone them. So, Amaechi, in a sense didn't say anything new last Thursday. If anything, he has been consistent on his advocacy that the pathway to good governance and political integrity in Nigeria is for the younger generation to wake up from their slumber and fight for the soul of the country. The fact that he is a major player in the Fourth Republic politics also makes it imperative that Nigerians should listen to him. He knows where the bodies are buried.

October 28, 2023, Amaechi blamed forcefully. After all, he was not the only person who spoke at the Abuja event. But they know that he was telling the truth, knowing exactly how elections are won and lost in Nigeria. So, their pretentious indignation is an attempt to scare him away from his self-imposed task of conscientizing the youths. Berating Amaechi for making

reckless, dangerous and inflammatory remarks unbecoming of a former 'public office holder,' Minister of State for Defence, Bello Matawalle, told him that power is earned through democracy, not intimidation, violence or lawlessness, as if Amaechi was in doubt. His claim that the Tinubu administration was committed to upholding peace, democratic values and security for all Nigerians flies in the face of

Of course, Nigerians know who is lying between the two. Suffice it to Tinubu's very Machiavellian idea of power and how it is acquired. Shortly before the 2023 elections, Tinubu, the then presidential candidate of the All Progressives Congress (APC), was seen in a video admonishing top campaign operatives to 'fight, grab and run (away) with' political power. Political power is not going to be served in a restaurant. They don't serve it a la carte. At all cost, fight for it, grab it and run with it," he said. And that was exactly what he did, which is also what will happen in 2027 unless Nigerians say enough is enough, the very direction that Amaechi is pointing them to. The very idea of fighting, grabbing and running away with political power is antithetical to democracy. In a democracy, power is given by the people in a free, fair

and credible election.

Of course, in a system that has normalized the idea of power not being given by the electorate but taken forcefully by the strong, in a system where might has always been seen as being right and democracy is a 'do or die affair' (apologies to former President Olusegun Obasanjo), Amaechi's advocacy can only be deemed as treasonable, which explains Matawalle's angst and threat on behalf of his principal.

'Let me make it clear: the security agencies are on high alert. Any individual or group found inciting violence or attempting to destabilize this nation will face the full force of the law. We will not tolerate any form of subversive rhetoric that seeks to undermine national unity or incite lawlessness. This government will not fold its arms and allow any individual to disrupt the peace and stability of Nigeria," he warned. But pray, how does Amaechi's charge to Nigerians to vote and ensure that their votes are not only counted but count in the outcome of elections be deemed an attempt to undermine national unity? Those who disrupt national unity are those who ensure that votes do not count in elections, people whose democracy worldwide undermine the very principle of democracy. In a democracy, power is given by the people, not taken willy-nilly by the powerful. Yes, every contest for power is a serious business. But the seriousness lies in the intense battle to win the support of the people who hold the supreme power. As I have always argued, democracy does not guarantee that the best candidate will win. No! But the

irreducible precondition for any democratic adventure is that power must be freely given by the people.

It may be tempting to dismiss Matawalle's threat as sheer bluster, an attempt to cow the people to submit to the Tinubu government's antidemocratic whims and caprices, but Nigerians must take it serious. As at today, nothing suggests that the government is planning for a free and fair poll in 2027 where the choices of the majority of the electorate will prevail.

But knowing the character of successive Nigerian governments since 1999, the messenger may well be endangered. It will, therefore, not be a surprise if the Economic and Financial Crimes Commission (EFCC) starts hounding the arrowheads of the emerging opposition to the prevailing political status-quo, with Amaechi as the principal target.

The former minister is aware of the risk he faces. At the TheNiche lecture, he told the audience that: "The worst thing about Nigerians is that even when you have not committed any crime and they pick you up tomorrow, they will chorus we said it, he is a thief,' and you will go to prison for nothing. The greatest fear I have is being found in prison for nothing and you can be found in prison for doing nothing." The fact that Amaechi knows the risks involved and yet is determined to bite the bullet makes his cause altruistic. And he is right. Nigerian politicians are unconscionable. They steal, maim and kill for power and will continue to do so for as long as there are no consequences for their atrocious behaviours. For democracy to thrive, Nigerians must fight for it with all they have, a reason well-meaning people must rally round Rotimi Amaechi rather than join the band of government apologists in vilifying him.

To be sure, this is not the first time he would task Nigerians to take their political destiny in their own hands.

Thus, the platform for wealth is released based on the covenant. When we step out into the covenant, we encounter the power to get wealth. Prosperity is not a promise we claim in prayers or with fasting and confession. No! It's a covenant we practice. That means, God has set a stage for us, but we must understand our part of it and then the power to realize the

promise will be delivered to us. Christian books A covenant as it were is

like a contract. So, it involves two or more people. In this case, it involves just you and God. God is the covenantor and we are the covenantee; that is, we are the beneficiary of the deal. All we need is a good understanding of what the covenant entails and we will be up in abundance. The Bible says, My covenant will I not break, nor alter the thing that is gone out of my lips (Psalm 89:34). God is a covenant keeper. His side of every covenant is forever secured; it is our side that is variable. But when we lay hold on the terms that relate to us and apply ourselves to it, God is committed. And once we locate the covenant and we enter into it, our struggles will come to an end. Since that day in March 1981 when I saw the covenant of prosperity, I entered into my rest. We don't pray or fast for a covenant, we just enter into it. As it is written, And they entered into a covenant to seek the Lord God of their fathers with all their heart and with all their soul; And all Judah rejoiced at the oath:

for they had sworn with all and make thy name great; their heart, and sought him with their whole desire; and he was found of them: and He moved as he was the Lord gave them rest round about (2 Chronicles 15:12, 15). Christian books

the Bible records that Isaac prevailed in famine, And there was a famine in the land, beside the first famine that was in the days of Abraham. And Isaac went unto Abimelech king of the

Philistines unto Gerar. Then Isaac sowed in that land, and received in the same year an hundredfold: and the LORD blessed him. And the man waxed great, and went forward, and grew until he became very great: For he had possession of flocks, and possessions of herds, and great store of servants: and the Philistines envied him (Genesis 26:1, 12-14). Note that the covenant is stronger than any climate! There is no economic dearth or crisis that can break the efficacy of the covenant. Furthermore, in Jacob's time, ... the famine was sore in the land (Genesis 43:1). But in spite of this, Jacob still had more than enough. 



Govt. Directs Communities In Boundary Disputes To Submit Proof Of Ownership

bia State Government has directed the Amaba Community in Ikwuano Local Government, Lodu Ibeku in Umuahia North and Olokoro in Umuahia South, involved in boundary dispute, to submit their claims of ownership to the state government, within one week.

The State Deputy Governor, Ikechukwu Emetu, gave the directive in his office, at Government House, Umuahia, during a meeting with the three contending communities warring over ownership of land.

He noted that the State faced both internal and external boundary challenges as she shared boundaries with seven States of Akwa Ibom, Anambra, Cross River, Ebonyi, Enugu, Imo, and Rivers, and restated the present administration's resolve to ensure that all the internal and external boundaries problems are resolved this year.

Obi eventually met Ada and they walked home together.


Chioma had finished eating and was about to lay down when her children came back. Obi greeted her, lay down and slept off almost immediately.

mmanuel Elechi Daniel was 🕇 born in Mbado-Aluu in Ikwerre Local Government Area of **Rivers State. He attended Government** College, Umuahia between 1948 and 1952. He proceeded to Survey School and graduated in 1954. He attended University of Ibadan, where he studied Physics and Mathematics between 1955 and 1959. He adopted the name Elechi Amadi while in the University to reflect his Ikwerre heritage.

After working for a while as a surveyor, he later took up teaching and taught in several schools including the Nigerian Military School Zaria, after he had joined the Nigerian Army.

Amadi rose to the rank of captain before he retired from the military. He joined the Rivers State civil service and rose to the rank of Permanent Secretary. Between 1987 and 1988, he served as the Commissioner for Education and moved to the Ministry of Lands and Housing in the next two years.

As an author, Elechi Amadi was best known for his historical trilogy about traditional life in Nigerian villages: The Concubine, published in 1966. In 1969 The Great Ponds was published and The Slave followed in 1978. These novels focused mainly on destiny and the extent to which it can be changed: the relationship between people and their gods is the central issue explored. His verse play, Isiburu, published in 1973 was about a champion wrestler who was ultimately defeated by the supernatural power of his enemy. He also wrote Pepper Soup and Road to Ibadan, both works were published in 1977. Estrangement was published in 1986 while the play Woman of Calabar was published in 2001.


Sunset in Biafra: A Civil War Diary was published in 1973. It focused on Amadi's experiences during the Nigeria-Biafra civil war. He ventured into sciencefiction in his later writing years and published "When God Came", a sciencefiction in 2013.

Elechi Amadi was kidnapped on January 5, 2009 in Aluu town by unknown gunmen and was released after 23 hours.

In 1992, he received Rivers State Jubilee Merit Award: Rivers State University of Science and Technology awarded him an honorary doctorate award in science and education in 2003.

He became a fellow of the Nigerian Academy of Education in 2003 and in that same year the Federal Government honored him with the Member of the Order of the Federal Republic(MFR).

On June 29, 2016, Amadi died at the Good Heart Hospital in Portharcourt at the age of 82.

t is do-or-die; cruise-or-crash; swim-or-sink; make-or-mar as the UEFA Champions League play-off second leg holds this Tuesday and Wednesday as 16 teams battle for the eight vacant place in the round of 16.

The biggest encounter will take place on Wednesday at the Santiago Bernabeu in Madrid Spain, where the most successful side of the competition, Real Madrid with 15 titles will host 2023

champions Manchester City.

The first leg ended 3-2 in favour of the Spaniards, which has made this match a must win for the English champions while Real Madrid will qualify with just a draw. It will be a let down by all standards if any of the clubs failed to reach the round of 16.

After breaking the jinx of never scoring for Manchester City against Real Madrid with the two goals he scored in the first leg, Erling Haaland will be expected to lead the attacking line of the English side. On the other hand Pep Guardiola must have a special plan to silence the deadly combination of Jude Bellingham, Kylian Mbappe and Vinicius Junior.

Ademola Lookman's Atalanta suffered a 2-1 loss to Club Brugge in Belgium and must win this Tuesday's encounter to stand a chance of qualifying. Now without the injured African Player of the Year, Atalanta have to struggle harder and they must be at their best to avoid elimination.

Bayern Munich welcome Celtic to the Allianz Arena after Michael Olise and Harry kane scored to give them a comfortable two goals lead in the first leg at the Celtic Park before Daizen Maeda pulled one back for the Scotish side. It will definitely be an uphill task for Celtic to get a favourable result in Munich, but the lone goal they scored is an anchor for any hope of an upset. The Giuseppe Meazza Stadium will be the battle field when Samuel Chukwueze's AC Milan take on Fevenoord who won the first leg at their home by a lone goal scored by Igor Paixao. Having lost for the fourth time in this campaign, AC Milan will need to significantly improve as they host the return leg if they will not be




shamefully eliminated from the competition.

Having won the first leg by a lone goal, Benfica have a better chance of reaching the last 16 as they welcome Monaco to the Estadio du Luz.

This second leg at the Parc des Princes will be a stroll in the park for the Parisians, who had defeated their opponents in their two meetings in the French League this season.

Borussia Dortmund are one leg into the round of 16 after ruthlessly defeated Sporting CP 3-0 in their first leg encounter at the Estadio Jose Alvalade. All the

Germans need at home is to avoid any defeat more than a two-goal margin to reach the round of 16.

The old ladies of Italy, Juventus will storm the Philips Stadium in Eindhoven to take on PSV whom they defeated 2-1 in Turin. This encounter is very open as any of the sides can still qualify.

Weston McKennie gave the Italians the lead in the 34th minute with a stunning strike from the edge of the box after the visitors failed to clear their lines. Ivan Perisic scored his first Champions League goal since 2020 to restore parity.

But, Samuel Mbangula scored the winner for Juventus eight minutes from time to give them a slim advantage ahead of Wednesday's second leg.

The first leg of the round of 16 matches will take place on March 4 while the second leg will take place one week later.

2006 World Cup Qualifier

qualify for the Germany 2006 World Cup losing the ticket to the Palanca Nigaras of Angola, who qualified for the first time. It was a heartbreaking experience for Nigerian fans, who had expected Nigeria to qualify from the group that had Algeria, Angola, Gabon, Rwanda and Zimbabwe. What really happened? Why did the Super Eagles failed to qualify for their fourth consecutive World Cup?

Nigeria made her debut at the World Cup in 1994 in USA and qualified for two subsequent editions in France 1998 and in Korea/Japan 2002. Having qualified for three consecutive World Cup tournaments, complacency stepped in as football authorities, players and the fans started thinking that qualifying for the World Ĉup is the right of Nigeria. Nigeria started the qualifiers on a bright note with Obafemi Martins scoring a brace to give Nigeria a 2-0 victory over Rwanda at the Abuja National Stadium. This result placed the Super Eagles top of the group with three points.

The second match was against Angola at the Estadio da Didadela in Luanda. Nigeria went to the match without key players like Austin Okocha, Kanu Nwankwo, among others. Fabrice Akwa scored an 84th minute goal to give Angola all three points.

On match day three, Joseph Yobo secured all three points for Nigeria against Algeria with an 84th minute goal and Nigeria returned to the top with six points after Angola drew 2-2 with Gabon. Nigeria remained on top after match day four as they went, saw and conquered Zimbabwe 3-0. On match-day five. Nigeria travelled to Gabon but could only settle for a 1-1 draw. This result allowed Angola to leapfrog Nigeria after defeating Zimbabwe by a lone goal. The next matchday Nigeria bounced back to the top after defeating Gabon 2-0 in Portharcourt and Angola losing by the same margin to Zimbabwe. Problem started on match day seven as key players failed to honour the Battle of Kigali which saw Nigeria drew 1-1 with Rwanda. Austine Okocha

igeria failed to was among the players who were absent and he claimed that he lost his way in London. Angola grabbed the opportunity with two hands and defeated Algeria 2-1 to reclaim the top.

> With three matches to go, Nigeria had all it takes to qualify, especially as one of the matches was against table toppers, Angola. On the other hand, the Angolans had their own plans, if they could get a draw against Nigeria and win their other two matches, World Cup ticket would be secured.

> The Nigerian Football Federation inexplicably, decided to take the Angola match to the Sani Abacha Stadium in Kano instead of playing the match at the National Stadium Abuja or the Liberation Stadium in Portharcourt. The match ended 1-1 and the Angolans realized that all they needed were to win their remaining matches and they would qualify for their first World Cup.

> Nigeria started their usual permutation and combination, hoping that either Gabon or Rwanda would do for them what they failed to do for themselves over two legdefeating the Angolans.

> Angola spank Gabon 3-0 as Nigeria defeated Algeria in Oran 5-2. In the last round of matches, Nigeria defeated Zimbabwe 5-1, but could not qualify as Angola defeated Rwanda 1-0. While there were celebrations in the streets of Luanda, there were sorrow and sadness in the streets of Abuja.

> Reality dawned on Nigerians. A World Cup ticket is not the right of any nation, those who are more prepared and fight for it will definitely get it.

> That qualifier produced a revolution across Africa. In Group 1, the Hawks of Togo qualified ahead of the Teranga Lions of Senegal who reached the quarter-final when they debuted at the previous World Cup. The Black Stars of Ghana qualified for their first World Cup in Group 2 ahead of Bafana Bafana of South Africa. In Group 3, the Elephants of Cote d'Ivoire qualified for their first World Cup instead of the Indomitable Lions of Cameroon and the Pharaohs of Egypt.

> In Group 5, the Carthage Eagles of Tunisia qualified ahead of the Atlas Lions of Morocco.


