

### Abia's Miraculous Bounce Back

In just two years—barely halfway through his first term—Governor Alex Chioma Otti has triggered monumental changes that many now refer to as "The Abia Miracle." But to appreciate the transformation, one must first reflect on the condition of Abia prior to May 29, 2023.

#### A State in Ruins

Before Governor Otti took office, Abia was widely regarded as one of Nigeria's least developed states. Under the administration of Dr. Okezie Ikpeazu (2015–2023), the state's infrastructure, economy, and public service architecture had deteriorated drastically.

Heaps of waste littered Umuahia and Aba. Roads were impassable. Power supply was erratic. Public schools and health facilities were dilapidated. The civil service was riddled with corruption, absenteeism, and inefficiency. Workers and pensioners were owed several months of salary arrears. Government buildings were crumbling, and the public debt burden was staggering—over N92 billion owed to banks, contractors, workers, and pensioners.

When Governor Otti assumed office, many government offices were shuttered due to an ongoing industrial action by organized labor. It was a state in near-total collapse—akin to the scene in Chinua Achebe's Things Fall Apart, where Okonkwo inherited a legacy of poverty and debt from his improvident father, Unoka.

#### Governor Otti and the Abia Miracle

Against this grim backdrop, Governor Otti's swift and strategic reforms have brought about what many call a miracle. Roads are being rebuilt—Okpara Square to Express Tower, Ngwa Road in Aba, and numerous others. Clean streets, smart schools, revamped hospitals, and upgraded government facilities now reflect a new era of governance.

But this "miracle" is not magic. It is the product of sound economic planning, strong political will, and an unyielding commitment to service.

#### Building a New Governance System

The "New Abia" is powered by a reformed governance structure built on:

Merit-Based Appointments: Professionals with proven track records have been appointed to key positions, regardless of gender, class, or ethnicity.

**Rule of Law:** Governance is now driven by due process, legality, and institutional integrity.

Leadership by Example: Governor Otti leads from the front, setting high standards of discipline, hard work, and transparency. Public workers are now paid regularly—on the 28th of every month, as promised during the

campaign.

Empathy for the Vulnerable: His administration has implemented free healthcare programs, settled salary and pension arrears, and expanded access to education through empowerment initiatives.

MDA Reform: Ministries have been restructured for efficiency, many now implementing projects via direct labor at minimal cost.

Fiscal Discipline: Strict adherence to budgetary provisions ensures that public funds are properly utilized. Payment cycles are transparent, with the Accountant-General mandated to release funds within 72 hours of approval.

**Strategic Partnerships:** The Governor has tapped into both local and international networks to attract investments and support. Structural

platforms such as the Transition Council, Global E c o n o m i c Council, and Security Trust F u n d have e n h a n c e d coordination.

#### A Culture of HardWork

Governor Otti's legendary work ethic has

redefined leadership in Abia. He is known to sleep less than four hours a night, constantly pushing the machinery of government forward. His relentless drive has inspired his team and established a governance tempo that ensures projects are delivered promptly and efficiently.

### Restoring Trust Through Accountability

Public funds are no longer siphoned off. The Due Process Office ensures value-for-money in all procurements, and the culture of stealing from state coffers has been decisively dismantled. The result? Investors and development partners now see Abia as a credible destination for business.

#### Inclusive Governance

Governor Otti's administration reflects inclusivity across all zones, communities, and gender lines. For the first time, women hold critical roles in government, and no part of the state feels marginalized.

### Conclusion: A New Abia Has Emerged

The "Abia Miracle" is not a fluke—it is the result of deliberate policies, disciplined execution, and people-centered governance. Governor Otti's administration has reawakened hope, restored pride, and repositioned Abia as a model of

transformation.

In just two years, Abia has not only bounced back from the brink—it is charting a bold new path toward prosperity. The once-forgotten state is now a shining example of what visionary leadership can achieve. Indeed, the New Abia is here to stay.

In fact, under Governor Alex Otti's administration, women have assumed key leadership roles across several vital state institutions. Offices such as

Accountant-General of the State; Chairperson s of the Civil Service Commission and the Primary Education Board; Commission

ers in the Ministries of Tertiary Education and Poverty Alleviation; Director-General of the State Orientation Agency; Chairman of the Hospitals Management Board; and the Chief Medical Director of Abia Specialist Hospital, Aba, are all led by women. Additionally, women hold approximately 75% of the Permanent Secretary positions in Abia

Gov Otti And His Team At The Monthly Expanded Exco Meeting

Governor Otti's commitment to inclusive governance is further demonstrated by the consistency of weekly State Executive Council meetings and monthly Expanded Executive Council meetings. These gatherings ensure collective decision-making and promote accountability among top government officials, allowing challenges to be identified and resolved collaboratively with set timelines for execution.

#### 1. Timely Payment of Workers' Salaries

In keeping with the biblical principle, "A worker deserves his wage," Governor Otti pledged during his May 29, 2023 inauguration that salaries would be paid on or before the 28th of each month. This pledge has been faithfully upheld. Prior to his administration, salary payments were

irregular and arbitrary. Today, in addition to prompt salary disbursements, all entitlements and allowances due to Abia workers are consistently honored. This has greatly improved staff morale and productivity, reinforcing a hallmark of good governance.

### 2. Recovery of Government Assets

A responsible administration ensures the protection and recovery of public assets. Governor Otti has demonstrated unwavering commitment in this regard by establishing a State Panel on the Recovery of Government Funds and Assets, chaired by Justice Mrs. Duruoha (Rtd). In 2024, he also commissioned a Visitation Panel for Abia State University. These efforts are aimed at curbing corruption and restoring accountability in public institutions.

### **3. Repositioning the Civil Service**Governor Otti has reinvigorated the Abia State Civil Service by:

Promoting merit-based recruitment, promotion, and disciplinary measures.

Renovating and upgrading government staff quarters and public infrastructure.

Combating ghost workers, absenteeism, and workplace truancy.

These reforms have transformed the Abia workforce into a more efficient and professional service, significantly improving government

service delivery.

### 4. Implementation of Direct Labour Mechanism

To fast-track service delivery and reduce costs, Governor Otti introduced the use of direct labour in key ministries like Works, Lands and Housing, and the Abia State Environmental Protection Agency (ASEPA). This approach leverages inhouse professionals, enhancing their capacities while saving public funds.

As Commissioner Chaka Chukwumerije aptly stated during the re-opening of the Old Secretariat Complex in November 2024, this approach "deepens the capacity of the State's Structural Engineers, Builders, Architects and Quantity Surveyors, while saving resources and delivering quality."



Abia State is now regarded as a huge construction site. Most government officials are now known by their busy schedules and haste to deliver quality goods and services. Indeed, numerous projects have been delivered since the coming into power of Dr. Alex Otti on May 29th

Such goods and services have been delivered at quick paces and with a most effective costs that leaves many observers quite bewildered.

Since there are legions of such projects, only few examples which roughly falls within the sectors that Governor Otti declared an Emergency on, when he assumed office on May 29th, 2023 would be showcased here.

#### Road Infrastructure Development

Abia's roads, once among the worst in Nigeria, have undergone a dramatic transformation. Over 300 roads-urban, intercity, and rural-have been constructed or rehabilitated. These roads are built to high standards and include drainage systems, street lights, and roundabouts. Governor Otti's collaboration with both local and international contractors has ensured lasting infrastructure improvements.


Two years into his administration, Dr. Otti has proven that meaningful progress is possible. He listens, he acts, and most importantly, he delivers.



# Editorial

### Otti At Midterm – A Clear Departure In Infrastructure Governance

t the halfway point of Governor Alex Otti's first term, Abia State finds itself at an inflection point. For a state long encumbered by developmental inertia and administrative lethargy, the last two years have marked a visible, if not transformative, shift-especially in the realm of critical infrastructure.

Unlike previous administrations whose infrastructural footprints were largely uneven, unsustainable, or mired in opacity, Otti's approach has so far leaned toward strategic planning, quality execution, and financial transparency. Roads, which had become perennial symbols of neglect in urban hubs like Aba and Umuahia, are now witnessing systematic rehabilitation, drainage inclusion, and better materials that promise durability rather than decay.

Past governments often launched projects with fanfare but completed few. White-elephant projects, abandoned sites, and pothole-riddled roads defined the infrastructural reality of successive regimes. Under Governor Otti, however, the story has begun to change. The Osisioma Flyover—left in limbo for years—was among the early interventions aimed at restoring public confidence in governance. Major roads like Port Harcourt Road in Aba and Ossah Road in Umuahia, long abandoned, are now seeing meaningful work. While these

projects are not without delays or criticisms, their implementation suggests a welcome departure from the cycle of "motion without movement."

Power infrastructure, though traditionally under the purview of federal institutions and private entities, has also received attention under Otti's leadership through partnerships aimed at boosting industrial energy supply. In contrast, previous administrations paid limited attention to energy infrastructure's enabling role in economic revitalization.

Furthermore, Otti's digitization of project monitoring and contract management adds a layer of accountability that was largely absent in the past. Open procurement processes, performance audits, and citizen feedback mechanisms are slowly becoming part of the governance fabric, challenging the old model of opaque budgeting and contractor favoritism.

That said, the work is far from complete. The state's rural infrastructure remains patchy, and some legacy issues—such as poor drainage, flooding, and rural-urban disparity—still plague many communities. But even here, Otti's government has made serious inroads, notably through rural road mapping and basic health center upgrades in most LGAs.

Governor Otti's midterm record on infrastructure is markedly progressive. If sustained, it may well set a new template for public service delivery in the state. Gov. Otti's leadership is not just promise made but promise kept.

Once again a big congratulation to the Able Governor on a meritorious 2 years in office.

### Taming The Soaring Cost Of Housing In The Southeast And South-south

Dear Editor.

he escalating cost of housing across the Southeast and South-South regions of Nigeria has reached alarming proportions. In major urban centers like Enugu, Owerri, Port Harcourt, Uyo, and Asaba, average citizens are increasingly priced out of the rental and ownership markets. What was once a problem of limited supply is now compounded by unchecked speculation, poor urban planning, and minimal government intervention.

Young professionals, artisans, and even middleincome earners are forced to live on the fringes of cities or endure exploitative rent conditions. Developers, in turn, often cite high costs of land acquisition, absence of infrastructure, and lack of financing options as major hurdles. This cycle has created a housing market that favors the elite while sidelining the majority.

To address this crisis, governments in these regions must urgently take a cue from the more proactive housing interventions seen in Lagos State. Over the past decade, Lagos has deployed a mix of public-private partnerships (PPPs), mass housing schemes, and affordable mortgage options through the Lagos State Home Ownership Mortgage Scheme (LagosHOMS). This model, though imperfect, has provided thousands of units to low- and middle-income earners, while also stimulating economic activity in the real estate sector.

Governments in the Southeast and South-South can replicate this model by:

Establishing regional mortgage boards that provide subsidized financing and rent-to-own options for first-time homeowners.

Investing in infrastructure—particularly roads, drainage, and electricity—in satellite communities to decongest urban centers and make land more viable for development.

Partnering with private developers through land swaps, tax incentives, and low-interest funding to accelerate affordable housing projects.

Enforcing housing regulation and rent control policies to discourage exploitation and gentrification in key urban zones.

The housing crisis is not just an economic issue—it is a social one. Without affordable shelter, the foundation of stable family life, productivity, and community development is weakened.

It is time for governors and urban development authorities in the Southeast and South-South to act decisively. Housing must be seen not merely as a commodity, but as a basic right—and government must lead the charge in making it accessible to all.

### Oil Bid: NEITI advises NUPRC to ensure full disclosure of beneficial ownership

The Nigeria Extractive Industries Transparency Initiative (NEITI) has called on the Nigerian Upstream Petroleum Regulatory Commission (NUPRC) to ensure full disclosure of beneficial ownership of oil assets across the country.

It advised following its independent observation and monitoring of the pre-qualification and technical bid processes of the 2022-2023 Mini Bid Round and the 2024 Licensing Round, in line with its statutory mandate under the Petroleum Industry Act (PIA) 2021 and the global Extractive Industries Transparency Initiative (EITI) Standard.

NETTI also identified other areas where it said NUPRC needed to make improvements. They include: strengthening the evaluation methodology and metrics, enhancing transparency in result disclosure, improving public access to bidder information, and integrating technical and commercial value assurance in evaluations.

The Advisory Report offered actionable recommendations to bolster future rounds, emphasising transparent disclosures, standardised scoring, and consistent stakeholder engagement.

The report also commended NUPRC for notable progress in the conduct of the 2022–2023 Mini Bid Round and the 2024 Licensing Round.

NEITI praised NUPRC's efforts, highlighting "notable improvements in inclusivity, digitalisation, and procedural integrity."

The report, presented to the NEITI National Stakeholders Working Group (NSWG) at its statutory meeting in Umuahia, Abia State, on May 9, 2025, described the licensing rounds as "significant milestones in Nigeria's upstream petroleum sector, designed to attract credible investments, unlock hydrocarbon potential, and advance national development objectives."

NEITI noted that the licensing process was generally professional, transparent, and inclusive, with adherence to published criteria as required by the PIA and EITI provisions.

Special concessions granted to indigenous and emerging firms were acknowledged as a progressive step that enhanced stakeholder participation and public confidence.

"The NSWG commended NUPRC's co-operation with NEITI and encouraged the adoption of the recommendations outlined in the advisory." said Orji Ogbonnaya Orji, Executive Secretary of NEITI.

At the same meeting in Umuahia, the NEITI Board also adopted a comprehensive Energy Transition and Climate Accountability Framework, developed in alignment with Nigeria's national energy transition plan, global climate obligations under the Paris Agreement, the Sustainable Development Goals (SDGs), and the 2023 EITI Standard.

The framework redefines NEITI's role in the energy transition, introducing a transparent and accountable mechanism for: Tracking greenhouse gas emissions and climate-related financial risks, Monitoring divestments by International Oil Companies (IOCs), Overseeing the implementation of Host Community Development Trusts (HCDTs) under the PIA, Promoting just transition planning and climate disclosures, Aligning NEITI's reports with national climate instruments, including NDCs and the Energy Transition Plan

"The framework positions Nigeria at the forefront of climate-compliant resource governance," Dr. Orji added.

To operationalise this policy, NEITI said it has outlined key implementation steps covering oil, gas, and solid minerals reporting, stakeholder engagement, institutional co-ordination, and bi-annual performance reviews.

The framework is being developed with support from the Ford Foundation as part of NEITI's ongoing study on the impact of energy transition on Nigeria's oil-dependent economy.

NEITT assured all stakeholders that it will continue to lead reforms that align resource governance with global sustainability imperatives while ensuring social and environmental justice across Nigeria's extractive sector.

### House of Reps withdraws compulsory

voting bill

he Speaker of the House of Representatives, Abbas Tajudeen, has withdrawn a bill seeking to make voting mandatory for all eligible Nigerians.

The bill, co-sponsored with Hon. Daniel Asama Ago, aimed to amend the Electoral Act 2022 to enforce compulsory voting as a means of deepening democratic participation.

In a statement issued recently by his Special Adviser on Media and Publicity, Musa Abdullahi Krishi, the Speaker said the decision followed "extensive consultations with a broad spectrum of stakeholders" across the country.

"From the outset, the bill

was introduced with the best of intentions—to bolster civic engagement and strengthen our democracy by encouraging higher voter turnout," the statement read

The bill had earlier passed Second Reading on the floor of the House on March 21, 2024, sparking widespread debate among lawmakers, civil society organisations, and the general public.

While proponents argued it would significantly increase voter turnout, critics raised concerns about its implications on individual rights and the feasibility of enforcing such

a law in Nigeria's diverse electoral landscape.

Citing global examples, the Speaker noted that compulsory voting has helped sustain participation rates above 90 per cent in countries such as Australia, Belgium, and Brazil, with similar practices adopted in Argentina and Singapore.

However, he emphasised that Nigeria must pursue democratic reforms that reflect its unique context and public sentiment.

"Lawmaking is ultimately about the people it serves, and any reform must respect individual freedoms," Speaker Abbas stated. Rather than compel citizens to vote, he expressed commitment to exploring alternative, non-coercive measures that incentivise participation, especially among young and first-time voters.

"This withdrawal will allow time for further dialogue on how best to cultivate a culture of voluntary participation that honours both our democratic ideals and the rights of our citizens," the statement concluded.

The bill had drawn a mix of reactions from Nigerians who called for sustained efforts to address the root causes of voter apathy, including electoral violence, lack of trust in the system, and logistical challenges on election days.

## Our reforms'll solve 80% of Nigeria's bureaucratic challenges - Shettima

According to him, strengthening the nation's institutional frameworks would address 80 per cent of Nigeria's public policy challenges.

The Vice-President stated this during the official presentation of the draft National Public Policy Development and Management Framework by the Special Adviser to the President on Policy and Coordination/Head of the Central Results Delivery and Coordination Unit (CDCU), Hajiya Hadiza Bala Usman.

Shettima described the new policy framework as a transformative approach that has been "long overdue" in Nigeria's governance architecture.

"If we get our institutional frameworks right, we will solve 80 per cent of our public policy challenges. This approach is long overdue," he said.

He called for a national reset in the way public policy is conceived, communicated, and implemented, noting that the mitochondria of every government is a workable national public policy.

Commending President Bola Ahmed Tinubu's leadership, Shettima praised the President's unique blend of public and private sector experience and his readiness to implement bold reforms.

"For the first time, we have a leader who understands the dynamics and speaks the language of economics. He has the courage to take far-reaching decisions. We cannot but commend President Tinubu for his very promising reforms across all sectors of the national economy," he

The Vice-President also stressed the importance of policy clarity and communication, pointing out that reforms must be clearly understood by the public and consistently implemented across all tiers of government.

Highlighting the role of e-governance and digitalization, Shettima advocated for data-driven policy execution and real-time monitoring, just as he also called for enforceable consequences within the policy framework.

"There must be targets and deliverables; if people fail to perform, they should be made to pay the price. Implementation without accountability is another word for lunacy. People must be made to account for their stewardship," the VP

said.

Emphasising the need to build strong institutions over reliance on individual leaders, the Senator drew a leaf from former United States President Barack Obama, saying, "Like former President Barack Obama said, what nations need is not strong characters or leaders, but strong institutions — institutions guided by strong, fair, and acceptable laws."

Éarlier, the Special Adviser to the President on Policy and Coordination, Hajiya Hadiza Bala Usman, told the Vice-President that the draft National Policy Development Framework was conceived by the realisation that the Federal Government had no document that at conceptualised government policies.

"It is interesting, Your Excellency, to know that at the beginning of this administration, it was quite baffling that the Federal Government did not have a guiding document which specifies the process by which policies should be conceptualised.

" M i n i s t r i e s , Departments and Agencies (MDAs) of government had been operating in silos, often producing overlapping and outdated policies. This has led to fragmentation, policy inconsistency, duplication of efforts, and ultimately in efficiency in the government's endeavours.

"These challenges have not only impeded the realisation of government goals, but they have also weakened public trust and discouraged investor confidence. Recognising this urgency and the need to address these systemic issues is what enabled us, as a team, to initiate this process," she stated.

Hajiya Usman, however, expressed confidence that the Draft National Policy Development Framework will address deep-rooted challenges of policy management and lack of coherence and consistency across MDAs.

The Draft National Policy Development Framework, she noted, is the result of extensive collaboration between her office, Office of the Vice-President, Office of the Secretary to the Government of the Federation, National Institute for Policy and Strategic Studies, foreign partners, and the National Economic Summit.

The presidential aide assured that with the input of the Vice-President, the draft framework will provide the much-needed clarity, structure, and coherence that will enable the development of policies with clear intent.

### Children's Day: President Tinubu reads riot act against child bullying

resident Bola Ahmed Tinubu has issued a powerful message urging Nigerians to unite in the fight against bullying as the country commemorates Children's Day 2025.

In a release from his Media Office today and made available to newsmen, his statement reaffirms government's commitment to protecting children's rights and fostering a safe, nurturing environment for every child in Nigeria.

The theme for this year's celebration, "Stand Up, Speak Up: Building a Bullying-Free Generation," reflects the urgent need to eradicate bullying in all its forms — physical, psychological, social, and online.

He said: "The pride and future of our great nation," and reaffirmed the government's dedication to safeguarding their welfare.

"Across every school, community, and home, you are the heartbeat of Nigeria's future. It is our constitutional and moral duty to protect your rights and nurture your dreams," he said.

The President highlighted troubling statistics: globally, more than one in three children experience bullying regularly, while in Nigeria, up to 65% of school-age children have faced some form of aggression.

"This is unacceptable. A child who learns in fear cannot learn well. A child who grows in fear cannot grow right," he stressed.

Under the Renewed Hope Agenda, Tinubu outlined ongoing and planned initiatives to combat violence against children, including full implementation of Nigeria's National Plan of Action on Ending Violence Against Children (2024–2030).

He noted that 36 states have domesticated the Child Rights Act, with efforts underway to review and strengthen relevant legislation such as the Child Rights Act (2003) and the Violence Against Persons (Prohibition) Act (2015).

He revealed that government is scaling up the Child Protection Information Management System (CPIMS) for real-time tracking of abuse cases and expanding community-based child protection programs. Efforts also include leveraging the Cybercrime Act to address online bullying and exploitation.

### Abia Medical City To Glup \$1.3 Billion

The Abia State Government has announced that the proposed Medical City, a flagship quaternary healthcare initiative by the present administration, would gulp a total investment of \$1.3 billion.

The project is aimed at transforming Abia into a regional hub for advanced medical services, as well as N i g e r i a ' s m o s t comprehensive healthcare ecosystem upon completion.

The Commissioner for Health, Professor Enoch Ogbonnaya Uche, disclosed this Saturday, when he led journalists on a tour of the 200-hectare project site around Owerrinta, IsialangwaSouth LGA.

Prof. Uche revealed that a globally reputable engineering procurement construction consortium, known as the MKP International Holdings, has been contracted by the State Government under a Develop, Build, Operate, and Transfer agreement to fund and deliver the project within 24 months.

"The Government is contributing land and goodwill, assets that are critical. That's part of what the government of Abia State has brought to the table," Prof. Uche noted.

He said that the Medical City, designed to meet global standards comparable to medical cities across the world, will feature a 1,000-bed ultramodern hospital, a state-of-the-art oncology center, a digital diagnostics hub, and surgical and transplant facilities capable of handling complex procedures such as robotic and organ surgeries.

According to the Commissioner, the complex will also include facilities for medical tourism, with a five-star hotel, a step-down hospital, and luxury accommodations for patients and their families.

"The idea is that people, when they are sick and they are seeking care here, their families can come and have a holiday, a medical holiday," Prof. Uche explained.

The Commissioner cited the staggering \$1.6 billion lost annually to outbound medical tourism as a major motivation behind the initiative, adding that the project would help curb the 'Japa' syndrome among doctors and nurses leaving the shores of the country due to poor working environments.

"We will have facilities that can cater for the tourism aspect of healthcare. We're also going to have an ultramodern oncology center. As you may well know, cancer care is one of the reasons people leave this country for care abroad.

"Whether you are talking about radiotherapy, you're talking about radiosurgery, radio-oncology, you're talking about emerging therapies, you're talking a bout the newer chemotherapeutic agents and their momentum for delivering those.

"All those are going to be available here with the bestin-class medical experts that can come in from all parts of the globe to be part of the workforce in this place.

"So this ecosystem will also house a modern surgical center that can take care of laparoscopic surgeries, robotic surgeries

"It will also take care of all forms of brain, spine, orthopedic, organ transplantation, cardiac transplant, cardiac surgeries—name it, any level of surgery.

"There will also be a place for cosmetic surgery. You know that a lot of people travel to go and have bariatric surgery, to go and have liposuction, to go and have nose jobs and all that.

"All those things will be done here in this place. And that will help to reduce the number of people going for such surgeries outside. Of course, while giving them the best-in-class qualitative service available anywhere in the world.

"We're also going to have an ultramodern children's hospital in this place, a fertility center. You will also have a place where you have the best-in-class ophthalmology center that will cater for the eye health needs of people. So name it—whether it's organ transplantation, whether it's orthopedics, whether it's neurology or neurosurgery or cardiac surgery,

interventional cardiology.

"And then it's also going to have a diagnostic center that is second to none in West Africa—perhaps in Africa. So they're going to have MRIs, PET scans, and the modern radiological diagnostic equipment and services that you find anywhere in the world.

"This center is also going to have a hub for digital health technologies. Of course, you know today that you have AI, artificial intelligence, virtual reality, and augmented reality. All these are now part of what doctors and nurses use anywhere in the world to support diagnosis and care of complicated cases.

"So you're going to have metaverse hospitals. Metaverse refers to virtual reality, augmented reality. So you're going to have all that in this place.

that in this place.

"There's going to be a helipad there that will ensure that we can have air a mbulance services connecting with hospitals across this nation. And then, of course, there's also an intention to ensure that the air ambulance service will be

active," Prof. Uche further explained.


He said that the Medical City will serve as a top-tier training institution, partnering with international universities and catering for students and residents from within and outside Abia State.

"This is going to be the apogee of a training institution. Our students will be exposed to the highest level of care and the best protocols globally.

"And beyond that, we're going to have research institutes that will be affiliated with the best hospitals and universities in this world, on the globe. As I'm talking to you, we have already received expressions of interest from top-class universities in the U.S. who want to partner with the medical city.

"So we will have a place where our children can be trained, where our old people can be looked after, our young people can be looked after, in an ecosystem that supports healthy living."

### NDLEA. HOIO sian MoU to strengthen fight against illicit druas

he National Drug Law Enforcement Agency (NDLEA) and the United Kingdom's Home Office International Operations (HOIO) have signed a Memorandum of Understanding (MoU) aimed at intensifying the fight against transnational organized crime, especially illicit drug trafficking between Nigeria and the UK.

The MoU was signed recently, at the NDLEA headquarters in Abuja.

Speaking at the ceremony, the Regional Manager (West Africa) of HOIO, Mr. Ian Cunliffe, expressed his appreciation for the strong collaboration between the two agencies. He acknowledged the productive relationship established by his predecessor, Christopher Hawksfield, and reaffirmed his commitment to building on that foundation.

"I'd like to thank the chairman for his time and the gracious welcome. The relationship between HOIO and NDLEA has been really productive, and I'm keen to enhance that as we enter this new phase of partnership," Cunliffe said.

D Chairman/CEO, Brig. Gen. Mohamed Buba Marwa (retd), described the MoU as a reaffirmation of mutual trust and cooperation.

He added that the NDLEA has continued to scale up drug control efforts in line with the National Drug Control Master Plan and that the new agreement provides a structured framework for intelligence and data sharing, aligned with international conventions, national laws, and global best practices.

This partnership strengthens our capacity to interdict criminal suspects, dismantle trafficking networks, and trace illicit financial flows more efficiently," Marwa noted.

He emphasised that stronger intelligence sharing translates into more effective enforcement, expressing optimism that the partnership will deepen collaboration in addressing drug-related crimes and safeguarding public health and safety in both countries.

The suspects were operating an unregistered motherless babies' home in their apartment, located on Ikot Ekpene Road, Aba.

The children, who came from various villages in

Investigations are ongoing, with the suspects currently being interrogated at the State CID, Umuahia. They will be arraigned in court once investigations

### **2027** Polls: Peter Obi to run on Labour Party Platform

he Labour Party (LP) presidential candidate in the 2023 election, Peter Obi, has confirmed his intention to contest the 2027 general election under the LP banner.

In a seven-minute, 16second video circulating on the party's WhatsApp platform, Obi addressed young supporters, reaffirming his commitment to the Labour Party despite ongoing internal challenges.

Speaking recently, Obi attributed the crises within the LP and the Peoples Democratic Party (PDP) to deliberate interference by the government.

What is happening in the Labour Party and the PDP is caused by the government. Quote me anywhere," he stated.

Drawing from past experience, Obi recalled resolving a similar LP crisis during the administration of late President Umaru Yar'Adua, who intervened to ensure stability. He contrasted this with the current situation, alleging that the government is intentionally destabilizing opposition parties to

Obi emphasised the need for strong opposition to ensure a functional democratic system, vowing to address such issues if given the opportunity to lead.

"These are some of the things I want to clean up if I have the opportunity. Parties will function very well because you can't have a system working without a strong opposition," he said.

The former Anambra State governor urged Nigerian voters, particularly vouths, to take responsibility for ensuring their votes count, noting that

while political parties may deploy agents to protect their interests, the ultimate power lies with the electorate.

He encouraged resilience in the face of resistance from beneficiaries of the current system, assuring supporters that positive change, though challenging, is achievable.

Commenting on his political future, Obi, who will be 65 by the 2027 election, expressed a preference for a retirement age for politicians, stating he would not wish to contest elections in his 70s. (NAN)

### First Lady's Renewed **Hope Initiative Food Outreach hits Abia State**

he First Lady of Nigeria, Senator Oluremi Tinubu, has launched the Renewed Hope Initiative (RHI) Food Outreach in Abia State, with the distribution of food items to vulnerable citizens, particularly those affected by economic hardship.

The food items distributed under the Renewed Hope Initiative Social Investment Programme include spaghetti, semolina, and rice.

Speaking at the event, held at the International Conference Centre, Umuahia, Abia State Governor, Dr. Alex Otti, lauded Senator Tinubu for her compassion and unwavering support for vulnerable Nigerians amid the current economic challenges facing the country.

The Governor highlighted his administration's commitment to social welfare, noting that one of his first actions in office was the creation of the Ministry of Poverty Alleviation and Social Protection.

According to him, the ministry collaborates with international and local partners to implement holistic programs that support women, youths, and vulnerable groups across the state.

"In several communities, women co-operative groups have been set up to access grants and zero to low interest rate facilities to establish businesses along the agricultural value

"Our conviction is that many of the individuals living in economic vulnerabilities can still add value to our GDP by engaging in productive ventures," Gov. Otti said.

The Governor expressed support of his administration for the Renewed Hope Initiative, emphasising that while palliative programs are valuable, long-term solutions are essential.

He stressed the need for a "realistic path" to overcome poverty, joblessness, and economic hardship.

"The goal at all times should be to keep reducing the number of persons living below the poverty line by offering the population a path to economic sustainability and ultimately independence," he noted.

In her address earlier, Sen. Tinubu said that the food outreach scheme, which began on March 8, 2024, in the Federal Capital Territory, has since reached 11 states and the FCT, including Benue, Cross River, Oyo, Delta, Edo, Ekiti, Gombe, Kano, Kogi, Kwara, and Nasarawa.

Represented by the Wife of the Vice-President, Hajia Nana Shettima, the First Lady said that the next states to benefit from the food outreach scheme are Enugu and Kaduna States.

She also announced a 200,000 naira grant each for 250 persons with disabilities in every state to support their small businesses and the planned distribution of 10,000 packs of sanitary pads per state to encourage young girls to stay in

"Under our economic empowerment, we will be giving a grant of 200,000 naira for 250 persons with disabilities to recapitalize their existing small businesses in the 36 states and the Federal Capital Territory.

The group urged leaders at all levels to put the interest of the state above personal ambition, stressing that unity and stability are essential for economic recovery and social progress in Rivers State.







### UEFA CHAMPIONS LEAGUE FINAL: PSG, Inter Battle for Glory By Joseph Jacob

Paris Saint Germain of France and Inter Milan of Italy will go head to head in the UEFA Champions League finaal on Saturday at the Allianz Arena in Munich, Germany.

While the French side are searching for their first triumph, with their best performance being losing in the finals in 2020, their opponents from Italy are gunning for their fourth title after they emerged champions in 1964, 1965 and 2010.

PSG finished 15<sup>th</sup> in the League Phase after winning four, drawing one and losing three matches. They went through the play-off, where they got their rhythm, smashing fellow French side 10-0 on aggregate.

The confronted English teams in the

next three stages and eliminated all. They started with Liverpool in the round of 16 and went through 4-1 on penalties after full and extra-time ended 1-1.

They took on stubborn Aston Villa in the quarter-final and escaped by the skin of their teeth 5-4 on aggregate.

They eliminated Arsenal 3-1 on aggregate in the semi-finals to book their place in Saturday's final.

Inter Milan finished fourth in the league Phase. They won six, drew one and lost only one match. They scored 11

goals and conceded only one goal. They hammered Feyenoord 4-1 in the round of 16 before eliminating Bayern Munich 4-3 in the quarter-finals.

Their semi-final clash with Barcelona ended 7-6 on aggregate and equalled the record for most goals in Champions League knockout tie. Recall that Liverpool defeated Roma 7-6 in the semifinal of the 2017/18 season and Bayern Munich thrashed Sporting CP 12-1 in a round of 16 match in the 2008/09 season.

Besides the trophy, The winners will also earn the right to play against the winners of the 2024/25 UEFA Europa League, Tottenham Hotspurs in the 2025 UEFA Super Cup. Both finalists have already secured places in the league phase of next season's Champions League...

### ...History Favours PSG

The final of this season's UEFA Champions League will hold at the Allianz Arena in Munich on Saturday, May 31, 2025. Either PSG or Inter Milan will be crowned the champion in Munich. However, history points to the emergence of a first time winner-PSG.

In the 1979 European

In the 1979 European Cup final hosted at the Olympiastradion, two teams who had never won the competition-Nottingham Forest of England and Malmo FF of Sweden battled for the trophy. Trevor Francis headed in John Robertson's cross in the first half of the extra time after full time had ended goalless. Nottingham Forests thus won their first European title.

Fourteen years later, the European Cup final returned to Munich with Marseille up against AC Milan. While Marseille were chasing their first European title, AC Milan were going for their fifth title. Basile Boli scored the only goal in the 44th minute as Marseille claimed their first European title.

In 1997 another first time winner emerged when German side Borussia Dortmund defeated Juventus 3-1 in Munich. The Italians were already two-time champions, so it was not surprising that the Germans won their first title. Karl-Heinz Riedle put the German side in front in the 29th minute with a low shot from inside the six yard box. Before the break, Riedle made it two when he headed in Andreas Moller's corner kick.

In the second half,

Juventus' hit man, Alessandro Del Piero came in as a substitute and pulled one back with a back-heel after a cross from the left channel by Alen Boksic to keep Juventus' hope of a comeback alive. But, in the 71° minute, 20 year-old Lars Ricken sealed the victory for Dortmund.

In the Champions League era in 2012, Chelsea took on home side, Bayern Munich, who had wonthe the competition four times. The home side out played Chelsea but failed to convert their chances until the 83" minute, when Thomas Muller headed Toni Kroos' cross down, the ball bounced over Petre Ceching of Chelsea, hit the crossbar and entered into the net. With two minutes to the final whistle, Chelsea won their first corner of the game, which was taken by Juan Mata. Didier Drogba's powerful header went past Manuel Neuer for Chelsea's equalizer. Extra time ended with no goals and Chelsea had to play another penalty shootout in a Champions League final after they lost on penalties in the 2008 final to Manchester United.

Chelsea won on penalties despite Juan Mata missing Chelsea's first penalty kick.

This year's final is returning to the Allianz Arena, whether you believe that history has a way of repeating itself or that people repeat history, all eyes will be on the final.

With Inter Milan having won the Champions League thrice, PSG is historically favoured to win their first Champions League title on Saturday.

### **Officials**

The UEFA Referees Committee has appointed Romania's István Kovács to referee the 2025 UEFA Champions League final between PSG and Inter Milan.

The 40-year-old, an international referee since 2010, will be officiating his third UEFA club competition final after his appointment as the referee for the 2024 UEFA Europa League final in Dublin, Republic of Ireland, between Atalanta and Leverkusen, and the 2022 UEFA Conference League final between Roma and Feyenoord in Tirana, Albania. He has refereed seven Champions League matches this season, including the round of 16 second leg between Liverpool and Paris.

He will be assisted by his countrymen Mihai Marica and Ferencz Tunyogi. The fourth official is Joao Pedro Silva from Portugal and the reserve Assistant Referee is Bruno Miguel Alves Jesus from Portugal.

The VAR team is led by Dennis Johan Higler from Netherlands. He will be assisted by Catalin Sorin Popa from Romania while Dutchman Paulus van Boekel is the VAR Support official.

### The Trophy



The UEFA Champions League trophy stands 73.5cm tall and weighs 7.5kg. "Everybody in football is keen to get their hands on it," said creator Jürg Stadelman.
