Governor Otti Starts Govt House Reconstruction. Insists On People's Welfare First

overnor of Abia State, Dr. Alex Otti, has announced the commencement of the long-awaited reconstruction of the Governor's Office at Government House, Umuahia.

Speaking during a Sabbath service at the Unity Chapel within Government House, the Governor said his administration adopted a strategic approach based on economic principles, prioritizing sectors that directly impact the lives of

"As a student of economics, we came in with a scale of preference. Everything is important, but some things are more important than others," Otti

"We didn't consider this Government House more important than paying salaries. It wasn't more important than revamping our Primary Healthcare Centres or our schools. We didn't think it was more important than providing free basic education so that children from low-income backgrounds can access the opportunities that many of us had".

He added that addressing poor road infrastructure and dilapidated public offices took precedence, and was only after recording significant progress in these areas was the Government House project initiated.


"Now that we've tackled many of those urgent issues, work has commenced here," he said, noting that visible signs of the reconstruction are already evident around the premises.

Dr. Otti also highlighted ongoing projects within the State Capital, including the reconstruction of the Michael Okpara Auditorium, which he said would be completed by the end of June.

He added that the Office of the Secretary to the State Government is currently being furnished, and construction work is progressing at the Government House Clinic.

Describing the current Governor's Lodge as "more or less a makeshift place," Otti announced plans to rebuild the lodge along with the Unity Chapel.

He reaffirmed his belief that governance must prioritize the welfare of the people, adding, "Leadership is only meaningful when it earns the people's support. Government is about the people, and without their support, leadership cannot thrive." Continued on P.2

Abia Govt Unveils Gov Otti's **2nd Anniversary Plans**

¬he Abia State Government has released a detailed schedule of activities to commemorate the second anniversary of Governor Alex Otti's administration, following growing calls from citizens and stakeholders for a more visible celebration.

Speaking with journalists after the weekly Executive Council meeting, the Commissioner for Information, Prince Okey Kanu, revealed that although the administration initially planned a modest observance, public demand prompted the governor to approve a more elaborate celebration.

"Since t h e announcement, there has been significant pressure on His Excellency to make the anniversary more visible".

"In response to despread requests from within and outside the State, the Governor has agreed to elevate the celebration,"

Prince Kanu said.

The anniversary events will start on May 25 with an interdenominational church service at the International Conference Centre, Umuahia.

On May 26, a special Executive Council session will be held. Children's Day,

May 27, will see the First Lady, Mrs. Priscilla Otti, visiting orphanages and destitute homes. Governor Otti is also expected to participate in the Children's Day parade, taking the traditional salute and joining in the celebration.

A keynote Anniversary Lecture will be delivered on May 28 by Dr. Kalu Idika-Kalu, a former Commissioner for Finance in the old Imo State and one-time Minister of Finance for the Federal Republic of Nigeria.

The anniversary will culminate on May 29 with a State broadcast by Governor Otti, followed by a grand celebration at Umuahia Central Stadium.

Meanwhile, the Commissioner announced the postponement of the commissioning of the newly reconstructed Port Harcourt Road in Aba and the flag-off ceremony for Abia Medical City, initially scheduled for May 23, Prince Kanu further stated.

"Some of you may have heard informally but let me confirm that the event has been postponed". "President Bola Ahmed Tinubu, who was originally slated to launch the project, will now visit in early June due to scheduling constraints."

In a related development, the Commissioner disclosed that the First Lady of Nigeria, Senator Oluremi Tinubu, and the wife of the Vice-President, Hajiya Nana Shettima, will visit Abia on May 23 for a humanitarian

Hosted by the Abia First Lady, Mrs. Priscilla Chidinma Otti, Senator Tinubu will formally launch her Social Intervention Initiative aimed at supporting vulnerable groups in the state. The programme will include the distribution of food items and essential supplies to disadvantaged residents.

"This outreach reflects the First Lady's commitment to uplifting the lives of vulnerable Nigerians". "It also highlights the spirit of collaboration between the Federal and State Governments in tackling social challenges," the Commissioner said.

Experts Call For Vigilance In Early Detection Of Autism, Learning Disabilities

ealth and education experts have called on parents, caregivers, and educators to be more observant of early signs of autism and learning disabilities in children.

The appeal was made at an awareness programme held today, in Umuahia, Abia State.

The event was organized by the Shades of Life Foundation in collaboration with the Abia State Commission for the Welfare of Disabled Persons.

Delivering the keynote address, Dr. Eziafakaku Nwaokolo, Chief Executive Officer of Shades of Life Foundation, described autism as a spectrum of complex neurodevelopmental disorders that affect communication, behavior, and social interaction.

'Autism Spectrum Disorder (ASD) presents differently in each child," Dr. Nwaokolo said. "Some show signs as early as 12 months, while others may not exhibit noticeable symptoms until 24 months or later. What's important is that caregivers and teachers pay close attention and do not dismiss these early indicators.

She emphasized that although autism typically begins before the age of three, it is a lifelong condition that evolves over time.

'Adolescents with autism may struggle with forming friendships, understanding

social cues, and adjusting to noted. expectations in school or the workplace," she added. "Early detection and consistent support are key to helping them reach their full potential."

Dr. Nwaokolo also highlighted the urgent need to combat stigma and misinformation about neurodevelopmental

We must move away from labeling children with autism as 'stubborn' or 'possessed,'" she said. "These are medical conditions that require compassion, professional care, and informed support."

She expressed gratitude to the Governor of Abia State, Dr. Alex Chioma Otti, for his inclusive policies and continued support for persons with disabilities.

Governor Otti has shown that he is a leader who listens and prioritizes the needs of institutions and civil society

"Raising awareness about autism, especially in rural communities, requires the combined efforts of parents, teachers, health workers, and traditional leaders," Dr. Onyebuchi said. He stressed the importance of professional training in autism diagnosis, noting that a tailored approach is required for each child.

There's no one-size-fits-all model," he explained. 'Diagnostic tools and interventions must be adapted to each child's age, environment, and unique challenges. Building local capacity is essential.'

He further urged health vulnerable populations," she organizations to extend

awareness efforts to grassroots communities, where knowledge about developmental disorders is often lacking.

Also speaking at the event, Comrade Dan Onuoha, Head of the Information Unit and Public Relations at the Secondary Education Management Board, outlined some key early warning signs of autism and learning disabilities

"If a child does not make eye contact by 12 months, avoids playing with peers, repeats certain behaviors, or doesn't use gestures like pointing or waving, these could be red flags," Onuoha said. "Teachers must be trained to identify these signs and communicate them to parents

He advocated for stronger collaboration between schools and health agencies to build inclusive learning environments for children with special needs.

The event concluded with a collective call for sustained public sensitization, stronger policy implementation, and a more empathetic approach to neurodevelopmental conditions.

'We need a society that sees ability—not disability," Dr. Nwaokolo said in her closing remarks. "With the right support, children with autism and learning challenges can thrive at home, in school,

He encouraged the workforce to remain diligent and selfmotivated, emphasizing the need to carry out their responsibilities with dedication – whether supervised or not. According to him, the Corporation plays a critical role as a communication arm of the government and must reflect the values of transparency accountability, and excellence.

Describing the media outfit as a vital platform for projecting the policies and activities of the state government, Prof. Kalu called for unity and teamwork among the staff to enable the organization achieve greater results. He assured them that the challenges presented would be addressed appropriately.

Earlier in his remarks, the General Manager of ANPC, Hon. Jones Nnanna Ike, expressed gratitude for the SSG's visit and described it as a morale booster for the entire staff. He highlighted the strategic importance of the

Corporation in preserving the historical and developmental records of the State.

"The newspaper house is not only for public information dissemination, but it also serves as the official record-keeper of government activities, offering future researchers valuable documentation," he said.

Hon. Ike recounted the poor state of the Corporation prior to the advent of the current administration, noting that there was a total breakdown in operations and infrastructure. He commended Governor Otti for prioritizing the revival of the public sector, with ANPC being one of the early beneficiaries through the Ministry of Lands and Housing.

While appreciating the support already received, Hon. Ike appealed for further assistance. particularly in the establishment of an inhouse printing press. "What is a publishing house without its own printing press? We need this to operate optimally and meet growing demands," he stated.

He also pointed out the inadequacies in equipment and technology, noting that the computer systems supplied to the Corporation were not built to handle its workload and had since broken down. He cited the lack of essential tools such as cameras, equipment as key operational setbacks.

The ANPC General Manager further stressed the need for skilled editorial staff to be injected into the system to improve content quality and boost productivity.

On a positive note, he praised the state government for its consistent and timely payment of salaries, noting that it has greatly enhanced staff discipline, reduced absenteeism, and

increased overall commitment to duty.

"We assure you that our staff are motivated and committed. They come to work and do the job they are paid for. Timely salary payments have truly made a difference," he concluded.

In a vote of thanks, the Head of Administration in the Corporation, Mr. Dandy Nwachukwu, appreciated the SSG for the visit and reaffirmed the Corporation's unwavering support for present the administration.

The visit featured an interactive session during which staff engaged the delegation on various issues.

The SSG was accompanied by the Permanent Secretary, Dr. Godwin Okezue; Senior Special Assistant to the Governor on Due Process, Dr. Oluebube Chukwu; and other senior government officials.

Abia Govt Signs MoU with MTN

he Abia State Government has signed a six-point Memorandum of Understanding (MoU) with MTN Nigeria Limited, aimed at positioning the state as a digital hub in Africa.

The Commissioner for Information, Prince Okey Kanu, made the announcement while briefing journalists on the outcome of Executive Council (Exco) meeting, presided over by Governor Alex Otti.

Prince Kanu noted that the strategic partnership between the two entities is the result of several months of meetings and negotiations between the Abia State Government and MTN's management.

He added that the collaboration would ensure 100 per cent broadband coverage across the state by the end of the year.

"The Digital Transformation Agenda of this administration received a major boost today with the signing of the Memorandum of Understanding between the Abia State Government and MTN Nigeria Limited, on the sidelines of today's Exco meeting".

"The strategic partnership between both entities comes after months of discussions between Abia State Government officials and MTN's management. This MoU covers six key areas, one of which is providing 100% broadband access across the entire state before the end of the year," Kanu explained.

The commissioner also outlined kev provisions in the MoU, including a device ownership scheme for civil servants, digital governance infrastructure, a digital mall for small and medium enterprises (SMEs), the rollout of 4G/5G services in key cities, and the creation of a state-owned digital

marketplace.

"The device ownership scheme for Abia civil servants will allow MTN Nigeria Limited to finance the acquisition of laptops, smartphones, and Wi-Fi devices for civil servants. This initiative is aimed at enhancing their efficiency and supporting the Digital Transformation Agenda of His Excellency Dr. Alex Otti".

"Another provision involves digital governance, which will include the provision of cloud services and dedicated cloud computing resources."

"Additionally, we will establish the Abia Digital Mall, which will focus on stabilizing the informal economy by leveraging digital tools to drive SME growth in the state. We will also roll out 4G/5G services in Umuahia, Aba, and Ohafia by the end of the year".

"Finally, the creation of a digital marketplace will support both egovernance and ecommerce initiatives within the state," he further stated.

Не further emphasised that the partnership would empower people in rural areas, including farmers, to conduct business remotely using technology.

"This partnership aligns with the governor's vision of digitally transforming Abia State and bringing it into the 21st Century. As you know, our governor is tech-savvy, and he expects no less for the Abia people. This collaboration will allow us to use technology to drive socio-economic growth."

"For example, rice farmers in Abam, cocoa dealers in Bende, or palm produce traders in Ukwa East Local Government, will be able to conduct business from the comfort of their homes in remote areas," the commissioner explained.

JAMB's 2025 UTME Mass Failure: A Systemic Failure with Real Consequences

he recently concluded 2025 Unified Tertiary Matriculation Examination (UTME) has become a flashpoint of national disappointment and outrage. The public outcry, especially from students, parents, educators, and civil society groups, stems from the widespread failure reported across the country. Now, with the Joint Admissions and Matriculation Board (JAMB) officially acknowledging systemic errors, it is imperative we confront the gravity of this failure and chart a concrete path forward.

The explanation provided by JAMB's Registrar, Prof. Is-haq Oloyede, was a sobering account of technical lapses, administrative oversights, and inadequate post-deployment checks that marred what could have been the Board's most successful UTME exercise yet. Over 380,000 candidates from 157 centers across Lagos and the South-East were directly affected by grading anomalies due to a software update patch that was improperly applied.

This, brought incorrect scores, psychological trauma, public mistrust, and, more worryingly, a threatened academic future for thousands of young Nigerians.

This failure is not merely technical. It is a human crisis with educational, social, and emotional repercussions. Remember, UTME is not just an exam—it is a gateway to higher education, career aspirations, and national development. For it to be riddled with such basic errors, after all the so-called "robust simulations" and "in-house innovations," is unacceptable. It reflects deep flaws in quality assurance mechanisms and raises questions about the competence and accountability of key service providers.

While JAMB's transparency in acknowledging its faults and committing to remedial exams is laudable, apology alone cannot erase the lost trust. This is the second year in a row where systemic issues have threatened the integrity of the UTME process. The recurring nature of these glitches hints at more than occasional lapses—it signals a pattern of operational instability that must be urgently addressed.

Moving forward and to forestall repetition of this ugly history, we must adapt the following:

Third-Party Audits of JAMB Systems: A complete overhaul and external audit of JAMB's examination and result-processing software must be conducted. In dependent tech experts and educationists should be involved in certifying the readiness and reliability of JAMB's platforms before every examination cycle.

Public Blacklisting of Inefficient Vendors: The service providers responsible for the botched update must be publicly identified, penalized, and barred from future contracts. Accountability should go beyond internal disciplinary action. When public trust is lost, only visible and firm action restores it.

Creation of a National Examination Integrity Taskforce: A cross-sectoral body involving stakeholders from WAEC, NECO, NUC, the Ministry of Education, and civil society should be established to monitor and evaluate the integrity of major public examinations in Nigeria.

Candidate-Centric Innovations: JAMB should prioritize students. This includes timely communication about errors, stress-relieving measures like counseling, flexible rescheduling, and provisions for special cases such as WAEC exam conflicts. The examination system must not punish candidates for failures beyond their control.

Reinforce the Role of Mock Exams: JAMB must re-evaluate how mock exams are used. They should serve as true stress tests for all systems—including delivery servers, grading algorithms, and database updates—not mere trial runs.

Education in this part of the world must not be a gamble.

JAMB's mantra for this year—"Man proposes, God disposes"—is philosophically poignant but practically unhelpful. Education, particularly public examinations, must never be reduced to matters of chance or fate. Nigerian students deserve a system they can rely on—one that upholds merit, fairness, and technical excellence.

As the Board regroups from this national embarrassment, it must do so with humility, transparency, and an unwavering commitment to reform. The future of millions of young Nigerians depends on it. Let this be the last time that technology, rather than talent, determines who makes it to the next phase of life.

Enough of the excuses—it's time for lasting solutions.

Is Gov Soludo envious of Peter Obi?

resident Tinubu was in Anambra. The timing of the visit was ominous. Anambra governorship elections are due in November. Southern first-term governors from opposition parties are defecting in droves to Tinubu's party. Soludo didn't defect but a defection might have been more hygienic. Soludo showcased his projects and swore allegiance to Tinubu. Soludo was within his right to twerk for Tinubu, but did he have to spit on Peter Obi to magnify and enchant the president?

The first line of Soludo's speech was reeked with pettiness. He said that the last time a President visited the state was in 2021 to commission the Premier Breweries which he called a private brewery project. That Soludo's preferred hook was puerile. Some might say it should be seen as political banter. But did Soludo need to introduce that famed line of bigotry peddled by Tinubu's men in this welcome address to the president to the home of Peter Obi,

Soludo was free to preach unity or choose churlish partisan politics. He was free to say Tinubu is the father of modern Lagos who tamed the Atlantic and transformed a jungle into a bustling city. Nobody would challenge hyperboles. But Soludo didn't have to sound like MC Oluomo or Bayo Onanuga riling up a Shinedu. He didn't need to use Peter Obi as the red carpet. If Peter Obi had a dog in the November fight, Soludo might have had a little justification. But Obi, it appears, isn't interested in the Anambra governorship, so why would Soludo seek to aggravate Obi's supporters with a gratuitous motor park

Soludo is brilliant but many have said he lacks political tact and emotional intelligence. But tact isn't required to abstain from irritating the youths in a state you govern. A brilliant Anambra governor in 2025 doesn't need emotional intelligence to know that while courting Tinubu he must not fart into the faces of Peter Obi's supporters. Even if that would titillate Tinubu. It's political maths. Obi will win any presidential election against Tinubu by a wide and wild margin. Soludo knows that. It wouldn't matter if Soludo took APGA to live in the boys' quarters of the APC. I understand the haste to ensure Tinubu doesn't avail Nicholas Ukachukwu of the APC federal forces of coercion to attempt the Edo experiment, but did Soludo have to serve Obi as nkwobi to Tinubu to fatten his ego? Has Tinubu now become the oba of Nigeria at whose feet governors must grovel without compunction? Or is Soludo's sporadic

Soludo once suspended a traditional ruler because he conferred a small village title on a serving senator, who was Soludo's political opponent. That unnecessary act of vindictiveness attracted a long letter of rebuke from the usually quiet Obi of Onitsha.

Soludo once attended the funeral ceremony of the mother of a popular catholic priest in Anambra. At the funeral service, he cast aspersion on the bereaved priest and his family because they printed posters and brochures for the funeral. He said the burial contravened the state's burial laws, which he dusted up on the assumption of office. Soludo's outburst attracted an acidic letter of reprimand from the Catholic Archbishop of Onitsha. The Archbishop said the governor had abandoned critical affairs of government to pursue shadows. He urged the governor to distinguish himself with big ideas rather than cantankerousness. So perhaps Soludo's penchant for the demystification of Peter Obi isn't envy.

Soludo had a first class. Obi had a colourless degree

certificate. Both are from the University of Nigeria. Soludo raced to become an Economics Professor and Adviser to international financial institutions. Obi on the other had a shop while he was a philosophy student at the UNN. He was probably eager to leave school and become a member of the famous OMATA. Their paths couldn't be wider apart. While Obi became a trader importing wines and groceries, Soludo lectured, researched and advised. Soludo went on to become chief economics adviser to President Obasanjo and later the central banker governor.

Obi survived the streets and the odds to become a billionaire, Chairman of a commercial bank and Anambra governor. At levels, Soludo had no reason to envy Obi. Both of them have now governed Anambra state. Soludo, who fancies himself as the Solution is perhaps the better intellectually endowed of the two. Peter never discusses Soludo. Soludo never misses an opportunity to mock Obi. Peter Obi has become a national political colossus. Is Soludo's thinly veiled animosity borne of disdain or envy? Does Soludo harbour contempt for Peter, seeing him as a lucky political charlatan riding the wave of luck? Or does Soludo envy Peter Obi as the new dominant political figure in the Southeast? Why is Soludo bellyaching?

Soludo had contested against Peter in 2009. In 2013 Peter backed Willie Obiano when a few thought Soludo was a better candidate. Willie became governor and fell out with Peter Obi. In a beautiful irony, Willie Obiano chose Soludo in 2021 and defeated Peter Obi's protégé. So Soludo and Peter have enough tension between them. But there could be more. President Yar'adua once toyed with the idea of grooming Soludo to be president. He recalled Soludo from the UK to get him to run for Anambra governor in 2009. Yaraduas's death truncated that mission but the seed had been sown in Soludo's heart. Obi parades an endearing simplicity, empathy, and a sense of frugality that has charmed the masses. Soludo, despite big ideas and great efforts, hasn't been able to create that magic. If Obi goes to the villa, Soludo's chances evaporate. Soludo owes Obi nothing. Ogun has more senior ministers than the entire Igbo land. Why does Soludo say things that would aggravate the sensibilities of his people?

House of Reps Committee Summons NRC, Railway Property Bosses Over Alleged Assets Mismanagement

he House of Representatives Committee on Land Transport, has summoned the Managing Director of the Nigerian Railway Corporation (NRC), Kayode Opeifa, and the Managing Director of the Railway Property Management Company Limited, Timothy Zalanga, over the management of NRC operations and its nationwide assets.

The decision followed a resolution reached during a committee meeting, where lawmakers raised concerns about alleged mismanagement and questionable sales of NRC properties. Committee members also decried reports that pensioners and staff were being forcefully evicted from NRC staff quarters, with the properties sold off without due process.

Chairperson of the committee, Hon. Blessing Onuh, clarified that the invitation is not intended to witch-hunt

the officials but to ensure accountability and transparency in the operations of the NRC and its subsidiaries.

Quoting Sections 88, 89, 128, and 129 of the 1999 Constitution (as amended), Onuh emphasised the oversight responsibility of the legislature, stating that the committee will not sit back and allow misconduct or mismanagement within key transport agencies.

The committee has directed the management of both the NRC and the Railway Property Management Company submit comprehensive documents detailing the 2022, 2023, and 2024 budget performances, the current status of NRC's assets, and all Public Private Partnership (PPP) arrangements. These documents are to be submitted to the committee secretariat on May 20, 2025.

Food Security: Varsity Don, **Ahamefule Champions Organic Farming**

he Deputy Dean, College of Agricultural Economics, Rural Sociology and Extension, (CAERSE), Michael Okpara University of Agriculture Umudike (MOUAU), Abia State, Dr. Blessing Ada Ahamefule, has advocated for sustainable agriculture and environmental resilience, highlighting organic farming as a vital tool in the fight against food insecurity and climate change in Nigeria and beyond.

The Agricultural expert who disclosed this during a community service outreach at Umudike, Ikwuano Local Government Area (LGA), Abia State recently, decried the disruption of microbial ecosystems, ammonia emissions among other biodiversity loss due to indiscriminate use of chemical fertilizers.

She emphasized that conventional farming practices have contributed significantly to environmental degradation, soil depletion, and reduced food quality, asserting that a shift toward organic agriculture could reverse these trends while ensuring long-term food security.

In her words: "Organic farming is not just an agricultural method—it is a holistic system that respects natural cycles, reduces reliance on harmful chemicals, and promotes biodiversity.

"By investing in organic practices, we are addressing two of the greatest challenges of our time: feeding our growing population and protecting our environment.

Dr. Ahamefule noted that organic farming minimizes carbon emissions through reduced use of synthetic fertilizers and pesticides, while improving soil health and water retention - key factors in climate adaptation.

The scholar who noted that the consumption of organic farm produce has no health risk, further identified other effects of indiscriminate use of chemical fertilizers to include; water contamination, nutrients imbalance, plant toxicity, reduced crop resilience, cancer risk, methemoglobinemia (blue baby syndrome), endocrine disruption among others.

Dr. Ahamefule who further urged the rural women to mitigate these negative effects by adopting sustainable agricultural practices, also called on policymakers, development agencies, and private sector players to support training, certification, and market access for organic farmers.

She said: "Our future depends on how we treat the soil beneath our feet and the food we put on our tables. It's time for a radical but achievable transformation - starting with organic farming."

In a vote of thanks, Mrs. Nwadinobi Adanma, on behalf of Umudike and Umudike Ukwu communities, thanked Dr. Ahamefule for sharing her research findings

Abia TechRise Equips Graduates For Digital

he Abia State Government, in collaboration with the 17 Local Government Mayors and LEARNFactory Nigeria, has celebrated the graduation of 510 youths trained under the Abia Tech Rise Initiative, equipping them with essential digital skills to thrive in the 21st-Century economy.

The ceremony, held recently at the new JAAC Building, Secretariat, U m u a hia, saw the Commissioner for Local Government and Chieftaincy Affairs, Hon. Prince Uzor Nwachukwu, describing the TechRise programmeas a transformative platform that prepares Abia youths with practical digital skills crucial for today's technology-driven world.

He emphasised that, in just three months of intensive training across three centres, Umuahia, Aba, and Ohafia, the programme had unlocked the potential of 510 youths. The initiative also fostered teamwork through sports, intellectual competitions, and cultural displays, culminating in the formal graduation event.

N w a c h u k w u highlighted that the programme reflects the government's commitment to technical education, youth e m p o w er m e n t, a n d community building. He expressed gratitude to Governor Alex Otti for his unwavering support in making the initiative a reality

In his keynote address, Governor Otti reaffirmed his administration's commitment to sustaining the TechRise programme. He directed the Chief Strategic Officer to establish a digital platform for ongoing engagement, mentorship, and global networking opportunities for the trainees.

From May 2023 to June 2025, the initiative will train three cohorts, totaling 155 individuals, including the current Head of IT at the Ministry of Digital Economy and SME, Abia State.

Abia Govt. Bids For 60% Stake In EEDC, To Boost Power Supply

he Abia State Government has submitted a bid to acquire a 60 per cent stake in the Enugu Electricity Distribution Company (EEDC) assets within the state.

The Commissioner for Information, Prince Okey Kanu, made this disclosure while briefing journalists on the outcome of the previous Executive Council (Exco) meeting, presided over by Governor Alex Otti.

Prince Kanu further revealed that negotiations for the acquisition of 60 per cent of EEDC's assets have reached an advanced stage. He also shared that the state is preparing to re-fence eight local government areas in Abia Central and Abia North Senatorial zones to

facilitate infrastructure and grid upgrades.

"In a major move to enhance the power initiatives of this administration, the Abia State Government has submitted a bid for the acquisition of 60 per cent of the electricity assets of EEDC in Abia State".

"The initial offer was made not long ago, and negotiations for the acquisition have now reached an advanced stage. Additionally, the process of re-fencing the eight LGAs in Abia Central and Abia North is already underway," he stated.

The Commissioner also announced that the state government would launch its participation in the EUsponsored Solar for Health power project next week,

aimed at providing solar electricity to at least nine healthcare facilities across the state.

"This project is financed through a 70-30 funding split, with the EU contributing 70% and Abia State providing 30 per cent of the counterpart funding".

"Once launched, the project will bring solar power to a minimum of nine health facilities across the stat, he further added."

He emphasised that these energy interventions a re part of the administration's vision to deliver uninterrupted power to citizens.

Contributing, the Commissioner for Power and Public Utilities, Mr. Ikechukwu Monday, said the proposed acquisition of EEDC assets is driven by the state's underperformance in power supply, particularly in Abia Central and Abia North, due to lack of investments.

"We've made progress with Aba Ring-Fenced, but from Umuahia to Abia North, we've been struggling", Monday stated.

He further disclosed that due diligence on EEDC assets had been completed, and the initial offer had already been submitted. The state government is now awaiting a response from EEDC's management.

"We are waiting for the management of EEDC to respond. Whether they accept or decline, we will return to the negotiation table until we reach a fair value", he added.

Monday also provided technical insight into the ongoing solar initiatives, stressing the importance of energy storage systems in the Solar for Health project.

"The design of the project will account for weather-related power fluctuations. For instance, if there's a fault or the solar panels aren't producing enough power during the rainy season, there will be a battery and energy storage system to handle that", he explained.

He also revealed that over 50 trained personnel from the Ministries of Power and Health have been selected to operate and maintain the solar systems.

Additionally, energy audits are currently being conducted in the selected health facilities to determine the best way to deploy the technology.

Experts Decry Rising Boat Hijacking In Rivers State

he recent hijacking of a passenger boat carrying 12 people from Port Harcourt to Bilie has raised fresh concerns about the safety of Rivers State's waterways.

Security analyst, Stanley Nsofor, described the increasing frequency of boat hijackings as "beyond alarming," warning that residents no longer feel safe using water transport.

He urged the government to take immediate action to restore public confidence, suggesting the declaration of a state of emergency on the waterways.

Nsofor criticized the Marine Police for their failure to respond to the hijacking, citing reports that officers were unable to act because they lacked fuel.

"What a country," he exclaimed, calling for a complete overhaul of the security personnel stationed on the waterways.

He further urged the Sole

Administrator of Rivers State, a retired naval officer, to take the lead in collaborating with the Nigerian Navy to improve marine security.

"This is his area of expertise; he must act to protect the riverine communities," Nsofor stated.

Another analyst, Charles Nko-Tariah, echoed these concerns, emphasising that the frequent hijackings highlight the weakness of current security measures.

He questioned the whereabouts of patrol boats donated by previous administrations and stressed the need for a strategic, demographic-based security plan, noting that water accounts for 60 per cent of Rivers State's 11,500 square kilometers

Nko-Tariah condemned the ease with which criminals operate on the waterways, describing them as a "free zone," for illegal activities. He called on the government to take immediate action to safeguard citizens across the coastal regions.



MARK TWAIN



ark Twain is a pen name of American writer Samuel Langhorne Clemens. He was born on November 30, 1835 in Florida, Missouri, United States of America. His parents were John Marshall Clemens and Jane Lampton Clemens. He was the sixth of seven

When he was only four, Twain's family moved to Hannibal, Missouri, a port town on the Mississippi River, this provided him with the setting for both novels. Tom Sawver and Huckleberry Fin.

Twain was only 11 when his father an attorney and judge died. The following year, he served as an apprentice with a printer. In 1851, he began working as a typesetter, contributing articles and humorous sketches to the Hannibal Journal, a newspaper owned by his older brother Orion Clemens.

When Twain was 18, he left Hannibal and worked as a printer in New York City, Philadelphia, St. Louis, and Cincinnati, joining the newly formed International Typographical Union, the printers' trade union. Twain educated himself in public libraries in the evenings, finding wider information than at a conventional school.

When Orion became secretary to Nevada Territory governor, James W. Nye in 1861, Twain joined him as he moved west. The brothers traveled more than two weeks on a stagecoach across the Great Plains and the Rocky Mountains, visiting the Mormon community in Salt Lake City.

Twain's journey ended in the silver-mining town of Virginia City, Nevada, where he became a miner on the Comstock Lode. He failed as a miner and went to work at the Virginia City newspaper Territorial Enterprise. Twain first used his pen name here on February 3, 1863, when he wrote a humorous travel account titled "Letter From Carson - re: Joe Goodman; party at Gov. Johnson's; music" and signed it "Mark Twain".

Twain and Olivia Langdon corresponded throughout 1868. She rejected his first marriage proposal, but Twain continued to court her and managed to overcome her father's initial reluctance. They were married in Elmira, New York, in February 1870.

Twain owned a stake in the Buffalo Express newspaper and worked as an editor and writer. While they were living in Buffalo, their son Langdon died of diphtheria in 1872 at the age of 19 months. They had three daughters: Susy, Clara and Jean.

Starting in 1873, Twain moved his family to Hartford Connecticut, where he arranged the building of a home next door to Stowe. In the 1870s and 1880s, the family summered at Ouarry Farm, in Elmira, the home of Olivia's sister, Susan Crane. In 1874, Susan had a study built, an octagonal gazebo set apart from the main house, as a surprise to Twain so that he would have a quiet place in which to write and enjoy his cigars.

Twain wrote many of his classic novels during his 17 years in Hartford between 1874 and 1891, and over 20 summers at Quarry Farm. They include The Adventures of Tom Sawyer (1876), The Prince and the Pauper (1881), Life on the Mississippi (1883), Adventures of Huckleberry Finn (1884), and A Connecticut Yankee in King Arthur's Court (1889).

The couple's marriage lasted 34 years until Olivia's death in 1904.

Twain was fascinated with science and scientific inquiry. He developed a close and lasting friendship with Nikolas Tesla, and the two spent much time together in Tesla's laboratory. Twain patented three inventions, including an "Improvement in Adjustable and Detachable Straps for Garments" (to replace suspenders) and a history trivia game. Most commercially successful was a self-pasting scrapbook; a dried adhesive on the pages needed only to be moistened before use. More than 25,000 were sold.

Twain made a substantial amount of money through his writing, but he lost a great deal through investments. Twain invested mostly in new inventions and technology, particularly the Paige typesetting machine. It was considered a mechanical marvel that amazed viewers when it worked, but it was prone to breakdowns. Twain spent \$300,000 (equivalent to \$9,774,828 in 2024) on it between 1880 and 1894, but before it could be perfected it was rendered obsolete by the Linotype. He lost the bulk of his book profits, as well as a substantial portion of his wife's inheritance. Twain and his family closed down their expensive Hartford home in response to the dwindling income and moved to Europe in June 1891.

Twain was awarded an honorary Doctor of Letter (D.Litt.) by Yale University in 1901 and a Doctor of Law by the University of Missouri in 1902. Oxford University awarded him a Doctorate of Law in 1907.

In his later years, Twain lived at 14 West 10th Street in Manhattan. He passed through a period of deep depression which began in 1896 when his daughter Susy died of meningitis. Olivia's death in 1904 and Jean's on December 24, 1909, deepened Twain's gloom. On May 20, 1909, his close friend Henry Rogers died suddenly. Twain died of a heart attack on April 21, 1910, in Stormfield. Twain and his wife were buried side by side in Elmira's Woodlawn

Nigerian Televangelist **Timothy Omotoso Deported to Nigeria Amid Rape Case Appeal**

igerian televangelist Timothy Omotoso, recently acquitted of 32 charges including rape, sexual exploitation, and human trafficking, was deported to Nigeria from Johannesburg's Tambo International Airport according to local media reports. The 66-year-old pastor's departure follows his rearrest on immigration charges and comes days after South African prosecutors announced plans to appeal his acquittal.

Dominion International (JDI) church based in Durban with branches in Nigeria and Israel, was acquitted in April 2025 by the Eastern Cape High Court in Gqeberha. Judge Irma Schoeman ruled that prosecutors failed to prove the case beyond a reasonable doubt, citing mishandling by the state. The decision sparked widespread outrage across South Africa, with many criticizing the National Prosecuting Authority (NPA) for its handling of the eight-year trial.

Omotoso was rearrested in East London for violating the Immigration Act after the Department of Home Affairs declared him a prohibited person due to an expired and allegedly fraudulent visa. ottenham Hotspur will clash with fellow English Premier League side, Manchester United in the final of the 2025 UEFA Europa League this Wednesday at the San Mamés Stadium in Bilbao, Spain.

Both sides have had a very disappointing domestic performance, this season with both teams just above the relegation zone in the league. This final offers them their only opportunity to win silverware this season and above all their route to play in the prestigious UEFA Champions League next season. This is simply a war of redemption.

Spurs have won this competition twice when it was known as the UEFA Cup in 1972 and 1984 while the Red Devils emerged champions in 2017.

To reach this final, Spurs won five, drew two and lost one in the league phase; scoring 17 and conceding only 9 goals.

In the round of 16, they eliminated Dutch side AZ Alkmaar 3-2 on aggregate before eliminating German side Eintracht Frankfurt 2-1 in the quarter finals.

Their biggest win came in the semi-final where they confronted Bodo Glimt and demolished them 5-1 in aggregate.

Manchester United, on the other hand, are the only side yet to lose a match in Europe this season. They won five matches, drew three scoring 16 and conceding 9 goals in the League

They crushed Real Sociedad 5-2 before their remarkable
