Abia Govt. Mandates Fire Extinguishers In Homes, Workplaces

By Chinedu Kelechi he Abia State Government has introduced a new safety policy, mandating the installation of fire extinguishers in all homes, offices, and business premises across the state.

The initiative, rolled out by the Abia State Orientation Agency, follows a three-day sensitization campaign in Aba that used radio broadcasts, market outreaches, and community meetings to educate residents on fire safety.

Chief Fire Officer of the Abia State Fire Service, Arch. Arua Nnanna, said the measure is aimed $at improving \, emergency \, readiness. \\$

"Preparedness is the strongest defense against fire disasters, Nnanna noted, saying, "A fire extinguisher within reach is more effective than a firefighter arriving from miles away. The governor's policy is about readiness-the first responder to any fire outbreak is

The campaign was partly motivated by recent incidents, including the fire outbreak at Enyimba FM in Aba. According to Director General of the Abia State Orientation Agency, Ure Abazie, Governor Alex Otti issued an executive order after concluding that many tragedies could have been minimized with the availability of fire extinguishers.

"Fire cannot be stopped by panic or shouting-it requires immediate action with the right equipment," Abazie said. According to him, certified vendors are already in place across the state.

This policy is not only about compliance but about safeguarding lives and investments.

Officials said, the directive is designed to make residents the first line of defense in emergencies and to set a new benchmark for fire safety awareness in Nigeria.achi Uzoukwu and Ebere Tasie

Osun Moves To

he Osun State Government's decision to commit N678 million to the reconstruction of the Sango-Timi Shrine and Grove in Ede, hometown of Governor Ademola Adeleke, has triggered widespread criticism from civil groups, analysts, and community leaders across the state.

Critics argue that the project reflects misplaced priorities at a time when the state is grappling with pressing economic challenges, unpaid worker entitlements. and abandoned infrastructure in other major towns.

Public affairs analyst. Adebayo Adedeji, faulted the government's decision, stressing that the allocation to the shrine nearly doubles the N376 million released as education subsidies for the entire state in the first half of 2025, according to the Q2 Budget Implementation Report.

He also noted that despite promises to workers, only N500 million - about 11.1percent of the N4.5 billion budgeted for gratuity arrears—has been paid so far this year. The Contributory Pension Scheme, he added, remains severely underfunded, with just □998 million (14.3% of the N7 billion allocation) disbursed.

"It is disturbing that the government finds it convenient to pour such huge funds into a shrine project when pensions, salaries, and education are underfunded. This raises serious questions about governance priorities,' Adedeji said.

Adedeji further decried what he described as a lopsided concentration of development in the governor's hometown.

"In 2025 alone, at least seven road projects worth over N70 billion have been awarded for dualisation in Ede. Meanwhile, vital projects in Ife, Osogbo, and Ilesa have remained abandoned nearly two years after they were flagged -off," he said.

He also questioned why the state would invest so heavily in the Ede shrine in the name of tourism while leaving other globally significant sites in neglect.

"If the objective is to promote tourism and protect cultural heritage, why is Ede the focus? What about Ile-Ife, the cradle of Yoruba civilization, or the Osun-Osogbo Sacred Grove, a UNESCO World Heritage Site that attracts global visitors?" he asked.

The $O\ s\ o\ g\ b\ o$ Development Action Group (ODAG) joined the chorus of disapproval, describing the shrine allocation as a "reckless expenditure" with little long-term benefit for the state's economy.

In a strongly worded statement, ODAG's coordinator, Omosola Olabode, insisted that the government should channel such huge addressed.

funds into developing the Osun-Osogbo Sacred Grove, which is internationally recognized and has the capacity to generate steady revenue and jobs through tourism.

'Governor Adeleke campaigned on a promise to upgrade the Osun-Osogbo Sacred Grove. That site remains a cultural jewel of Yoruba land and a global tourist attraction. Directing nearly N700 million to a local shrine while neglecting a UNESCO-listed heritage site is wasteful and unjustifiable," Olabode

The development has since sparked heated debates on social media and in community forums. with many Osun residents accusing administration of focusing on symbolic projects in Ede while leaving more pressing needs unattended.

Observers warn that the backlash could erode public trust in Adeleke's government if concerns over uneven development and misplaced priorities are not urgently

Abia Disability Commission Rallies Support for Children with Intellectual Disabilities

hildren with intellectual disabilities deserve love, patience, and opportunity-not stigma, discrimination, or neglect.

This was the resounding message at a one-day sensitization and training programme organized by the Abia State Disability Commission held recently in Umuahia, Abia state.

The programme, attended by teachers, health workers, education secretaries, local government officials, and permanent secretaries, sought to deepen understanding of intellectual and learning disabilities while promoting inclusive policies and practices.

Chief Magistrate Nnenna Grant Osu; a certified brain trainer and CEO of Brain Activate Initiative, emphasized that every child is a gift to society.

She explained that conditions such as Down Syndrome, Fragile X Syndrome, and Prader-Will Syndrome - alongside learning challenges like autism, cerebral palsy, and dyslexia – do not define a child's worth. "With the right environment and support, these children can thrive and contribute meaningfully to society," she said.

She further identified genetic, environmental, and hereditary factors as common causes of intellectual and learning disabilities, stressing the need for early intervention, professional support, and public awareness.

In his address, the Commission, Mr. David Anyaele, called for the removal of barriers that hinder persons with disabilities in Abia State. He urged government, faith-based groups, and civil society to make public facilities accessible and prioritize inclusive budgeting. "We must create awareness, enforce disability rights, and ensure no child is excluded. Persons with disabilities deserve the highest respect and care," he declared.

Education was

highlighted as a critical tool society must provide for empowerment. Experts at the training advocated for inclusive classrooms, individualized learning plans, and teaching approaches that accommodate diverse Disability Commission, needs. Such interventions, they noted, not only aid the state to sustain learning but also foster peer acceptance and reduce

Abia State Validates Guidelines For Alternative Child Care

igeria Stakeholders in Child Welfare and Protection have unanimously endorsed the domestication and validation of the Abia State Guidelines for Alternative Care of Children, marking a major step forward in safeguarding the rights and welfare of vulnerable children across the State.

The endorsement took place during a high-level validation meeting held at the Ministry of Women Affairs Headquarters in Umuahia. The event was convened by the Abia State Government to review and formally adopt the policy document, which outlines standardized procedures for the care and protection of children without parental care.

Participants at the meeting included representatives from the International Federation of Women Lawyers (FIDA), the National Orientation Agency (NOA), the National Agency for the Prohibition of Trafficking in Persons (NAPTIP), the Nigeria Police Force (NPF), Nigeria Security and Civil Defence Corps (NSCDC), the National Children's Parliament, the traditional

institution, and media organizations, among others.

Commissioner for Women Affairs, Dr. Maureen Aghukwa, called for the formal endorsement of the guidelines during the meeting. The motion to validate the document was moved by Comrade Victor Orji, Director of NOA in Abia State, and seconded by CSP Ngozi Kanu, Officer in Charge of Gender at the Nigeria Police Force, Abia State Command.

Delivering her keynote address, Dr. Aghukwa said the guidelines would serve as a legal and policy framework to protect children who are unable to live with their biological families due to abandonment, abuse, or other crises. She emphasised that the document aligns with national legislation and international standards, including the United Nations Guidelines for the Alternative Care of Children.

"The true measure of these guidelines will be seen in the smiles of children who find love, care, and stability in alternative family settings and in the reduction of child neglect, abuse, and exploitation," she stated.

Presenting a summary of the guidelines, Abia State Coordinator of the Child Protection Network (CPN), Ambassador Onyinyechi Joy Nwosu, said the document outlines

procedures for assessing, placing, and supporting children in alternative care arrangements. These include kinship care, foster care, adoption, residential care, and emergency placements, with a clear preference for family-based and community-driven solutions over institutional

She noted that the validation marks the culmination of several years of collaborative work between the Ministry of Women Affairs, the Child Protection Network, and development partners, particularly SOS Children's Villages Nigeria.

"This process is not just about producing a document; it is about ensuring that every child in Abia State grows up in a safe, caring, and supportive environment," she said.

Earlier in the programme, Director of the Child Department in the Ministry of Women Affairs, Mrs. Goddy-Onulaka Josephine, welcomed stakeholders and commended their dedication to strengthening child protection systems across the state. The newly validated

guidelines are expected to reduce unnecessary institutionalization, reinforce family and community care structures, and establish uniform protocols for child placement and ongoing monitoring.

With this milestone Abia State joins a growing number of Nigerian states leading the way in child welfare reform — ensuring that no child is left without love, safety, and dignity.

"This is a timely move. As disasters become more frequent, we must bring emergency co-ordination closer to the people," Dr. Jackson said. He also promised that the government will support the committees with what they need to work properly.

Also speaking at the event, the Commissioner for Environment, Mr. Philemon Ogbonna, represented by the Permanent Secretary, Mr. Ikechukwu Oriuwa, praised the government's effort. He said, the committees would act as first responders in emergencies and promised full support from the ministry.

On behalf of all LGAs, the Mayor of Aba North, Mr. Timothy Iheke, stressed the importance of involving local communities in disaster management. He also suggested that dedicated offices should be set up for the committees in each council for quick response.

During the event, Dr. Jackson gave presentations on how to build and strengthen the LEMCs, as well as strategies for local preparedness and resilience.

Chima Anyaso Revives Umuahia Correctional Centre, Feeds 843 Inmates, Sponsors Exams

he Umuahia Medium Security Custodial Centre witnessed a remarkable act of philanthropy as business man and philanthropist, Dr. Chima Desmond Anyaso, donated millions of naira worth of food, clothing, educational support, and logistics to the facility's inmates.

Arriving with what many described as a life-changing intervention, Dr. Anyaso ensured that three grounded prison vehicles were restored to full use after he provided brand new tyres and five heavy-duty batteries. The gesture, according to officials, will ease the movement of inmates to and from court, a process that had faced delays for months.

The philanthropist, who recently marked his 45th birthday, also supplied several bags of rice to improve the feeding conditions of the over 843 inmates, alongside quality wrappers and clothing to restore their dignity.

Beyond immediate needs, Dr. Anyaso unveiled a far-reaching educational intervention. He pledged to renovate the National Open University (NOUN) study centre within the facility and personally sponsor NECO registration fees for 16 inmates currently pursuing secondary education while serving their terms.

Encouraging the inmates during his visit, Anyaso said their present condition did not define their future.

"God never ordained anyone to live in trouble. This is not your final destination. Hold on to faith, keep hope alive, and you will rise again," he assured.

He further announced plans to partner with the Nigerian Correctional Service through the prison ministry of his church, House on the Rock, to provide sustained support, mentoring, and spiritual guidance.

The Deputy Controller in charge of the Custodial Centre, DCC Mabia Ojiakor Michael, commended the gesture, describing it as the true definition of leadership and service.

"Choosing to invest

The inmates, represented by their General Provost, Mr. Chikadi Dick, expressed deep appreciation, noting that the visit restored their hope for a second chance in life.

he Abia State Government has announced the full installation and beginning of operations at its newly established Materials Testing Laboratory, aimed at enforcing quality standards in construction across the state.

The Commissioner for Information, Prince Okey Kanu, disclosed this recently, stating that the lab is now fully functional and equipped to carry out a wide-range of critical testing services.

"We are happy to announce that the laboratory is fully installed and operational. It offers services, including concrete testing, soil testing, aggregate testing, asphalt pavement testing, sond destructive testing, and various field tests," he said.

Kanu explained that the

facility was established to ensure high standards in engineering and building projects across the state.

He emphasied that this initiative aligns with Governor Alex Otti's commitment to improving infrastructure quality and reducing the risks of structural failure and building collapse.

Speaking on youth empowerment, the commissioner revealed that the Abia TechRise ICT Training Cohort 2 is nearing completion of the applicant verification stage, with 850 individuals screened across all local government areas. He announced that training for successful candidates started on September 25, 2025.

"This programme is part of the state government's agenda to equip our youth with ICT skills for relevance in the 21st Century. It will grow Abia's digital workforce, boost youth empowerment, and enhance job creation opportunities," he said.

Kanu also recalled that during the first cohort, 19 graduates received automatic employment from the state government — a gesture likely to be repeated in the second cohort.

In another development, the commissioner disclosed that the Ministry of Local Government and Chieftaincy Affairs, in collaboration with local councils, had begun implementing the East Agricultural Intervention Project. The scheme aims to improve food security and create employment across rural communities.

He also announced plans for the construction of four prototype markets across the 17 LGAs. Each market will feature 40 open stalls, solarpowered lighting, boreholes, conveniences, and solar phone charging points.

"This initiative will boost local trade, expand rural economic opportunities, and promote women and youth entrepreneurship. "It will also help curb rural-urban migration by providing sustainable livelihoods," he said.

Also speaking at the briefing, the General Manager of the Umuahia Capital Development Authority (UCDA), Mr. Kingsley Agomoh, confirmed that the Materials Testing Laboratory is located at the UCDA Headquarters in Ogurube Layout, Umuahia.

He noted that the facility was established in response to the rising cases of building collapse in the state.

Mr. Ferdinand Ekeoma, Special Adviser to the Governor on Media and Publicity, was also present at the briefing.

Time To End The Era of Fake Degrees In Nigeria

he Federal Government's decision to enforce a has struck at the very root of this national compulsory nationwide credential verification system, beginning October 6, 2025, marks a historic turning point in Nigeria's long struggle against academic fraud, certificate racketeering, and the cancer of fake degrees. For too long, fraudulent qualifications have compromised the integrity of our education system, infiltrated our public service, and corroded confidence in Nigeria's intellectual capital. This decisive reform anchored on the National Education Repository and Databank (NERD) and implemented through the National Credential Verification Service (NCVS) offers a credible pathway to restore sanity

The service-wide circular signed by the Secretary to the Government of the Federation, Senator George Akume, is clear and unequivocal. All Ministries, Departments, and Agencies (MDAs), alongside private and public tertiary institutions, must now comply with a structured verification process that makes every certificate digitally traceable. Employees and prospective job seekers alike will require clearance through NCVS before their appointments can be confirmed. Each certificate will be tagged with a National Credential Number (NCN) and secured with digital codes, ensuring instant verification at any point in the country or indeed, the world.

This is not merely another bureaucratic measure. It is the first time Nigeria is instituting a federated, independent quality assurance mechanism that stands above individual institutions, many of which have historically failed to detect, or even abetted, certificate fraud. The legal foundation rests firmly on the Education (National Minimum Standards and Establishment of Institutions) Act of 1985, ensuring that this policy is not only enforceable but binding on all tiers of governance.

The urgency of this reform cannot be overstated. For decades, fake universities, diploma mills, and syndicates trading in fraudulent degrees have flourished, aided by weak verification procedures. The consequences are staggering: unqualified individuals occupying sensitive offices, erosion of meritocracy, and the cheapening of the hard work of genuine students and scholars. Worse still, the presence of such fraudsters in critical sectors health, engineering, security-directly endangers lives. By digitising and centralising verification under NERD, the government

embarrassment.

Encouragingly, the NCVS is fully operational. As confirmed by Ms. Haula Galadima, Executive Director of Communication and Cybersecurity for NERD, the infrastructure is ready, and focal officers in MDAs and schools are being onboarded. The system is more than a database: it integrates the National Student Number (NSN), National Credential Number (NCN), and National Document Number (NDN), creating a holistic web of accountability that will feed into a National Database of Resource Persons. With this, Nigeria will, for the first time, have a single, verifiable pool of qualified individuals across disciplines

The message is loud and clear: come October 6, fake degrees and forged honours will no longer slip through the cracks.

But while this is a bold federal initiative, we advocate that it must not stop at Abuja. State governments must embrace, domesticate, and actively enforce this policy across their civil and public services. Too often, states have looked the other way, tolerating the presence of unqualified staff in their workforce. Governors and state legislatures must move swiftly to align with the federal standard, ensuring that every teacher, health worker, engineer, or administrator employed within their jurisdiction holds verifiable qualifications. Anything less would amount to sabotage of the national reform effort.

In addition, tertiary institutions themselves; universities, polytechnics, and colleges of education must view NERD not as an intrusion on their autonomy but as a collective safeguard. The Governing Council of NERD already includes key regulatory bodies: the National Universities Commission (NUC), National Board for Technical Education (NBTE), and National Commission for Colleges of Education (NCCE). Their participation underscores the collaborative ownership of this initiative. Academic leaders must therefore shed the temptation to protect fraudulent insiders and instead embrace this transparency tool as a shield for their institutions' integrity.

Nigeria's reputation in the global knowledge economy depends on the credibility of its certificates. Genuine students who toil to earn their degrees should not have their achievements diluted by the proliferation of fakes. Employers, both at home and abroad, deserve the confidence that a Nigerian certificate stands for competence, not corruption.

This is why state governments cannot afford to treat this reform as optional. To defeat the scourge of fake degrees, Nigeria requires a united front federal, state, institutional, and private sector. Only then can we restore respect for merit, ensure fairness in recruitment, and build an education system worthy of the nation's aspirations.

With the NCVS, the Federal Government has laid a firm foundation. The states must now follow suit. The era of fake degrees must

A Welcome Development for Drivers Licence

Dear Editor.

he recent proposal by the National Drug Law Enforcement Agency (NDLEA) to make drug testing compulsory for all applicants and renewals of driver's licences is both timely and commendable. Brig. Gen. Mohamed Buba Marwa (retd.), is right in pointing out that reckless driving, rising cases of avoidable accidents, and violent behaviour on our roads have direct links to psychoactive substance abuse. For too long, Nigerians have suffered needless loss of lives and property due to impaired drivers who operate vehicles while under the influence.

Drug abuse is not only a criminal act; it is a serious public health and road safety threat. The driver of a vehicle holds the lives of passengers, pedestrians, and other road users in his or her hands. Allowing individuals whose judgment and reflexes are compromised by drugs to obtain licences is akin to legalising danger on our roads. Mandatory drug testing would therefore act as both a deterrent to potential abusers and a safeguard for the commuting

However, for this measure to succeed, it must be strictly enforced without bias or compromise. Nigeria is a society where regulations often falter at the altar of corruption, selective enforcement, or class privilege. If drug testing for licences is to make an impact, it must cut across all strata: the influential and the ordinary, the rich and the poor, the urban and the rural. There should be no sacred cows. A commercial driver in Aba should be subjected to the same standard as a senior government official in Abuja. Anything less will defeat the noble objective of this initiative.

Furthermore, designated testing centres must be adequately equipped, accessible, and affordable. The process should be transparent, with results verifiable and protected from manipulation. It is also important that those who test positive are not merely denied licences, but referred for appropriate counselling and rehabilitation, in line with the NDLEA's War Against Drug Abuse (WADA) campaign. This way, the policy will not only protect road users but also contribute to national healing from the scourge of drugs.

Several countries have adopted similar policies with measurable success in reducing road accidents. Nigeria must not lag behind. The Federal Executive Council should approve this proposal without delay, and implementation should begin in earnest. Our nation can no longer afford to treat road safety casually. Every Nigerian life matters, and ensuring drug-free driving is one sure way to protect it.

FCTA Launches Clearance Operation At Kpakuma Kobi Village

The Federal Capital Territory Administration (FCTA), has launched a clearance operation at the Cashew Plantation in Kpaduma-Kobi Village, along the Asokoro-Guzape corridor, following an attempted kidnap on September 15.

Secretary of Command and Control, Dr. Peter Olumiji, said the exercise is aimed at eliminating criminal hideouts and preventing further incidents. He confirmed that police swiftly responded during the attack, rescuing both victims, although a vigilante lost his life in the operation.

Olumiji disclosed that drones will be deployed to monitor the area, working alongside hunters and conventional security operatives. He added that a 24hour police post and solar-powered streetlights will also be installed to strengthen security.

Director of Development Control, Mukhtar Galadima, described the move as part of a broader strategy to reclaim ungoverned spaces across the FCT. "Similar operations have been carried out in Apo Resettlement, Guzape, and last year in the Mabushi scavengers' colony," he said.

Community leaders have endorsed the clearance, insisting that the forest had become a danger to residents. Iliya Iwadagba, a resident of Kobi Village, said criminal elements began invading the area about five years ago, making the route unsafe, especially at night.

The FCTA urged residents to co-operate with security agencies, assuring that it remains committed to ensuring the safety of lives and property in the territory.

NCoS Stops Drug Smuggling Attempt At Kuje Custodial Centre

He also cautioned visitors with "ulterior motives" to desist, stressing that vigilant officers would always foil such plots. He further appealed to the public to support the Service's efforts in reforming and rehabilitating inmates to enhance public safety.

2027 Coalitions And Collisions

he undeclared kick-off of the 2027 general election campaign is something of a false start. It's a start nonetheless - one laden with boasts, bluster and outright threats. To be fair, the stuff isn't just coming from one direction: the ruling All Progressives Congress (APC) and those who would love to oust it, are giving as good as they get ...

Last weekend, the party's high command descended on Uyo, the Akwa Ibom State capital, to formally receive Governor Umo Eno, who had finally executed his oft-threatened exit from the Peoples Democratic Party (PDP). Everyone from Vice President Kashim Shettima to the party's entire slate of governors was present.

The state is home turf for Senate President Godswill Akpabio who was once its governor. Naturally, he was in his element celebrating the bloodless coup that further enfeebled the main opposition party. Akwa Ibom, like most states in the South-South zone, was until recently died-in-the-wool PDP territory. So, it was no mean feat that the entire structure of the governing party would dissolve overnight into enemy camp without

While applauding Eno for making the right political choice, Akpabio suggested governors of Bayelsa and Rivers would soon follow. It wasn't the appeal of a suitor; it was a statement delivered with the certainty of a prophet. Were his prophecy to be fulfilled, not too many would be surprised given that stranger

things have been happening lately.

The punch-drunk PDP didn't have much of a response to the loss of another heavyweight from within its ranks. It was probably too preoccupied trying to identify which of many claimants was its rightful National Secretary to worry about the rising number of rats fleeing its listing ship.

With its 10 governors, 36 senators and 118 members of the House of Representatives, it remains, on paper, the preeminent opposition party. But it's a measure of how low its stock has sunk that some of its leading lights like former Vice President Atiku Abubakar and ex-Senate President David Mark are among onsors of the yet-to-be-registered All Democratic Alliance (ADA)

By their actions and utterances, the two men have written off PDP as a viable vehicle for prosecuting the 2027 election. Atiku has been arguing for months that the only way President Bola Tinubu and APC can be defeated at the next polls is for all opposition platforms to come together. Mark has been less voluble but no less committed to the cause

Unfortunately for Atiku, his passion for defeating his onetime ally by all means necessary is not shared by PDP governors who have declared they won't touch his coalition with a ten-foot pole. This is a significant disagreement which suggests that those who now control the party are unlikely to make the former VP flag bearer given he's lost faith in the platform. It's also a pointer that he could yet exit to actualise his ambitions elsewhere.

Although it remains very much work in progress, what the

coalition, or a likely new party, lacks in terms of membership or office holders, it makes up for with bluster and threats. In the face of every setback dealt the opposition by way of high profile defections to the ruling party, its boosters head for television talk shows to offload incendiary interviews.

Former Kaduna State Governor, Nasir El-Rufai, was at it again this week, regurgitating the same talking points. Apparently, he and his confederates had been conducting opinion polls which claim Tinubu had less than 10% approval in every corner of the country.

For a man of his intellect and sophistication, this faith in his "scientific" polls is touching. Beyond offering comfort to he and his co-conspirators, El-Rufai should treat polls and pollsters with a healthy dose of caution. For one thing, their reputation isn't what it used to be after they misfired badly in the 2016 Hillary Clinton versus Donald Trump presidential contest

For months last year they predicted a tight race between Kamala Harris and Trump - only for Election Day to reveal a chasm in support between the two candidates. What's more, today's polls may be meaningless in two years when actual voting would be taking place.

Truth is wise men don't rush to conclusions on the strength of dodgy opinion polls - especially in a country as unpredictable as Nigeria. If tough economic conditions were the only determinant of electoral success or failure in these parts, then Tinubu wouldn't be president given the state of the nation between January and February 2023

Another noisy figure in the nascent opposition platform is one-time Foreign Minister and former Jigawa State Governor, Sule Lamido. What can be gleaned from his regular utterances is $his \, readiness \, to \, join \, any \, grouping \, that \, can \, remove \, the \, incumbent$ from office.

The focus of these individuals is clear, how to transit from dreaming to reality has become a giant obstacle. For all their hot air, the would-be coalition hasn't done much to inspire confidence about their project within the political class and in the wider polity. They can't even agree on how to proceed.

At the onset, the Social Democratic Party (SDP) was touted as their platform of choice. El-Rufai announced his defection there with much fanfare. But their ardour for the arrangement cooled rapidly. The party's National Secretary, Dr. Olu Agunloye, now describes his would-be collaborators as "confused people" who are only interested in taking over. Former presidential adviser turned critic, Hakeem Baba-Ahmed, has been equally unsparing, describing the coalition's promoters as only concerned with being the face of project. Just as many had predicted, a collision of egos and ambitions is already playing out. Baba-Ahmed laments that even before getting out of the starting block, Nigeria's latest set of would-be saviours have blown the opportunity of offering a credible challenge to the administration.

The most important thing they're doing wrong is putting themselves forward," he said on Arise TV. "It's a coalition of a few politicians who hope that they can arrive at some understanding and then open the door and say, 'ok, fellow Nigerians, we've agreed. This one will be this, and this one will be that, and you can now come in.'

It's the wrong way about it. None of these people should lead or be seen in a position where they're determining who should be in that coalition. They can work behind the scenes. What they need is a generational shift and a political shift away from who they are, what they've done, what they want to do, to a different set of Nigerians who can give Nigerians hope.

These are not the people who are saying, give us trust. Trust us again to solve the problems that the APC is creating. This is the wrong thing. And it's very difficult to convince politicians that Nigerians can see through you. They don't have faith that you actually represent a future, a different future from this government. You just want to replace President Tinubu."

Put differently, those offering change are as stale as they

come, laden with all sorts of unattractive baggage. Virtually all have been active participants in making Nigeria what it is today. That's why their project is having difficulty scaling the credibility hurdle. It's often said you don't get a second chance to make the first impression. What those who claim to be speaking for the coalition have succeeded in doing so far is projecting vengeance and retribution, as well as the promotion of the interests of a section of the country, as their agenda.

Bitterness and outpouring of venom against the incumbent president is no alternative to providing voters an alternative governance vision. All we hear is "we must remove Tinubu." If that's all Atiku, El-Rufai and company have to offer, they are set for a rude collision with reality in the not-too distant future.

Go on, Fubara, Become a Hero

Pe made so much noise and raised plenty of eyebrows, but Sir Siminalayi Fubara was successfully sent packing from office for six months in a controversial display of federal might and presidential powers by President Bola Ahmed Tinubu. On Wednesday, Fubara was officially restored to office. In summary, he lost the battle for supremacy with his predecessor and benefactor, Chief Nyesom Wike, who is a minister in Tinubu's cabinet. When the war broke out, I was never in doubt as to who the president would support. Tinubu is not just a godfather who does not take kindly to rebellion, we also know Wike played a major spoiler role to help Tinubu win the 2023 presidential election.

Therefore, my money was on Wike winning the derby with Fubara. And win he did. That does not mean I was not surprised, or even disappointed, that Tinubu imposed emergency rule and sent Fubara on suspension. The idea behind a state of emergency is that there is chaos and disorder during which things cannot run their normal course, so you have to suspend certain aspects of the constitution to allow for extraordinary measures to be applied. That is certainly not the time to hold council elections. If the governor and legislators are not functioning — as important as they are in the hierarchy — what is the urgency to install council chairpersons and councillors? Only a few people are fooled by this

All said and done, Fubara is now back in office. As Wike boasted during an interview with Channels TV, "If we don't want this state of emergency to be lifted, we would have done one or two things to ensure that it continues." He has demonstrated how powerful he is in this government, and I don't think anybody should fool with him. If Tinubu decides to extend the emergency rule for another six months, all we will do is make more noise and raise more eyebrows but Wike will have his way. Let's not kid ourselves. The National Assembly will approve it via WhatsApp or do voice vote again. Heavens will not fall. Obasanjo and Tinubu have really done us a "strong thing" in this country.

We can only hope that peace will now return to Rivers in its true meaning. Wike has openly promised to give the governor his space. He said: "I cannot go and impose anything on the governor. Why would !? Assuming I go to the governor and say, "I want this," will the state collapse? I will not. I have no candidate (for commissionership), and I will not [have]," Wike said. As a form of affirmation on their new relationship, he said emphatically: "I have already said that we've been speaking. I will not engage with a man I have not forgiven. Everything is over. We must move forward." It must be noted, however, that most members of the House of Assembly are still loyal to Wike, so he still has the rope.

On his part, Fubara has promised to pursue peace. In his broadcast, he said: "In the course of the six-month period, Mr. President graciously brokered the peace process with all the parties successfully. Our Leader, His Excellency, Nyesom Ezenwo Wike, CON, all members of the Rivers State House of Assembly and I, as your Governor, have all accepted to bury the

hatchet and embrace peace and reconciliation in the best interest of our dear Rivers State." In what should be re-assuring, Fubara concluded: "We believe the political crisis is now behind us and that peace and stability have once again returned to Rivers State, though not without the hard lessons learnt from the emergency rule."

For peace to reign in the political arena of Rivers state, all the key actors must keep to their words. Wike, in his role as the "Our Leader" (as the governor described him), should stand by his public statements that he would let the governor be. He has every reason to protect his political structure if the governor was indeed chipping away at it — but there is a thin line between safeguarding your territory and diminishing or humiliating a governor, even if you are the one that installed him. Every human being wants some respect. Indeed, respect begets respect. When someone feels unduly disrespected, it is just a matter of time before he or she begins to show resistance. That is a fact.

Fubara should also genuinely embrace peace. He said the right things and made the right gestures in his broadcast. I am hoping this came from the bottom of his heart. He must acknowledge that the story of his life can never be written without a huge space devoted to the role Wike played. He became governor using Wike's umbrella, although Wike just nearly swept him away. When he anointed Fubara, many of those who opposed it later showed up to instigate the governor against his Wike. Nigerian politics is full of crisis entrepreneurs known in Yoruba as "arije ninu modaru". Fubara must be careful with those posing as allies simply because he was fighting Wike. They are dangerous.

Now that he is back in the saddle, he can decide what he wants to use power for: to serve the people of Rivers state with "heart and might" or engage his godfather in another game of wits. He can choose to become a hero to his people. He can choose to serve his people faithfully by touching their lives for the remainder of his tenure. He can focus on making sure every village has electricity, every primary health care centre has personnel and drugs, every school has teachers and desks, and every community has water to drink. He can choose to make every senatorial district and every local government much better than they are. These are easy wins. And his people will love him to death.

Alternatively, he can choose to engage his godfather in another round of the battle for supremacy. I don't think he can win that fight. He has just been worsted. The president has shown clearly to all of us where he pitches his tent. He has the security agencies at his beck and call and will not fail to deploy them as he deems appropriate. One legacy Obasanjo left behind in 2007 is that if you have presidential power in a third world country, you must

know how to use, misuse and abuse it. The fact that Presidents Umaru Musa Yar'Adua, Goodluck Jonathan and Muhammadu Buhari were somewhat restrained in their use of presidential powers does not mean every other president will follow suit.

Finally, I really would want this issue of emergency rule conclusively sorted out. Can an elected governor be suspended from office by the president? The 1999 Constitution clearly spells out how a governor can be removed: it is only by the House of Assembly after an impeachment process. There is no constitutional provision whatsoever that empowers the president to remove a governor under any circumstance. My understanding is that what a law does not provide for, you cannot import into it. I would instinctively conclude, therefore, that a governor cannot be removed by the president. In a federation, the president is not superior to a governor except in maters listed on the exclusive list.

But here is the catch. Tinubu did not remove Fubara — he only suspended him. Suspension is not the same thing as removal. The one is temporary, the other permanent. And section 305(d) of the constitution says he can take "extraordinary measures" to avert "a clear and present danger of an actual breakdown of public order and public safety in the Federation or any part". If the president determines that the governor is a danger to the community, he can claim that suspending him is an extraordinary measure that needs to be taken. It is a loophole that a clever lawyer can explore to justify the suspension. When you create a loophole like this, you can't blame people for exploiting it.

The Supreme Court has always failed to make a pronouncement on this emergency rule controversy, specifically on the issue of sanctioning a governor with suspension. Since Obasanjo started the game with Plateau state in 2004, the Supreme Court has tactically avoided making a definitive pronouncement on the legality of suspending a governor. It chose the technical ground in the Plateau issue,

ruling that the plaintiff, Governor Joshua Dariye, did not have the locus as he was no longer in office. The unwritten explanation is that in matters of national security, the apex court does not want to interfere so as not to impede the president's ability to maintain peace, law and order.

I would suggest that an amendment be made to the laws to remove any doubts about the powers of the president in emergency rule. We should not leave such an important matter hanging. With sincerity of purpose, we can address our political and constitutional challenges in a decent way. Our democracy is evolving and our constitution is being fine-tuned regularly to address emerging issues. We should not waste the Rivers crisis. As Fubara said, it has been a teachable moment for everyone. I welcome Fubara back to office with these words: go on, create a legacy of good governance and let your people remember you as one of the greatest governors ever. Against such, there is no law.

I commiserate with those who lost their loved ones in the fire tragedy at the Afriland Towers, Lagos, on Tuesday. It is so devastating! However, without first investigating and establishing the cause of the incident, the Federal Fire Service has announced plans to conducta "nationwide fire safety compliance audit". Sadly, we make policies on impulse in Nigeria. We usually start from the solution before researching the problem. Otherwise, we should first investigate what went wrong at Afriland Towers and then conduct an audit based on the findings in order to address the challenges robustly. How can policies be effective when they are based on conjectures and assumptions? Commonsense.

For those who believe the removal of history from school curriculum is the root of our problems, they now have an opportunity to prove it. The federal government has restored the subject, 16 years after it was removed. To be clear, I am fully for history to be taught — although I learnt the history of Nigeria by research as I did not take the subject in secondary school. I am happy history is back: I am tired of reading on social media that "it is because history is no longer taught in schools" that someone has just spewed some nonsense. I want to monitor how this will impact discourse in the years ahead. My hunch is that teaching history does not give sense to the senseless. Observing...

Women Demand Passage Of Special Bill to Boost Female Political Development

from across Nigeria Imarched through the streets of Abuja recently, calling on the National Assembly to pass the proposed Special Seats Bill, which seeks to create reserved legislative seats for women in both the Senate House Representatives.

The bill, which requires a constitutional amendment. proposes the addition of one women-only seat per chamber in each of Nigeria's

undreds of women Capital Territory. Supporters said the legislation would mark a critical step towards addressing Nigeria's longstanding gender imbalance in political representation.

The protest, described by organizers as one of the largest in recent years for women's political rights, featured more than 1,000 participants, according to activist Dorothy Njemanze, who helped coordinate the

36 states and the Federal buses, vans, and and 16 of 360 House seats, trucks-some blasting Afrobeats music-as they moved through major routes in the capital before submitting a petition with thousands of signatures to the House Committee on Constitutional Review.

according to figures from the Policy and Legal Advocacy Centre (PLAC) – making Nigeria one of the lowestranked countries globally in terms of female legislative representation.

Proponents argue that special seats would provide a necessary entry point for women who face structural barriers, including limited access to campaign financing, entrenched gender norms, and male-dominated political networks. They also point to successful quota models in countries such as Rwanda, Senegal, and Tanzania, where gender-inclusive policies have led to significantly higher female representation in government.

Minister of Women's Affairs, Hajiya Imaan Sulaiman-Ibrahim, has expressed support for the bill, aligning with President Bola Tinubu's broader pledge to increase gender equity. However, PLAC cautions that the road ahead is steep: constitutional amendments require approval by two-third of both chambers of the National Assembly and ratification by at least 24 of the 36 state assemblies. Despite the challenges demonstrators remained optimistic.

"Iwant seat – because tomorrow, I may be the one contesting for it," said Onu Ihunania, a 50vear-old civil servant from Enugu State, echoing the hope many women carried into the day's march.

As momentum builds, advocates said the real test will come in the political will of lawmakers to translate public outcry into legislative

he current class of state governors, Alex Otti of Abia stands conspicuous over most of his contemporaries. He is showcasing good governance and enlightened politics. This remarkable progress has got him into "good trouble". He has become a favourite of both good media and toxic voices from our political Bahylon. Those who appreciate the political Babylon. Those who appreciate the progress in Abia are praising the governors. The most remarkable thing about this category is that they are mostly common people for whom Mr. Otti has brought government to mean something positive to them. For this group, democracy and good governance mean the same thing: meeting the people halfway on the road to progress.

On the contrary, Otti is getting undue negative attention from partisan media and commentators from the other side of the partisan divide. It does not matter how many roads he builds, how many new schools he reads the builds, now many pensioners he pays arrears or how promptly he now pays salaries. Those politically opposed to his political position and very incumbency cannot see them. These voices of incurable negativity are dripping from the bile tanks of Abia's political Babylon, a place of incurable "bad belle".

The well meaning social and traditional media have their job mostly done by Mr. Otti's sterling performance. Even among the ordinary people in the villages and the urban centres of Aba and Umuahia, the publicity is self-defining. Even then, the Otti phenomenon is beginning to suffer a typically Nigerian handicap in terms of discourse and public opinion. The political opposition is digging up and padding up a mixture of falsehood and mangled narratives to score points preparatory to the 2027 campaigns. That of preparatory to the 2027 campaigns. That of course is in the nature of political exchanges. More dangerously, the favourite Nigerian game of unbridled sycophancy has encroached into the Otti narrative. Professional partisan sycophants and hirelings have been joined by new recruits in the form of "town criers" in the social media. While most are showcasing Governor Otti's more obvious infrastructure achievements and magnifying them for obvious partisan reasons, the voices of Babylon are singing old tunes of finding faults in every place. Between pro government sycophants and their equally feverish opponents, the road ahead is littered with media landmines.

But so far, Mr. Otti is one clear step ahead of his traducers and opponents. He has raised the stakes of his incumbency beyond the Government House in Umuahia. He has raised the meaning of government above blaring of sirens to disturb the peace of the poor and innocent. He has also gone beyond the usual landscape decoration of roads, bridges, and empty buildings. The dividend of democracy is not a decorated landscape. It is the transfer of political power back to the people to whom it rightfully belongs. For the first time since its creation, Otti has bridged the tragic divide between government and the people. He has given back government to the Abia people by making it accessible and meaningful to their daily lives. He explains to them the policies of government. He accounts periodically to them for his actions and the expenditure of government money. Those who used to vote and go home to be forgotten for another four years are now recalled from their villages and their accrued and arrears of salaries and pensions paid as and when due. The people now have a stake and a say in how they are governed.

The basic principle for the existence of the state is the social contract which binds government the people. A state that conducts its affairs indifferent to the desires and aspirations of the people is not a democratic state. It is at best a feudal fiefdom or autocracy. Abia, along with most Nigerian states came into existence as pseudo feudal enclaves created by military fiat with a democratic nomenclature but in essence autocratic.

Unfortunately, it took 24 years and three consecutive two-term governorships for Abia to struggle free from this feudal origin and

authoritarian orientation. In essence, the real history of a democratic Abia State began in May 2023. Only since then was the Abia Leviathan born and the social contract of an enlightened state inaugurated. It is perhaps since then that we can accept valid criticisms of government action in an atmosphere of free

The basic outlines of feudal rule in Abia can be briefly outlined to understand what happened over the past 24 years.

The long-standing bad reputation of Abia was not just because the roads were bad, Aba was rotten and neglected and government was populated by too many small and big thieves. It was rather in the more imperceptible fact that the government in Umuahia and the majority of Abia people travelled separate ways for a whole 24 years.

What obtained in Abia for the first 24 years was a feudal Babylonian captivity of the state and its people and resources.

Government was indifferent to the plight of the people. Those in authority collected votes at election time and turned the other way for years on end. The light of the people meant nothing to the successive governments. Politicians were in government for and imperial rule to a feudal oligarchy, from one depressing season of exploitation to a more humiliating fanfare of deception in the name of governance.

All manner of miscreants have come and gone, claiming electoral mandates that remain unverified. Extremely poor people have been frightened off the bad roads by authorized hooligans blaring sirens with accompanying goons with horsewhips and assault riffles.

We need to put in context what the state witnessed for a whole two and half decades prior to 2023. In the period between 1999 and 2023, Abia state was an unusual political 2025, Ania state was an unusual pointical experience among the states of the federation. While it was guided and governed by the Nigerian constitution, Abia operated more like a feudal enclave and unregulated extractive colony with peculiar characteristics.

Its most enlightened and illustrious citizens were consciously excluded from its governance and mostly lived and earned their living outside the state. The state economy was so privatized that the commanding heights were controlled by the imperial governor, his family and cult of

Over the 24 year period under reference, the quantum of resources that accrued to the state

The governor was more of an emperor ruling above criticism and reproach. In 24 years, no Abia governor was taken to court by a citizen on account of rights infringement or acts of misgovernance. Like feudal emperors, our successive governors were more of imperial feudal overlords.

The machinery of state was 'privatized' as the separation of powers was observed mostly in default. The legislature ran the errands of the executive governor and seemed to have a duty to pass legislations 'for' the governor routinely. The legislations that rolled out of the State House of Assembly were more of feudal decrees and imperial edicts than debated laws of a democratic assembly.

The judiciary had no independent voice as judges owed their appointments, promotions and general welfare to the benevolence of the imperial governor. Officials of the state judiciary were selected and hired on the basis of loyalty to the governor and the party cabal in

Quite routinely, the imperial governor set up and empowered an assortment of task forces and mobile courts to collect sundry revenues and levies in the name of the state but account to no institution of public accountability. Public accountability was mistaken for creative accountancy.

From available records, between 1999 and 2007, the Governor's Office issued and signed off on newspaper full page advertisements of the state's financial statement compiled and "audited" by the same Governor's Office. In other words, the governor authorized expenditure, spent the money, 'accounted' for it, audited the expenses and informed the public accordingly that the audit had been certified!

It failed as an organized criminal cartel. It failed its people, failed itself as an organized syndicate of enlightened thieves ("there is honour even among thieves", it failed the nation and failed the concept of democratic sovereignty.


In terms of tenure and power the thieves of Abia had no honour. Some of them toyed with self -succession, that is succession from within the family of the incumbent. One governor so empowered his mother that a new terminology was coined for the system of government that gave the mother of the governor virtual executive authority over some government decisions. It was called – "Mamacracy". Another governor attempted to be succeeded by his son whom he had manipulated into the position of Assembly Speaker. It was attempted hereditary monarchy.

Therefore, the question that Abia needed to answer with the outcome of the 2023 governorship election was simple: would the state correct course and return to the path of responsible democratic governance or continue as a feudal enclave under the captivity of a political oligarchy and Babylonian overlords?

The picture of the state on the eve of the rship election in 2023 was sad and almost tragic. Abia was easily the most indebted state in the federation with a debt portfolio of over N189.9 billion.

Abia was the state with the longest period of default in the payment of the salaries of staff in the public sector especially education and Doctors and teachers were owed anywhere between 24 to 30 months in salary arrears. System was unheard of. Aba was literally an inhabited refuse dump. Mounds of refuse greeted the eyes at nearly every inch of the city which had a permanent stench of something dead. Most roads in the town were in desperate disrepair.

The media rhetoric about Abia today is merely an exchange between spokespersons of a dying feudal political culture and a nascent democratic and republican order. Those in the vanguard of defending and protecting what Governor Otti is doing must understand what they are up against. Of course, the defenders of the feudal order have a right in a democratic space to do what they have always done- spew lies and spatter blackmail. Gladly, Abia people have left the Babylonian captivity of feudalism behind for all time. There is no going back.

because of themselves. Workers were unpaid for months on end. Teachers, doctors, university lecturers, pensioners shared a common plight of collective condemnation to a life time of penury. What has changed in Abia since the onset of the 2023 Otti administration is a decisive reversal of the focus of government from a conclave for itself to a service assembly for the people.

Perhaps the successive administrations may be termed Babylonian overlords. This is unlike other democratic federations that came into being as a result of popular will and mandate from below to the top, the Nigerian federal structure was created by an all conquering federal might from above. This is unlike the United States in which it was the states that voluntarily joined the federation for collective security and grandeur. In Nigeria, it was the central military of Nigeria that created the states and imposed an administrative structure on the entire nation.

Abia state has had a tortuous encounter with formal democracy. On the contrary, Abia people have for over 24 years tumbled from one season of state capture to another. Democratic transitions have been for these people more of ritual migrations from one Internally Generated Revenue was not matched in any way by the volume or tempo of development in the state.

In the same period, an annual Google search of the economy of the state indicated that in each of those years, of the five richest people in Abia State on a year-on-year basis, three at the top of the list coincided with the most prominent political figures.

prominent political figures.

The inevitable conclusion therefore is that for whatever reason, Abia was essentially a feudal enclave for 24 years (1999 to 2023) and has only been struggling to free itself from feudal captivity since after the 2023 governorship election. Between 1999 and May 2023, the state does not qualify as a democratic sub-coverign part of the Niverian federation. sub sovereign part of the Nigerian federation. Politics and the democratic process were only deployed as instruments for state capture by different factions of the Abia political elite. Once captured, the state in each of these years was run more like either a private feudal enclave or an unregulated extractive colony.

The rights of the citizens to fair treatment were grossly violated. The entitlement of the people to good government in terms of healthcare, education, security, infrastructure

Police Arrest 474 at Palestine Action Ban Protest

Olice have arrested 474 people at a demonstration in London in support of banned group Palestine Action.

The Metropolitan Police said 466 protesters were arrested for supporting the group, five for assaults on police officers, two for public order offences, and one for a racially aggravated offence.

Scores of people simultaneously unveiled handwritten signs with the message "I oppose genocide. I support Palestine Action" at the protest, organised by Defend Our Juries at Westminster's Parliament Square.

It was the biggest protest since the government proscribed the group in July under the Terrorism Act of 2000, making membership of or support for it a criminal offence, punishable by up to 14 years in prison.

No officers were seriously injured, and the Met Police said the number of arrests was the largest made by the force on a single day in the last 10 years.

Home Secretary Yvette Cooper thanked police for their response, while charity Amnesty International described the mass arrests as "deeply concerning".

Footage from the square showed officers moving among the protesters, who were mainly seated on the ground, and speaking to them before leading them away.

Protesters whose details could be confirmed at temporary prisoner processing points nearby were bailed with conditions to return to a police station at a future date and to not attend any further protests in support of Palestine Action.

People who refused to give their details or whose identities could not be verified were taken into custody.

Many of the protesters didn't want to speak to media who came to cover the protest, but one-who didn't give her name-told the BBC: "If they ban Palestine Action, what other group is next? Until we're just no longer allowed to protest anything. That's the opposite of democracy."

Another, Claudia Penna-Rojas, 27, said: "I don't think anyone wants to get arrested, but I'm more concerned with what is happening to people in Palestine right now, and I refuse to be a bystander."

Jacob Ecclestone, 86, said: "I believe in freedom of speech. What this government is trying to do is deeply authoritarian. And it's extremely dangerous."

Earlier, the Met Police had said about 500 to 600 people Earlier, the Met Police had salu about 500 to 500 people were in Parliament Square when the protest began, but that "many were onlookers, media or people not holding placards in support of Palestine Action".

At 13:00, when Big Ben chimed, hundreds of people sat on the square pulled out their placards, at which point the police started making multiple arrests at a time, working their way through the crowds.

Protesters patiently waited their turns. Some chose to walk out quietly. Those who refused to move, lying on the ground, were carried out by police to chants of "shame on you" directed at the officers.

The protest comes just days after the first three people to be harged with supporting the group in England and Wales were named.

Yvette Cooper thanked police for their work handling Palestine rights protests across the UK on Saturday, saying there had been a "very small number of people whose actions crossed the line into criminality".

She defended the banning of Palestine Action, which she said was based on "strong security advice following serious attacks the group has committed" as well as "plans and ideas for further attacks, the details of which cannot yet be publicly reported due to ongoing legal proceedings"

Many people may not yet know the reality of this organisation, but the assessments are very clear - this is not a non-violent organisation. UK national security and public safety must always be our top priority."

Shadow home secretary Chris Philp said protesters supporting Palestine Action "should feel the full force of the law.

Chief executive of Amnesty International, Sacha Deshmukh, said people outraged by the "ongoing genocide" in Gaza were "entitled under international human rights law to express their horror'

"The protesters in Parliament Square were not inciting violence and it is entirely disproportionate to the point of absurdity to be treating them as terrorists," he said.

"We have long criticised UK terrorism law for being excessively broad and vaguely worded and a threat to freedom of expression. These arrests demonstrate that our concerns were justified."

Security expert Lizzie Dearden told the BBC that the laws protesters were arrested under "were not designed for a the protesters were arrested under "were not designed for a group of this nature or a group of this size".

"When (the Terrorism Act) was drafted in the late Nineties, the kind of terrorist group that was really being envisaged were groups like the IRA, al-Qaeda, armed militant groups that were operating often abroad.


"So the law is being applied in a completely new way."

Organisers Defend Our Juries claimed there were more than 1,000 "sign-holders" at the protest - and a large number had not been arrested.

Responding, the Met Police said: "That claim simply isn't

Defend our Juries said the turnout "shows how repulsed and ashamed people are about our government's ongoing complicity in a livestreamed genocide".

It added that "Palestine Action and people holding cardboard signs present no danger to the public at large".



Trump Asks Supreme Court To Limit Passport, Sex Marker Choice For Trans And Nonbinary Americans

he Trump administration ▲ asked the Supreme Court to let it limit passport sex markers for transgender and nonbinary individuals, its latest effort to get the justices to intervene in a fight over restrictive policies targeting LGBTQ+Americans.

Just after taking office in January, President Donald Trump issued an executive order that said it's the policy of the federal government to recognize only two sexes and that those sexes "are not changeable and are grounded in fundamental and incontrovertible reality.

The State Department later suspended its processing of passport applications seeking the gendermarker of "X."

The move reversed changes made during the Biden administration that were meant to accommodate non-binary, intersex and gender nonconforming persons. Beginning in April 2022, Americans had been able to select X as their gender

Lawsuits quickly ensued, and earlier this year, a federal judge in Massachusetts blocked the government from enforcing the policy on a

nationwide basis via a class-action lawsuit.

Private citizens cannot force the government to use inaccurate sex designations on identification documents that fail to reflect the person's biological sex especially not on identification documents that are government property and an exercise of the President's constitutional and statutory power to communicate with foreign governments," Solicitor General D. John Sauer wrote in the emergency appeal to the high court.

In her ruling, US District Judge Julia Kobick, a Biden nominee, ruled that the policy on its face classified 'applicants on the basis of sex" and therefore warranted higher judicial scrutiny.

Noting that passports are often used for nontravel purposes, like renting a car or opening a bank account, the judge said that absent a ruling halting the policy, individuals who would be affected by it would experience "irreparable experience "irreparable harm ... from their inability to use their passports anywhere without outing themselves."

Those individuals, Kobick explained, are

likely to face a heightened risk of "anxiety, psychological distress, discrimination, harassment, or violence any time they use their passports, not simply because they face these risks when using their passports for international

A federal appeals court in Boston earlier this month denied the administration's request to block that order. Though it wasn't central to its decision, the court said that the government had failed "to engage meaningfully" with the lower court's claims that the policy might run afoul of the Constitution's Equal Protection Clause.

Sauer argued on Friday that lower courts erred when it scrutinized the policy under a heightened level of judicial review, and said the rulings blocking the policy conflict with a major Supreme Court ruling issued in June that bolstered efforts by conservative state lawmakers to pass and preserve divisive laws targeting transgender Americans

That 6-3 ruling from the court, he wrote, "makes clear that the challenged policy does no discriminate based on sex. does not

Trump issues An Ultimatum For NATO Countries On Russia Sanctions

resident Donald Trump issued an ultimatum to NATO allies in a letter, saying the US will issue "major" sanctions on Russia only when they agree to do the same and stop buying oil from Russia

Meeting Trump's demands would mark a major shift among the alliance, and there are major questions as to whether there would be collective interest in taking these steps.

"I am ready to do major Sanctions on Russia when all NATO Nations have agreed, and started, to do the same thing, and when all NATO Nations STOP BUYING OIL FROM RUSSIA," he said in a post to social media, quoting what he said was a letter sent

social media, quoting what he said was a letter sent to his NATO/Counterparts.

He continued, "As you know, NATO/S commitment to WIN has been far less than 100%, and the purchase of Russian Oil, by some, has been shocking! It greatly weakens your negotiating position, and bargaining power, over Russia. Anyway, I am bargaining power, over Russia. Anyway, I am bargaining power are. Just say when?"

The president also called on NATO countries to ignificantly ramp up tariffs on China in a show of

"I believe that this, plus NATO, as a group, placing 50% to 100% TARIFFS ON CHINA, to be fully withdrawn after the WAR with Russia and Ukraine is ended, will also be of great help in ENDING this deadly, but RIDICULOUS, WAR," he

Trump added that Russia's war in Ukraine would end "quickly" if those steps were taken.

CNN has reported that the European Union imposed a ban on maritime Russian oil imports and refined oil products like diesel, but many countries continue to import Russian fossil fuels and liquefied natural gas.

The president has repeatedly previewed the possibility of additional sanctions on Russia, telling Fox News' "Fox & Friends" on Friday he's considering "hitting very hard with sanctions to banks and having to do with oil and tariffs also."

He has already doubled tariffs to 50% on India which purchases oil from Russia, and acknowledged the move "caused a rift" with the country. India has argued that it's being unfairly targeted with the tariff increase, calling it "unjustified" given that other nations also do businesswith Moscow.

It remains unclear whether NATO countries will take these steps, which would mark a dramatic departure from their existing tariff policies.

Earlier when the president spoke with a European delegation from the EU, he pushed them to put 50-100% tariffs on both China and India, according to people familiar with the conversation. But notably, Trump's missive to his NATO counterparts on did not mention India. The EU is in final stages of negotiating a trade deal with India, so it was unlikely they would go along with that

By issuing his Russian oil ultimatum to NATO instead of the EU, Trump is including Turkey, which is the third largest purchaser of Russian oil after China and India, in those demands. The EU has largely cut off oil purchases, with exceptions for Hungary and Slovakia, but Turkey is still a customer, underscoring the steep demands.

Momentum to end the war around Trump's August 15 meeting with Russian President Vladimir Putin in Alaska has largely stalled and Trump's latest demands risk prolonging the conflict even further. Time is a valuable commodity for Putin, giving Russia the ability to make more gains on the battlefield and shore up control over occupied areas.

inaugurated
Africa's largest hydroelectric dam a project that will provide energy to millions of Ethiopians while deepening a rift with downstream Egypt that has unsettled the region.

Ethiopia, the continent's second most populous nation with a population of 120 million, sees the \$5 billion Grand Ethiopian Renaissance Dam (GERD) on a tributary of the Nile as central to its economic ambitions.

The dam's output has

gradually increased since the first turbine was turned on in 2022, and it reached its maximum 5,150 MW of power on Tuesday. That puts it among the 20 . biggest hydroelectric dams in the world, at about onequarter of the capacity of China's Three Gorges

At a ceremony at the site in Guba, an Ethiopian fighter jet flew low over the mist from the dam's white waters, which plunge 170 meters (558 feet).

Beneath the canopy of giant Ethiopian flag, Prime Minister Abiv

Ahmed addressed a crowd of dignitaries including the presidents of Somalia. Djibouti and Kenya. "To our (Sudanese and

Egyptian) brothers; Ethiopia built the dam to prosper, to electrify the entire region and to change the history of black people," Abiy said. "It is absolutely not to harm its brothers.

Abiv has said the dam will improve access to electricity for the almost half the population who had none as recently as 2022, and export the surplus to the region.



Amos Tu

mos Olatubosun Tutuola Odegbami was born on June 20, 1920, in Wasinmi, a village just a few miles outside of Abeokuta, Nigeria, where his parents Charles Tutuola Odegbami and Esther Aina Odegbami, who were Yoruba Christian cocoa armers, lived.

Amos was the voungest son his father; his mother was his ather's third wife When Amos as seven years old, in 1927, he ecame a servant to F. O. Monu, in Igbo man, who sent him to the alvation Army primary school in lieu of wages. At age 12, he attended the Anglican Central chool in Abeokuta. His brief education was limited to ears (from 1934 to 1939). When is father died in 1939, Tutuola left school to train as a blacksmith, the trade he practised from 1942 to 1945 for the Royal Air Force in Nigeria during WWII.

He subsequently tried a number of other vocations, ncluding selling bread and cting as messenger for the

Vigerian Department of Labour.
In 1947, he married Victoria Alake, with whom he had four ons and four daughters; he would also marry 3 other wives. He was the uncle of the Nigerian footballers Segun Odegbami and Wole Odegbami

Despite his short formal education, Tutuola wrote his novels in English. In 1956, after he had written his first three ooks and become internationally famous, he joined the Nigerian Broadcasting Corporation in Ibadan, Western Nigeria as a storekeeper. Tutuola also became one of the founders of he Mbari Club, the writers' and publishers' organization. In 1979, he held a visiting research fellowship at the University of Ife (now Obafemi Awolowo University) at Ile-Ife, Nigeria, and in 1983 he was an associate of the International Writing Program at the University of Iowa. In retirement he divided his time between residences Ibadan and Ago-Odo

Tutuola's most famous novel, The Palm-Wine Drinkard and his Dead Palm-Wine Tapster in the Deads' Town was first published in 1952 in London by Faber and Faber, then translated and published in Paris as L'Ivrogne dans la brousse by Raymond Queneau in 1953

Tutuola died at the age of 76 8 June 1997 hypertension and diabetes.

Govt Moves Against Fake Degrees In Nigeria

The Federal Government has intensified its crackdown on certificate racketeering and academic fraud, directing the compulsory enforcement of a new credential verification system across the country from October 6, 2025.

The directive, contained in a service-wide circular signed by the Secretary to the Government of the Federation (SGF). Senator George Akume, mandates all Ministries, Departments and Agencies (MDAs), as well as public and private tertiary institutions, to adopt structured academic checks under the National Policy for the Nigeria Education Repository and Databank (NERD).

Under the scheme, both existing and prospective employees must obtain clearance through the National Credential Verification Service (NCVS) before their The directive, contained in

(NCVS) before their appointments can be confirmed. Each verified certificate or diploma will be issued a National Credential

Number (NCN) and a set of security codes, making every qualification traceable and instantly verifiable.

The SGF stressed that the reform departs from past ad-hoc measures by establishing a nationwide quality assurance mechanism that operates independently of any single institution. The policy draws its legal backing from Section 10(1) of the Education (National Minimum Standards and Establishment of Institutions) Act 1985.

The NCVS was formally launched in March 2025 by the Minister of Education, Dr. Tunji Alausa, following approval by the Federal Executive Council (FEC). At the launch, Alausa described the scheme as a decisive step to curb fake degrees, forged honours, and diploma mill operations that have undermined the integrity of Nijegria's education system. of Nigeria's education system.

Confirming the readiness of the system, Ms. Haula Galadima, Executive Director of Communication and Cybersecurity for NERD, said all services are now fully operational. She urged MDAs,

schools, and private employers to enrol their NERD Focal Persons and Records Officers via the official onboarding portal

"NERD is a federation initiative and the national initiative and the national standard for higher education digitisation. It is designed to protect national security, safeguard education integrity, and boost the global competitiveness of Nigeria's academic system," Galadima exid.

She explained that NERD manages the National Student Number (NSN), National Credential Number (NCN), and National Document Number (NDN), which Number (NDN), which together ensure that every legitimate certificate or award is digitally identifiable. These records will also populate a National Database of Resource Persons, enabling instant verification of academic verification of academic

According to her, fake degrees thrive because verification processes are often cumbersome and open to compromise. The new platform

provides a federated one-stop digital system linking digital system linking decentralised institutional databases while preserving their autonomy.

The NERD Governing

Council, chaired by the Minister of Education, includes key regulators and stakeholders such as the National Universities Commission (NUC), National Board for Technical Education (NBTE), National Commission for Colleges of Education (NCCE), the National Library, the Committee of Vice-Chancellors, the Committee of Rectors, the Committee of Provosts, and the Nigeria Data Protection Commission.

Galadima emphasised that the reform is a collective effort, jointly owned by all tertiary institutions and regulatory

Gates Foundation, Indian Firm To Roll Out Affordable HIV Prevention Injection

he Bill & Melinda Gates Foundation has partnered with Indian pharmaceutical company Cipla Ltd. to produce a low-cost, longacting injectable drug designed to prevent HIV infection, in a move described as a major breakthrough for global public health.

The injection, which costs around \$40 per dose and is administered twice yearly, offers a more convenient and reliable alternative to daily oral preexposure prophylaxis (PrEP) pills. Medical experts say this innovation could dramatically cut particularly in Africa, where the burden of the virus remains disproportionately high.

Under the collaboration, Cipla will manufacture the drug at scale while the Gates Foundation provides funding support and technical expertise to ensure affordability and widespread access. especially in low- and middle-income countries.

Health advocates note that adherence to daily HIV-prevention pills has been a challenge for many at-risk populations. The injectable shot, by requiring issues and could become a game-changer in HIV prevention strategies.

A statement from the Gates Foundation said the initiative reflects its broader commitment to expanding access to life-saving medicines and reducing health inequities. "Ensuring that cost is not a barrier is at the heart of this partnership. The twice-yearly injectable will make prevention easier, more discreet, and more effective for millions of people who need it," the foundation noted.

Global health experts have hailed the move, but only two doses a year, stressed the need for strong (WHO).

down new HIV infections, addresses compliance distribution frameworks, education, and awareness campaigns to ensure that communities at high risk of HIV transmission fully embrace the innovation.

The injectable prevention therapy is currently undergoing regulatory approvals in several countries, with pilot rollouts expected in sub-Saharan Africa and parts of Asia within the next year.

If widely adopted, the breakthrough could accelerate the global target of ending HIV/AIDS as a public health threat by 2030, according to the World Health Organization
