NANS To FG: Protect Dangote **Refinery from Sabotage Threats**

Nigerian Students (NANS), has called on the Federal Government to safeguard the Dangote Refinery and its facilities from sabotage by individuals and groups allegedly opposed to the company's operations in the oil and gas sector.

In a statement issued on Sunday, NANS, President, Usman Adamu Nagwaza, warned that ongoing tensions between the Dangote Refinery and the Nigeria Union of Petroleum and Natural Gas Workers (NUPENG) could trigger a return to fuel scarcity, with dire consequences for the economy.

"If the feud persists, we foresee a likelihood of returning to the days of fuel scarcity. The negative impact on the economy and its injurious consequences are not farfetched," Nagwaza said.

He cautioned against possible attacks on the refinery's newly acquired

From Sophina Ovuike Compressed Natural Gas The National (CNG)-powered fuel Association of distribution trucks, citing security reports that alleged plots by oil cartels to destroy the assets.

"Any attack on them is without question, an attack on the future of our nation," he stressed, urging the National Security Adviser and other security agencies to act decisively.

Nagwaza also reiterated the importance of freedom of association. insisting that no individual or group should be coerced into membership of any union. He advised NUPENG to embrace dialogue and avoid being used by "economic saboteurs."

Highlighting the refinery's role in boosting local fuel production and easing supply pressures, NANS urged the Federal Government to ensure maximum protection for the facility to prevent disruptions that could plunge the nation back into scarcity.

Abia Assembly's Only APC Member Joins Labour Party

n a dramatic political realignment, Hon. Barrister Anderson Kelechi Akaliro, the sole All Progressives Congress (APC) lawmaker in the Abia State House Assembly, has defected to the Labour Party.

Akaliro, who represents the Ohuhu/Umuahia North State Constituency, announced his exit from the APC in a resignation letter to the party chairman in Umuahia North. He cited internal rancour, marginalisation, and repeated suspensions as reasons for his decision.

"The atmosphere within the party has become increasingly hostile and toxic. My decision to leave is not taken lightly, but it has

continued effective representation of my constituents," the legislator stated.

His defection leaves the APC without a single seat in the 24-member Abia Assembly, further weakening the party's become necessary for the presence in a state where

politics has largely been dominated by the Labour Party (LP) and the People's Democratic Party (PDP).

Political analysts describe the move as both symbolic and strategic, pointing to the Labour constituency Party's rising influence in Abia State.

Otti Confirms Resumption Date for 5,394 Teachers, Inspects Road Project

bia State Governor, Dr. Alex Otti, OFR, has announced that the 5,394 newly recruited teachers in the state will officially resume duties on September 22, coinciding with the reopening of schools for the new academic term.

Governor Otti made the disclosure recently during an unscheduled worship service at Salvation Ministries, Aba. He emphasized that the recruitment process was conducted transparently, based strictly on merit.

"In our recruitment, we hired 5.394 teachers, and they

will all resume on the 22nd of this month. There was no Governor's list, no Deputy Governor's list, no Senator's list. Everything was transparently - applicatio n, test, interview, and selection," he told the congregation, to resounding applause.

The Governor stressed that merit-based appointments would remain the hallmark of his administration, noting that it would be unfair to place unqualified individuals above deserving candidates.

Dr. Ogbonnaya Onu Polytechnic **Ends Statements Of Result. Adopts Instant Certificate Issuance**

he Rector of Dr. Ogbonnaya Onu Polytechnic, Aba, Dr. Christopher Okoro, has introduced a landmark reform in the institution's graduation process by abolishing the issuance of statements of results and replacing them with immediate certificate issuance.

Speaking during a live programme on Don 103.7 FM, Umuahia, Dr. Okoro said the initiative eliminates the stress and financial burden students previously faced in returning to collect their certificates, a system he described as outdated and inconsistent with global best practices.

He disclosed that since assuming office, his administration has signed and issued over 15,000certificates, averaging about 115 certificates daily

The Rector further noted that while the reform has been widely welcomed by students and parents, it has disappointed individuals who exploited delays in the old system, describing them as "street urchins' who profited at the expense of graduates.

Dr. Okoro emphasized that the new process underscores his administration's commitment to transparency, efficiency, and student-friendly practices designed to reposition the Polytechnic for excellence.



Relief To Households As Food Prices Drop In Rivers Market

fter months of rising costs, residents of ⊾Port Harcourt are finally seeing relief as prices of staple foods fall across major markets. A market survey conducted at Mile 1, Mile 3, Slaughter, Crick Road, and Rumuokoro revealed significant reductions in rice, beans, garri, and other essentials

Traders attributed the decline to improved supply chains and fresh local harvests. A 50kg bag of foreign rice, previously sold for N94,000, now costs N80,000, while local rice has dropped from N64,000 to N50,000. Similarly, beans prices have fallen sharply-from N150,000 to N105,000 per bag-while garri now goes for N55,000-N60,000, down from

At Mile 3 Market, trader Mrs. Elizabeth Ukaegbu confirmed the reductions: "Company rice that was N95,000 is now N80,000. Local rice has dropped from N65,000 to N50,000. Iron white beans that sold for N150,000 is now N105,000. Even brown beans, once N200,000, is now N110,000."

Other staples also recorded declines. A bag of crayfish fell from N150,000 to N120,000, while onions dropped from N70,000-N50,000 to N30,000-N25,000. At Rumuokoro Market, palm oil prices slid from N65,000 to N60,000 per container, and groundnut oil fell from N70,000 to N58,000.

Consumers welcomed the Nwankwo, a resident, said: in Port Harcourt markets.

"Last month, I couldn't afford beans because of the high price. Now, I can at least buy some for my family. I just pray it doesn't rise again."

Market analyst Dr. Samuel Okafor of the University of Port Harcourt explained that the decline is seasonal. "What we see now is largely due to the harvest period, especially for rice, beans, and garri. However, unless government addresses inflation, transport costs, and forex instability, the reductions may not last," he warned.

He stressed that long-term stability would require agriculture, storage, and rural infrastructure.

For now, however, traders and consumers alike are breathing a sigh of relief as change. Mrs. Florence food becomes more affordable



Aba Recovers As Fuel Supply Stabilizes After NUPENG Strike

ormalcy is returning to Aba, Abia State, following the suspension of the nationwide strike by the Nigeria Union of Petroleum and Natural Gas Workers (NUPENG), which had triggered days of acute fuel scarcity.

During the strike, the city experienced skyrocketing pump prices, long queues at filling stations, and severe strain on businesses and transportation.

Mrs. Joy Chimezie, a trader who shuttles between

7Up and New Market, said the crisis took a heavy toll on small businesses. "The petrol scarcity affected everything. We paid more to move goods, and customers could not afford our prices. Now that the strike is over, things are easier for traders like me," she noted.

Transport workers also welcomed the relief. Mr. Dickson Uka, a tricycle operator, said the scarcity nearly crippled his work. "No petrol means no income. Even when we got fuel, it was too costly, and we had to hike fares. The suspension has been a huge relief," he said.

Business owners were not spared. David, who operates a cybercafé at Obikabia Junction, explained that his services almost ground to a halt. "I run on petrol most of the time. Without it, I could barely function. Now, I can operate normally and keep prices affordable," he said.

With fuel supply easing, transport fares have dropped, businesses are bouncing back, and residents report a gradual return of economic stability. However, many remain cautious about the possibility of future disruptions.

Drug Abuse Crisis Worries Rivers Communities

rug abuse is fast becoming a public health and security crisis in Rivers State, sparking alarm among parents, students, and community leaders over its growing grip on young people.

What was once considered a ringe issue has spread into schools, homes, and neighborhoods across Port Harcourt, with visible consequences on education, family life, and public safety.

Mrs. Grace Okoro, a parent in Diobu, described the trend as heartbreaking. "We are losing our children to these things. Some parents don't even know their children are already into it because they hide it so well. Once they start, it affects their education and behavior stability would require at home. Parents must wake up greater investment in beforeitistoolate," shelamented.

Students also admit the lure of narcotics. Chinedu Eze, a Sociology undergraduate at the University of Port Harcourt, said many succumb to peer pressure and easy access. Sometimes it starts as an experiment. Before you know it, the person is addicted. Some think it helps them study or makes them bold, but in the end, it damages them," he explained.

Community leaders are urging collective responsibility. Chief Baridam Nwinee of Borokiri said traditional institutions and residents must work with authorities. cannot leave this fight to NDLEA alone. Communities must expose the dealers and users instead of shielding them. If we keep quiet, tomorrow our community will pay the price," he warned.

Security experts link rising crime, cultism, and robbery in Rivers to drug use. The National Drug Law Enforcement Agency (NDLEA) confirmed the spread, describing it as a ticking time bomb. Assistant Commander of Narcotics, James Awoji, identified Awoji, Borokiri-popularly called Abuja Down – as a hotspot.

"They do drugs on the streets and even in their houses. Most users are youths, including students. Men often introduce females, and when women get involved, they consume more because of anxiety," Awoji said.

He also noted traffickers' new tactics, such as using dispatch riders and online platforms. "Some drugs are disguised as food, even wrapped like shawarma. Dispatch riders must be vigilant and not accept suspicious packages," he cautioned.

While assuring that surveillance and enforcement are ongoing, Awoji stressed that the NDLEA cannot win the fight alone. "Parents must talk to their children, schools and communities must act, and religious leaders must speak out. Everyone's hands must be on deck," he said.

Analysts warn that without urgent action, the menace could escalate into a nationwide emergency with dire consequences for public health, education, and security.

Rivers Begins Transition To Democratic Governance **As Emergency Rule Ends**

he Rivers State Government has announced the commencement of a transition from emergency rule to democratic governance, nearly six months after a state of emergency was declared.

In a statement issued by the Secretary to the State Government (SSG), Prof. Ibibia Lucky Worika, made available to newsmen, stakeholders were invited to an interdenominational church thanksgiving service to mark the beginning of the transition process.

The service is scheduled to hold on Sunday, September 14, at the Ecumenical Centre, Abonima Wharf Road, Port Harcourt, by 10:00 a.m., with guests expected to be seated by 9:30 a.m.

Those invited include permanent secretaries, local government chairmen, heads of security and paramilitary agencies, traditional rulers, chairmen and members of boards and governing councils, as well as captains of industry. The state's Administrator, Vice Admiral Ibok-Ete Ibas (Rtd), will serve as Special Guest of Honour.

The move comes after President Bola Tinubu, in a nationwide broadcast on March 18, declared a state of emergency in Rivers State at the height of a political crisis between Governor Siminalayi Fubara and the Minister Of The Federal Capital Territory, Nyesom Wike.

At the time, Tinubu accused Governor Fubara of ordering the demolition of the State House of Assembly and subsequently suspended him, along with his deputy, Ngozi Odu, for six months. All elected members of the Rivers State House of Assembly were also suspended, with Vice Admiral Ibas appointed as sole administrator.

Tensions in the state eased in June following a reconciliation between Wike and Fubara during a meeting with President Tinubu in Abuja. Since then, Wike has regained firm control of the state's political structure, further strengthened by the recent local government elections in which his allies swept all available seats.

With the expiration of the emergency rule, the Rivers State Government says the thanksgiving service is part of activities to formally usher in the return of democratic governance.

Rising Waters, Failing Systems

very year, Nigeria is confronted with the same grim story: heavy rains, swelling rivers, and devastated communities. Flooding has become a recurring nightmare, and 2025 has been no exception. Entire communities in Niger, Kogi, Anambra, and parts of the North have been submerged, families displaced, farmlands destroyed, and critical infrastructure damaged beyond repair. Sadly, this tragedy has now become so routine that we seem almost resigned to it—yet it is precisely this complacency that makes each disaster more painful than the last.

The human and economic toll of these floods is staggering. Farmers who invested their sweat and savings have seen their crops drown, aggravating Nigeria's already fragile food security. Thousands of households have been displaced, with families forced into makeshift shelters where poor hygiene often breeds disease. Children have been pushed out of schools as classrooms double as relief camps, while vital roads and bridges have been cut off, paralyzing trade and transport. Hospitals, already struggling with limited resources, have been overwhelmed. Beyond the immediate suffering, the ripple effects – rising poverty, hunger, and declining productivity – will haunt the nation long after the floodwaters recede.

We must admit a bitter truth: flooding in Nigeria is no longer merely an act of nature. It is, in many ways, a reflection of our collective failure as a people and as a government. Meteorological Agencies regularly issue forecasts, and experts raise alarms, yet year after year we fail to act in advance. Instead of embracing proactive solutions, we respond with sympathy visits, ad-hoc relief materials, and political promises. This reactive cycle has left us unprepared, vulnerable, and perpetually overwhelmed.

We must change course. What Nigeria needs is a comprehensive, dynamic, and coordinated national flood management strategy. This begins with investment in resilient infrastructure—dams, levees, drainage systems, and embankments capable of controlling excess water. Our rivers must be dredged regularly, while drainage channels in urban centers

We cannot afford to tolerate this recklessness any longer. Government Agencies must ensure that zoning laws are respected, and violators penalized. When we look the other way, we invite disaster.

Environmental stewardship is another critical pillar of flood mitigation. Deforestation has stripped our land of natural buffers that absorb rainfall, leaving communities exposed. We must commit to aggressive tree planting and reforestation programs while also addressing the menace of indiscriminate waste disposal. Every plastic bag or refuse dump that blocks a drainage system increases the likelihood of flooding. This is why we must embrace public enlightenment campaigns that stress communal responsibility. Each of us has a role to play in protecting our environment.

At the same time, early warning systems must be strengthened. Technology exists to predict rainfall intensity and river overflow with accuracy, but information is only useful if it reaches vulnerable communities in time. We must ensure that citizens are not only warned but also provided with evacuation plans, designated shelters, and adequate relief facilities. Preparation saves lives.

Climate change has worsened the scale and unpredictability of rainfall, and Nigeria cannot afford to be caught unprepared. While the world debates climate policies, we must act locally. A national emergency framework that brings together federal, state, and local governments, alongside civil society, the private sector, and international partners, is urgently required. Flood management is too complex to be left to chance; it requires coordination, planning, and sustained investment.

We must no longer treat flooding as a seasonal inconvenience. It is a national emergency that demands a dynamic, proactive approach. The consequences of inaction are too grave: destroyed homes, ruined farms, wasted investments, and shattered hopes. As a people, we must resolve to now, not tomorrow, not when the next disaster strikes, but today.

If we fail to take bold, coordinated steps, the rising waters will continue to wash away not only our homes and farmlands but also our collective dreams of security, prosperity, and sustainable development.

Dear Editor,

he recent announcement that Nigeria's inflation has eased for the fifth consecutive month, dropping to 20.12% in August from 21.88% in July, no doubt appears encouraging at first glance. On paper, it suggests that government efforts to stabilize the economy are beginning to bear fruit. However, for ordinary Nigerians, the reality remains unchanged: prices of essential goods are still painfully high, and the cost of living continues to squeeze households to breaking point.

While it is true that food inflation is no longer climbing as steeply, the slowdown offers little comfort to families struggling to buy rice, bread, beans, or cooking oil. The average market visit today leaves shoppers spending more but taking home less. Workers' salaries remain stagnant, purchasing power is weak, and many households have been forced into desperate adjustments—reducing meals, cutting back on education costs, or abandoning basic healthcare. For the poor, inflation is not a statistic but a daily battle for survival.

This disconnect between national figures and lived experience highlights the urgent need for policies that address root causes rather than symptoms. The government must step up efforts to support local agriculture, as food production remains key to stabilizing prices. Farmers should be empowered with inputs, affordable credit, and access to modern storage and irrigation facilities. Improved transportation and market linkages are equally vital to ensure food gets to consumers without excessive middlemen costs.

Furthermore, attention must be given to energy and fuel costs, which directly influence the price of goods and services. Stabilizing these sectors would help reduce the ripple effect of rising expenses on households. Equally important is a review of wages and salaries. It is unrealistic to expect workers to cope when incomes have remained stagnant in the face of spiraling living costs.

Inflation easing is good news, but it must translate into real relief for ordinary citizens. Until Nigerians can afford basic necessities without anguish, such statistics will remain hollow victories. The ultimate measure of economic progress is not in percentages but in the dignity and well-being of citizens.

Abia in Safe Hands Under Gov Otti - Nwokochah

bia State, 34 years of existence and two years of Governor Alex Chioma Otti's reform-driven leadership have been an issue of public interest as attention shifts to the tier of government closest to the people — the local government system. At the heart of this structure lies the Local Government Service Commission (LGSC) an institution that Commission (LGSC), an institution that shapes the efficiency, professionalism, and delivery of services across the 17 Local Government Areas of the state.

Steering this critical engine of grassroots governance is Elder Nwokochah James Ebere (JP), Chairman of the Commission. Known for his calm but firm administrative style, Elder Nwokochah with his team, has brought renewed energy into repositioning the LGSC as a vehicle for accountability, capacity development, and staff welfare. The Commission aligns seamlessly with Governor Otti's "Rebuild Abia" agenda, ensuring that governance is not only seen at the top but also felt at the grassroots. In this exclusive interview with the Editor, *National* exclusive interview with the Editor, National Ambassador Newspapers; Deacon Chukwuemeka Egejuru, Elder Nwokochah speaks on the progress so far, the challenges of grassroots administration, and his vision for a revitalized local government system that truly serves the people of Abia State.

Abia State is 34 years old. Looking back, how would you assess the growth and challenges of the local government system since the creation of the state in 1991?

The local government system in Abia has The local government system in Abia has come a long way since 1991. From very modest beginnings, we have seen gradual improvements in infrastructure, human capacity, and service delivery at the grassroots. However, challenges have persisted particularly issues of inadequate funding, manpower gaps, and sometimes politicization of the system. What is most encouraging is that each administration has contributed in its own way, and today, under the watch of Governor Alex Otti, we are experiencing a holistic reform-driven are experiencing a holistic reform-driven push to reposition local governments as true engines of grassroots development.

In what ways has the Local Government Service Commission contributed to the overall development of Abia State?

The Commission is essentially the human resource manager of the third tier of government. Our contribution has been to trained, and properly deployed to serve Abians at the grassroots. Beyond personnel management, we have taken steps to instill professionalism, accountability, and welfare support for staff so that they are motivated to deliver quality services. A well-trained and committed workforce is the foundation of sustainable development, and that is where our impact is most visible. Governor Alex Otti's administration in two years has done so much in this direction and workers should reciprocate with more commitment.

Since the assumption of office by Governor Alex Chioma Otti, two years ago, what significant reforms or changes have been introduced in the local government

Governor Otti's administration has brought unprecedented reforms. First, there brought unprecedented reforms. First, there has been a deliberate emphasis on transparency and accountability ensuring that local government funds are utilized for the people. Second, staff welfare has been prioritized, with prompt payment of salaries and pensions. Third, a strong emphasis is now placed on merit, discipline, and professionalism within the system, recardless of where any worker is coming. regardless of where any worker is coming from in line with the unified system. These reforms are changing the narrative of local government administration in Abia.

How has the Governor's "Rebuild Abia" agenda influenced the operations and priorities of the LGSC?

The "Rebuild Abia" agenda is our guiding compass. It emphasizes rebuilding

institutions, not just infrastructure. At the LGSC, this means building a workforce that is efficient, honest, and people-centered. We are aligning our operations to ensure that the local government system reflects the Governor's vision of service delivery, accountability, and grassroots development.

What specific improvements have you observed in staff welfare, capacity building, and efficiency within the local government service under this administration?

The difference is clear. Staff are now more motivated because they receive their

Gov. Otti's administration has taken a firm stand on ghost workers. The Commission has put in place a panel to fish out ghost workers and defaulters of biometric offences from the system. Investigation is ongoing.

We have conducted verification exercises to clean up the payroll. Redundancy is being managed through redeployment and retraining, while manpower gaps are gradually being handled. Capacity Building and Human Capital Development is indeed the Commission's watch word.

What training and retraining opportunities are being provided for local

salaries and pensions promptly.

Also as I speak, the Commission, in line with Gov. Otti's administration vision, have started rolling out structured training programmes, some in collaboration with external partners. There is a renewed culture of discipline and performance monitoring, which is gradually improving service delivery at the grassroots. Local Government Autonomy and Service Delivery

Local governments are often described as the closest tier of government to the people. How is the Commission ensuring that LGAs in Abia truly deliver grassroots governance?

By focusing on manpower and professionalism. We will ensure that qualified staff are recruited once there is a eed for recruitment and deployed where their services are most needed.

There is no doubt that the 17 LG councils are meaningfully being engaged in the transformational agenda of His Excellency, in terms of infrastructure, human capacity development among

What is the Commission doing to strengthen transparency, accountability, and professionalism among local government staff?

We have introduced stricter monitoring and evaluation systems, regular audits of staff performance, and disciplinary measures for misconduct. Equally important, we are rewarding excellence to encourage professionalism. Our goal is to create a culture where public servants see themselves as accountable to the people, by changing their awkward orientation.

How are issues of ghost workers, redundancy, and manpower gaps being addressed?

Government workers to enhance service delivery?

We have reactivated regular training workshops, seminars, and leadership courses for staff at all levels. These cover areas like financial management, ICT skills, and customer service. The idea is to make sure our workforce is continuously updated with modern knowledge and practices in line with Gov Otti's "New Abia" agenda.

How is the Commission integrating technology and digital processes into the operations of local governments in Abia?

Technology is the future, and we are gradually digitizing local government processes. Staff attendance and payroll systems are being digitized to curb fraud. systems are being digitized to curv irauu. We are also exploring e-governance platforms to make services faster, more transparent, and accessible to the public.

Are there deliberate efforts to encourage youth and women participation within the local government workforce?

Absolutely. We are deliberately studying the LG system to ascertain if there is a need to recruit more young people into the service and encouraging gender inclusion. Until the Commission finishes sanitizing the system, we cannot request for the approval for recruitment from His Excellency, Dr. Alex Otti.

Meanwhile, women are now occupying key administrative positions across the LGAs, and we see this as vital for balanced and inclusive governance. Gov. Alex Otti is gender-friendly Governor and we have also aligned to that.

For instance, here in the Commission, we have also keyed into the Gov. Otti's administration inclusive governance as our Permanent Secretary, Director of Finance and the Public Relations Officer, are all women and they are all doing very well.

What are the biggest challenges facing the Local Government Service Commission today, and how are you addressing them?

Funding and infrastructure deficits have been major constraints before now. Resistance to change on the path of the workforce has also been a challenge to the

Gladly enough, our Governor, has taken care of all these sufficiently but like Oliver Twist the Commission still expects

We are also tackling them head-on through prioritization, partnerships, and continuous sensitization of staff through training and retraining workshops

How is the Commission collaborating with other government agencies and stakeholders to achieve its mandate?

Collaboration is at the heart of what we do. We work closely with the Ministry of Local Government, the Office of the Head of Service, training institutes, and even civil society organizations. These partnerships help us broaden our reach, improve capacity building, and enhance service delivery

Looking ahead, what is your vision for the LGSC and the local government system in Abia in the next 5–10 years?

The greatest problem the system will have is if there is lack of sustainability and momentum. The strength of every system lies in the quality of her leadership.

That's why Abians at home and diaspora should pray earnestly for our amiable Governor and pragmatic leader so that God will touch his heart to sustain this divine mandate.

My vision is to build a fully professionalized, technology-driven, and people-oriented local government system. In 5-10 years, I want to see our LGAs function as true engines of grassroots development where citizens can feel the presence of government in their daily lives.

If you were to highlight one key legacy you wish to leave as Chairman of the Commission, what would it be?

A legacy of being proactive, accountable, people-centeredness and professionalism oriented.

Also, I want to be remembered as the Chairman, who repositioned the LGSC into a truly modern, people-focused institution that restored confidence in local government administration.

Finally, what's your overall assessment of Governor Otti? I must sincerely thank God for blessing Abia with a man of vision, integrity, and courage like His Excellency, Dr. Alex Chioma Otti, OFR. He came at a time when the state was in dire need of purposeful leadership and has since demonstrated uncommon commitment to rebuilding Abia on the path of transparency, accountability, and progress.

Governor Otti is not only salvaging the state from years of decay but is also laying solid foundations for sustainable development. His emphasis on prudence in managing resources, prompt payment of workers' salaries and pensions, infrastructural renewal, and institutional reforms are clear testimonies of his resolve to make governance truly serve the people.

FIRS, EFCC Deepen Collaboration To Tackle Tax Evasion, Boost Revenue

he Federal Inland Revenue Service (FIRS) and the Economic and Financial Crimes Commission (EFCC) have reaffirmed their commitment to strengthening collaboration aimed at improving tax compliance and safeguarding Nigeria's public revenue.

The renewed partnership was sealed during a courtesy visit by the FIRS Executive Chairman, Dr. Zacch Adedeji, to the EFCC headquarters in Abuja on Wednesday.

Adedeji credited Nigeria's ability to meet its revenue targets to preventive strategies and robust partnerships with agencies like the EFCC, describing it as a "collective achievement."

In his response, EFCC Chairman, Mr. Ola Olukoyede, assured Dr. Adedeji of the Commission's unwavering collaboration, stressing that both institutions share a common goal of strengthening Nigeria's financial system through accountability and compliance.

The renewed partnership is expected to drive stricter enforcement, discourage tax evasion, and improve revenue mobilisation nationwide.

Nigeria Records N7.46tn Trade Surplus In Q2, Up 44% – NBS

igeria's trade balance improved significantly in the second quarter of 2025, as the country recorded a N7.46 trillion trade surplus, representing a 44.31 per cent increase compared to the first quarter of the year, according to the National Bureau of Statistics (NBS).

In its latest report on foreign trade in goods, the NBS said total merchandise trade stood at #38.04 trillion in Q2 2025. This figure represents a 20.05 per cent increase compared to 31.68 trillion in the corresponding period of 2024, and a 5.59 per cent rise from #36.02 trillion in O1 2025.

Exports remained the main driver of the improved trade position, accounting for 59.81 per cent of total trade with a value of □22.75 trillion. This marked a 28.43 per cent jump from □17.71 trillion in Q2 2024 and a 10.45 per cent increase over #20.60 trillion in the previous quarter.

Crude oil exports continued to dominate, contributing #11.97 trillion or 52.60 per cent of total exports. Non-crude oil exports were valued at □10.78 trillion (47.40 per cent), of which non-oil products such as manufactured goods and agricultural produce contributed #3.05 trillion, equivalent to 13.39 per cent of total exports.

On the other hand, imports accounted for 40.19 per cent of total trade, valued at #15.29 trillion. This represented 9.43 per cent increase

FCT Partners APSON To Strengthen **Paediatric Surgical Care**

he Minister of the Federal Capital Territory (FCT), Chief Nyesom Wike, has pledged the administration's support for the Association of Paediatric Surgeons of Nigeria (APSON) in a bid to strengthen paediatric surgical services across the territory.

Wike, who was represented by the Minister of State for the FCT, Dr. Mariya Mahmud Bunkure, gave the assurance at the opening of APSON's 24th Annual General Meeting and Scientific Conference held in Abuia on Thursday.

In his remarks, Prof. Philip Mshelbwala, chairman of the local organising committee, raised concerns over the glaring shortage of paediatric surgeons in the region. According to him, the FCT and neighbouring Nasarawa State have only 15 paediatric surgeons catering to a population of 4.3 million people more than half of whom are children. He stressed the urgency of bridging this workforce gap to meet rising healthcare needs.

Dr. Bunkure acknowledged the challenges confronting the sector, such as inadequate infrastructure, limited manpower, and high costs of care. She said the FCT administration was committed to expanding access to quality healthcare, strengthening referral systems, and ensuring timely surgical interventions for children in both urban and rural areas.

The Minister commended APSON's role in advancing training, research, and mentorship, and urged stronger collaboration between paediatric surgeons, family physicians, and community health workers to reduce late presentation of surgical cases.

Delivering the keynote address, Dr. Paul Manya Dogo, called for paediatric surgery to be formally prioritised in Nigeria's Health Sector Strategic Blueprint. He argued that such inclusion would not only secure dedicated funding but also guarantee implementation across state and local

On his part, Dr. Chris Isokpunwu, Permanent Secretary, Ministry of Steel Development, who chaired the event, urged APSON to focus on grooming young surgeons while continuing to advocate for better infrastructure and financing to improve paediatric care nationwide.

Prof. Mshelbwala expressed optimism that the conference would foster knowledge sharing and capacity building, ultimately strengthening paediatric surgical services across the country.

The three-day conference brings together experts, policymakers, and stakeholders to deliberate on emerging challenges and opportunities in paediatric surgery.



Rivers State Unveils Flood Control Measures Ahead of Heavy Rains

he Rivers State Government has rolled out a comprehensive flood control plan as the state braces for peak rainfall and the heightened risk of flooding in the coming weeks.

The measures were announced during a stakeholders' meeting in Port Harcourt by a senior official of the Ministry of Environment who said the initiative aims to safeguard lives, property, and livelihoods in communities historically ravaged by seasonal

Key interventions include clearing and expanding drainage channels, constructing additional culverts, and introducing a community-based early warning system to alert residents of impending floods.

"The government is deploying modern flood management strategies to mitigate the risks," said a senior ministry official. 'This is not just an environmental issue but a public safety priority.'

Desilting exercises are already underway in flood-prone local government areas such as Obio/Akpor, Ahoada East, Oyigbo, and Ogba/Egbema/Ndoni. The Ministry is also collaborating with the State Emergency Management Agency (SEMA) to distribute flood response kits, prepare evacuation plans, and intensify sensitization campaigns against indiscriminate waste disposal, which officials say remains a major cause of urban flooding.

Experts have welcomed the initiative but stress the need for sustainable solutions. A hydrologist at the University of Port Harcourt noted that while drainage clearing is useful, "Periodic measures alone are not enough. Rivers State must invest in green infrastructure and modern urban planning to build long-term

Still, skepticism lingers among some residents. "Every year we hear the same promises, but the floods keep coming," lamented Mrs. Stella Owhor, a trader at Rumuokoro market. "We need action, not announcements."

With the Nigerian Meteorological Agency (NiMet) predicting above-average rainfall through October, the government has urged residents in low-lying areas to remain alert and cooperate with local authorities.

The Ministry of Environment has also appealed to residents to avoid dumping waste into drainage channels and to promptly report blocked waterways. Monthly sanitation exercises are being reinforced, with local councils directed to ensure strict compliance.

"Flood control is a shared responsibility," the Ministry said in a statement. "We urge all residents to take preventive steps seriously.

NLC, Labour Party, Others Demand Senate Reinstate Natasha or Risk Nationwide Shutdown

he Labour Party (LP) has called for the immediate reinstatement of Senator Natasha Akpoti-Uduaghan, insisting that her continued suspension violates democratic principles and the rights of her constituents.

LP's National Publicity Secretary, Tony Akeni, in a statement on Saturday in Abuja, condemned the Senate's refusal to comply with a subsisting court order that nullified the six-month suspension of the Kogi lawmaker.

Akeni disclosed that an American

diplomat recently drew attention to a letter written by Gambian lawmaker Fatoumatta Njai, who sharply criticized the Nigerian Senate for defying the judgment delivered on July 4,2025. The diplomat described the Senate's disobedience as "shameful for y o u r c o u n t r y . " Njai, a member of the Pan-Africa Parliament's Gender and Children's Welfare Committee, in her letter dated September 9, urged compliance with the court ruling, stressing: "In law, one must comply first, then challenge." She warned that silencing Akpoti-Uduaghan sends a disturbing signal across West Africa, noting that she represents the aspirations of millions of women and youths. The LP echoed Njai's position and aligned with prominent voices, including former Vice President Yemi Osinbajo and senior lawyers, who have faulted the Senate's stance.

Legal luminaries Femi Falana (SAN)

and Ebun-Olu Adegboruwa (SAN) separately described the Senate's action as contemptuous and vindictive. Falana accused Senate President Godswill Akpabio of treating court verdicts with disdain, while Adegboruwa said the decision was petty and an affront to democracy.

Civil society and labour groups have also rallied behind Akpoti-Uduaghan. Nigeria Labour Congress (NLC) President Joe Ajaero vowed to mobilize workers against what he described as a deliberate attempt to bar her from performing her constitutional duties. Women's rights coalition Womanifesto

similarly demanded her reinstatement.

Akeni urged Senate President Akpabio, House Speaker Tajudeen Abbas, and Justice Minister Lateef Fagbemi to respect the rule of law and restore Akpoti-Uduaghan without further delay, saying, "A word is enough for the wise."

Rabindranath Tagore

abindranath Tagore was born on May 7, was boin on, 1861 in Calcutta, ndia.

He was the son of the eligious reformer Debendranath Tagore, he early began to write verses, and, after incomplete studies n England in the late 1870s, he returned to India. There he published several books of poetry in the 1880s and completed Manasi (1890), a collection that marks the maturing of his genius. It contains some of his bestknown poems, including many in verse forms new to Bengali, as well as some social and political satire that was critical of his fellow Bengalis.

He is widely considered one of India's, and indeed the world's, most significant literary figures. He was a polymath - a poet, novelist, playwright, philosopher, musician, painter, and social eformer. Tagore is particularly renowned for his reshaping of Bengali literature and music, and for nis profound influence on Indian art. He was the first non-European to win the Nobel Prize in Literature (1913).

Beneath The Surface

razil is often described as the world's second-largest African nation, and this is evident everywhere - in the rhythms that move a crowd, in the devotion of Candomblé (a religion with roots in West African Yoruba culture), and in the language that carries West African echoes across the oceans. Yet Brazil also shows how a country can celebrate the symbols of its Black heritage while turning away from the people who keep that heritage alive. The myth of "racial democracy" makes for a beautiful poster; the streets tell a different story. Brazilian society remains shaped by a system of social exclusion, where the darker-skinned segments of the population are controlled through force and systematically marginalized from public life. It is a paradox with familiar contours, and it invites Nigerians to look in a mirror we might prefer to avoid.

Into this landscape stepped Jair Bolsonaro, and with him a promise that the old, punishing certainties could be restored: discipline in the place of debate, loyalty in the place of law, force in the place of reform. This gave him the presidency of Brazil October 2018 election. He preached a politics of the clenched fist-shoot your way through crime, sneer your way past dissent, mock your way past the poor. Evangelical megachurches offered pulpits and media reach, reactionary elites found a champion who would roll back the tide of inclusion, and digital disinformation did the quiet work of turning neighbours into suspects.

But after his presidency and reelection shenanigans, Bolsonaro faces five allegations: attempting a coup, participating in an armed criminal group, attempting to violently dismantle the democratic rule of law, and two charges related to the destruction of state property. It felt, for a while, like a past Brazil had chosen to bury was climbing back upstairs and trying on the keys again. Electoral malfeasance and dogged hold on to power at all costs was demonstrated by Bolsonaro and his supporters. However, something else also happened, something less dramatic yet more consequential: democracy held on to transparency and free and fair election. Institutions remembered their purpose. Courts drew lines Electoral authorities defended the count. Journalists and civic groups kept receipts. Elements of the state refused to be dragooned into overturning results. Democracy bent, which is what democracies do under stress; it did not snap. This resilience, this refusal to be broken, is a beacon of hope for Nigeria and all democracies facing similar challenges.

For Nigeria, the lesson lands with the weight of a warning and the texture of hope. Judicial independence is not an ornament for ceremonial days; it is the oxygen line that keeps constitutional life breathing when the room grows thin. A court that can try the powerful is a shock

absorber against the worst political instincts, but only if its budget cannot be manipulated and its appointments cannot be influenced. We must learn, too, to speak about due process in a language that the street can understand, because accountability without public comprehension curdles into grievance and then into conspiracy. When political losers start to call judges' enemies of the people, what stands between a nation and the cliff is trust, well-earned and plainly explained.

Elections are the other hinge. Confidence in the vote is not a device; it is a chain of events. Technology helps, but the moral force of the results comes from the links surrounding it: transparent tabulation, auditable trails, open data, and independent observers who are not treated as tolerated nuisances. Disputes should be resolved in courts that are fast, credible, and final-so that politics can grieve its losses and move on. The alternative is not only uncertainty; it is the creeping normalisation of threats, the flirtation with soldiers, the quiet logistics of powers with clear sunsets; and oversight that cannot be wished away. Populists ask us to trade law for resolve: the bill always arrives, and it is always expensive.

Civil-military relations deserve candour. Coups in this era rarely kick down doors at dawn; they creep. Statements first, then escorts, then the withholding of logistics, then a hint that someone knows better than the ballot. The line must be bright: soldiers defend the republic; they do not referee its politics. Parliamentary scrutiny, career penalties for anti-constitutional flirtations, civic education inside the ranks-these are the kinds of quiet investments that keep uniforms where they belong when tempers flare outside the barracks.

Legitimacy also lives or dies in the encounter between a citizen and a police officer. Use-of-force policies mean little if not enforced; body-worn cameras without independent oversight are expensive jewellery. Every unlawful killing that passes without consequence empties another cup of trust. Protecting mischief-fuel here, a convoy there, a minority rights and cultural expression

that prevents yesterday's corruption from setting tomorrow's terms. Security cooperation, where sensible, should borrow from best practice in deescalation, not the choreography of militarised crowd control that both our societies must unlearn.

If we need a dashboard for danger at home, it is not hard to assemble. Watch budgets and tenures for signs of an axe hovering over courts and election bodies. Listen for the "stop the count" chant hiding in different words. Track the botnets and WhatsApp chains that turn rumours into rage. Read proposed laws for the quiet ambition to muzzle NGOs and journalists - especially those painted as "foreign-funded," as if patriotism were a matter of bank accounts. Notice when lethal policing is shrugged off as the acceptable price of order. Notice when a religious bloc treats rights as negotiable. And build coalitions that can move when red lines are crossed-bar associations, media, student unions, labour, business - because institutions are only as brave as the people who stand up for them.

In the near term, lock in budgets for courts and the electoral commission by formula rather than favour. Force transparency in political advertising-who paid, how much, to whom-and open election data to the public eye. Establish an independent police oversight authority that not only recommends but also refers cases for prosecution. Over the next few years, scrub party finance with real-time disclosure and hard ceilings. Over the longer arc, complete the arduous work of professionalising police and prosecution; and remember the past by memorialising victims of unlawful state force, so that the future knows where the line is.

Reform becomes a press release if not enforced and measured. Count how long it takes to resolve election disputes and whether orders are enforced. Count the use-of-force incidents and how many lead to prosecution. Count the rights cases that are upheld when it is difficult, not only when it is easy. Numbers do not save democracies, but they help us know if we are saving them.

Brazil teaches a quiet moral. Democracy is not a feeling; it is a habit. When truth-telling, lawful constraint, and equal dignity are practised daily, they develop muscle memory. When they are neglected, strongmen step into the slack and sell us certainty. We do not have to learn these lessons in the heat of our own crisis. We can now build the scaffolding: courts that breathe freely, elections that persuade both winners and losers, security that protects as much as it deters, and a political culture that treats opponents as rivals, not enemies. The mirror across the Atlantic offers both a warning and a promise. What we do with the reflection is still up

at all. Transparency in governance is not just a buzzword; it's a shield against uncertainty and a promise of a fair and just system.

Then there is the fog that settles over any democracy under stress: polarisation that turns rivals into traitors, and disinformation that makes the truth feel like just another opinion. Brazil's lesson is that this is not merely a media problem, but a governance problem. You attack it with rules for transparent political advertising, with consequences for coordinated inauthentic behaviour, with independent fact-checking that has real reach and is not captured by anyone's patronage. And you create habits of cross-party dialogue that feel tedious when times are calm, so they can be lifesaving when tempers rise.

Authoritarian shortcuts will always be marketed as a sign of courage. They are seductive because they are fast, and it is tempting to mistake speed for effectiveness. But the "tough" solutions that work are the dull ones: professional prosecutors with insulation from political pressure; procurement that is transparent rather than opaque; internal controls that actually bite; emergency is not an indulgence; it is fidelity to the promise written on our national paper.

Religion, finally, asks for a wise state. Evangelical blocs are organised, wellfunded, and global. They are not going away, nor should they be treated as intruders in public life. The answer is principled engagement under a secular compact: transparent lobbying rules, curricula grounded in rights and critical thinking, equal protection for those most easily offered up to the fires of a culture war-women, LGBTO citizens, dissenters. When policy is smuggled through pulpits, the constitution shrinks. Civic education is not just a tool; it's a responsibility we all share to ensure a fair and just society.

Beyond the cautions, Brazil also offers a map of opportunity. We can insulate Africa-Brazil ties from ideology and electoral weather. Cultural exchanges that are more than a spectacle-shared archives of Yoruba-Candomblé history, residencies that travel, and festivals that return-can deepen the bridge. Universities can establish joint chairs in public health, agrotech, and energy transition, with scholarships protected from the fluctuations of politics. Trade can grow, anchored by transparency

UEFA CHAMPIONS LEAGUE: Combatants Return to Trenches

he group phase of this season's UEFA Champions League kicks off this midweek with familiar foes going for each other's insular

PSV will open their campaign at home to Union Saint-Gilloise, who are making their first appearance in the competition proper as the champions of the Netherlands and Belgium fight to finish. PSV's last match against a Belgian team came in the 2013/14 third qualifying round, when they defeated Zulte Waregem 2-0 at home and 3-0 away. The Dutch club have lost only one of their five home matches against Belgian teams, winning three.

Union SG have won their two

Union SG have won their two matches away to Dutch teams, both in last season's UEFA Europa League: 1-0 at Twente in the league phase and 2-1 at Ajax in the knockout phase play-off second leg, although they went out 2-3 on aggregate after losing 0-2 at home.

PSV are Dutch champions for the 26th time – and the second season in succession. Peter Bosz's side were 14th in last season's league phase to reach the knockout rounds for the second successive season. They beat Juventus in the knockout play-offs – their first victory in a knockout tie since 2006/07 – but were then defeated by Arsenal in the round of 16.

Union SG were Belgian champions in 2024/25, their 12th title overall and first since 1934/35. This is Union SG's debut in the Champions League proper. They are the eighth Belgian team to appear.

Athletic Club's first UEFA Champions League game in 11 seasons brings Arsenal, semi-finalists in 2024/25, to Bilbao. Athletic have lost only two of their nine home matches against English clubs, although one of those defeats came in the most recent fixture -0-3 against Manchester United in last season's UEFA Europa League semi-final first leg.

Arsenal have won their last five

Arsenal have won their last five games against Spanish teams, including all three in the 2024/25 Champions League: 2-1 at Girona on Matchday 8 and home (3-0) and away (2-1) against holders Real Madrid in the quarter-finals. Wins at Girona and Madrid made it six victories in Arsenal's 20 away fixtures against Spanish sides. They have four victories – and five defeats – in their last nine visits.

Having not featured in the Champions League proper between 2016/17 and 2023/24, Arsenal are making their third successive appearance. The Gunners reached the semi-finals last season – their best run since 2008/09 – before a 1-3 aggregate defeat by eventual champions Paris Saint-Germain.

Real Madrid kick off their latest UEFA Champions League campaign at home against a Marseille side returning to the competition for the first time since 2022/23. Madrid have won all four matches between the teams – all in the group stage. They have lost only one of their 17 home matches against French teams, with six wins in the last seven.

Marseille have won only one of their eight games away to Spanish teams. This is their 12th Champions League campaign, but only their third in the last 12 seasons. They have not progressed to the knockout rounds since reaching the quarter-finals in 2011/1

Madrid are in the Champions League proper for the 30th time, a competition record they share with Barcelona. They last missed out in 1996/97 and have qualified for the knockout rounds in all 29 campaigns. They have won on Matchday 1 in 16 of their last campaigns, losing only two. Madrid have also won 199 matches in the Champions League proper and scored 698 goals - both competition records. They will be looking for their 200th victory when they host the French side

Qarabağ return to the Champions League proper with a trip to competition regulars Benfica, both sides having reached the 2025/26 league phase via the qualifying rounds. This is the teams' first

meeting and Berfica's firet game against a club from

Qarabağ have twice faced Portuguese teams. They lost 0-2 away and 1-6 at home against Sporting CP in the 2018/19 UEFA Europa League group stage, but defeated Braga 6-5 on aggregate in the 2023/24 Europa League knockout play-offs courtesy of a Nariman Akhundzade goal in the final seconds of extra time.

There will be a repeat of the 1997 UEFA Champions League final when Juventus welcome Borussia Dortmund to Turin. This is the first meeting between the teams since the 2014/15 round of 16, when Juventus won 2-1 at home and 3-0 away. Juve have won six of their nine games against Dortmund – although the German side were 3-1 winners in Munich in the 1997 final.

Juventus have lost only two of their last 12 matches against German teams, winning seven, although one of those defeats came in the most recent fixture – 0-1 against Stuttgart on Matchday 3 last season. That ended a five-game winning run against Bundesliga clubs, home and away

Last season's UEFA Europa League winners Tottenham Hotspur will tread tackles with their 2020/21 predecessors Villarreal. This is the first European match between the teams. Tottenham have won only two of their 14 games against Spanish teams – including only one of seven at home. Having been victorious in their first three games against Premier League opponents, Villarreal have won only two of their subsequent 20. They have one victory and six defeats from their ten matches in England.

Olympiacos return to the UEFA Champions League after four seasons away with a home game against competition debutants Pafos. This is the first European fixture between the teams – and Pafos' first against a team



from Greece. Olympiacos have lost only three of their previous 12 matches against Cypriot clubs, although they have drawneach of the last three.

Slavia Praha's first game in the UEFA Champions League proper for six seasons pits them against Bodø/Glimt, who are making their competition debut. This is the teams first meeting and the first Champions League group stage/league phase fixture between teams from Czechia a n d Norway Slavia Praha's only previous match against a Norwegian team was a 2-2 draw at Viking in the 2005/06 UEFA Cup group stage. Bodø/Glimt have played two previous European fixtures against a Czech team, beating Bohemians Praha 3-0 at home and 4-2 away in the 2023/24 UEFA Conference League second

qualifying round. Paris Saint-Germain kick off their UEFA Champions League defence at home to an Atalanta side who are fast becoming competition regulars. The teams' only previous match was a 2-1 Paris victory in the 2019/20 quarterfinals, a one-off fixture in Lisbon in which Marquinhos scored a 90thminute equaliser, Mario Pašalić having given Atalanta a first-half lead. Paris have lost only one of their last 12 have lost only one of their last 12 matches against Italian teams, winning of the last six. Atalanta's 2020 defeat by Paris is their only loss in five matches against French teams, both their previous games in France ending 1-1.

World champions Chelsea return to the scene of their first UEFA Champions League triumph when they travel to Bayern München on Matchday 1. This is a repeat of the 2012 final at the Fußball Arena München, when Chelsea lifted the trophy for the first time with a 4-3 penalty shootent victory after full and extra time had

The teams' most recent encounters were in the 2019/20 round of 16, Bayern winning 3-0 in London and 4-1 in Munich on their way to lifting the trophy. This is the first time the teams have met in the group stage/league phase. Bayern have won eight of their last ten home matches against English teams.

Liverpool and Atlético de Madrid meet again as they kick off their UEFA Champions L e a g u e campaign at A n field. This is the third time the

been paired together in the last six Champions League seasons. Liverpool won the last two games in the 2021/22 group stage, having had their title defence ended by Atlético in the 2 0 1 9 / 2 0 round of 1 6. The Reds have won their last four Champions League group stage/league phase games against Spanish teams, beating Real Madrid and Girona in 2024/25. Atlético have won only one of their last eight Champions League matches against Premier League opponents and have never won a group stage/league phase game against an English team.

Former European champions Ajax and Inter will fight to finish in their opening match in Amsterdam. This is the sides' first meeting since the 2005/06 round of 16, when Inter won 3-2 on aggregate 10, aggregate 11, aggregate 11, aggregate 11, aggregate 12, aggregate 12, aggregate 12, aggregate 12, aggregate 12, aggregate 12, aggregate 13, aggregate 12, aggregate 12,

giving Ajax a 2-0 victory in Rotterdam. Club Brugge's seventh UEFA Champions League campaign in eight seasons begins with a home game against Monaco, who also reached last season's knockout rounds. The teams' last meetings were in the 2018/19 group stage, when a 1-1 draw in Belgium on Matchday 3 was followed by a 4-0 away win for Club Brugge on M a t c h d a y 4.

Their only other encounters were in the 1988/89 European Cup second round when Monaco overturned a 1-0 away defeat with a 6-1 home victory in the record less.

Copenhagen return to the UEFA Champions League with a home game against Bayer Leverkusen. The teams' only previous meeting came in the 20.4/15 play-offs, Leverkusen

winning 3-2 in Denmark and 4-0 in G e r m a n y . Copenhagen recorded their first-ever victory against German opposition in their most recent encounter, 3-1 at Heidenheim in the second leg of last season's UEFA Conference League knockout phase play-offs to complete a 4-3 aggregate triumph.

Manchester City kick off their campaign at home to Italian champions Napoli as Kevin De Bruyne makes a speedy return to the City of Manchester Stadium. The previous four matches between these teams were in the group stage. In 2011/12 a 1-1 draw in Manchester was followed by a 2-1 home win for Napoli. City won both fixtures in 2017/18, 2-1 at home a n d 4 - 2 a w a y . Pep Guardiola's side are hosting an Italian team on Matchday 1 for the second season in succession, having drawn 0-0 against Inter in 2024/25. Napoli are without a win in their ten away matches against English teams.

Eintracht Frankfurt and Galatsaray are both making their returns to the UEFA Champions League as they meet in Germany on M a t c h d a y 1 . The only previous matches between the teams came in the 1992/93 UEFA Cup second round, Galatasaray winning 1-0 on aggregate. That second-leg loss is Frankfurt's only defeat in eight matches against Turkish teams, their most recent encounter a 3-1 win at Beşiktaş on Matchday 2 of the 2024/25 UEFA Europa League.

Sporting CP's bid to reach the UEFA Champions League knockout rounds again kicks off at home to competition debutants Kairat Almaty. This is the teams' first meeting, and Kairat's first game against a Portuguese club. Sporting's only previous matches against a team from Kazakhstan were a 6-4 aggregate defeat of Astana in the 2017/18 UEFA Europa League round of 32

Memories will be stirred of a famous UEFA Champions League hattrick when Newcastle United take on Barcelona at St James' Park on Matchday 1. The teams have met four times in UEFA competition, Barcelona recording three wins to Newcastle's

Faustino Asprilla's hat-trick gave Newcastle a 3-2 home victory on Matchday 1 of the 1997/98 Champions League, Barça winning the return leg 1-0 on Matchday 5. The Spanish team won 3-1 at home and 2-0 away in the 2002/03 second group stage.

Para Badminton Championships: Abia State Hosts Fundraising Dinner

n a landmark move to promote inclusivity in sports, the Abia State Government hosted a high-profile fundraising dinner in support of the upcoming First Abia Para Badminton International Championship and the All-African Para Badminton Championships, scheduled to take place in Umuahia in September and October 2025.

The event, held at the Banquet



Hall of the Governme nt House. brought together dignitaries, stakeholders, and sports enthusiasts for what was described as "a night of purpose, partnership, and mission.

Governor Alex Otti, represented by Deputy Governor Engr. Ikechukwu Emetu, welcomed guests and shared the state's vision for para

Reflecting on Abia's journey in para badminton, Governor Otti noted:

"For nine years, we hosted the Match Pass Para Badminton Championship with limited support and visibility. But under this

He stated that the events would boost the tourism, hospitality, and transport sectors, while also promoting youth engagement and social inclusion.

Ekeoma noted that the championships aim not only to spotlight elite para badminton talent but also to position Abia as the continental hub for inclusive athletic excellence.

The highlight of the evening was the official unveiling of the championship logo and mascots – symbolizing Abia's hospitality, the resilience of para-athletes, and the unifying spirit of the sport.
