On infrastructure, he declared that Abia is witnessing road construction on a scale no one had ever seen before," with new projects not only opening up communities but also driving economic activities in trade. real estate, transportation and agriculture.

Waste management, long a sore point in urban centres like Aba and Umuahia, has also been streamlined, with the Governor boasting that, "our urban centres now rank as some of the cleanest in the region."

"We have made wonders through the graduates we have produced, yet we have been cast aside from the rewards of those wonders," Prof. Onyebinama said.

On their part, Echendu and Ogazie lamented the endless cycle of fruitless negotiations with government and appealed

He also highlighted the importance of cybersecurity, teaching reporters how to safeguard their devices and data through measures such as two-factor authentication and other protective practices.

In his remark, veteran journalist Mr. Chikezie

Emelike underscored the centrality of ethics and professionalism in journalism. Delivering a lecture on "Ethical Journalism and Basic Principles of News Reporting and Feature Writing", Emelike urged journalists to exhibit a high level of ethical standards in the discharge of their duties.

He maintained that truth, fairness, balance, and accuracy remain the cornerstones of responsible journalism, warning that any compromise could undermine public trust in the media. According to him media. According to him, journalists must resist the temptation of sensationalism and ensure that their reports serve the public interest rather than personal or political gains.

Contributing to the training, another veteran journalist, Elder Kalu K. Eziyi, emphasized the relevance of investigative reporting, feature writing, and adherence to media laws in strengthening the practice of journalism.

# **CBN Unveils Bank Customers' Bill of Right**

he Central Bank of Nigeria (CBN), has made available in a pamphlet, the rights and duties of a bank customer. The document which was recently unveiled and made available on the CBN's website aims to acquit and sensitise bank customers with certain rights and duties guaranteed by laws, regulation and convention.

The document which identified the customer as the most important person in the economy noted that every business succeed only when the customer is happy. It further described the customer as a king and that as a king, the customer has many rights as well as duties which he owes himself and the society.

The rights of a bank customer as stated in the document 'Bank Customers Bills of Rights', includes: the Right to be informed, the Right to chose, the Right to safety, the Right to redress, the Right to privacy and confidentiality, the Right to good service, the Right to equality and the Right to free monthly statement of account.

A further breakdown of some of the rights showed that a bank customer has a right of disclosure of information from banks on products and services that banks offer. 'Your banks must explain to your understanding all contractual terms and changes prior to the consummation of any agreement or contract. It amounts to a breach of right your bank fails to provide this information or deliberately misleads you in any way', the document revealed.

Bank customers also have rights to select from a range of product and services made available by the bank at competitive prices. Banks are expected to provide customers with a redress mechanism to express their displeasure or grievance.

The mechanism must be free, accessible, transparent, timely and convenient. You have a right to efficient complaints management system through which you can lodge complaints against your bank. You also have right to be kept abreast of resolution

Under the Right of equality, a bank customer is expected to be treated equally as other customers regardless of differences in financial standing/deposit balance, physical ability, age, gender, ethnicity or creed. It is wrong for a bank to offer preferential treatment to some customers at the expense of other similar kind of

On the other hand, the document also highlighted the duties and responsibilities of a bank customer. These duties include; the duty of knowledge and sharing, the duty of obligation, the duty to protect instruments and information, the duty to factual information and not to mislead the bank, the duty to report suspected fraud or error, the duty of personal safety and safety of assets.

Further explanations on bank customers duties disclosed that customers are duty bound to report promptly any suspected wrong postings into their accounts so that such errors can be corrected immediately.

It is the duty of customers to ensure that cheque books, ATM cards and all information relating to their accounts like PIN, passwords, codes,etc are

As a bank customer, you are also required to repay credit facilities and pay mutually agreed interest on loans and other financial services rendered by your bank as and when due.

The CBN, under Governor Olayemi Cardoso, is committed to ensuring that bank customers have a clear knowledge of their rights and duties to enhance smooth banking operations across the country.

**T**he Abia State Health Insurance Scheme has surpassed its 2025 enrolment target of 100,000 participants, recording 103,076 enrolees as of August

Commissioner for Information, Prince OkeyKanu, made this known recently in Umuahia, while briefing journalists on the outcome of the State Executive Council meeting, presided over by Governor . Alex Otti.

"The current enrollment figure is 103,076 participants. This is more than an eloquent endorsement of the scheme by the sector participants and a display of an abiding trust by the participants that the scheme has the potential to address their most pressing health care needs", Prince Kanu said.

He disclosed that enrolment for the informal sector will start this week, with details to be made available soon.

Prince Kanu also revealed that the Ministry of Health recently created two new departments; the Abia Drug and Medical Commodities Management Agency and the Department of Nutrition, in line with the Federal Government's N-774 Nutrition Initiative.

The Commissioner also revealed that 121 Primary Health Centres (PHCs) have been completed under the Government's Project Ekwueme, with 17 already functional and 33 currently being equipped.

"Thirty-three of the completed PHCs are being equipped currently and ready for functionalisation.

When completed, this will investment in the healthcare bring the total number of functionalised PHCs to 50.

"The next batch to be functionalised thereafter, will be another 50. And this will form part of the third phase of the completed PHCs to be fully equipped for use by members of the public", the Commissioner explained.

Prince Kanu noted that delays in meeting the earlier 100-day completion target were caused by an expanded scope of work, weather conditions and contractor lapses, adding Environment Policy for civil that the revised completion date is now set for October 31, 2025.

The Commissioner cited the growing public confidence in health, safety and well-being the health sector with bed occupancy at ABSUTH which implementation details rose from 50 per cent in August 2024 to 100 per cent in governor. March 2025, as a result of the

These include promoting renewable energy, building c l i m a t e - r e s i l i e n t infrastructure, enhancing environmental governance, and reducing greenhouse gas emissions across sectors.

"The document will not only guide our implementation strategies but also position the state to effectively access climate finance and funding opportunities," she stated.

In their joint remarks, the Permanent Secretaries of the Ministries of Information and Finance, Sir Chris Onwuegbu and Mrs. Agatha Obi Chianakwalam, commended the organizers and emphasised the importance of inclusive participation.

They expressed optimism that the newly developed policy will drive transformative climate action and accelerate the transition to a low-carbon economy.

The permanent secretaries called for stronger collaboration between the public and private sectors, urging increased investments in clean energy, sustainable a griculture, and environmentally responsible infrastructure projects.

He emphasized that the projects will promote local content development, create massive opportunities, and align with the Akwa Ibom State Government's ARISE Agenda.

"The community will be fully digitalized from the gate, with no vehicles allowed except eco-friendly ones. Every student will enjoy access to laptops, steady internet, and worldclass learning facilities,' Dowells stated.

He added that peednet Technology – available only in the United States and Nigeria, with headquarters in Akwa Ibom-will give the state a competitive edge in digital education and attract foreign students.

The press conference was attended by Engr. Frank Oyewale, Dr. Gordons Henry, and Mr. Dominic Okon, among other officials.

ugust 27, 2025, marked the 34th anniversary of the creation of Abia State; a milestone that calls for both joyous celebration and sober reflection. Since its birth in 1991, carved from the old Imo State by General Ibrahim Babangida, Abia has grown from modest beginnings into "God's Own State," defined by resilience, enterprise, and unity.

# Estimated Electricity Bills: Punishment & Hardtimes

Dear Editor,

t is with deep concern that I wish to highlight the growing menace of outrageous estimated electricity bills being imposed on residents across Umuahia and many parts of Nigeria. This exploitative practice has become a cruel punishment on citizens who are already battling for daily survival in the face of inflation, high fuel prices, and rising food costs.

In Umuahia, the situation has reached an unbearable level. Residents of the World Bank Housing Estate, for instance, are being forced to pay between N47,000 and N53,000 every month as electricity; bills that are not only unjustifiable but also grossly out of tune with the poor power supply they receive. How can households that barely enjoy six to eight hours of power daily be compelled to part with such outrageous sums? For context, this amount is more than the entire monthly minimum wage of an average Nigerian worker, leaving families with no option than to either borrow to pay, cut down on basic needs like food and healthcare, or simply endure disconnection.

The irony is painful: citizens are asked to pay luxury-level tariffs for darkness. Businesses that depend on electricity to survive barbers, welders, small retail shops, cold room operators are being crippled by this trend. Some have closed down entirely, while others spend more on fuel for generators, passing the cost to consumers and further worsening inflation. The multiplier effect is devastating: loss of jobs, rising unemployment, and a general decline in quality of life.

This problem persists because the power sector has failed to achieve universal deployment of prepaid meters, despite several government promises and interventions. Estimated billing has become a loophole exploited by electricity distribution companies to milk helpless citizens. Sadly, regulatory bodies like the Nigerian Electricity Regulatory Commission (NERC), who should defend consumers, have not shown enough bite.

What Nigerians demand is simple and just: we should only pay for the power we actually consume. No more, no less. Government must urgently enforce mass metering, sanction erring distribution companies, and introduce stricter consumer protection measures. Citizens cannot continue to pay for inefficiency and systemic failure.

Electricity is not a luxury; it is a necessity for education, health, business, and security. To deny people affordable and fair access electricity through exploitative billing is to deny them the opportunity to live decently and productively. If nothing is done, the anger and frustration of citizens will continue to mount, eroding confidence in governance and in the reforms of the power sector.

It is high time that leaders and regulators listened to the cry of ordinary Nigerians. We are not asking for favours we are only asking for fairness. Let every home and business be issued with a prepaid metered, and let people pay for what they consume, not for what distribution companies imagine. Anything less is daylight robbery.

# From Grassroots to Glory: Abia's Journey in Sports Development In 34 Years

s Abia State celebrates 34 years of existence and reflects on two years of Governor Alex Chioma Otti's administration, attention turns to progress across various sectors, including sports. Fondly known as God's Own State, Abia has produced some of Nigeria's finest athletes and is home to iconic clubs such as Enyimba International FC and Abia Warriors.

At the centre of the state's sports revival is Director of Sports, Abia State Sports Council, Comrade Obioma George, A dedicated administrator and passionate advocate for youth empowerment through athletics, Comrade George has played a pivotal role in grassroots sports development across the 17 Local Government Areas of the state. With a strong background in sports management and community mobilization, he has led initiatives to revitalize facilities, discover young talents, and promote a multi-sport culture.

In this special interview anchored by the Ag. Editor, *National Ambassador Newspaper*, Deacon Chukwuemeka Egejuru, the Director of Sports Abia State, Comrade George speaks on Abia's sporting journey, the impact of Governor Otti's administration, and his vision for the future

#### **Excerpts:**

Abia State is 34 years old. Looking back, how would you describe the journey of sports development since its creation in 1991?

Sports in Abia started on a progressive note. As at 1991, it was sound and vibrant under the leadership of the then Director of Sports, Mr. Anelechi Obonna. From August 1991 to December 2002, Abia dominated weightlifting, athletics, female volleyball, and handball — with the famous Valiant Handball Team ruling both Nigeria and Africa.

After his exit, fortunes dwindled. But under Governor Alex Chioma Otti, that lost glory is being restored. Today, sports in Abia have a clear direction, better infrastructure, renewed hope, and public confidence. Abia is once again recognized as a serious sporting state.

What landmark achievements can you highlight from the Sports Council over the years?

The Valiant Handball Team remains one of our proudest legacies. Abia has also consistently produced world-class champions in weightlifting and powerlifting. Notably, at the Paris Paralympics, Onyinyechi Gift, an Abian, won Nigeria's first gold medal.

Under Governor Otti, new investments in equipment and facilities are opening up fresh opportunities for athletes.

Under Governor Otti's administration, what key improvements have been made?

Several dormant sports have been revived, including volleyball, handball, and athletics. The state has procured modern equipment in weight if ting, powerlifting, basketball, and track events—facilities welacked for decades.

What policies are in

## place to support grassroots sports development?

Physical Education has been reintroduced in schools, ensuring at least two sports periods weekly. The Secondary School Games have been revived, providing a platform for young talents.

In 2023, Abia placed 2nd overall at the National Para Games, a strong sign that grassroots participation is yielding results across all 17 LGAs.

How has funding and infrastructure been addressed?

This is the best funding Abia sports has received since state creation. For the first time in decades, government is giving sports the attention it deserves.

Can you mention athletes positively impacted in the last two years?

Yes. Chinenye Okafor Junior in table tennis represented Nigeria at the Africa Secondary School Games in Algeria. Beyond her, many Abia athletes are winning medals nationally and internationally in table tennis, athletics, parabadminton, cricket, and handball.

Which sport brought Abia its first medal of

Table tennis. At the 56th Molade Okoya Thomas National Championship in Lagos (Jan. 27 - 30), Chinenye Grace Okafor wongold.

How did Abia fare in cricket?

The U-17 female team finished 3rd at the PWC U-17 Cricket Championship in Ebonyi (Feb. 5 - 10). Abia also hosted a 3-day

"Train the Trainers" course in Umuahia (June 11 - 12), boosting grassroots development.

Any international medals?

Yes. At the Level 2 Para-Badminton Championship in Spain (March 4 - 9, 2025), Eze Chukwuebuka

and Jeremiah Nnana won bronze in men's doubles.

How about handball and team sports?

At the National U-12 & U-15 Championship in Umuahia, Abia's boys and girls U-15 teams both finished 1st.

At the National Division One Handball League in Umuahia, the men's team finished 1st, qualifying for the top league.

In volleyball, Abia's female team The Excelsiors finished 2nd at the National League (August), while the male team placed 8th.

What are the highlights in athletics and marathon events?

Abia athletes excelled:

Esther Affigbo starred in long-distance races: Benin 10km Marathon (gold), ECOWAS Abuja 21km (silver), and Enugu City Marathon (silver).

NDDC Sports Festival, Uyo (April): 7th overall with 32 medals (9 gold, 10 silver, 13 bronze). National Sports Festival, Ogun (May): 11th overall with 63 medals (10 gold, 16 silver, 37 bronze).

How strong is Abia in table tennis?

Very strong. Chinenye Okafor and Elizabeth Emelike dominated:

Effiong Edem Championship, Uyo (April): 2 gold, 1 bronze.

National Junior Camp, Abuja (May): Okafor and Somtichukwu Emeka won 1st place each. Nigerian Federation

Championship, Abuja: Okafor (gold), Emelike (silver).

What about para-sports?

Abia is a powerhouse:

National Open Para-Badminton (Umuahia, July): 1st overall with 17 medals (4 gold, 4 silver, 9 bronze).

ValueJet World Para Table Tennis, Lagos (July): Goodness Young won 1 silver and 1 bronze.

Any notable

achievements in wrestling and basketball?

South East Wrestling Championship, Enugu (July): 2 gold, 1 silver, 1 bronze.

Fifty-One Alliance Basketball Cup, Umuahia (June): De Stones Academy finished 2nd.

What efforts are being made to nurture young talents across the 17 LGAs?

Through the National Youth Games, we scout children from all LGAs, refine their skills, and expose them to bigger competitions. Governor Otti' s support makes him the most sports-friendly governor in Abia since 1991.

Do you believe sports helps curb youth restiveness and crime?

Absolutely. Sports keeps youths busy, engaged, and away from crime. Every week, Abia hosts activities that draw youths to training rather than social vices. The governor is deliberately using sports as a tool for crime reduction and youth empowerment.

What is the current state of Abia's sporting facilities?

Frankly, we lack a standard stadium. Enyimba Stadium is below international standard, while Umuahia Township Stadium is just an enclosure. But Governor Otti has approved a facelift for Umuahia Stadium and maintenance at Enyimba Stadium. Plans are also underway for a world-class 35,000-capacity stadium, with site clearing already begun.

Beyond football, how is the council promoting othersports?

We now participate in 31 sports (up from 20 - 25 previously). At the National Youth Games, Abia fields athletes in athletics, basketball, wrestling, boxing, traditional sports, and more.

What steps are being

taken to attract private investors?

We are establishing Sports Associations in every discipline. These associations will drive sponsorships and partnerships, reducing the financial burden on government.

Is there a meeting point between sports and education in Abia?

Yes. Through the Ministry of Sports and Youth Development, we are partnering with a UK-based Sports School to run programmes at Ogbonnaya Onu Polytechnic, Aba. This allows youths to combine education with sports training.

How does the Sports Council collaborate with national and international bodies?

There's a clear structure — from international federations to national federations and down to states. Abia provides the athletes who eventually represent Nigeria globally.

What is your vision for Abia sports in the coming years?

To see Team Abia dominate nationally and globally. Already, things have improved greatly under Governor Otti. My dream is for youths to embrace sports as a viable career path, even without academic qualifications.

What legacy would you want to leave?

Sports is light. I want to be remembered as the Director who helped Abia youths use sports to rise, fend for themselves, and live meaningful lives.

Finally, expectations are high for the 2025 National Youth Games. What should Abians expect?

For the first time, Abia is traveling with 281 athletes across 31 sports. This is unprecedented. Last year, 15 of our athletes were selected into Nigeria's National Youth Camp. This year, our target is a top 5 finish on the medal table.



# SERAP Urges Tinubu To Reject Unlawful Pay Rise For Politicians The Socio-Economic Rights and Accountability Project (SERAP), has called on President Bola Tinubu to stop the Revenue Mobilisation Allocation and Fiscal

Allocation and Fiscal Commission (RMAFC) from implementing an "unlawful and unconstitutional" pay rise for political and public office holders.

SERAP insists that any increase in the salaries of the president, vice president, governors, deputies, and lawmakers would be unjustifiable, given the current economic realities. The group argued that the RMAFC has no constitutional or statutory power to raise the pay of political office holders arbitrarily.

'The RMAFC's constitutional and statutory mandates clearly do not imply the unrestrained powers to increase the salaries of the president, vice-president, governors, their deputies, and

lawmakers," the letter read. SERAP warned that approving the pay hike would further undermine citizens' trust in government, especially at a time of economic hardship.

"Suspending the imminent pay rise for political office holders would serve legitimate public interests When the exercise of RMAFC's constitutional and statutory mandates clashes with Nigerians' fundamental rights, the public interest in

political and public office holders to reflect the current economic challenges in the country, the commission is arbitrarily increasing the salaries for the president, vice-president, governors and their deputies, and lawmakers.

The letter read in part, "the imminent pay rise for political and public office holders in Nigeria particularly the president, vice-president, governors and their deputies, and lawmakers is a gross misuse of the RMAFC's constitutional and statutory

SERAP urged President Tinubu to personally reject the proposal and encourage other political leaders to do the same.

The group also demanded that the Attorney General of the Federation and Minister of Justice, Lateef Fagbemi, ensure compliance with a subsisting judgment directing RMAFC to reviewdownward the salaries and allowances of National Assembly members.

SERAP requested that the recommended measures be taken within seveb days of the receipt and/or publication of the letter. If not, SERAP shall take all appropriate legal actions to compel the government and RMAFC to comply with the request in the

# **FCT Black Spots Under Siege**

n a bid to combat drugrelated crimes in the Federal Capital Territory Abuja, the Anti-Narcotics Section of the FCT Police Command has launched a series of targeted raids across notorious hotspots.

From August 1, 2025, to date, police officers have conducted co-ordinated operations to rid the area of illicit substances and curb associated crimes.

The FCT Police Command's Anti-Narcotics Section conducted a series of operations in several areas, including Asokoro, Trademore, Mapape, Kurudu, Kubwa, Gwarimpa, Jikwoyi, Utako, Life Camp, Zuba, and Karshi. These efforts resulted in the arrest of 116 suspects.

During the operations, police recovered various illicit substances, hard drugs, and dried leaves suspected to be cannabis.

After thorough screening, 89 suspects were released, while 27 offenders were charged to court for public nuisance and possession of illicit substances.

FCT Commissioner of Police, Ajao S. Adewale, commended the operatives for their efforts, reaffirming the command's commitment to maintaining a safe and drug-free capital city.

He urged residents to remain law-abiding, avoid hard drug abuse and trafficking, and support ongoing security initiatives.

As a child of God, you have been given power and authority to overcome every work of the enemy, including physical affliction Psalm 110:1-3. This dominion is not just a spiritual concept—it's meant to be lived and experienced in your daily life, through your covenant relationship with

God has not called you to live in fear or defeat. He wants you to live in health, strength, and victory. Jesus paid the price not just for our sins but also for our healing (Isaiah 53:5). When you understand and walk in this truth, you no longer accept sickness as normal. Instead, you begin to resist it with confidence, knowing that healing is your covenant right.

Just like a healthy tree Just like a healthy tree needs to stay rooted to flourish, you need to stay planted in God's presence to grow strong and stable (Isaiah 61:3). When you're rooted in the place God has assigned you, your life becomes fruitful. But when you wander from His plan, you open yourself up ris plat, you open yourself up to unnecessary battles. In these end times, God is revealing His glory through His people. One of the signs of His divine distinction is the exemption of His children from sickness,

disease, and affliction. You were not created just to survive - you were empowered to overcome.

Psalm 110:1 reminds us that Christ is seated at the right hand of the Father, and we are seated with Him in a place of authority. (Exodus 23:25-26; Deuteronomy 28:1-14)



# NIPSS Selects Aba As Hub For South-East Industrial Development

By Amarachi Uzoukwu he National Institute for Policy and Strategic Studies (NIPSS) has unveiled plans to drive President Bola Ahmed Tinubu's mandate on industrial development in the South-East, selecting Aba, Abia State, as the hub for the initiative.

The Institute's Chairman and former Senate President, Senator Ken Nnamani, and its Director-General, Prof Ayo Omotayo, disclosed this during a courtesy call on Governor Alex Otti, at his residence in Nvosi, IsialaNgwa South Local Government Area.

Nnamani, commended Governor Otti for what he described as good governance in Abia, stressing that the decision to situate the hub in the state was well deserved.

Contributing,Omotayo explained that the choice of Aba was evidence-based and reflected the South-East's longstanding reputation for innovation, trade and industry.

"Mr. President believes that

a whole lot of potentials exist in all the six geographical regions, and that we must unlock those potentials.

"We found that for trade and industry, out of the six geographical zones, the most talents exist more in  $the South\hbox{-} East.$ 

"Without doubt, the South-East has the natural talent for factories, for innovation, for buildings, and so on. So, we chose the South-East as the best hub for local industrial development, local industrial revitalisation of what it used to do. After the South-East was chosen, we broke them down into each of the states.

"At the National Institute, we don't put emotions into things. It's based on the data and we found that Abia is the hub for local inventions, local innovations, and an area where we can easily take out local content", Prof Omotayo stated.

In his response,

Abia and noted that the decision was in line with the ongoing economic transformation of the state.

"I want to also thank you for considering Abia and resisting the pressure from others. I want to assure you that the decision you took is the right decision.

"I can assure you that this one fits perfectly into what we are quietly doing here. You may not have known that we just set up an Export Growth Lab in Abia", the governor said.

He assured the Institute of his administration's support in implementing President Tinubu's industrialization mandate and directed his Principal Secretary and Chief Strategy Officer to liaise with NIPSS to provide all necessary assistance.

Governor Otti expressed highlighted Abia's appreciation to NIPSS for industrial capacity, resisting pressure from other quarters and choosing disclosed that the Ariaria International Market alone hosts about 60,000 shoemakers, while the state has also restructured the management of the Enyimba Shoe and Garment Factories.

"The state has also taken active interest in the management of Enyimba Shoe and Garment Factories. So they appointed new management who are funding it very well.

"And NIPSS, you may also want to take interest. Just see what we are doing there. It's still early days, but I'm sure you'll be happy.

Our predecessors handed it over to us, but the structure and the management was very faulty. So we spent over a year trying to untie some of the roadblocks, and then I think we have gotten it off think we have gotten it off the ground now", the governor explained.

# **Aba Power Pledges** End to Estimated Billing, **Rolls Out Mass Metering**

ba Power Limited (APL) has assured e l e c t r i c i t y consumers that the era of estimated billing will soon be over as the company begins a massive rollout of prepaid meters across Aba and neighboring communities.

The assurance was given during a customer interactive forum held at Aba, where officials of the company engaged customers on challenges in the power sector, outlined ongoing reforms, and unveiled innovations designed to improve service delivery.

Head of the Commercial Department, Engr. Emeka Victor Ngwoke, said the problem of estimated billing is a nationwide challenge affecting all distribution companies (DisCos), but stressed that APL has taken it upon itself to meter every customer.

He explained that the metering exercise will be carried out feeder by feeder to ensure thoroughness, adding that more than 39,000 meters have already been installed, while over 100,000 additional units are expected in the coming months

Ngwoke also noted that electricity tariffs in Aba remain relatively low compared with global benchmarks. According to him, tariff adjustments fall strictly under the jurisdiction of the Nigerian Electricity Regulatory Commission (NERC).

He, however, pointed out that many customers still hold the mindset that power should be cheap or free, which fuels resistance to payment.

Speaking on dispute resolution, Barr. Charles Tooti of APL's Customer Complaints Unit (CCU) explained that the unit is well equipped to handle grievances in line with the Customer Protection Regulations Act 2023.

He outlined the steps for redress to include: Lodging complaints directly with the CCU through letters, emails, or personal visits; Escalating unresolved issues to the Managing Director of APL; Reporting to NERC Forum Officers; and as a last resort, seeking justice in a competent court of law among others.

"Regulations may not favour everybody equally, but the important thing is that every customer has access to justice," Tooti said

For operational convenience, Engr. Ekwueme introduced a new mobile application, "Nkeanyi," now available on the Google Play Store. The app enables customers to monitor and regulate their meters, make payments, and transact seamlessly with APL from the comfort of their homes.

During the forum, participants voiced a range of concerns bordering on metering, tariffs, and adaptation to new innovations in the electricity sector.

Mr. Omenihu Michael, a resident of World Bank Estate, questioned how property owners could recover funds already spent on meter procurement. Similarly, Mr. Odoemelam Enyinna expressed worries about cases of meter bypassing as well as what he described as the burden of high tariffs on consumers.

From Umuode Village, Mr. Njoku Leonard complained about the malfunctioning of one of two meters installed in his compound, stressing the need for prompt rectification.

On his part, Mr. Obioma Chinemerem lamented the loss of revenue and underscored the challenges customers encounter while trying to adapt to new innovations introduced in the sector.

Responding, APL officials assured customers that their concerns would be addressed promptly, while reaffirming the company's commitment to transparency accountability, and

improved power supply.
Mr. Edise Ekong Brand Communications Manager of Geometric Power, said the engagement was designed to feel the pulse of customers, enlighten them on regulatory policies, and take feedback back to the drawing board for service improvement.

"We want customers to see APL not just as a service provider but as a partner committed to fairness and accountability," he said.



# Poor Waste Disposal In Rivers State: Prof, Residents Call For Urgent Action From Nzeuzor Jane, Port Harcourt

The growing menace of poor waste disposal in Rivers State has raised concerns among experts and residents, who are now calling for urgent intervention. Professor Sydney ObidinmaNzako, a lecturer in Animal and Environmental Biology, has urged the government to embark on a statewide campaign on waste bagging, disposal, and proper environmental practices.

Speaking in an interview with our reporter, Prof. Nzako lamented the activities of scavengers, which he said are undermining the status of Port Harcourt as the "Garden City." He stressed that reorientation of waste pickers and the public is necessary to drive a sustainable waste-towealth initiative.

'Somebody bags his refuse, then you scatter it, pick the valuables, and walk away without re-bagging it. You leave it there for the wind to spread around. These scavengers should be arrested and taken to a place where they will be reoriented on how to do things Even if you must pick from the waste in the name of waste-to-wealth, you cannot practice it at the expense of public health," he

Prof. Nzako further warned about the health risks associated with indiscriminate dumping and unpacked refuse across Port Commissioner for Harcourt metropolis. He expressed concern Agriculture, Dr. Cliff that citizens appear more interested in Agbaeze, highlighted the making social media videos than in demanding cleaner surroundings.

The patriotic aspect is missing. People at the roadside just snap and post online instead of raising alarm. When we should be talking about health, the environment is filthy. And by default, everybody is affected because parasites and diseases spread by contact. A man with low health quality cannot claim to be healthy," he added.

Meanwhile, residents across Port Harcourt and its environs have expressed disappointment over the performance of the Rivers State Waste Management Agency (RIWAMA). They say littered waste, foul odour, and the growing number of flies are making life unbearable.

"The level of pollution in Rivers State is becoming alarming. Health, they say, is wealth. But how can we live well in this kind of environment? Rivers State used to be the Garden City, a place of serenity. Now waste is everywhere. It should be a wake-up call for government intervention," a resident said.

Another resident at Oyibo added: "RIWAMA is nothing to write home about. When it rains, it becomes worse. Here in Oyibo, refuse is ignored. It stays for days and weeks, breeding flies, causing bad odour, polluting and defacing the environment.

Both experts and residents are therefore appealing to the government and relevant agencies to act swiftly before the city's waste crisis escalates into a major public health disaster

# 2025 National Youth Games: **Team Abia Dazzle**

The "catch-them-young" program in sports by the Dr. Alex Otti-led government of Abia State has started yielding positive results with the dazzling performance of Team Abia at the just-concluded National Youth Games in Asaba, Delta State.

Team Abia, which comprised of 287 athletes, competed in 31 sports including athletics, badminton, volleyball, boxing,

cricket, gymnastics, handball, judo and others.

As at press time, Team Abia has won 12 gold, eight silver and seven bronze medals. They have already surpassed their last year's performance, when they finished 10th with a total of 31 medals comprising seven gold, 12 silver and 12 bronze medals.

In boys' football, Team Abia successfully defended their title after Paul Bassey Offiong's lone strike gave the boys from God's Own State victory over hardfighting Oyo State. To qualify for the final, the team eliminated Lagos State 2-0. After a goalless first half, Israel Asuquo and Chibuike Ubani scored to hand Team Abia the final's ticket. In their earlier two matches, they scored five goals and conceded none, defeating Adamawa State 2-0 before thrashing Plateau State 3-

Similarly, the female handball

team were head and shoulders above all their opponents as they clinched gold at the expense of the host state despite underhand tactics to swing victory to their opponents. Team Abia won 12-11. The team faced Lagos in the semifinals and took them to the cleaners 24-12.

Abia State's first medals came from weightlifting, when Vitalis Eze won three gold medals in the 55kg, 76kg and 95kg categories.

In para-table tennis, it was an all-Abia final when David Emeka took on Jaja Celestine, with the former clinching gold as the latter settled for bronze. In the female category, Goodnews Young defeated Raji Aishat Anulowapo of Ogun State to win bronze for Team Abia. David Emeka and Goodnews Young teamed up to win gold in mixed doubles with a 3-1 victory over Ogun State. In the female doubles event, Goodnews Young and Victoria Ikechi won gold after thrashing Imo State 3-0. In the boys' category, Somto David and Jaja Celestine won gold at the expense of Ogun State.

In Poomsae, Chidiebere Prosper Ikechukwu won bronze and paired with Ogechi Elekwa to win bronze in Poomsae Pairing.

Promise Basil won silver in the 43kg para-powerlifting event, while Chinyere settled for silver in table tennis. Nwakobi Miracle dethroned the darts champion from Delta State in boys' singles, while Izuchukwu Emmanuel Chidiebere won bronze. The duo of Nwakobi Miracle and Out Favour won bronze in mixed doubles.

In para-athletics, Glory Mmesoma won gold in the T46/47 event while Samuel Obilor clinched silver.

Kasarahi Chioma gave Abia State a silver medal in high jump, while another silver medal came from female judo.

Ovowumi Avomide won silver for Team Abia in boxing.

These exploits by Team Abia bear eloquent testimony to the fact that Abia State is heading in the right direction in sports development.
