Mixed Reactions Trail Appointment Of **Amupitan As New Inec Chairman**

eactions have continued to trail the appointment of Professor Joash Ojo Amupitan, SAN, as the new Chairman of the Independent National Electoral Commission (INEC), with prominent Nigerians across political and civil society circles expressing mixed opinions on his emergence.

The appointment, officially approved by the National Council of State (NCS), following President Bola Ahmed Tinubu's recommendation, was confirmed during the Council's meeting recently at the Presidential Villa, Abuja.

The meeting, presided over by President Tinubu, had in attendance former Presidents Goodluck Jonathan and Abdulsalami Abubakar, several state governors, and other

Former presidential Spokesman, Ajuri Ngelale, described the appointment as a demonstration of the President's commitment to strengthening democratic institutions

"The President was deliberate in choosing a man of character and competence. Professor Amupitan's legal background and reputation for integrity make him well-suited to lead INEC into a new era of reform and trust," Ngelale said.

Senate President, Godswill Akpabio, also lauded the choice, calling it "A strong signal of commitment to credible elections.

"Professor Amupitan's antecedents in legal scholarship and public ethics give Nigerians confidence that INEC will be guided by fairness, firmness, and transparency," he added.

However, the House of Representatives Minority Leader, Hon. Kingsley Chinda, urged the new INEC boss to guard the Commission's independence jealously.

"He must be above political pressure and ensure the sanctity of the ballot remains sacrosanct," Chinda stated.

The ruling All Progressives Congress (APC), hailed the appointment as a step in the right direction, describing Professor Amupitan as a "tested professional with no partisan". baggage.

In a statement signed by its National Publicity Secretary, Felix Morka, the party expressed confidence that the new chairman would "consolidate the gains of recent electoral reforms and deepen the culture of free and fair elections."

Conversely, the opposition People's Democratic Party (PDP), called for vigilance, warning that INEC's credibility must not be compromised.

According to the PDP National Publicity Secretary, Debo Ologunagba:

"While we acknowledge his qualifications, Nigerians expect him to resist executive influence and ensure that INEC operates as a truly independent institution."

The Labour Party (LP), also welcomed the appointment but charged Amupitan to "prioritize electoral credibility and voter confidence.

Civil society groups and election observers have also shared their expectations.

The Transition Monitoring Group (TMG), in a statement by its Chairperson, Auwal Rafsanjani, commended the appointment but urged the new INEC chairman to "clean up INEC's internal processes, improve staff discipline, and enhance logistics."

YIAGA Africa's Executive Director, Samson Itodo, said the appointment presents "an opportunity to rebuild trust in the electoral system." $% \begin{center} \begin{c$

"INEC's next phase will test his leadership. Nigerians want transparency, accountability, and a clear plan for electoral technology and security," Itodo remarked.

Falana Lauds Gov Otti's Development Strides

uman Rights Lawyer and Senior Advocate of Nigeria, (SAN), Femi Falana, has called on the Federal Government to ensure greater access to justice for ordinary citizens, noting that the country's judicial system currently serves mainly the elite.

Falana, made the call recently in Nvosi, Isiala Ngwa South LGA of Abia State, while South LGA OF ADIA STATE, WITHE speaking with journalists shortly after a closed-door meeting with Governor Alex Otti.

He criticised the notion that the judiciary is the last hope of the common man, insisting that the common man has no means to go to court.

"Access to justice by the people, that is what the judicial system needs. Right now we have a lot of access to justice by politicians. Only their cases move in court because political cases are time-bound.

"Other cases for me must be time-bound. People make the mistake of saying the judiciary is

the last hope of the common man. The common man has no means to go to court.

"The judiciary is the last hope of the elite, the bourgeoisie", Falana said.

The human rights lawyer, therefore, urged governments at all levels, to promote alternative dispute resolution mechanisms which he described as rooted in African traditions.

Falana, who cited the example of a South-South state

where palace law reports exist, stressed the need to strengthen customary courts and traditional dispute resolution mechanisms.

"If you want the ordinary people to benefit from the judicial system, you must promote alternative dispute resolution.

"The majority of our people do not go to Western courts, they patronise traditional rulers and community leaders to solve

"So the governments of our ountry, including that of Abia State, must also reform the customary courts, palaces of traditional rulers where our people access daily to resolve their disputes.

"What they now call alternative dispute resolution is actually African dispute resolution. Before the colonialists came, our people had nothing to do with adjudication.

Appointments, Strictly Based On Merit Says Governor Otti

The Abia State Governor, Dr. Alex Otti, OFR, has reaffirmed that appointments in his administration are strictly based on merit and proven track records, not on favoritism apprenticeship.

Governor Otti made this

known recently, during the 60th birthday celebration of the Commissioner for Sports and Youth Development, Sir Nwaobilor Nwadimma Ananaba, held in Umuahia.

"This is a government that relies on track record. Some people think government is a place for apprenticeship or where you learn on the job. Not in our government. If you don't know the work, you can't be here," Otti stated.

He explained that appointments under his administration are made based on competence and capacity to deliver, stressing that such positions should not be viewed as favours

However, a legal practitioner, Sir Ifeanyi Ejiofor (KSC), has expressed deep concern over the recent appointment of Prof. Joash Ojo Amupitan, as Chairman of the Independent National Electoral Commission (INEC), describing it as a potential threat to the neutrality and integrity of Nigeria's electoral process.

In a commentary titled "When the Umpire Was Once on the Pitch - The Curious Case of Prof. Amupitan as INEC Chairman,"
Ejiofor questioned the moral and constitutional implications of
appointing someone allegedly linked to partisan political
activities to head an institution that serves as the guardian of electoral fairness

electoral fairness.

Ejiofor argued that while the 1999 Constitution empowers the President to appoint the INEC Chairman subject to Senate confirmation, the office demands more than procedural legitimacy—it requires unquestionable integrity and apolitical standing. He noted that public speculations linking Prof. Amupitan to President Bola Ahmed Tinubu's legal team during the 2023 election tribunal, if true, present serious ethical challenges including conflict of interest, appearance of bias, and the establishment of a dangerous precedent that could erode public trust in the electoral system. "An umpire must never have worn the jersey of any team," he emphasised, warning that even the perception of partisanship could undermine confidence in future elections. future elections.

The lawyer further called on the Senate to exercise due diligence and prioritize national interest over political expediency during the confirmation process.

He cautioned that confirming the appointment without rigorous scrutiny would blur the line between politics and impartiality, thereby jeopardizing the independence of INEC and the credibility of Nigeria's democracy. Ejiofor maintained by urging lawmakers to ensure that "conscience still finds a seat in the Red Chamber," as the integrity of the ballot box remains the soul of democratic governance

Professor Amupitan's appointment was ratified after due consideration by the National Council of State, marking the beginning of what many see as a reform era for the electoral body.

A Senior Advocate of Nigeria (SAN) and Professor of Law at the University of Jos, Amupitan hails from Kogi State and is renowned for his scholarship in constitutional law, governance, and human rights.

He has served as Dean of the Faculty of Law, Chairman of the Committee on Legal Reforms, and Consultant to the National Assembly on legislative drafting.

Known for his forthright views on constitutionalism and democratic accountability, Professor Amupitan has consistently advocated for transparency and the adoption of technology in

As preparations intensify for the 2027 general elections, expectations are high that the new INEC Chairman will strengthen institutional independence, address logistical lapses, and ensure full implementation of electronic result transmission.

Observers said, his first major task will be to unveil an internal reform blueprint focused on staff integrity, voter data security, and effective logistics management.

With his academic rigor, legal authority, and reform-minded disposition, many Nigerians believe Professor Amupitan's tenure could mark a decisive step towards restoring public trust in Nigeria's electoral process

Police Rescue 18 Stolen Children, Arrest 10 Suspects In Child Trafficking Syndicate

he Abia State Police Command has rescued 18 children, including 8, infants, and 10 suspects for their alleged involvement in a child-stealing and trafficking syndicate operating within Aba and its environs.

According to a statement issued on Friday, October 10, 2025, by the Police Public Relations Officer (PPRO), DSP Maureen Chinaka, the operation followed a distress report and subsequent intelligence-led raids on suspected hideouts in Aba.

The case began on September 27, 2025, when a young woman from Abakaliki, Ebonyi State, reported to Ohuru Isimiri Police Division that her two children had been stolen by a man who lured her to Aba under the pretext of marriage.

Acting on credible intelligence, police operatives on October 8 stormed a residence in Aba where five suspects identified as Mrs. Best Ndubusi (41), Charles Enyinnaya (25), Eunice Ezekiel (35), Nnena Kalu (60), and Gideon Esther (25)—were arrested. One

infant and seven children were rescued during the operation.


Further investigations led to another successful raid on October 9, along Aba/Owerri Road, where four more suspects - Obiegbunam Von (65), Ezeoma Rejoice (21), Ngozi Owoh (20), and Favour Ernest (22)were apprehended. Officers rescued an additional seven infants and three children.

On October 10, the police arrested another

suspect, Brittney Oyemuwa Zion (22), leading to the recovery of rescued victims are currently in safe custody, while investigations continue at the State Criminal Investigation Department (SCID), Umuahia

ASHTF Arrests Fake Revenue Agents Over Extortion In Aba

The Abia State Harmonized Taskforce (ASHTF), has arrested four individuals for allegedly impersonating members of the National Union of Road Transport Workers (NURTW) and extorting money from residents in Aba.

The suspects were apprehended recently, at the Flyover Junction in the Ugwunagbo area during an operation authorized by the Aba area coordinator of the Taskforce, Mr. Uche Wogu.

In a statement issued by the Taskforce spokesperson, Mr. Miracle Chukwunenye, the agency said the arrests followed multiple complaints from traders, market women, and tricycle operators about a syndicate that had been harassing and extorting them along the Port Harcourt Road axis.

"Upon arrival, the Taskforce, in a joint operation with the police, arrested Mr. Ahuama and three accomplices who were caught extorting money from unsuspecting traders and tricycle operators under the false pretence of being NURTW officials," Chukwunenye said.

He disclosed that the suspects had earlier impounded about 20 tricycles that morning and collected illegal levies from the owners before being intercepted.

According to the spokesperson, the suspects resisted arrest and attacked Taskforce and police officers but were eventually subdued and taken into custody.

Chukwunenye reminded residents that Abia State operates a "No Cash-at-Hand" revenue policy, warning that no government-authorized official is permitted to collect cash directly from citizens.

"We urge traders, transporters, and residents to report any unauthorized revenue collector to the authorities," he said.

The Taskforce reiterated its commitment to eliminating illegal revenue collection and ensuring that legitimate government taxes and levies are paid through the approved digital channels.

Tovernor Alex Otti of Abia State has pledged government's support and partnership with the Back To The Herro's Past Charity Organisation (BATHEP), in the establishment of a proposed N5 billion Geriatrics Village Project, spearheaded by his Special Adviser on Policies and Interventions, Rev. Fr. Christian Anokuvru.

The governor made the commitment during the public presentation of Fr. Anokwuru's new 554-page book, "Nature and Nurture: Beyond My Autobiography, Vol. 1," and the official unveiling of the Geriatrics Village initiative held at the JAAC Building, Umuahia, recently.

Governor Otti described the proposed village as a "family-friendly environment" designed to provide dignified living, companionship, and specialized healthcare for elderly citizens.

He assured that the state government would not allow Fr. Anokwuru to embark on the massive project alone.

"I don't think, as a government, we should sit by and watch him do this alone". So, I am looking at a partnership whereby the government will engage with him and partly own and support it financially." Gov Otti stated.

The governor immediately directed the Commissioner for Poverty Alleviation and Social Protection, Mrs. Ngozi Blessing Felix, to liaise with Fr. Anokwuru and present a workable partnership framework for government involvement.

Otti commended Fr. Anokwuru for his foresight, compassion, and intellectual courage, describing the cleric's commitment to the welfare of the elderly as "a true demonstration of faith in action."

He also praised the author for his literary achievement, revealing that the priest's resilience had inspired him to revive his own unfinished book project.

"With people like Father Anokwuru, I've now been encouraged to go back and look at it," Otti said.

Speaking at the event, Chairman of BATHEP, Prof. Charles

Chilekezi, explained that the proposed Geriatrics Village — to be sited at Amuzu Ubakala would feature an integrated facility valued at N1.5 billion, comprising residential housing, hospital, physiotherapy and recreation centres, and professional training for caregivers

He said the project aims to ensure that the elderly, "live with dignity, not just survive in hospitals," adding that the facility will pursue self-sustainability through large-scale agricultural ventures cultivating crops like cassava, melon, and yam to support its operations and the less-privileged.

Prof. Chilekezi assured donors that all contributions to the foundation would be used judiciously to create maximum social

In his address, Rev. Fr. Anokwuru said the Geriatrics Village is not merely a retirement home but a comprehensive institution

s not inerety a retirement home but a comprehensive institution that will train professional caregivers and provide medical and social support for senior citizens.

He expressed gratitude to Governor Otti for his encouragement and leadership, noting that his association with the governor had "deepened his belief in purposeful governance."

Fr. Anokwuru, however, criticised what he described as the "desperate antics of opposition elements", who, under the guise of demanding accountability, were attempting to undermine the government's progress

A non-agenarian, Chief John Nwankwo, also spoke at the event, commending the initiative as "a dream come true", for elderly citizens and praising Governor Otti for his people-centred

The ceremony, co-chaired by the member representing Isialangwa North and South Federal Constituency, attracted dignitaries, including former Minister of State for Mines and Steel Development, Chief Uche Ogah, religious leaders, scholars, and members of the Abia political class.

Gov Otti Reaffirms Commitment To Universal Eve Care As Abia Marks World Sight Day

bia State Governor, Dr Alex Otti, has reaffirmed his administration's commitment to ensuring universal access to quality eye care services across the state.

Governor Otti stated this in Umuahia, at a symposium organised by the Abia Health Eye Management Bureau to commemorate the 2025 World Sight Day themed, "Love Your Eyes, Vision for All".

The Governor, reprsented by the commissioner for Health, Prof Enoch Uche, described the theme as a call to action for individuals, communities, and institutions to prioritise eye health as a vital component of general well-

He noted that his administration prioritises health care and welfare of Abians which is evidence in the reforms in the sector, ranging from infrastructural rejuvenation to human resource upgrade, and As well as improvement in the remuneration package for healthcare workers.

He noted that his administration places high premium on the healthcare and welfare of Abians, as evidenced in reforms in the sector such as infrastructural renewal, human resource development and improved remuneration of healthcare

Governor Otti outlined preventive measures such as regular eye check-ups, reduced screen exposure, and prompt professional attention for any visual changes and cautioned against patronising unlicensed practitioners and using unverified herbal remedies.

The Governor further warned media organisations against promoting unverified medical products, saying the Ministry of Health would act decisively against misinformation.

He therefore urged traditional rulers and community leaders to intensify awareness campaigns and monitor health-related activities within their localities

In her remarks, the Administrator of the Abia Health Eve Management Bureau, Dr Betty Emeka-Obasi, reaffirmed the State Government's determination to eliminate avoidable blindness and expand access to affordable eye care

She highlighted the achievements recorded since the Bureau's establishment by executive order in July 2024.

"Since inception, we've screened over 15,000 people, provided 11,000 free screenings, and conducted 2,000 life-changing eye surgeries. Our vision is clear: no one in Abia should suffer from preventable blindness", she stated.

Dr Emeka-Obasi disclosed that the Bureau had upgraded the State Specialist Hospital Eye Centre and established integrated vision centres in ten primary healthcare facilities, with four currently operational.

She announced the introduction of the School Eye Health Programme, under which 190 teachers have been trained to identify early signs of eye conditions in schoolchildren.

Dr Emeka-Obasi expressed concern over widespread quackery and harmful eye practices, especially in rural areas, warning that the prevalence of preventable blindness in the state had risen above the national average.

In a keynote address, Professor Emmanuel Esenwah called for greater collaboration among individuals, organisations, and governments to tackle preventable blindness and vision impairment.

Prof Esenwah, noted that the lack of accessible eye care services in low-income areas often forces people to rely on self-medication and traditional remedies, which can worsen eye conditions and lead to permanent vision

He commended the Abia State Government for establishing vision centres in primary healthcare facilities, describing the initiative as a major step towards universal health coverage and the attainment of Sustainable Development Goal 3.

A Consultant Ophthalmologist, Dr Chioma Uchendu, cautioned against using substances such as breast milk or urine to treat eye problems, describing such practices as dangerous and capable of causing blindness.

She advised adults aged 40 and above to undergo annual eye examinations, explaining that some conditions like diabetic retinopathy may progress silently without

Also speaking, the Head of the Optometry Department at Gregory University, Dr Obilor Osigwe, emphasised the role of nutrition in maintaining eye health and encouraged the inclusion of Vitamin A rich foods such as palm oil and omega-rich fish in daily diets.

The Director of Public Health and Disease Control in the Ministry of Health, Dr Princess Orieji, reiterated the state's commitment to public education, community outreach, and strong advocacy against quackery in eye care.

MOUAU Trains Abia Youths On Tomato/Pepper Production

he Michael Okpara University of Agriculture, Umudike (MOUAU), in collaboration with the Science and Technical Committee of the Nigerian Institute of Food Science and Technology (NIFST) and the Hope for Farmers Women and Girls Initiative (HOFWGI), has launched the Cohort 1.0 Youth Empowerment and Agricultural Skills Training. The practical initiative is designed to equip young people from the university's host communities and beyond with hands-on skills in tomato and pepper cultivation as well as value addition through processing.

Declaring the training open, the Sixth Vice-Chancellor of the University, Prof. Maduebibisi Ofo Iwe, said the initiative reflects the university's strong commitment to community development, food security, and youth empowerment.

Represented by the Deputy Vice-Chancellor (Academic), Prof. Nneoma Elechi Obasi, the Vice-Chancellor explained that 23 youths were selected for the first phase of the training, which focuses on the entire process of tomato and pepper cultivation – from nursery establishment to harvesting.

"We are empowering Abia youths through this initiative. Our goal is to first train young people from four university host communities – Umudike, Umudike Ukwu, Okwu Olokoro Autonomous Community, and Umuopara Ozara Olokoro Autonomous Community, Prof. Obasi stated.

She described the programme as a hands-on training designed to engage participants practically and them become productive entrepreneurs.

"In addition to farmbased instruction, participants are receiving laboratory training on processing techniques to extract and produce tomatobased products such as juice, purée, ketchup, drinks, and tomato powder.

"We are empowering them to make good use of their time and become useful to themselves and their communities. This training can spark something in them that will inspire future entrepreneurship," she

emphasized.

the initiative adopts a 'Train-the-Trainer' model, under which four participants were selected from each community. Those trained will, in turn, extend the knowledge to other youths in their localities, thereby expanding the programme's impact. Earlier in her remarks,

the Director of the Centre for Gender, Youth and Child Development, Prof. Mabel Ifeoma Onwuka, described the project as a long-term empowerment drive aimed at giving back to society while promoting agricultural innovation.

"We are here to empower the youths, starting from our university host community. We are doing it in phases, and the essence is to give back to society," she noted. Prof. Onwuka who is

also the Supervisor MOUAU Greenhouse Project on Tomatoes and Peppers Production, further explained that the training also equips participants with starter kits comprising seeds, manure, and other necessary materials to help them establish their farms after the programme.
"We will keep track of

their progress and provide follow-up support to ensure sustainability," she said.

She added that the programme, implemented by the Centre for Gender, Youth and Child Development in collaboration with the Hope for Farmers Women and Girls Initiative (HOFWGI) and the Department of Food Science and Technology, will be sustained and expanded to accommodate more participants in future cohorts.

"After this cohort, the She further revealed that next batch will also be trained to expand knowledge, improve livelihoods, and ensure food and nutritional security in

Nigeria," she assured.
Onwuka emphasized that beyond food production, the initiative seeks to foster peace and stability within local communities by meaningfully engaging youths in productive ventures, thereby reducing restiveness and unemployment.

They also appealed to Governors in the South-East and South-South regions and other tiers of government to prioritize food security by investing in youth-driven agricultural programmes.

Governments should take advantage of the strength and creativity of our youths to boost agriculture and ensure food sufficiency," Prof. Onwuka

She stressed that greater investment in irrigation and modern farming techniques would enable all-yearround cultivation of key crops, thereby boosting food availability and rural livelihoods.

The Agriculturist described the programme as part of MOUAU's Corporate Social orporate Social Responsibility (CSR) and reaffirmed that it aligns with the university's broader mission to use agricultural knowledge for sustainable community transformation and national food security.

"This is an extension of k n o w l e d g e - o u r contribution to society. We want to ensure that every household has enough food, adequate nutrition, and the purchasing power to sustain it. If this training is practiced, it will positively impact both the micro and macro economy," she state

The Professor of Soil Science who trained the youths from Cultivation to harvesting stages of tomatoes and peppers, encouraged the participants to maintain close contact with the university for continuous mentorship and

The university doors are open. The trainees are free to come in for further clarifications and free consultations as they implement what they have learned," Prof. Onwuka noted.

The Cohort 1.0 Youth Empowerment Programme represents a vital step in MOUAU's ongoing efforts to promote agricultural innovation, enhance youth self-reliance, and strengthen Nigeria's food and nutritional security

Prof. Onwuka also demonstrated the production and use of biochar as a sustainable and affordable fertilizer to improve soil fertility and boost tomato and pepper production in Southeast Nigeria. She described biochar as an eco-friendly product made from agricultural waste such as crop residues, rice husks, and animal dung through a controlled heating process known as pyrolysis

Explaining during a demonstration session with youths, Prof. Onwuka explained that applying biochar to the region's degraded and acidic soils helps increase crop yield, enhance nutrient availability, and improve soil structure. She added that biochar enriches the soil with essential nutrients like phosphorus, calcium, and potassium while supporting beneficial microorganisms.

According to her, biochar offers farmers a low-cost alternative to chemical fertilizers, making it ideal for smallholder farmers cultivating tomatoes and peppers. She emphasized that the technology not only recycles agricultural waste into valuable farm inputs but also helps mitigate climate change by reducing greenhouse gas emissions during production.

She also commended Mrs. Kasie Okakpu from the Department of Food Science and Technology, who showcased various local food products such as Monkey Kola and demonstrated juice extraction from indigenous

Autism, Pregnancy And The Imperative Of Safe Drug Use

cross the world, conversations around autism and possible environmental or medical contributors are intensifying. In recent years, studies have examined a potential link between the use of acetaminophen—widely known in Nigeria by the brand name Tylenol or paracetamol—during pregnancy and the risk of autism or other neurodevelopmental disorders in children. While no study has established a proven causal link, the growing body of research has raised important public-health questions that Nigerians cannot afford to ignore.

Several large-scale studies from Europe and the United States have suggested a possible association between prenatal acetaminophen use and a slightly increased risk of autism spectrum disorder (ASD) or attention deficit hyperactivity disorder (ADHD) in children. However, these are observational studies, meaning they can identify correlations but not necessarily prove cause and effect.

More rigorous analyses—especially those comparing siblings, where one pregnancy involved acetaminophen use and another did not—tend to show no significant difference in autism risk. This suggests that other factors, such as genetics or shared environmental conditions, may be responsible for the apparent association.

Expert reviews and global health authorities, including the World Health Organization (WHO), the U.S. Food and Drug Administration (FDA), and the American College of Obstetricians and Gynecologists (ACOG), all agree on one thing: the evidence remains inconclusive and does not prove that acetaminophen causes autism. Nevertheless, they urge cautious and responsible use—especially during pregnancy.

In response to accumulating research, the FDA has started reviewing labeling for acetaminophen products to include mention of studies suggesting possible neurodevelopmental effects. However, the agency and most professional bodies still maintain that acetaminophen remains the safest pain and fever medication for pregnant women when used correctly.

For Nigerians, this conversation is both timely and necessary. Acetaminophen is among the most commonly used medications in the country, available over-thecounter and often used casually for headaches, fever, and general pain relief. Pregnant women, in particular,

frequently rely on it because it is considered mild and safe compared to stronger painkillers. Unfortunately, self-medication and overdose are common, and few are aware that excessive or prolonged use-even of "simple" paracetamol—can pose risks to both mother and child.

Autism is not caused by a single factor. Genetics, environmental exposures, infections, and pregnancy-related complications all play roles that scientists are still working to understand. However, awareness about modifiable risks—those we can reduce through education and better choices—is essential.

In Nigeria, autism remains poorly understood, often stigmatized, and rarely diagnosed early. Many families struggle in silence, mistaking developmental delays for stubbornness or spiritual problems. The country urgently needs broader education about early detection, intervention, and possible preventive measures

Sensitizing expectant mothers, families, and healthcare workers about the safe use of medications during pregnancy could contribute meaningfully to long-term prevention efforts. Women should not stop taking acetaminophen abruptly or without medical guidance, but they should know the right questions to ask:

What does is safe

Are there non-drug options for managing pain or fever?

Health authorities, professional associations, and media organizations in Nigeria should begin structured campaigns to educate the public on safe medication use during pregnancy. Pharmacists and community health workers must also play a stronger role in counselling patients and discouraging self-prescription.

At the same time, we urge government agencies and researchers should invest in local studies to understand how factors unique to Nigeria—such as malnutrition, poor access to healthcare, or environmental toxins—interact with medications and child development outcomes. Without local data, Nigeria risks relying solely on foreign findings that may not reflect our realities.

Reducing the future burden of autism and related developmental disorders requires a multi-pronged approach: promoting maternal health, encouraging safe drug practices, reducing stigma, and improving early childhood care. Pregnant women should continue to follow medical advice, using acetaminophen only when necessary, at the lowest effective dose, and for the shortest possible duration.

Autism awareness in Nigeria must shift from fear to informed action. Science does not yet prove that acetaminophen causes autism—but the debate underscores a larger truth: that every medication, even the most common, deserves respect and proper guidance. Sensitization today can help secure a healthier, more informed generation tomorrow.

Bridging The Education And Skill Gap Among Nigerian Youths

Such skills will empower young Nigerians to compete globally while contributing locally.

Private sector participation is also key. Industries must partner with schools to provide internships, mentorship programs, and practical exposure. This collaboration can bridge the divide between theory and practice, ensuring that graduates are ready for the modern workplace.

Moreover, the government must expand digital access by investing in ICT infrastructure and affordable internet connectivity, especially in rural areas. In today's world, access to information is access to opportunity.

Finally, there must be a national reorientation that restores the dignity of labour and values innovation over shortcuts. Our youth must be encouraged to dream, create, and compete — not just survive.

Tinubu's Mercy Doctrine and the Imperative of National Inclusion

hen President Bola Ahmed Tinubu, granted presidential pardon to a host of historic national figures — including the revered Nigerian nationalist Herbert Macaulay, the Ogoni Nine, and Major-General Mamman Vatsa — the move was widely hailed as a bold stride toward reconciliation, restorative justice, and national unity.

The gesture, which also saw 82 inmates across the country regain their freedom and 959 citizens and foreigners receive national honours, reaffirmed Tinubu's stated commitment to healing old wounds and building a more inclusive Nigeria.

For many, it was not just an act of statecraft — it was a signal of compassion, courage, and the political maturity to confront Nigeria's painful past with empathy.

While the courts continue to deliberate on his case, the broader question remains: Can there be true national reconciliation when one of the most symbolic figures of ethnic agitation remains behind bars?

Extending clemency to Kanu, as part of a carefully structured peace and reconciliation process, would not only demonstrate President Tinubu's magnanimity but also reaffirm his administration's commitment to dialogue, inclusiveness, and long-term stability.

The South-East, like other regions, yearns for justice, recognition, and belonging. A presidential pardon for Kanu could serve as a bridge of trust, rekindling faith in the federal system and showing that the government is willing to forgive in the interest of peace.

It would also align with the spirit behind the pardons granted to the Ogoni Nine and other historical figures — men

once condemned for their convictions but later vindicated by history.

By freeing Kanu, President Tinubu could set the stage for a broader conversation on national cohesion, equity, and the restructuring of Nigeria's political dialogue — a conversation that must be had if the nation is to truly move forward.

Leadership is not only measured by the firmness of justice but also by the grace of mercy. History often remembers leaders not for how harshly they punished, but for how bravely they forgave.nt Tinubu's bold use of the prerogati

Presideve of mercy shows that he understands this truth. Extending it further to Mazi Nnamdi Kanu could mark the beginning of a new chapter in Nigeria's democratic journey — one defined not by retribution, but by reconciliation.

"The Senate cannot proceed with the consideration of the MTEF without first receiving a detailed account of the performance of the 2024 Budget," Senator Musa stated.

"Accordingly, we are giving the Executive up to October 23 to present a documented performance report, after which deliberations on the MTEF will commence."

The Senate reiterated its commitment to fiscal responsibility, accountability, and transparency in the appropriation process assuring Nigerians that due diligence will be followed in all budgetary considerations.

Among those granted posthumous pardon are Nigerian nationalist Herbert Macaulay, co-founder of the National Council of Nigeria and the Cameroons (NCNC); the Ogoni Nine, executed in 1995 under the regime of the late General Sani Abacha; and Major-General Mamman Vatsa, a poet and military officer executed in 1986.

In addition, Farouk Lawan, a former member of the House of Representatives, and several other Nigerians – including Mrs. Anastasia Daniel Nwaobia, Hussaini Umar, and Ayinla Saadu Alanamu – were granted clemency following the recommendations of the Presidential Advisory Committee on the Prerogative of Mercy (PACPM), chaired by the Attorney-General of the Federation and Minister of Justice, Prince Lateef Fagbemi,

Bayo Onanuga confirmed the development in a statement released Thursday, noting that the decision followed the endorsement of the National Council of State which met in Abuja.

The President also extended clemency to 82 inmates across the country, reduced the prison terms of 65 others, and commuted the death sentences of seven inmates to life imprisonment. Furthermore, 959 Nigerians and foreigners were approved for national honours in recognition of their

outstanding contributions to national development.

The statement read in

The PACPM, inaugurated on 15 January 2025 by the Secretary to the Government of the Federation, Senator

George Akume, reviewed 294 applications and interviewed 175 inmates across correctional centres nationwide.

Its recommendations were guided by considerations such as old age, terminal illness, good conduct, and evidence of rehabilitation.

Among the pardoned inmates were Nweke Francis Chibueze, serving a life sentence for drug trafficking, and Dr. Nwogu Peters, who had already served 12 of a 17year term for fraud.

As part of the reconciliatory gesture, the Ogoni Nine – Ken Saro-Wiwa, Saturday Dobee, Nordu Eawo, Daniel Gbooko, Paul Levera, Felix Nuate, Baribor Bera, Barinem Kiobel, and John Kpuine - received formal presidential pardon.

The Ogoni Four Chief Albert Badey, Chief Edward Kobani, Chief Samuel Orage, and Theophilus Orage - were awarded posthumous national honours.

President Tinubu's decision reflects his administration's unwavering commitment to justice sector reforms, rehabilitation, and national healing.

Nigeria and The Growing Burden Of Non-communicable Diseases

cross Nigeria's bustling cities and quiet rural communities, a silent crisis is unfolding — one that kills more people every year than infectious diseases, accidents, or insurgency combined. It is the growing menace of noncommunicable diseases (NCDs) such as hypertension, diabetes, stroke, cancer, and chronic respiratory illnesses. Once thought to be "diseases of the rich," these ailments now cut across social classes, affecting farmers in Benue, teachers in Enugu, artisans in Lagos, and traders in Kano.

According to the World Health Organization (WHO), NCDs account for nearly 30% of all deaths in Nigeria, a figure that continues to climb each year. Yet, the country's health system remains largely structured to fight infectious diseases such as malaria, tuberculosis, and HIV/AIDS — leaving a dangerous gap in the prevention and management of lifestyle-related illnesses.

Paradoxically, the rise of NCDs in Nigeria is not only a result of affluence but also of poverty. Across many low-income communities, people consume cheap, processed foods loaded with sugar, salt, and unhealthy fats. The once vibrant culture of eating fresh fruits, vegetables, and locally prepared meals has been eroded by urbanization and the proliferation of fast-food outlets.

"Most Nigerians today eat to fill the stomach, not to nourish the body," says Dr. Tunde Akinyemi, a public health physician based in Ibadan. "We are living fast, eating fast, and dying fast. Obesity, hypertension, and diabetes are now common even among people in their 30s."

Compounding the problem is a sedentary lifestyle. Many Nigerians spend long hours in traffic, at desks, or on their phones, with minimal physical activity. The result is a population gradually losing its vitality — one in which stroke, heart attack, and kidney failure are increasingly common among the young and middle-aged.

The economic and social costs of this health transition are staggering. A 2023 report by Nigeria's Federal Ministry of Health estimates that productivity losses due to NCDs exceed \$\pi\$\$ trillion annually \$-a\$ figure equivalent to nearly 2% of the nation's GDP. Families are pushed into poverty by the cost of managing chronic diseases, which require lifelong medication and regular checkups rarely covered by health insurance.

For example, the average hypertensive patient spends between □15,000 and □30,000 monthly on drugs and clinic visits. For a diabetic, the figure can double. "Many patients simply stop their medication because they can't afford it," explains Nurse Amaka Eze, who works at a general hospital in Abia State. "By the time they come back, their condition has worsened. Some die quietly at home."

This reality highlights another critical flaw — Nigeria's weak primary healthcare system. Most local health centres lack the equipment and expertise to diagnose or monitor NCDs. Many rural clinics do not even have functioning blood pressure

monitors, let alone facilities for blood sugar or cholesterol testing. Consequently, millions of Nigerians live with undiagnosed conditions until complications set in.

Urban residents are not spared either. While major cities like Lagos, Abuja, and Port Harcourt boast private hospitals and diagnostic centres, these services are largely unaffordable for the average citizen. Health insurance coverage in Nigeria remains below 10%, and even among the insured, the benefits are often limited.

sugary drinks and junk food through aggressive advertising has further normalized unhealthy habits.

"Many young people now think it's cool to skip breakfast, survive on energy drinks, and eat late-night shawarma," laments Dr. Bimbo Olawale, a Lagos-based nutritionist. "But the body keeps score. These habits plant the seeds of disease early."

Mental health challenges — anxiety, depression, and drug dependence — also play a role, creating a vicious cycle between emotional distress and physical illness.

"The urban poor are at high risk," notes Professor Amina Yusuf, a lecturer in Community Health at the University of Abuja. "They are surrounded by processed food, pollution, and stress — yet they lack access to preventive healthcare. Meanwhile, those in rural areas are battling ignorance and lack of facilities. It's a lose-lose situation."

Perhaps the most alarming dimension of the crisis is the growing vulnerability of Nigerian youth. Studies have shown a sharp increase in obesity, hypertension, and prediabetes among young adults, driven by poor diet, alcohol consumption, and substance abuse. The glamorization of Experts agree that reversing the tide of NCDs in Nigeria will require more than individual discipline — it demands a systemic policy overhaul. The National Policy and Strategic Plan of Action on NCDs, first introduced in 2013, has suffered poor implementation due to inadequate funding and weak political will.

What Nigeria needs, according to health advocates, is a multi-sectoral approach:

Taxation and regulation of sugary drinks and tobacco products.

Public health campaigns to promote exercise and healthy diets.

School-based programs that teach nutrition and physical education.

If urgent action is not taken, the silent epidemic of non-communicable diseases could become our next national emergency.

Workplace wellness initiatives in both public and private sectors.

Increased budgetary allocation for preventive healthcare and NCD management.

"The government must treat this as a national emergency," insists Dr. Emmanuel Oche, a cardiologist at the National Hospital, Abuja. "We have focused too long on curative medicine. Prevention is cheaper and more sustainable."

There is, however, a glimmer of hope. The rise of digital health startups and mobile-based monitoring solutions is helping bridge some gaps in access. Apps that track blood pressure, sugar levels, and medication adherence are increasingly popular among tech-savvy Nigerians. Telemedicine platforms now connect patients in remote communities to specialists in urban centres.

Moreover, community-based programs led by NGOs and faith-based organizations are gaining traction. Initiatives such as free medical outreaches, lifestyle seminars, and health walks are helping to raise awareness. Yet, as observers note, these efforts must be scaled up and sustained.

Health, as the saying goes, is wealth—and no nation can rise above the health of its citizens. Nigeria's journey toward sustainable development cannot be complete without addressing the burden of non-communicable diseases. The time has come for government, civil society, the private sector, and individuals to act in concert.

Citizens must adopt healthier lifestyles: eat balanced meals, exercise regularly, avoid smoking and excessive drinking, and go for periodic health checks. Communities must organize health awareness campaigns, while policymakers must enact and enforce laws that promote wellness.

As Dr. Tedros Ghebreyesus, Director-General of the WHO, once said, "No one should have to choose between death and financial ruin because of a disease they could have prevented." For Nigeria, that message is more urgent than ever.

Abia LP House of Reps Caucus Slams Ben Kalu over 'Unguided Utterances' Against Otti

bia Labour Party [LP] H o u s e of R e presentatives Caucus has condemned what it described as the "unguarded and unhealthy utterances" of the Deputy Speaker of the House of Representatives and member representing Bende Federal Constituency, Rt. Hon. Benjamin Kalu, warning that his actions threaten the peace and unity of the state.

In a press statement issuedrecently, the caucus said it was dismayed by "a recent unfortunate political development in our dear state, Abia," allegedly triggered by Ben Kalu's comments and conduct.

The lawmakers recalled that in 2024, when newly elected officials were still settling down to governance, Hon. Kalu "fired the first political salvo," boasting that the All Progressives Congress (APC) would "capture Abia" in

2027 and "flaunting his 'number six' position in the federal hierarchy as if political power were a personal trophy".

According to the caucus, "Such careless talk, repeated shortly after assuming office as deputy speaker was not only unintelligent and insensitive but also unbecoming of a public officer who ought to embody humility and emotional intelligence".

The group accused the deputy speaker of exhibiting "arrogance and recklessness," making "provocative, sycophantic and inflammatory statements both publicly and privately," which they said were aimed at "inciting the Federal Government and the ruling party at the centre against the Abia State Government".

The lawmakers alleged that Hon. Kalu's recent political moves were "not about service, they are about personal ambition and power-drunk tendencies, even at the expense

of peace of Abia State".

They emphasised that Governor Alex Otti "has consistently shown respect for both the age and the exalted office of Mr. President", and therefore, Ben Kalu "is expected to accord due respect to the governor, not only in recognition of his office as the State's Chief Executive but also in deference to his age, in keeping with Igbo cultural values and proper upbringing".

The statement noted that despite differences in party affiliation, Governor Otti had extended goodwill to Hon. Kalu upon his emergence as deputy speaker by hosting an elaborate state reception in his honour, attended by Labour Party officials and federal legislators.

It added that the governor had also directed all Abia LP members in the House to support Kalu's emergence for the position.

"This co-operation should have been reciprocated by Hon. Kalu. Sadly, he has chosen instead to stoke the embers of political disharmony in Abia", the lawmakers lamented.

The caucus advised Kalu to engage in "sober self-reflection", reminding him that "many have occupied and will still occupy that seat, decorum, not arrogance, defines true leadership."

They commended governor Otti's performance, highlighting numerous federal projects facilitated and executed by his administration, including Port Harcourt Road, Ohafia-Arochukwu Road, Omenuko Bridge, and the 25 km Umuahia-Ikot Ekpene Road, soon to be flagged off'.

The caucus urged Kalu to use his influence as deputy speaker and his much-vaunted "number six" position to support Governor Otti's projects "for Abia's growth, rather than playing cheap politics in his six years as a member of the House of Representatives".

They added; "If the massive public endorsement of Governor Otti's achievements, witnessed recently in Aba as applauded by the president who was ably represented by Distinguished Senator David Umahi and the good people of Abia at the flagoff ceremony unsettles Hon. Kalu, that is no justification to pursue mischief and incitement".

"If he persists on this trajectory, he may find himself at odds with Ndi Abia. Abians and Nigerians are hereby urged to disregard Hon. Kalu's empty boasts and divisive rhetoric. His actions are driven by selfish ambition, not love for the people".

The LP House of Reps Caucus reaffirmed their support for Governor Otti, noting that "no amount of political scheming by Hon. Kalu can disrupt Abia's steady progress, the people of Abia "are politically discerning" and can see through "Hon. Kalu's selfish antics."

They, therefore, called on Abians from all works of life irrespective of political affiliation to stand united in support of the transformational work of Governor Alex Otti "and to reject attempts by any individual to drag the state backwards for personal gain".

Calls Grow For Probe As Fubara Threatens To Punish Erring Officials

ebate continues to intensify in Rivers State following Governor Siminalayi Fubara's recent warning that permanent secretaries who allegedly aided illegal acts during the six-month emergency rule will face strict numbered punishment.

Governor Fubara said Governor Fubara said recently that his administration will not hesitate to discipline any public officer found guilty of misconduct or administrative irregularities during the interim administration. The statement, which has since generated widespread public interest, is seen by many as a bold move to rectors accountability in the restore accountability in the state's civil service.

In an exclusive interview, a labour law expert, Dr. Emma Wosu, said the governor is constitutionally empowered to discipline erring public officials, provided that due process is observed.

"The governor has the authority to act independently on matters concerning discipline within the civil service. However, such actions must follow proper investigations and align with established civil service rules," Dr. Wosu explained.

Dr. Wosu, a senior lecturer in the Department of Commercial and Industrial Law in Rivers State University, emphasised that the level of punishment should correspond to the gravity of the offence committed.

"It depends on the kind of offence. Some infractions warrant suspension, while others may attract outright dismissal. The most important thing is that the process is fair and lawful," he added.

He further noted that public officers who feel victimized by government action retain the right to seek redress through the

"Anybody who feels wrongly punished can go to court. If a civil servant believes his rights has been infringed upon, the law provides a channel to challenge such decisions," he stated.

Governor Fubara comments have also revived calls from civil society groups and political observers for an

independent probe into the activities of the former sole administrator who governed the state during the emergency rule period. Many residents believe that the investigation should go beyond the civil service and extend to top officials who allegedly benefited from the irregularities.

A social critic, Promise Dappa, urged the governor to include Retired Vice Admiral Bok-Ete Ibas, the former sole administrator, in the probe, saying that transparency and justice demand full disclosure of any wrongdoing.

"He must expose all acts of corruption. Even if he cannot personally prosecute, he should make the findings public so that relevant authorities can take it up. Accountability begins with

truth," Dappa said.

Dappa, however, expressed doubts about the Fubara administration's ability to conduct a fully independent inquiry, alleging that political influence continues to undermine genuine governance in the state

"You cannot have a government that is controlled from somewhere else. A true government should be independent and free from political shackles. What Rivers people need is leadership that represents the will of the people," he remarked. "You cannot have

He lamented that the current political atmosphere in Rivers State reflects deep divisions and growing disillusionment among citizens, many of whom believe their voices have been sidelined

Political analysts have described the unfolding situation as a test of Fubara's political resolve, noting that how he handles the matter could determine his long-term credibility and his relationship with the state's civil service.

Meanwhile, several advocacy groups have called on the government to prioritize transparency and fairness in any disciplinary action to prevent victimization of innocent officers.

As public interest grows, all eyes remain on Government House, Port Harcourt, to see whether the Fubara administration will make good on its promise to cleanse the system or succumble problical pressures. or succumb to political pressures that have long shaped governance in Rivers State.

If not, one wonders what new, better magic of performance the Abuja freebooter has to offer that he badmouths Governor Otti so disrespectfully and turns himself into a national disgrace to Ndi Abia? Surely, the escalating gutter antics of the rampaging raider raise alarm bells for Ndi Abia, who must be ready to resist his self-serving theatrics and sinister plans to rig himself into Umuahia Government House in 2027.

By the way, when we shift attention from petty party politics of whether Abia State should be under Labour, PDP, APGA or APC flag and focus on the personality, integrity and quality of leadership, the noisy desperado is the most unfit. The 54 years old lawmaker's journey from relative obscurity to his current unearned, undeserved Deputy Speaker status has been a public knowledge in Abia. But he has chosen to behave like the proverbial Nza bird from Chinua Achebe's "Things Fall Apart," whose unbridled ambition leads him to fly too high and overreach binself

Yet, another instructive proverb from "Things Fall Apart" aptly depicts their ilk: "Those whose palm-kernels were cracked for them by a benevolent spirit should not forget to be humble." The man was helped to his present status by a former governor of Abia State whom he has paid back with brazen ingratitude, hubris and treachery. Today, he has leveraged his position to elevate himself alone while neglecting even his direct constituency in Abia. A review of his tenure so far reveals a wide gap in tangible contributions to Bende, the constituency he represents in Abuja, despite the humongous salaries, allowances and perks he draws. This then raises the question of how he has metamorphosed into a self-styled critic of a governor who is actively doing the work of

Thus, it can be seen that the pirate's flailing attempts to vilify Governor Alex Otti emanate not from a place of concern for the state's progress but rather a hunger for power that threatens to plunge Abia back into the shadow of neglect. As earlier hinted, the desperado cloaks his ambitions with the guise of wanting to support President Bola Tinubu and the APC in their quest for electoral dominance in Abia, but this veneer falters under scrutiny. It is evident that his motivations are steeped in his own self-interest rather than genuine service to the people of Abia or even APC. His relentless opportunist forays into Abia's political space, replete with reckless threats and brash accusations, factor more into a strategy of anti-progress mischief than that of a visionary leader.

As vigilant, intelligent citizens, it is imperative that Ndi Abia remain alert to the machinations of politicking cloaked in mischief. As for the desperado, he would do well to return his attention to the duties he presently occupies in Abuja to help President Tinubu solve urgent national challenges of extreme poverty and insecurity still afflicting Nigerians, instead of continuing his nuisance to undermine a performing governor.

When 2027 comes, it is the Abia people who will decide with their votes whether Governor Otti should continue or quit, not a self-appointed messiah from Abuja. But if the push comes to shove, the incumbent governor can play the political game with gloves off. At the same time, H.E. Dr. Alex Otti as our reformer in the driver seat now is at liberty to decide on which vehicle that can take us to the Promised Land and Abians will join him. As someone well known to President Tinubu long before he became president, Governor Otti has the flexibility to play his cards. What we expect of him is a responsibility to reassure the Abia people that their mandate will be defended by all means fair and decisive, so that they are not cowed to surrender to bullying. Renegades should not be allowed to overrun the media space with their boastful grandstanding and rabid hyperventilation to unseat the governor. Neither should we play laid-back gentlemen and watch them play their hatched plans to rig the election via bribing voters, snatching ballot boxes, compromising INEC officials and unleashing violence to steal victory.

He appealed to Governor Alex Otti (OFR) to continue engaging other South East governors and relevant authorities toward a just and compassionate resolution of Kanu's case.

The Deputy Speaker further urged South East lawmakers and Ohanaeze Ndigbo to sustain peaceful dialogue with the Federal Government, stressing that justice, fairness, and humanity remain vital for peace and stability in the region.



In Group A, hosts Morocco will face Brazil, Italy, and Costa Rica. Group B features defending champions North Korea alongside Mexico, Cameroon, and the Netherlands.

In Group C, the United States will battle Ecuador. China, and Norway, while



Nigeria will confront Canada, France, and Samoa in Group D.

The most successful side in the history of the competition, Spain, will play in Group E against Colombia, South Korea, and Ivory Coast. Meanwhile, Group F will see Japan, New Zealand, Zambia, and Paraguay fight for qualification to the knockout VOL. 28 NO. 017

Abia's 1st International Para Badminton Championship: Nigerian Players Shine

The first Abia International Para Badminton Championship has ended, with Nigeria's Paralympic bronze medallist, Eniola Bolaji, emerging champion in the Women's Singles SL3 category.

The tournament, which concluded recently at the International Conference Centre, Umuahia, saw Bolaji-ranked second globally in the SL3 category by the Para World Badminton Federation – defeating Cameroon's Danyele Mouafo 2-0 (21-7, 21-3) to claim the top prize.

In the Men's Singles SL4 category, Nigeria's Jeremiah Nnanna, Africa's number one in that class, outclassed his compatriot Yahaya Ayuba 2-0 (21-9, 21-8) to secure gold. Mary Nathan added gold for Nigeria after beating Brazil's Juscileia Silva 2-1 (5-21, 21–18, 21–17) in the Women's Singles WH1 event.

Nigeria finished with three gold, four silver, and nine bronze medals, placing fourth on the medals table. Nigeria's silver medallists included Jeremiah Nnanna, Obinna Nwosu, Chinyere Okoro, Yahaya Ayuba, and Ijeoma Chukwuemeka.

Brazil topped the medals table with seven gold, three silver, and five bronze medals, followed by India with six gold, five silver, and 14 bronze. Peru came third with six gold, three silver, and two bronze.

A total of 114 players from 14 countries competed in 19 sporting events. Participating countries included Brazil, India, Peru, Egypt,





Tunisia, Burkina Faso, Rwanda, Cameroon, Zimbabwe, DR Congo, Mauritius, Mozambique, and host nation Nigeria.

Speaking at the closing ceremony—which also marked the opening of the All Africa Para Badminton Championship, Governor Alex Otti congratulated the winners and commended all participants.

Governor Otti described the

championship as "the first of its kind in Nigeria and in West Africa. reaffirming his administration's commitment to inclusiveness and empowerment for persons living with disabilities.

"I want to congratulate those that won awards and medals in this competition – the first of its kind, I'm told, in Nigeria, even in West Africa. For us in Abia State, our mantra is inclusion. And that's one of the

reasons why we offered to host vou. If vou are anywhere and vou don't pay attention to inclusion, then you are not getting it right," the Governor said.

The Governor drew inspiration from the story of John Faulkner, a limbless motivational speaker, and challenged the athletes to always give their best regardless of their circumstances or physical

"You have no excuse not to do what others are doing; and for us in leadership, we have no excuse not to provide opportunities for people who are born with one little problem or challenges.
Therefore, it gives me great
pleasure that you have come and
demonstrated that these little challenges will not stop you from participating in sports," he added.

Governor Otti also revealed that Abia State's request to host the

second edition of the championship has been approved. He further announced a \$50,000 support package for participating countries, to be disbursed through the State Ministry of Youth and Sports Development.

In their separate remarks, the Chief Executive Officer of the Badminton Confederation Africa, Mr. Jeff Shingoli, and the President of the Badminton Federation of Nigeria, Mr. Francis Orbih, commended Abia State and Nigeria for hosting the historic championship.
In his address,

Commissioner for Youth and Sports Development, Mr. Nwaobilor Ananaba, noted that under Governor Otti's leadership, Abia is fast becoming a destination for sports tourism and international sporting excellence.

The Commissioner lauded Governor Otti for his vision, unwavering support, and provision of the necessary resources that ensured the success of the event. adding that the Governor has once again demonstrated that sports play a vital role in promoting inclusion, unity, and development.

"Governor Otti's vision and

unwavering support have indeed, made this dream come true. Through the provision of world-class

facilities, including Nigeria's first wheelchair para badminton mats, access to transport, local flights, and other logistics, His Excellency has demonstrated once again that sports are instrumental to inclusion, unity, and growth. As we close this historic first edition, we open another—the All Africa Para Badminton Games—which begins tomorrow. It is a powerful reminder that sports never stop, and that Abia is becoming a destination for sports tourism and international excellence," Ananaba noted.

In a vote of thanks, the Second Vice President and National Co-ordinator of the Badminton Federation of Nigeria, Mr. Ekeoma Samuel, commended Governor Otti for making history as the first Governor in West Africa to host an international para badminton event.

He noted that the mats used for the tournament were the first wheelchair-accessible badminton mats in West Africa, procured by the Abia State Government. He also thanked the Governor for providing a wheelchair-accessible bus for persons with disabilities.

"Your Excellency, you are the only Governor that has produced a wheelchair-accessible bus that can carry persons with disabilities without dehumanisation. On this note, we are proud of you," he stated.
