MOUAU, UNIZIK **Approve Amnesty**

for Stranded Students By Chukwuemeka Egejuru & Ikechukwu Chinaza

The Senate of Michael Okpara University of Agriculture, Umudike (MOUAU), has approved a one-year academic amnesty to enable stranded students complete their programmes and graduate, following years of administrative and academic challenges that hindered their completion.

The approval, communicated via a memo dated October 30, 2025, from the Office of the Registrar and signed by Dr. M. A. Agbai for the Registrar, with

MOUAU/R/SEN/26A/VOLI X, followed the institution's 253rd Senate meeting held on October 2, 2025, at the University Senate Chamber, Umudike.

According to the resolution, the amnesty window, covering the 2025/2026 academic session, will allow affected students to regularize their academic records, complete outstanding courses, and process their graduation under the BMAS curriculum through which they were originally admitted, ahead of the full transition to the CCMAS curriculum.

The Senate stressed that the gesture aligns with the university's values of fairness and inclusion, noting that only students with no record of examination misconduct or disciplinary actions will benefit.

A senior Senate member described the decision as "a historic and humane gesture," adding that the university sought to restore dignity to students who had spent years awaiting resolution.

The Ministry of Foreign Affairs has reaffirmed Nigeria's commitment to leveraging opportunities across multiple sectors of the global economy during the 2025 G20 Summit in Johannesburg, South Africa. Ambassador Bolaji

"This is more than a policy decision, it is a moral intervention. We are giving deserving students a second chance to redeem their years of effort," the official said.

For years, several students who completed their coursework were unable to graduate due to missing results, outdated course codes, administrative issues. counseling processes to

Some reportedly matriculated as far back as 2005 to 2018, remaining stuck in the system.

Following the approval, the Registrar has been directed to issue detailed guidelines for implementation, while Deans and Heads of Departments will compile and verify the lists of eligible students. The Directorate of Academic Planning will coordinate advisory. other registration, and

support returning students.

The development has sparked relief among affected families, many of whom described the move as a "long-awaited miracle."

"We've prayed for this day," one parent said. "Finally, our children can complete what they started. It's hope restored."

The amnesty year, which takes effect in the 2025/2026 academic session, is considered one of the most student-centered reforms in MOUAU's history, combining compassion with institutional renewal.

In a related development, Nnamdi Azikiwe University (UNIZIK), Awka, has also approved an academic amnesty programme for students who have exceeded the maximum duration of their studies

The meeting follows Trump's recent remarks accusing Nigerian authorities of failing to adequately protect Christian communities from violent attacks. Trump warned that the United States could consider cutting aid to Nigeria and even hinted at possible military action if what he described as "targeted killings" continue.

In response, the Nigerian Presidency reiterated its commitment to addressing insecurity and protecting all citizens, regardless of religion.

Bwala further recalled that during Trump's previous tenure, the U.S. approved the sale of military equipment to Nigeria—a partnership the Tinubu administration continues to leverage in its anti-terror operations.

Adamawa, **Consortium**

he Adamawa State Government has teamed up with the Malaria Consortium to start a programme that will give medicine to children to protect them from deadly diseases.

According to the News Agency of Nigeria (NAN), the plan aims to reach about 1.1 million children across the state.

Mr. Benjamin Gubi, the Programme Manager of the Adamawa Malaria Elimination Programme, shared the details on Saturday in Yola during a meeting on the training of health workers for the exercise.

He explained that the medicine, Azithromycin, is a commonly used antibiotic in Nigeria. It helps treat and prevent illnesses such as pneumonia, diarrhoea, and malaria-related infections. which are the main causes of death among children under five years old. The event, themed Strengthening Communication and Collaboration for Effective Azithromycin MDA,' focused on the importance of community awareness, partnerships, and media support to make the programme successful. The programme targets children aged one month to 59 months and aims to reduce deaths from pneumonia, diarrhoea, and m a l a r i a . "The campaign will take place in all 21 local government areas, 226 wards, and communities in the state. It will be carried

out house-to-house using the state's existing health structures About 1,500 trained health workers and 6,500 community volunteers will take part in the four-day exercise from November 21 to 25," Gubi said. He added that the goal is to reduce child deaths and improve child health by preventing common infections. The programme was first tested in six states in 2021 and is now being expanded to 11 states across Nigeria.

Gubi noted that there were very few side effects during earlier rounds Mr. Abubakar Isa from the Malaria Consortium said the project is supported by the Bill & Melinda Gates Foundation, the Nigerian Institute of Medical Research, and other partners. He added that the programme fits into the state's Seasonal Malaria Chemoprevention (SMC) plan and will use syrup forms of the medicine for easier use by children. Dr. Lucky Daniel, Adamawa Coordinator for

Neglected Tropical Diseases (NTDs), said the project is called SARMANA 2, meaning Safety and Antimicrobial Resistance of Mass Administration of Azithromycin in Children Nigeria. i n He stressed the need for media and community involvement to build awareness and support. He also said the programme will monitor how bacteria respond to the medicine to make sure children don't develop resistance to it. Dr. Daniel emphasized that

the project belongs to the people and government of Adamawa, while partners will provide technical and logistical help to ensure s u c c e s s . The NAN reports that the community-based child health project is jointly carried out by the Malaria Consortium, the Adamawa State Ministry of Health, the National Primary Health Care Development Agency, and the National Agency for Food and Drug Administration and Control (NAFDAC).

Michael Okpara University of Agriculture, Dr. Ogbonnaya Onu Polytechnic etc, a lot of students have access to tertiary education—but their challenge has often been funding. The NELFUND scheme eliminates the financial uncertainty that too often stands between a student and graduation.

However, some students and parents often express skepticism about government loan programs, fearing bureaucratic traps or future debt burdens which often limits enrollment into the programme.

However, NELFUND is unique as its structure; repayment only begins two years after the beneficiary completes the National Youth Service Corps (NYSC) and secures employment. This repayment plan is tied to income, making it fair and manageable. There are also legal safeguards to ensure transparency.

It is against this background that we urge our needy students to embrace the scheme.

School Administrators, Traditional rulers, Youth Organizations, Churches, and Community Leaders in the Southeast should assist to raise awareness about the NELFUND loan scheme. Guidance counselors should help students understand the application process, and local governments must work with institutions to ensure no eligible student is left out due to ignorance or misinformation.

Parents must also see this loan not as a burden but as an investment in the future of their children. Students, especially those from low-income backgrounds, should seize the opportunity of NELFUND with both hands. The days of dropping out due to tuition difficulties can finally come to an end—if we act.

NELFUND is not just a policy; it is a chance to rewrite the story of education in Abia State and the entire Southeast. It is a chance to equip the next generation with the knowledge and skills to lead, innovate, and transform our region and nation. Let no student be left behind. Let no dream be deferred because of poverty. The time to act is now.

By and large, intimate partner violence presents stalking sexual and physical violence, and psychological aggression by a current or former partner

Globally, domestic and family violence is difficult to identify, and many cases go unreported to health professionals or legal authorities.

Finally, with the prevalence of domestic and family violence in societies, the healthcare professionals including psychologists, nurses, pharmacists, dentists, physician assistants, nurse practitioners, and physicians, are to join hands to evaluate and possibly treat a victim or perpetrator of domestic or family violence.

The Bible describes Moses as the meekest man in the earth; as a result, he had access to the ways of God (Numbers 12:3; see also Psalm 103:7). Kalu Urges Stronger Parliament-Judiciary Collaboration

eputy Speaker of the House of Representatives, Hon, Benjamin Kalu, has called for closer cooperation between the National Assembly and the Nigerian Bar Association (NBA) to improve Nigeria's justice system and restore public trust.

Kalu made the call recently when he received an NBA delegation led by its President, Mazi Afam Osigwe (SAN), at his office in Abuja.

He said the 10th House of Representatives has made justice reform a key priority, using bills, motions, and oversight to promote transparency, efficiency, and accountability in the judiciary.

"The House is working to rebuild public confidence through inclusive, evidence-based reforms," Kalu said. "We are engaging stakeholders on bills that ensure timely justice, expand court capacity, improve pay for judges, and strengthen trust in the system.

As Chairman of the House Committee on Constitution Review, Kalu said the ongoing constitutional amendment process will include input from legal experts, the judiciary, and civil society. He praised the NBA for defending constitutional rights, promoting human rights, and upholding the rule of law.

He referenced the World Justice Project's 2024 Rule of Law Index, which ranked Nigeria 120th out of 142 countries, saying it shows the urgent need for sustained reforms through strong collaboration between the Bar and Parliament.

Kalu listed several reform bills before the House, including:

High Court of the FCT (Amendment) Bill - to add more judges

Judicial Office Holders (Salaries and Allowances) Bill - to ensure fair pay for judicial officers.

Amendments to Legal Aid Council and National Legal Education Acts - to improve access to justice and modernize legal training.

Harmonization of the Constitution (Fifth Alteration) Bill - to strengthen separation of powers and accountability.

"The rule of law is not upheld by courts alone; it depends on a culture of justice that flows from Parliament to the people. When justice works, society thrives," he

Kalu emphasized that effective governance relies on cooperation among the legislature, judiciary, and executive. "The legislature makes the law, the judiciary interprets it, and the executive enforces it all guided by one goal: serving the people," he concluded.

Reps Approve Tinubu's \$2.35bn Loan, \$500m Sovereign Sukuk for Infrastructure Development

he Nigeria House Representatives has approved President Bola Ahmed Tinubu's request to borrow \$2.35 billion to finance part of the 2025 budget deficit. alongside plans to issue a \$500 million debut sovereign sukuk in the international capital market.

The approval came recently following the consideration and adoption of the report by the House Committee on Aids, Loans, and Debt Management during plenary in Abuja.

According to the committee's report, the green chamber endorsed the implementation of a new external borrowing of N1.84 trillion (equivalent to \$1.23 billion) at the approved exchange rate of N1,500 per dollar, to part-finance the N9.28 trillion deficit in the 2025 Appropriation Act.

Earlier this month, President Tinubu sought legislative backing for the borrowing plan in accordance with Sections 21(1) and 27(1) of the Debt Management Office (Establishment) Act, 2003, which require National Assembly approval for all new loans and refinancing arrangements.

The President explained that the funds would be sourced through one or a combination of instruments, such as eurobonds, syndicated loans, or bridge financing, depending on prevailing market conditions.

Tinubu stated that the pricing of the proposed eurobonds would align with yields on Nigeria's existing nationwide. international bonds, which currently range between 6.8 and 9.3 per cent, depending on maturity.

On the proposed \$500 million sovereign sukuk, the President said the initiative would help diversify Nigeria's investor base, broaden funding sources, and deepen the domestic government securities market.

He recalled that the Federal Government had successfully raised over N1.39 trillion through domestic sukuk issuances between 2017 and 2025, which funded major road and infrastructure projects

The proposed international sukuk, he complement domestic part global investors.

"It is imperative to open new sources of Government and to deepen the FGN securities market," President Tinubu said in his letter to the House.

Reps Push for Digital Civil Registration

he House of Representatives has called for a modern, technology-based system to register births, deaths, marriages, and other important life events across Nigeria. The goal is to improve national planning, social services, and security.

The call was made by the Speaker of the House, Rt. Hon. Abbas Tajudeen, during a public hearing on a new bill to update the Births, Deaths, etc. (Compulsory Registration) Act. The Speaker was represented by Hon. Godwin Offiono (PDP-Cross River). He said the new law would modernize Nigeria's civil registration system using digital tools to collect and manage data.

"Accurate and timely registration of births, stillbirths, deaths, marriages, and other important events is very important for national planning and good governance," Abbas said. "The current law was made for a time before digital tools and modern data systems existed."

He added that Nigeria's growing population and the need for databased decisions make a digital registration system necessary. The new system would reduce fraud,

prevent duplicate records, improve identity management, and make it easier for people to get certificates anywhere in the country.

Hon. Odimayo Okunjimi, Chairman of the House Committee on Population, said the current system is outdated and not suitable for today's technology-driven world.

"Without reliable registration and data, the country cannot plan properly or provide social services," he said. "This bill will create a modern, unified system that meets today's needs and prepares for the future."

The bill aims to create one national system for registering births, deaths, marriages, divorces, adoptions, and other important events. It will also clarify the roles of the National Population Commission (NPC), state registries, local governments, and relevant ministries

Okunjimi said modernizing the registration system is very important. 'It will strengthen identity management, improve governance, enhance national security, and provide a solid foundation for data-driven development," he said.

Biya, Okpebholo And The New Service Chiefs

They say President Paul Biya has been declared winner of the presidential election in Cameroon. The man has been in power since 1982. At 92, he is the oldest president in the world. Now that the Constitutional Court has given him another tenure of seven years in office, it means he will be president till almost 100. What exactly is wrong with us in Africa?"

"It means Paul Biya is likely to die in office. What you have in Cameroon is not a democracy. It is a monarchy. It is a mockery of democracy. You asked the right question. Truly, something is wrong with us in Africa. We are not okay at all. Do you know that Paul Biya only showed up once to campaign? African dictators have adopted a new style. They campaign with effigies. Biya did it in Cameroon. Museveni has done the same in Uganda. It was his effigy going about waving to the people. He is so sick, so big, so disoriented he even says it is the Gen Z youths that want him in power. You can be sure he too will be declared winner. In Cameroon, how can a man who never campaigned for votes win 53.66% of the votes?"

"Will he get away with it? Where are the people?"

"Paul Biya has been getting away with impunity since 1982. He is likely to get away with it. But this may also be the beginning of his end. On Sunday, the people took to the streets in Yaounde, Garoua, Maroua, Douala, Maiganga, Yagoua, Kaele, and Bafoussam. Four persons were killed. About 30 opposition politicians and activists have been arrested and detained. There is tension in Cameroon. Tchairoma Bakary, leader of the main opposition party who leads the Front for the National Salvation of Cameroon party and the Union for Change, has threatened that he would not accept a stolen vote and that his party won the election. He has called on the people to defend their mandate."

"That is a familiar response. If Bakary is not careful, he will be arrested and detained for challenging the Constitutional Court. Bakary used to be the spokesperson and spin doctor for this same Biya. He was Communications Minister for ten years, 2009 to 2019. He helped to create the Cameroonian monster. The establishment will find an excuse to arrest and jail him."

"But the people. Democracy is about the people."

"They have started killing the people. Maybe there will be sustained protests in the separatist Anglophone regions and heightened Boko Haram insurgency in the Far North. But Biya will have his way."

"We pray that God should intervene and save the people of Cameroon from Biya's bondage."

"Whatever happens, I think we should worry more about the future of Cameroon. After Paul Biya, what next? The country is already on its knees. Corruption. Violence. Bad governance. Biya does not want peaceful change. He seems to be stoking the fire of violence. It is just unfortunate that most adults in Cameroon have never known any other leader."

"I don't think the Nigerian government should congratulate him. President Tinubu must stay away from his inauguration. Nigeria must show leadership by sending a strong message to Paul Biya. The African Union and ECOWAS must condemn the theft of the people's vote."

"I beg, leave matter. Nigeria will congratulate. Nigeria will attend. Even Trump will send a delegation. Are you not aware that Trump wants to do a third term in 2028? His strategists are working hard at it. And Trump, who says he is the chief peacemaker in the world, would rather rule the United States forever. This thing is not just in Africa. Trump is the dictator in the United States."

"There is God. Of that, I am sure."

"Stop blaming God. It is all about power. Most leaders have learnt not to take chances. Look at our own President Bola Ahmed Tinubu. He has learnt to seize the moment when he can."

"He will not dare try tenure elongation in this country. It will not work here."

"You can't be too sure. We used to say America is the bastion of democracy. Look at what Trump is doing, and he is getting away with it. The US Government has been shut down for about a month, simply because it is either what Trump wants or nothing else. Canada runs an

advert featuring Ronald Reagan and condemning Trump's tariffs. Canada gets slammed with an additional 10% tariff, bringing the total amount of tariffs against Canada to 45%. I am not even talking about that. I am talking about how President Tinubu has swiftly changed the service chiefs, leaving behind only the Director of Military Intelligence."

"Nobody saw that coming."

"That is power. There was some rumour and speculation about some elements in the military toying with the idea of a coup. Whether it is a rumour or whatever it is, Tinubu has acted swiftly. He has refused to allow what happened in Mali, Niger, Chad, Burkina Faso, Gabon, Guinea Conakry, and Madagascar to happen under his watch. No time for nonsense."

"But you know nobody can try a coup in this country. Democracy has come to stay."

"I don't know what you know. My strong view is that those in positions of authority should pay more attention to good governance and lead the people right. I don't like what is going on in Edo State, for example. If I were from that state, I would hide my face in shame. But I don't know

whether they have enough people in Edo State who are capable of shame." $\sp \sp$

"Their governor is the matter. Governor Senator Monday Okpebholo has given a new definition to the art of sycophancy. He has directed all his commissioners and advisers attending the State Executive Council Meeting, if they are dressed in native attire, to wear the Tinubu Emilokan cap. Whoever flouts the order will be suspended."

"Wonderful."

"He says he owes his election to President Bola Ahmed Tinubu and that he is determined to deliver 2.8 million votes to the president in the 2027 election."

The Blatant Falsehood Against Otti That Ended Ben Kalu's Cosmetic Affection Different individuals colleagues in the National

Dave Umahi, showered profound encomia on him, describing him as "a miracle worker". This is coupled with the massive turnout of Aba residents for the memorable inauguration of the Port Harcourt Road and six other economically strategic roads in Enyimba City. Analysts see the outpouring of genuine admiration and love for the governor by the people during the event as the likely source of BoK's envy, given his rumoured ambition "to take over Abia in 2027".

It was largely believed that BOK's caustic shot at the State Government was a futile attempt to puncture and deflate the governor's fame and also neutralise the far-reaching impact of his massive organic following as lavishly showcased by Aba and Umuahia residents, when the President visited.

That BOK's governorship ambition was heavily threatened by the massive turnout of the admirers of good governance by Gov. Otti's government is not in doubt. Therefore, the only way to shake the table and upset the apple cart for the governor was to blackmail him and his government. That was exactly what BOK and his

fellow treacherous Abians in the All Progressives Congress (APC) had tried to do.

The political implication of the positive outcomes of the President's visit left him not only befuddled and dumbfounded but also depressed and

Hence, rather than expect a retreat, the governor's media team should gear up and expect more venoms from him, going forward - a ceasefire may actually not be in sight.

Those who have followed his political trajectory say that he only acted true to his chameleonic character of changing his colour to suite any situation or circumstance any time, any day.

Otti, in spite of the difference in their political leanings, organised a state reception in his honour shortly after he emerged the Deputy Speaker of the green chamber of the National Assembly.

It was such a colourful, well-attended ceremony, held at the International Conference Centre. But little did anybody envisage that BOK would suddenly balloon and turn around so soon to behave like the "nza", the tiny bird which, in Chinua Achebe's classical novel, "Things Fall Apart", after feeding to its full, would turn around to challenge its "chi" (god) to awrestling contest.

It is curious that his ascension to the exalted

office of the Deputy Speaker of the National Assembly has become nemesis to his political mentors and god-fathers, who he has branded his political adversaries in Abia.

He is presently taunting everyone with his new found political power as the "No. Six Citizen", after the President, Vice President, Senate President, Deputy Senate President, and Speaker. This is like a badge he flaunts and brandishes at every public event East of the Niger.

And the first victim of the presumed power and influence that the office confers on him, unfortunately, is his political godfather, OUK, who mentored and gave him life politically.

In his overbloated ego, he expects OUK to now pay homage and obeisance to him. This is currently the bone of contention between the two prominent sons of old Bende bloc and their different political camps in Abia.

Today, he has wittingly or otherwise extended the list of his victims to include Gov. Otti, whom he claimed to call "De Alle".

during his October media chat at the Government House, Umuahia, the governor formally responded to the attack. And in his characteristic manner, he spoke in measured and firm language that conveyed a simple message, which should expectedly humble and lower BOK from his Olympian height.

The governor said that he had forgiven him as a younger brother but warned that anybody planning to write the 2027 result of the Abia Governorship Election "should first write his will". Simpliciter!!

No doubt, the No. Six Citizen, who ought to know better, scandalously shot himself in the foot with his callous and careless spread of falsehood on the finances of Abia. He should, therefore, be ready to bear the full consequences of his unconscionable action.

Already, he is being hounded and pummeled from different quarters and presently unsettled by the stern reactions trailing his shamelessly uninformed comment. Thus, he now watches helplessly as he crashes from fame to shame, grace to grass and has become isolated and snubbed as a leper in his home State.

Different individuals and groups, including his colleagues in the National Assembly from Abia, have sounded him a note of warning to refrain from his malicious attacks against the governor. The lawmakers described his comments against the Ottiled government as unguarded, unhealthy, careless, unintelligent and "unbecoming of a public officer, who ought to embody humility and emotional intelligence".

It will be in his own interest that he gives heed to those words of wisdom, otherwise he will have his fingers burnt well ahead of the 2027 General Elections.

Abians of means and men of good conscience are unshakably united behind Gov. Otti, who has so far demonstrated an unwavering commitment to transform and bring Abia at par with its neighbouring sister-states, in terms of infrastructure development, after 24 years of suffering and gross underdevelopment.

The people are ever determined to take up the fight on his behalf because they have tasted and are extremely satisfied with him and his governance style and cannot afford again to gamble with their future in the hands of selfish, unreliable, deceptive and mercantile politicians that mutated from the shredded and decimated Peoples Democratic Party into APC.

The development gap that exists between nations is clearly not about the quantity of mineral resources buried beneath its soil or the presence or absence of other natural body of advantages. It is also noble that even in our gratitude, we have clearly not lost sight of the fact that on several scores, we have betrayed the lofty dreams that inspired our fathers to fight for an independent Nigeria. It is my considered view that we are still not too far gone to rediscover the promise of Nigeria and rise collectively to take our place in

Let me on this note, thank the founder of the Oxford Global Think Tank one of our country's brightest exports - Prof Arunma Oteh, for convening this event and for the excellent use of her platform to consistently point us to the right path. May I use this auspicious occasion to specially appreciate this revolutionary amazon for her brilliant and peerless contributions to the holistic development of the human community, especially in Nigeria and across Africa, While it is beyond dispute that the former Treasurer and Vice President of the World Bank has distinguished herself through decades of active leadership and service in development finance, capital market regulation, academia and humanitarian pursuits, her recent gift of a wonderfully-written book, All Hands on Deck: Unleash Prosperity through World Class Capital Markets, reflects, more than anything else, her generosity and belief in the power of ideas to transform nations and

Our route to recovery could actually be found in creating an environment for all of us to thrive - right here in our land. This we can do by rebuilding the system to reward excellence, offer equal opportunity to everyone and create multiple spaces for individuals to live out the full expression of their talents

We may not all agree but on the evidence of what we have seen in the last 65 years of Independence, genuine social and economic development have their foundation in the human mind; without creating spaces where the mind is nurtured and exposed to noble thoughts, bold ideas and a higher philosophy of living, all models of development become illusory. This is where education and the structures of learning come into play. Prof Oteh is an excellent proof that quality education, especially at the foundational level, can make a world of difference in what a child becomes. I would, therefore, insist that the key to unlocking our rich but largely dormant human potential is the restoration of standards and values in the education sector. Beyond recruiting quality teachers, $upgrading\ infrastructure\ and\ instilling\ a\ strict$ culture of discipline in the learning environment, we also have to pay attention to curriculum development

I would like to specially thank the Federal Ministry of Education for the recent changes in basic and secondary education curriculum but as I have learnt in my interactions, developing an excellent body of curriculum is one thing, effective implementation is another, all together. To achieve the outcome that we seek, we have to be prepared to cover the entire nine yards.

The learning process in our schools must be structured to prepare the next generation for the challenges of the environment they are going to live in — not tie them to the world of their forefathers except of course as lessons in history. The products of our school system should embody excellence, capacity for independent thinking and of course, be made

to appreciate that education is only valuable when it is applied to a higher objective.

Prof Arunma Oteh at 60 remains a shining light and a brilliant example of what we are capable of becoming when leadership is driven by the commitment to make an impact. I am immensely proud of what she has achieved in her long career but even then, I know that her best years are still ahead. As the Governor of Abia where she hails from, I often find myself under a lot of pressure to build systems and institutions that would produce more Arunma Otehs.

This is partly the reason we have continued to commit the largest share of our annual budget to the education sector. For the past two consecutive years, 20% of our budgetary provision has gone to the education sector and we are likely to going to remain on that route for the foreseeable future. We have also made education free and compulsory in the whole state. This resulted to a spike in enrollment, which more than doubled in 3 months. We recently recruited more than 5,000 teachers for the public school system and preparations are in place to recruit another batch of 4, 000. We are also committing enormous resources to infrastructure upgrades, security of pupils and teachers and welfare packages to keep the staff motivated.

At the tertiary levels, we are also making diligent efforts to support the holistic development of our students. In the light of the competitive nature of the 21st century environment, the focus in our tertiary institutions has shifted from producing graduates that will be dependent on the system for survival to building leaders who will shape the future of their industries.

Another priority area in our governance outlook is healthcare delivery because it is tied to our broad programme of human capital development. Leaning on the 2001 Abuja Declaration, we have consistently set aside, 15% of our projected annual public expenditure outlay to healthcare development and I am happy to report that the results are beginning to show with improved access to healthcare for everyone, especially rural dwellers. The target is to have a properly equipped and staffed medical facility within a walking distance in all parts of the State.

My expectation will be that all of us will leave here with a new consciousness and a resolute commitment to model excellence in our individual undertakings. May I also encourage us to get copies of Prof Arunma Oteh's wonderful book and digest the important lessons it holds in sustainable wealth creation through knowledge of the capital market and the new leadership paradigmit invites us to.

The truth is we have stayed in the difficult place of mediocrity and for too long. At 65, we should be able to stand firmly on our feet and march forward in an unyielding resolve to pay whatever price is required to actualise the great destiny that our nation has been called to.

Over 2,000 Benefit From Seadogs' Free Medical Outreach

ore than 2,000 poor residents of Afaha Atai in Ibesikpo Asutan Local Government Area, Akwa Ibom State, have received free medical care from the National Association of Seadogs (NAS), also known as the Pyrates Confraternity.

Members of the group, who were in Uyo their 2025 First-Quarter Pyrates Working Council Meeting, also handed over a solarpowered borehole to the community. The project was meant to solve the problem of unsafe drinking water and reduce waterborne diseases.

Speaking at the event, held at Afaha Atai Primary Health Centre, on Friday, the NAS Cap'n (national president), Dr. Joseph Oteri, said the outreach was part of activities marking their quarterly meeting.

He explained that the group chose Afaha Atai because of the high rate of waterborne and communicable diseases there.

'Each of our quarterly meetings is an opportunity to help people in a real way," Oteri said. "We usually visit different communities to find out what illnesses are common and how many people live there. That helps us decide how many drugs to buy and how many medical workers to bring."

Oteri added that NAS started its medical missions in 2011 and has made a big impact in many states. He said their website contains many stories from people who have benefited from the programme.

Also speaking, Dr. Eshiet Ekanem, the Medical Mate of the Sancta Riviera Deck, said his team first visited Afaha Atai and nearby villages - Afaha Etim and Mbietebe - to study their health needs before the outreach.

He said the outreach was planned for about 2,000 to 3,000 people and offered treatment for malaria, typhoid, skin infections, and diseases common among the elderly.

"We found that water

scarcity here has caused more waterborne diseases," Ekanem said. "We brought enough medicine for malaria, typhoid, and skin infections like scabies. We also noticed that around 35% of residents are elderly, with many above 70 years old, so we prepared drugs for arthritis, poor eyesight, and other age-related problems."

He added that the medical team included doctors (optometrists), who carried out eye tests and referred serious cases to hospitals approved by the Akwa Ibom State Ministry of Health.

The Chairman of Ibesikpo Asutan Local Government Area, Evang. Edidiong Inyang, thanked the Seadogs for their kind gesture, describing it as a big help to people who cannot afford healthcare.

While commissioning the renovated solarpowered borehole, Inyang noted that the water facility had been abandoned for years. forcing residents to depend on unsafe water

"This borehole has been abandoned for a long time. Its repair today brings great relief not only to Afaha Atai but to nearby villages too," he

One of the beneficiaries, Mr. Edet Edem, thanked NAS for the free treatment.

"I am verv happy because I could not afford hospital treatment. The Seadogs have brought healing and hope to us," he said.

Another beneficiary, Mrs. Ekaette Udo, a 65year-old widow, said the outreach was a blessing.

"For years, I've been suffering from arthritis and poor eyesight, but I couldn't afford hospital care. Today, the doctors checked me and gave me eye drops and medicine for my joints. I thank the Seadogs for remembering people like us," she said, emotionally.

The outreach is part of its ongoing commitment to humanitarian service. public health, and ommunity development, especially in underserved rural areas across Nigeria.



Bende People Honour Gov Otti, He **Promises More Development**

Trump's Unusual Tariff Strategy Puts America's Allies in a Near-Impossible Situation



resident Donald Trump has made it clear that his favorite method to gain leverage over opponent countries on the other side of a negotiating table is to raise tariffs. It doesn't matter whether the offense is traderelated or not.

If there had been any lingering doubt (and I doubt there was), it was erased when Trump announced last week that he was increasing tariffs on Canada by 10% because he official and by 10% because the didn't like an anti-tariff commercial Ontario aired across the United States. Ontario Premier Doug Ford's TV ad quoted the late former President Ronald Reagan, who in 1987 criticized the use of general tariffs as a weapon of trade policy.

It might seem obvious that there is no direct causal trade link between Ontario's and, by response was hardly a

The Canadian incident shows countries on the other side of the negotiating table with the United States face a near-impossible situation.

First, they must negotiate trade deals by coming to Washington with a transactional mindset: "What can we offer up?'

Second, they must, at the last minute, be prepared for the US president to want more — so they better have something else up their sleeve they can give as an offering.

And there's a third wrinkle: Never mind reciprocal tariffs – the United States is in the business of retaliatory tariffs for seemingly unrelated issues. It means no country can know what decision, policy, or indiscretion will offend Trump, who may retaliate at virtually any time with further

This is uncharted territory. This is uncharted territory, and it is not the normal way of doing business. Traditionally, tariffs have been used to correct a perceived trade imbalance and to protect the home market by making imports more expensive.

What seems clear is that Trump's love of tariffs will ensure they remain at the heart of US economic policy. I see no scenario in which the president, even after having negotiated a trade deal, doesn't reserve to himself the right unilaterally to change his mind, threaten, and then launch a fresh tariff.

Some of Trump's tariffs contain at least a scintilla of geopolitical logic. For example, his decision to punish Lati his decision to punish India with 50% tariffs came because the country is still buying oil from Russia. One could – just about – argue the tariff was supporting some wider, strategic goal in halting the Russia-Ukrainewar.

With others, it remains with others, it remains difficult or impossible to understand the trade purpose of tariffs. Take Brazil's case: Trump thinks it's wrong to prosecute the former Brazilian President Jair Bolsonaro for allegedly plotting to overturn President Jair Bolsonaro for allegedly plotting to overturn an election. Describing the prosecution as "a witch hunt that should end immediately," Trump raised the tariff to 50%, "in part due to Brazilie." "in part due to Brazil's insidious attacks on Free Elections and the fundamental Free Speech Rights of Americans." (The previous tariff had been around 10%.)

According to the Brazilian Specialty Coffee Association, exports of special coffees are now down 70%, and the IMF is warning of a more general slowdown in Brazil's economy

because of the tariffs. The tariff weapon has hit its mark.

Then there's Colombia. After Colombian President Gustavo Petro criticized Trump's bombings of alleged drug smugglers off the Caribbean coast, Trump called Petro "an illegal drug leader" who is "low-rated" and very unpopular. The punishment: cutting off foreign aid and an unspecified increase in tariffs.

For a country where democracy is often fragile at best, the economic disruption from increased tariffs could have devastating political effects.

Trump also imposed steep tariffs on South Africa for its perceived ill-treatment of White farmers and land reforms.

The list goes on. Last week's threat against Canada only confirmed the trend.

After the last few weeks and months, countries have been warned. No one should be surprised if and when the weapon is fired.

So far, the only country that has stood up to Trump and won is China. Xi Jinping has mastered the careful art of letting Trump appear to win while quietly claiming victory at home. Xi played his hand perfectly and came away from perfectly and came away nome their meeting this past week with a reduction in tariffs.

But there's one final vrinkle: The US Supreme Court next week will hear Trump's appeal of two lower court rulings that found his use of tariffs as leverage to be an illegal use of his emergency powers. If the Supreme Court upholds those rulings, Trump's favorite tool could be significantly blunted.

Disney Channels Go Dark On Youtube TV After Media Giants Fail To Resolve Carriage Dispute

isney's been removed from YouTube's pay-TV platform after the two media giants failed to reach a new carriage agreement before the deadline passed.

The blackout will leave subscribers unable to watch content from Disney networks, including ESPN, ABC, Disney Channel, FX, National Geographic, and Freeform.

The two companies remain in talks, although neither indicated when customers can expect programming to

"Unfortunately, Google's YouTube TV has chosen to deny their subscribers the content value most by refusing to pay fair rates for our channels, including ESPN and a Disney

spokesperson told CNN.

"Without a new agreement in place, their subscribers will not have a c c e s s t o o u r programming, which includes the best lineup in live sports anchored by the NFL, NBA, and college football, with 13 of the top 25 college teams playing this weekend."

In its own statement, Google said the decision "directly harms our subscribers while benefiting their own live TV products, including Hulu + Live TV and Fubo."

"We know how disruptive it is to lose channels you enjoy, and we're committed to continuing to work with Disney to reach an agreement," YouTube TV said on X late Thursday.

The blackout should

YouTube subscribers, who for the last week have seen announcements warning of a stalemate. Since last Thursday, Disney has run public messages notifying YouTube TV customers of a possible blackout.

At its core, this has been a showdown over financials.

Disney wants higher carriage fees to reflect the value of its networks, such as ESPN. "We invest significantly in invest significantly in our content and expect our partners to pay fair rates that recognize that value," a Disney spokesperson told CNN.

Meanwhile, YouTube has said Disney's demands would "raise prices on YouTube TV customers and give our customers fewer choices."

Israel Receives Remains Of Two Deceased Hostages Held In Gaza

srael received the remains of two deceased hostages held in Gaza. The remains were transferred to Israel via the Red Cross and taken to the country's national forensics laboratory for identification.

The deceased hostages were identified as Amiram Cooper and Sahar Baruch, according to a statement from the Prime Minister's Office.

Cooper, 84, was one of the founders of Kibbutz Nir Oz near the border with Gaza. He was kidnapped by Hamas on October 7, 2023. His family was notified in June 2024 that he was killed in c a p t i v i t y . T h e circumstances of his death remain unclear, but the Israel Defense Forces (IDF) said he was killed in captivity around February of last year.

Cooper was the last remaining hostage from Nir Oz, one of the communities hardest hit during the initial attack two years ago, whose body had not been returned. We will always remember Amiram as a man of people and of words, a pioneer with values, a person of initiative and ideas who so deeply loved the kibbutz its members," the kibbutz said in a statement.

Baruch, 25, was also taken hostage during the October 7 attack from his mother's home in Kibbutz Be'eri. Baruch's brother

and grandmother were killed in the attack. Two months later, Baruch was killed in Gaza during a failed rescue attempt. "In this difficult and painful moment, we hope the family can find a measure of comfort in the closing of a horrific circle of 755 days and nights," the kibbutz said in a statement.

The transfer leaves the bodies of 11 deceased hostages remaining in Gaza.

"The effort to bring back our hostages continues uninterrupted and will not cease until the return of the last hostage,' the Israeli Prime Minister's Office said in a statement.

The transfer of the remains comes just two days after Israel carried out punishing strikes in Gaza in response to the Hamas killing of an Israeli soldier in Rafah on Tuesday afternoon. The Israeli strikes killed more than 100 Palestinians, including at least 46 children, according to the Palestinian Ministry of Health, marking by far the deadliest day in Gaza since the ceasefire went into effect nearly three weeks

Even so. Hamas and Israel said they were still committed to the USbrokered ceasefire agreement. The transfer of two more sets of remains from Hamas to Israel on Thursday marked the strongest indication yet that the deal had not collapsed, despite the

severe test it faced just days earlier.

US President Donald Trump said that "nothing's going to jeopardize" the Gaza ceasefire. He threatened to "take out Hamas very easily."

The latest transfer appeared to proceed without the issues that have plagued recent attempts to return the remaining deceased hostages from Gaza. announced it was set to hand over one set of remains before saying under Israeli bombardment hours later that it would not transfer

Hamas handed over remains of deceased hostage Ofir Tzarfati, whose body had been recovered by Israel in Gaza two years earlier. Tzarfati was not among the remaining deceased hostages to be returned under the ceasefire, prompting Prime Minister Benjamin Netanyahu to accuse Hamas of a "clear violation" of the deal.

The IDF then released video it said showed Hamas staging the discovery of the remains in Gaza City and turning over the remains to the Red Cross. In a statement, the Red Cross said, "It is unacceptable that a fake recovery was staged when so much depends on this agreement being upheld and when so many families are still anxiously awaiting news of their loved ones.

Atletico Madrid will welcome Union Saint-Gilloise to the Wanda Metropolitano Stadium in their first ever meeting and the first time the Belgian side id meeting a Spanish side.

Boda/Glint will host Monaco in their first ever meeting. Bodø's only previous match against a French team was a 1-1 draw away against Nice in last season's Europa League.

Juventus will take on Sporting hoping to sustain their recent form over the Portuguese side. In their last four meetings, Juventus have won two and drew two.

Olympiacos will lurk horns with PSV Eindhoven. The only meetings between these teams came in the 2020/21 Europa League round of 32, Olympiacos advancing with a 5-4 aggregate victory. Olympiacos are unbeaten in their last seven home games against Dutch teams and will hope to sustain the momentum.

Struggling Tottenham Hotspurs will take on Copenhagen hoping to continue their unbeaten run in their last 21 UEFA competition matches at home

Pafos and Villarreal will battle for supremacy in their first meeting. It will not be a stroll in the park for Villarreal. Pafos have lost just one of their nine Champions League matches this season. The Cypriot side have kept clean sheets in five of their last eight Champions League games.

Qarabag will take on world champions, Chelsea, who are expected to take all three points. These two teams met in the group stage of the 2017/18Champions League, Chelsea following up a 6-0 home victory on Matchday 1 with a 4-0 success in Azerbaijan on Matchday 5. Qarabağ have also lost all their previous seven matches against English teams, the last six without scoring a goal. Anything less than a victory for English side will be a disappointment.

Victor Osimhen will hope to sustain his goal scoring form when Galatasaray storm Amsterdam to take on Ajax. He has scored in seven consecutive

European matches dating back to last season, a total of nine goals overall.

Benficawil host Bayer Leverkusen in a match the German side are expected to win because their host have won only one of their last eight home Champions League group stage/league phase matches

Barcelona will take on Club Brugge as they hope to bounce back to winning ways after that painful 1-2 defeat to PSG. Barcelona won the two previous meetings between these sides in the Champions League, claiming a 3-2 victory at home and 1-0 triumph away in the 2002/03 first group stage.

Inter Milan and Kairatwill be meeting for the first time and this is the first time either club has faced opponents from the other's country. Inter are in top form in Europe as they are unbeaten in their last 17 Champions League home matches. They have kept 11 clean sheets in their last 12 Champions League group stage/league phase games.

Manchester City will welcome Dortmund to the Etihad Stadium. They have won their last 11 matches against German teams in Manchester and they will be



counting on their hit man ErlingHaaland, who scored 86 goals in 89 games for Dortmund before joining City in summer 2022. The Norwegian striker had faced his former club twice in the 2022/23 group stage winning one and drawing the other. He scoring the winning goal in Manchester in the first of those encounters. The Norwegian forward has 37 goals in his 33 Champions League group stage/league phase appearances.

Marseille will take on Atalanta at the Orange Velodrome in Marseille. The clubs' only previous meetings came in the semi-finals of the 2023/24 Europa League. After a 1-1 draw in the first leg in France, Atalanta reached the final with a 3-0 home win. Unfortunately, Marseille are without a win in their last nine matches against Italian teams since a 1-0 home victory against Inter in the first leg of the 2011/12 Champions League round of 16.

Newcastle United and Athletic Bilbao will fight to finish at the Saint James' Park. Nevertheless, the English side need to be very careful as they have lost six of their last nine games against Spanish teams

Also speaking, the Director of Sports in Abia State, Mr Obioma George, described the competition as "competitive, tight, and tough," and expressed optimism that the


volleyball league would return to Umuahia next vear.
