Abia State Governor, Dr. Alex Otti, has warned that Nigeria risks a future of 'guaranteed anarchy", if it fails crude oil.

warning while delivering the 37th Convocation Lecture of 37th Convocation Lecture of the Federal University of Technology Owerri (FUTO), titled, "Economic Development and Sustainability: Beyond Oil, Exploring Alternative Revenue Potential for Economic Growth and Sustainable Development in Nigeria".

The governor said that Nigeria must urgently embrace alternative revenue sources backed by strong political will institutional reforms and largescale investment in human capital in order to secure long term stability.

He argued that Nigeria's over-reliance on oil has over-reliance on oil has crippled innovation, weakened tax systems, stifled other high-potential sectors, and repeatedly derailed development plans that looked

promising on paper.
Governor Otti cautioned that a sudden collapse of oil revenue would throw many states into turmoil adding that what follows would be guaranteed anarchy.

"The objective assessment, a position Usman et al also share, is that without oil revenue, government operations in several states and local governments would come to a grinding halt. If that happens, what follows is guaranteed anarchy".

He attributed Nigeria's

ersistent development persistent development failures not to a shortage of ideas, but to "policy inconsistency, executive indecision and lack of political will", citing Vision 20:2020, the National Industrial Revolution Plan. the Agricultural Plan, the Agricultural Transformation Agenda and Transformation as examples of under-implemented

programmes.

Governor Otti who lamented that Nigeria's GDP per capita "fell from \$1,820 to \$807 in 2025" despite decades of ambitious plans, added or amuluous plans, cooks that the country's tax-to-GDP the deoil.

Governor Otti gave the African average and called for a complete overhaul of the

revenue architecture.

"The tax system in the Country is largely inefficient and dysfunctional. The reason stems from the absence of sufficient knowledge of the power of tax to transform an economy", Governor Otti stated.

The Governor cited Abia's

tax reforms as proof that a trust-based model works, insisting that taxation must be repositioned as "a major instrument of development and not a tool of punitive control".

He recalled that his administration suspended informal sector tax collections for six months in 2023 and

The governor disclosed that entrepreneurs in Abia, now voluntarily pay taxes, "to appreciate the work that is being done", adding that Abia was recently ranked among States with the best fiscal performance for the first fiscal performance for the first

He also criticised decades of neglect in the solid minerals sector, noting that Nigeria's deposits, valued at an estimated \$750 billion have been left to illegal miners and criminal syndicates.

"Our nation may continue to fall short of its revenue target if the precious metals mined here are smuggled into neighbouring countries and sold in the black market with the proceeds going into the pockets of non-state actors", he said.

The governor further noted that despite decades of Agricultural Programmes, 30.6 million Nigerians still face acute food insecurity.

He noted that, in the meantime, the most realistic National Goal in Agriculture is to "ramp up output to be able to feed the population, fight the menace of hunger and create certain categories of jobs," stressing that improved productivity must be treated as an urgent priority.

Governor Otti highlighted Abia's efforts to revive Palm, Rubber and Cashew Plantations, support for small holder farmers and partner with research institutions such as Michael Okpara University of Agriculture and NRCRI

The Governor who emphasised that Nigeria's most valuable asset is not oil or minerals, but its people said, "the biggest resource advantage for our country is not what is buried in the ground, it is in the minds of its over 200 million

He noted that sustainable development requires education, innovation and a well-trained workforce capable of extracting value from other sectors and highlighted that his administration allocates 20% of its annual budget to Education and 15 per cent to Health.

The governor said that the selfish orientation of the present generation has stolen the voices that could have pushed for a better deal for every member of the society and urged Nigerians to rediscover the community-before-self ethos of earlier generations and develop a national mindset that supports accountability, shared responsibility and sustainable economic growth.

Abia State Empowers Poultry Farmers With Modern Skills To Strengthen Food Security

bia State has concluded a three-day capacitybuilding programme for poultry farmers drawn from across its Local Government Areas a concrete step toward scaling up meat production and ensuring lasting food security in the state.

Speaking during the flag off ceremony held at the Abia Agricultural Development Programme Office in Umuahia, the Commissioner for Local Government and Chieftaincy Affairs, Prince Uzo Nwachukwu, explained that the training was designed to transfer globally accepted livestock management practices to grassroots

The aim is to raise standards, amplify production and build a sustainable poultry industry across the state.

As part of the Local Government Agricultural Intervention Scheme in collaboration with the Abia Agricultural Development Programme (ADP) the initiative selected six participants from each LGA (five farmers plus a farm manager), who will represent their communities and cascade knowledge and skills to other

Prince Nwachukwu emphasized that poultry is not the only focus, that parallel trainings in piggery, maggot farming, and pepper cultivation are also ongoing across different centers

He lauded Governor Alex Chioma Otti's strong commitment to agricultural investment and urged trainees to put their new skills into immediate practice for the benefit of their localities.

Contributing, the Permanent Secretary of the Local Government Service Commission,

Mrs. Ezinne Judith Ngwakwe ph.D, encouraged participants to view poultry farming as a robust, lifelong agribusiness venture capable of generating stable income.

Earlier in his address, the Programme Manager, Abia ADP, Mr. Okoro Nleanya Kalu, revealed that beneficiaries would receive starter kits including a foundational number of birds, equipment, and other essentials with plans to establish modern poultry outlets in select LGAs, each will be managed by a trained farm manager.

According to him, the strategy is to build a network of well-trained farmers who will step down the training to others in their communities, thereby expanding the State's livestock production capacity.

During the training sessions, one of the resource persons, Mrs. Angela Nwosu, spoke on the theme 'Poultry Production and Management.'

She emphasized the technical demands of broiler production, stressing that proper site selection, feeding, brooding techniques, disease control, and drug administration are critical to minimizing loss

Other facilitators also offered practical guidance on hygiene, disease prevention, and vaccine administration.

Also, an Agricultural Consultant and member of the Joint Agricultural Intervention Programme, Engr. Stanley Anuforo encouraged households and youths to venture into poultry agribusiness, describing it as a reliable pathway to food security, job creation, and sustainable economic g

The Council with the 2025 theme, "Repositioning Civil Service Commissions in Nigeria, as a Hub of Professionalism in Public Service Human Resource Management", brought out strategic plan to ensure professionalism as the hub of public service in Nigeria.

At the week long event held at the International Conference Centre, Ogurube Layout, Umuahia, Abia State, the Council deliberated on how to reposition the Civil Service Commissions across the Federation.

independence. Other deliberations included, transforming CSCs into hubs of Human Resource (HR) professionalism through enhanced HR processes, technology adoption, performance management and ethical governance, ensuring alignment with national development objectives such as the Renewed Hope Agenda.

The Council which is the highest consultative and advisory platform for strengthening institutional capacity, operational efficiency and governance culture across Federal and State Civil Service Commissions in Nigeria, harped on the need to enhance assertiveness in line with the constitutionally enshrined independence of the Civil Service Commissions, the need to handle political interference and nepotism within the law and regulations through the establishment of comprehensive and strict rules guiding personnel management processes, as well as, advocacy out to educate the populace,

including the politicians.

They addressed staff syndrome, improving remuneration and providing conducive work environment. They prioritized the need for standardise training for all cadres to engender merit-based promotion and career development of civil servants in the face of paucity of training funds, urging state governments to give the State Civil Service Commissions free hand to

Idima Abam People Calls For Peace. Return Of EzeOgo Chukwu Jonah

The people of Idima Abam in Arochukwu Local Government Area of Abia State have expressed sadness over the arrest and detention of their king, Ezeogo Chukwu Jonah, by the Nigerian Police Force. They also condemned the destruction of properties, the killing of innocent people, and political intimidation allegedly carried out by the Red Chamber group led by Sampson Orji and Mike Okorie.

During a recent protest by the people of the Idima Abam. the President General of the Idima Abam Development Union, Arch Dike Patrick Kalu, who spoke to journalists criticized the the detention of their Ezeogo by the police from the IRT Unit Guzape Abuja.He said such detention was against a subsisting court order from an Abia High Court which had granted Ezeogo Chukwu Ionah freedom from any arbitrary arrest.position between two factions of the Umudi Ndiume. This dispute began after the death of the former Ezeogo, Okorie Joshua of Umudi NdiOkorie, in 2022, who had earlier been forced into exile in September 2019 by the Red Chamber.

Arch Dike Kalu further said the accusations made by Sampson Orii and Mike Okorie that Ezeogo Jonah was leading a terrorist group were false and intended to disrupt his leadership.

Speaking during the protest, Mrs. Mary Chukwu Jonah, the wife of the detained king, confirmed that her husband was arrested by the Nigerian Police on November 19, 2025 at Ntigha in Abia State and taken to Abuja the following dav.

The youth leader of the Idima Abam Development Union, Mr. Okorie Oloko, added that Governor Alex Chioma Otti had earlier suspended the activities of the Red Chamber group in Idima Abam due to increased violence, destruction of property, loss of lives, and the kingship crisis.

In their separate accounts, victims of the Red Chamber attacks Cecilia James Iroh, NwanyiSunday Okoro, and Thomas Kalu Okorie appealed to the state government to restore lasting peace in the Community, intervene in the crisis, and release Ezeogo Chukwu Jonah so he can continue his kingship rule in Idima Abam.

Nigeria's New Envoys And The Demanding Road Ahead

igeria's newly nominated diplomats face a world more complex than at any other time in the country's recent political history. Their appointments come at a moment when global alliances are shifting, economic nationalism is resurging, and Africa is redefining its role within the international system. For Nigeria, a regional power contending with domestic economic strain, security challenges, and the urgent need to restore investor confidence; the conduct, competence and clarity of its foreign service representatives have never mattered more.

Diplomatic postings are not ceremonial assignments. They are national strategic missions. Whoever receives Senate confirmation must recognize that they are stepping into roles that demand technical ability, political sensitivity, deep understanding of Nigeria's priorities, and the discipline to balance national interests with global realities.

The first task before the new envoys is to rebuild Nigeria's international credibility. Over the past decade, the country has witnessed fluctuating global perception, shaped by concerns about economic instability, insecurity, inconsistent policy signals and institutional weaknesses. Diplomats must work deliberately to communicate policy direction, reassure partners, and restore confidence in Nigeria as a stable international actor. This requires not just protocol but mastery of economic data, geopolitical intelligence, and country-specific priorities.

Second, the envoys must actively support Nigeria's economic diplomacy agenda. As foreign direct investment in Africa becomes increasingly competitive, Nigerian diplomats cannot afford a passive presence in their host nations. They must champion trade negotiations, market access, technology partnerships, and diaspora-driven investment. Missions should function as economic intelligence hubs—mapping opportunities, guiding Nigerian businesses seeking global expansion, and advocating for fairer bilateral arrangements.

Countries that thrive in the 21st century do so through the deliberate integration of diplomacy and economic strategy. Nigeria's envoys must transition from traditional diplomacy to result-oriented engagement: attracting industries, promoting exports, securing bilateral development programs, and building the country's global competitiveness.

Third, Nigeria's diplomats must help reposition the country within the African and multilateral spheres. The continent is experiencing a realignment: new military governments, rising influence from non-Western powers, and competing development models. Nigeria's voice, once a decisive force through ECOWAS and the AU, has in recent vyears grown quieter. The new envoys must work to rebuild Nigeria's leadership profile by championing stability, democracy, regional economic integration, and conflict resolution. Nigeria's foreign service cannot be reactive; it must reclaim an active, constructive seat at continental and global tables.

A fourth priority is protecting Nigerian citizens abroad. The challenges facing migrants, students, traders and professionals have increased from unlawful detentions to workplace exploitation, xenophobic violence, and human trafficking. Nigerian embassies must no longer be perceived as distant bureaucratic outposts; they should function as accessible support systems. Efficient consular services, regular engagement with diaspora communities, and strengthened bilateral protections must become institutional norms.

Equally important is the need for internal reform within the foreign missions themselves. Many embassies suffer from poor funding, irregular maintenance, outdated equipment and staffing shortfalls. The new diplomats will need to demonstrate administrative competence by ensuring that missions operate with professionalism, accountability, and strategic foresight. Fiscal discipline, transparent management of resources and modernization of embassy operations are essential steps toward restoring institutional integrity.

Finally, the incoming envoys must embody a renewed commitment to national unity and non-partisanship. Diplomacy is not an extension of local political disagreements. It is a national undertaking carried out on behalf of over 200 million citizens, regardless of political affiliation. Nigeria's diplomatic corps must reflect the values of cohesion, discipline, respect for diversity and dedication to national interest above personal or partisan considerations.

The Senate's confirmation process should therefore go beyond formalities. Nominees must be scrutinized for competence, integrity, diplomatic temperament and understanding of global affairs. The stakes are simply too high for appointments to be treated as patronage or rewards.

Nigeria's future in the global arena depends heavily on the quality and character of its representatives abroad. The nation needs envoys who can articulate policy, build alliances, attract investment, protect citizens and elevate Nigeria's standing. The road ahead is demanding, but effective diplomacy remains one of the most powerful tools for shaping the country's destiny.

The task before the new diplomats is clear. The question is whether they will rise to meet it with vision, responsibility and unwavering commitment to the national interest.

Minimizing Fire Incidents This Dry Season

Dear Editor,

Permit me to draw the attention of your esteemed readers to the need to remain cautious this dry season to ensure that the rate of fire incidents is reduced to the barest minimum.

According to statistics released by the Federal Capital Territory (FCT) Fire Service, fire outbreaks in Nigeria show a seasonal pattern, with a significant increase from late November to March, often linked to the dry season and increased bush burning. Monthly data for the FCT showed peak months in January (59 incidents), February (64 incidents), and March (33 incidents).

Therefore, as we enter another peak dry season, it is very important to consider the major causes of fire incidents and what should be done to reduce their occurrence during this period.

Bush burning is one of the major causes of fire outbreaks during the dry season. Most times, no one takes responsibility for such fires, which end up destroying farms and properties worth millions of pairs.

When preparing farmlands, bush burning is an activity many of our farmers still engage in. Unfortunately, they often fail to control the fire, and it eventually overwhelms them and spreads.

Similarly, hunters—during their quest for game—often set bushes on fire and fail to control it, thereby allowing it to go out of control. While this act may help them get more game, it is detrimental to the environment and frequently destroys people's cash crops and properties.

Farmers, hunters, and the general public should be sensitized on the need to avoid bush burning because of its negative effects on the environment. Shrubs cut down for farming can be left to decay naturally to add nutrients to the soil rather than being burnt.

However, if farmers must set shrubs on fire, they should supervise the fire carefully, ensure it does not spread beyond the intended area, and confirm that it has died down completely before leaving.

The Hunters' Union should sensitize its members on the destructive effects of bush burning and develop better hunting strategies. This will help conserve the environment, protect wildlife, and safeguard society from the harmful consequences of uncontrolled fires.

Another cause of fire outbreaks during this season is the storage of flammable materials at home. Constant scarcity of petroleum products during this period makes some people store petrol, gas, and kerosene in their houses.

This act should be discouraged, as its consequences outweigh whatever benefits are derived from it. The government should ensure the availability of petrol, gas, and kerosene this festive season so that people will have no reason to store them at home.

Furthermore, homemakers must be meticulous this period to prevent fire incidents. For instance, those using cooking gas should stay close to the kitchen to monitor what they are cooking and turn off the gas completely when not in use. They should use their sense of smell and hearing to detect leakages and take swift action to prevent fire outbreaks.

Many fire incidents are linked to electricity; therefore, quality electrical materials should be used when building. Additionally, electrical appliances should be used only for their intended purposes. People should pay attention to heating appliances such as electric cookers, pressing irons, and boilers. These appliances use a lot of current and should be plugged into appropriate sockets with the right wiring to support their load.

Electrical appliances should be unplugged and the sockets switched off immediately after use.

When leaving home every day, all electrical appliances should be disconnected and sockets turned off to conserve power and prevent fire outbreaks that may result from power surges.

Finally, a popular saying goes, "Fire is a good servant but a wicked master." Therefore, may we continue to put fire to good use and avoid allowing it to become our master by letting it get out of control, as this is always disastrous.

Ministers Summoned As Lead Poisoning Crisis Worsens In Lagos-Ogun Border Communities

launched a fullscale investigation into the alarming outbreak of lead poisoning devastating Ogijo, a heavily populated community located along the Ogun-Lagos border.

This follows widespread scientific reports confirming toxic contamination linked to multiple used lead-acid monitoring and global battery recycling plants operating in the area.

Consequently, the Senate has summoned the Ministers of Environment, Health, Solid Minerals, and Labour and Employment, as well as the Director General of the National Environmental Standards and Regulations Enforcement Agency (NESREA), to appear before its Committee on Environment and Solid Minerals for an urgent briefing on the unfolding crisis.

According to the Senate, unchecked activities of the factories have escalated into a major public health emergency. Children, women and factory workers are reportedly suffering long-term, lifealtering health conditions motion, Senator Abiru after years of exposure to hazardous emissions.

To contain the crisis, the Senate approved a series of sweeping emergency measures, including:

Immediate deployment of medical teams by the Nigeria Centre for Disease Control and Prevention (NCDC) to conduct free toxicology screenings, blood-lead tests, chelation therapy and long-term treatment for affected

Comprehensive environmental remediation by the Federal Ministry of Environment and NESREA assess contamination

> Establishment of a National Lead Poisoning Response and Remediation Office within the National Emergency Management Agency (NEMA) to coordinate cleanup operations, medical intervention, traceability of exported

> The resolutions followed a joint motion sponsored by Senator Adetokunbo Abiru (Lagos East) and Senator Gbenga Daniel (Ogun East), who warned that Ogijo is now facing "an e n v i r o n m e n t a l catastrophe of global significance." Scientific assessments show contamination levels as high as 186 times above internationally accepted safety standards.

> Presenting the expressed deep concern over the years-long health complaints reported by residents, including persistent headaches, abdominal pain, seizures, memory loss and cognitive decline - symptoms strongly associated with prolonged lead exposure.

> After extensive debate, Senate President Godswill Akpabio directed the Committee on Legislative Compliance to monitor the execution of the resolutions and report back to the chamber within two months.

Senate Demands Clarity From **CBN Over Alleged Non-Remittance** Of N1.44tr Operating Surplus

he Senate has called on the Central Bank of Nigeria (CBN) to give a detailed account of the alleged non-remittance of N1.44 trillion operating surplus to the Federation Account.

The request was made by the Senate Committee on Banking, Insurance and Other Financial Institutions, chaired by Senator Adetokunbo Abiru (APC, Lagos East), during an interface with the apex bank on its 2025 economic performance and projections for 2026.

Abiru said the clarification was necessary to strengthen public confidence in the nation's monetary authorities and ensure full compliance with financial regulations. He stressed that the Auditor-General's query on the unremitted surplus required a "clear, comprehensive and unambiguous" response from the CBN.

While commending the apex bank for Nigeria's improving economic indicators, the senator urged its leadership to sustain ongoing reforms to guarantee a more stable economic environment in

Officials within the ministry note that sustained collaboration between government agencies, reform partners and school communities remains key to achieving long-term goals in the sector. They emphasize that recent successes, such as the NILDS competition victory, illustrate what can be achieved when stakeholders at all levels work in alignment. Furthermore, expansion of supervisory frameworks, reactivation of quality assurance processes and digital documentation of school evaluation reports have been identified as current focus areas for the ministry

Looking Ahead: Consolidating Progress in the Education Sector

The recent series of achievements and activities in the basic education subsector suggests that Abia State is positioning itself for broader transformation. The combination of structural reforms, academic competitiveness and teachercentered development indicates a shift towards sustainable improvement.

As the state prepares for the next round of academic competitions, continues school reforms and strengthens institutional collaboration, education stakeholders say the priority remains ensuring that students receive quality education backed by modern support systems, motivated teachers and improved learning environments.

With infrastructure upgrades ongoing, field mentoring

Tinubu's Ambassadors

o one should be surprised at the level of controversy that President Bola Ahmed Tinubu's ambassadorial list of 35 nominees, whose names have been sent to the Senate for confirmation has generated in Nigeria. Former Ambassadors were recalled in September 2023, and now it has taken two years and two months for the government to announce new ambassadors, against the background of loud protests about the faceoff with US President Donald Trump, over alleged Christian genocide in Nigeria. The alleged Christian genocide in Nigeria. The general argument was that if the government had appointed Ambassadors before now, and the country was represented in the US by an Ambassador Plenipotentiary, not by a junior Charge d'Affaires, the US-Nigeria religious issue may not have escalated so badly. As part of the efforts to address this charge, the administration has now hurriedly due, up. a list and initiated a conversation dug up a list and initiated a conversation about ambassadorial postings. In April 2025, it had been reported that the Federal Government was screening persons to be posted to the country's diplomatic posts. Some of the names reportedly on that old list, are now in the list that has been made public. in November 2025. Perhaps if there had been no diplomatic issues with the United States, we would still have been waiting for Godot.

Ambassadors represent the sovereign, and they are also the personal representatives of a Head of State in a receiving country, with the responsibility to promote the country's interest abroad, build and foster relationships, trade and business, gather information, negotiate agreements, assist Nigerians in the country, and communicate with special interests in the receiving/host country and advise the sending/home country on foreign policy. My favourite book on the subject is the book generally considered the Bible of Diplomacy, namely R.G. Feltham's Diplomatic Handbook which covers the broad scope of diplomacy as a serious business of international law and relations. With its announcement of 35 ambassadorial nominees, the Tinubu administration has finally acknowledged the seriousness of the business of diplomacy, but the main criticisms are noteworthy: one, that it is a list of persons of questionable pedigree, character and temperament, two, that it is a patronage list which seeks to reward party chieftains, foot-soldiers, political families, expired politicians and boys looking for jobs; three, that the list does not reflect the quality and depth of talent available in Nigeria, and four, that it is so underwhelming, it should be withdrawn.

Nonetheless, an ambassadorial posting is a prestigious assignment. It is a great honour to fly one's nation's flag in a foreign flag. Besides, the title of Ambassador is retained for life, and you get addressed as "Your for life, and you get addressed as Your Excellency" for the rest of your life even if you stopped being Excellent. Ambassador Joe Keshi, Nigeria's former Consul General in Atlanta, USA, submits that the list is Atlanta, USA, submits that the list is composed of the good, the bad and the ugly as in the 1966 Western film epic, starring Clint Eastwood. He is right. Character is important in diplomacy, and this is the main issue that has been raised with President Tinubu's list of

For obvious reasons, there may be no reason to panic. The nomination of a person as an ambassador is merely the first step in a process. The nominee goes through security screening by the sending country. Nigerians in their preliminary reactions argue that the in their preliminary reactions argue that the Nigerian security system cannot be trusted to do any diligent screening. They claim that that they have found on the list, persons of questionable pedigree: persons who have no principles, professional political jobbers who stand for nothing, wife beaters, corrupt politicians, party hacks, with only a small percentage of career ambassadors making the list, and that if proper screening had been done, certain personalities should never have shown up on that list. But there a second step: the nominee's name is submitted to the Senate for further screening and confirmation. Here, the Senate Committee on Foreign Affairs is expected to further re-examine the nominee, ask every possible question, assess the person's temperament and evaluate objections by the public, and on the basis of this, take a decision. In a value-based process, the filtering process at this level should filter out the bad and the ugly.

Whereas Nigerians may be aware of this, they claim that they are skeptical of the present National Assembly, an Assembly that seems to dance to the dictates of the Executive arm of government and particularly the Presidency. But even if Senators rubber stamp the President's list, the Foreign Affairs Ministry would still have to request an agrement - that is an official consent to the nomination by a receiving/host

who at 83, was excited to be nominated as a non-career ambassador. He died in Maryland, US, at 85, three years after his appointment. The least that Nigerians can do is to campaign vigorously and urge persons who may have been nominated and who know that they are not fit or good enough to step down. Self-knowledge is a virtue, and every man must be true to himself. Nigerians are unfortunately too desperate. Nigerians need capable men and women as diplomats. The kind of situation at home whereby it is easier for touts, and persons with dubious wealth to get to high places should not be exported to the international arena. Diplomacy is meant to advance the country's estimation in the eyes of the world, not to lower it. In a country of over 200 million people, and with a rich resource of talented people, the Tinubu administration should not settle for the lowest of the pack. In many of the countries abroad, there are Nigerians who are already embedded in foreign systems, with a deep knowledge of culture, history and



signaling agreement that the person so nominated is acceptable to the receiving country. There are no obligations here, the receiving country is at liberty to either accept or reject the proposed diplomat without offering any explanation, upon which the sending country would either have to offer a replacement or downgrade the receiving post. Nigerians may draw consolation from this. Even if the system at home is compromised, it would be difficult to do so at the receiving end. It is by the way, a process that may take months, and a lot of diplomatic negotiations. The persons on Tinubu's list may not jubilate too early. They should not count their chickens before they are hatched. The various embassies in the country are listening posts. The current public debate about the various nominees is important to the extent that they provide cheap and free intelligence on the basis of which the foreign missions will advise their home states. Nigerians cannot bribe the embassies. The level of diligence however varies from one mission to the other. varies from one mission to the other.

There is yet another dimension: the nominee may choose to decline the nomination either on health grounds or for any other reason. Professor Bolaji Akinyemi famously rejected his nomination as Ambassador to the United States under Presidents Umaru Yar'Adua and Goodluck Ionathan. On the contrary, we have also had a Justice Sylvanus Nsofor

who could be recruited to represent their home country. Sending village people, whose only credential is that they belong to the right political party or that they once did the President a favour or had gone to him to beg him and his wife for forgiveness and help misses the point entirely. In choosing non-career ambassadors, there are Nigerians in Diaspora who are qualified and competent.

It is now up to the National Assembly to prove itself or disappoint the country. They must put Nigeria's interest first. Nigerians will be pleasantly surprised if they were to reject the "Baba so pe" (Our Father has directed...and so be it) or "Emi lo kan" (It is my Turn) principles. No nominee must be asked to take a bow. There must be no sentiments. No emotions. An ambassadorial appointment is not a chieftaincy title. It is a call to duty. The screening must be done in the open, in the full glare of the public. The President may have powers under Section 171 (2c) of the 1999 Constitution to appoint or fire a m b a s s a d o r s b u t p u b l i c opinion/perception should be considered in the screening process. Nigeria belongs to all of us. We have a stake in ensuring that nobody goes out there to embarrass the rest of us. Incidentally, President Bola Ahmed of us. Includentally, resistent bold Affilied Tinubu's foreign policy approach is based on a doctrine of 4Ds – Diaspora. Development, Demography, Democracy and Global Impact. It was a policy approach championed by the incumbent Foreign

Affairs Minister, Ambassador Yusuf Tuggar. How much of that policy does any of the nominees seeking to become Ambassadors understand? Do they think it is a useful policy or they just want to be an ambassador for the sake of the title? There are ambassadors who served under the Buhari administration about 83 of them who have already established contacts in various countries abroad for Nigeria. Is there a review system to identify some of them and return them to duty, especially the career ones, instead of changing diplomats every Eke market day?

President Tinubu recalled 83 diplomats in September 2023. He has now named only in September 2023. He has now named only 35 nominees. Nigeria has 109 missions abroad including 76 embassies, 22 High Commissions and 11 Consulates. Is he going to name more persons? If so, he should be thoroughly guided by current responses from the public. But what would have been preferrable is a proper review of the country's foreign diplamacy process: the country's foreign diplomacy process: a rationalization of the number of missions, the welfare of diplomats and a deepening of capacity at the Ministerial level to monitor the missions. There is no point having an ambassador in every post. For example, one Ambassador can cover the Scandinavian countries. One person can oversee Niger and Chad, or Togo, Cameroon and Chad. Things became so poor in Nigerian missions abroad at a point that the embassies could not pay for utilities. Many diplomats could not pay for utilities. Many diplomats could not travel with their families because they had to share apartments with their colleagues. Funding from the home state was irregular. The ambitious and aggressive ones among our diplomats became traders, using diplomatic privileges to make quick profit. It is only luck that has saved this country so far that we have not had a scandal that would be a cause celebre had a scandal that would be a cause celebre in international diplomacy, that cannot be covered up! We can trim the bureaucracy.

The plight and interest of career ambassadors should be treated as paramount. Diplomacy may be political, but it is also a professional calling. The convention is a 70: 30 ratio in favour of career diplomats. The dream of every professional is to get to the top in their line. The politicization of diplomacy frustrates the ambition and dreams of those who have chosen it as a vocation. It can be doubly depressing to see outsiders crowd one's space, and watch them dominate just because they have political connections. This kills morale. In a random review of President Tinubu's list, most of the persons are not from the Foreign Affairs Ministry the lowest ratio in recent years. The people from the intelligence sector even seem to have a better deal. Is this an open admission of the known fact that the golden season of Nigeria's Ministry of Foreign Affairs is long

So much talk about Nigeria's diplomacy since President Tinubu named his proposed ambassadors. We end this commentary with the well-worn view, nonetheless important, that domestic policy drives foreign policy. Nigeria's standing in the world will be determined not solely by Tinubu's ambassadors, but by a full reflection of how Nigeria treats its people at home. Do the people have enough to eat? Do they feel safe? Are they well taken care of? Are the children well provided for? Do the people trust their government? In the age of modern diplomacy, as different from traditional diplomacy, the reproducibility of technology, the rise of artificial intelligence, globalization, the increasing role of non-state actors and the multiplication of wicked problems overtesting the wisdom of the community has created new frontiers in world diplomacy. Nigeria must learn to measure up!

This achievement reflects our deliberate investment in human health capital, robust budgetary allocations (14.8% of the state budget), and strong governance systems. It underscores the effectiveness of our recruitment and capacity-building efforts and the state's readiness to respond effectively to health-crises.

How is the Commission addressing issues such as redundancy, skill gaps, and productivity in the civil service?

We are adopting a strategic and developmental approach. That is why we introduced the Skills Mapping process. First, we conduct regular assessments to understand where gaps exist—whether in skills, staffing levels, or performance. Based on these findings, we implement:

Need-based recruitment - we recruit young, skilled, and passionate staff into the service. We also recruit experienced staff where necessary; e.g., the ongoing recruitment is engaging consultants. Reskilling and redeployment for officers whose roles no longer align with priorities.

Strengthening of performance evaluation stems to improve accountability.

Our mandate is not just to fill vacancies, but to

Our mandate is not just to fill vacancies, but to build a workforce that is relevant, passionate, efficient, and prepared for the demands of 21st-century governance.

Are there any new guidelines or policies for recruitment, promotion, or disciplinary procedures within the civil service?

Yes, we are currently updating several key guidelines to reflect transparency, fairness, and modern HR standards. For recruitment, we have adopted stricter verification processes and clearer criteria for qualification and selection. This also includes CBT testing and practice-based interviews. For promotions, we are strengthening the use of competency assessments, productivity metrics, and performance ampraisals to ensure that metrics, and performance appraisals to ensure that elevation is earned, not given.

On disciplinary procedures, we have improved response timelines, documentation standards, and the overall objectivity of the standards, and the overall objectivity of the process. Our goal is to ensure that due process is followed, but also that discipline is firm, fair, and consistent across all cadres.

As the State HCD Focal Person, how do you see the link between human capital development and effective governance?

Human Capital Development is about the government investing in people. When citizens are empowered and government is vestions effectively.

empowered and government systems effectively address social sector needs, our human capital indicators rise. In Abia State, we have taken a deliberate, structured, and inclusive approach to HCD—ensuring that every sector that touches the lives of our citizens is strengthened. Our HCD framework spans key ministries such as Education, Health, Agriculture, Poverty Alleviation, Women Affairs, and the Disability Commission, as well as the Civil Service Commission. This multi-sector approach ensures that development is not isolated - it is interconnected and supports overall

he Imo State Police Command has arrested a 38-yearold businesswoman, Mrs. Juliet Igwe, for the brutal torture of her six-year-old housemaid, Onyinyechi. The suspect was paraded recently at the command headquarters in Owerri.

Police Public Relations Officer, ASP Henry Okove, described the assault which involved burning the child's private parts with an open candle flame, pouring boiling water on her hands, and dripping hot wax on her body as "despicable, barbaric and totally unacceptable in any civilized society.

According to Okoye, operatives of the Ideato North Division arrested Igwe in Uruala Community following credible intelligence. He commended the Stand for Human Rights Foundation, led by activist-journalist Chidiebube Okeoma, for promptly alerting the police and assisting in the rescue.

'The Commissioner of Police, CP Aboki Danjuma, is deeply saddened by this wicked act. He has directed the Deputy Commissioner of Police in charge of the State CID to take over the case and ensure the suspect is charged to court without delay," Okoye stated.

During questioning, Igwe admitted to the torture

Police Parade Suspects In Killing Of FRSC Officer

he Osun State Police Command has arrested three suspects over the gruesome murder of a Federal Road Safety Corps (FRSC) officer, Lasisi Funmilayo, and her 12year-old daughter, whose bodies were allegedly dismembered for ritual purposes.

Police Commissioner, Ibrahim Gotan, while briefing journalists recently, in Osogbo, said the arrest followed a report lodged by the wife of one of the suspects, Fajemirokun Victor (38), who claimed her husband had gone missing after travelling to

According to Gotan,

operatives of the Anti-Kidnapping Unit traced the matter to Ikoyi, where Fajemirokun's abandoned vehicle was recovered. Further investigation led to the arrest of an herbalist, Gboyega Aberefa (39), on November 16. Aberefa reportedly confessed that Fajemirokun brought the victims to his shrine in Ijebu-Jesa on November 2, 2025, for money rituals.

Aberefa further revealed that his boys Sunday James (38), and two others identified as Kehinde and Idowu (currently at large) slaughtered the FRSC

officer and her daughter, removed their vital organs, and disposed of their bodies in separate locations. The mother's remains were dumped in a river in Esa-Odo, while the daughter's body was abandoned in a nearby

Fajemirokun, speaking to newsmen, admitted taking the victims to the herbalist after being told the woman's existence was the cause of his misfortune.

"After I agreed to the killing, my conscience disturbed me and I ran away. I later told people in Ibadan that my life the fleeing accomplices.

Echoes of 2015: Is Nigeria Sleepwalking into 2027?

umans are wired to look for patterns. It is how we tame Luncertainty: by joining dots, comparing seasons, and reading omens in what has gone before. In Nigeria today, many politically attentive citizens are doing precisely that. As 2027 slowly comes into view, they look back at 2014-2015 and feel an unnerving sense of déjà vu. Rising insecurity. A shattered economy. Opposition forces groping towards a coalition. Northern politicians are complaining of marginalisation. A wary, sometimes hostile, posture from Washington. Are these just isolated coincidences, or are we watching an old script being dusted off for a new performance?

The 2015 elections were not ordinary. They marked the first time an incumbent president lost at the federal level, the first time power passed peacefully to an opposition coalition, and the moment when a mood of "anything but this" swept across much of the country. Beneath that historic outcome sat five powerful currents: the escalation of insurgency and insecurity; a fraying relationship with the United States; a stumbling economy; a coalesced opposition under a single banner; and a deep sense of political alienation in parts of the North. Those same currents, in slightly altered form, are again visible in the run-up to 2027. That alone should give us pause.

national imagination. Entire local governments in the North-East were effectively under insurgent control. The Chibok abductions became a stain on the conscience of the state. Scenes of internally displaced persons lining up for rations, students taking exams in camps, and soldiers complaining of poor equipment defined a campaign in which "securing the country" was not just a talking point but a desperate plea.

Today, Boko Haram and its offshoots have been joined by other actors: heavily armed bandits, kidnap-for-ransom gangs, and hybrid jihadist-criminal groups operating across large swathes of the North and Middle Belt. What were once isolated horror stories have turned into a steady drumbeat of attacks and abductions. In too many communities, schools have become soft targets rather than safe spaces, forcing repeated closures or "holiday without date." When government announcements celebrate the rescue" of abducted children, yet citizens cannot name a single high-profile mastermind tried and convicted in open court, people draw their own conclusions: either the state is overwhelmed, or someone, somewhere, is playing politics with their pain.

Layered on top of this is the economy. The 2015 vote took place after a sudden collapse in global oil prices exposed the fragility of Nigeria's mono-product dependence. Salaries were delayed; reserves thinned, and talk of "belttightening" grew louder. It was painful, but for many, it still felt like a storm that might pass.

The current moment feels different. For millions of Nigerians, the phrase "economic hardship" barely captures the reality. Hunger is not a theoretical threat; it is in the pot that is now half-empty, in school fees that cannot be paid, in the meet basic needs. On paper, technocrats argue about reforms, exchange rates, and fiscal adjustments. On the streets, people see something simpler: a government that cannot balance its books without borrowing heavily; a currency that buys less every month; a cost-of-living crisis without a visible safety net.

climate are Elections in such a primarily about survival. In 2015, the promise of "change" rode on this economic anxiety as much as on any ideological difference. Voters did not need sophisticated policy analysis to know that the status quo was hurting them. The same is true today. The danger for incumbents is obvious; the threat to democracy is more subtle. When hardship persists across administrations and party labels, people stop believing that any election can change their material reality. Cynicism, not hope, becomes the default.

Then there is the choreography of opposition politics. The 2015 story cannot

opposition space is more fragmented, with strong personalities each carrying loval bases and substantial baggage. Coalescing is harder when nobody can automatically play the role of first among equals. If 2015 showed how powerful a united opposition can be, 2027 may test whether such unity is still possible without a prominent anchor.

Running through all of this is the question of northern political sentiment. In 2015, mainstream northern politicians and a significant portion of the northern electorate felt deeply aggrieved. They believed the region was under-represented in key appointments, unfairly targeted in media narratives, and above all, abandoned to an escalating insurgency. Whether entirely fair or not, that sense of injustice translated into electoral behaviour. Many northern states swung heavily against the incumbent, and the "northern mood" became a decisive factor.

Today, a new variation of that narrative is emerging. Many northern political actors handling of internal crises have created the impression, in some circles, of a White House that is, at best, impatient with Abuja and, at worst, openly hostile. For Nigerian voters already mistrustful of external interference, this reinforces a familiar storyline: that crucial elections at home are being watched - and perhaps influenced - from abroad.

So, are we dealing with a coincidence or

Coincidences are random alignments; patterns suggest underlying structure. When the same five elements worsening insecurity, economic crisis, opposition coalescence, northern alienation, and fraught US relations-reappear in the build-up to another pivotal election, it is hard to argue that this is mere chance. What we may be seeing is the predictable outcome of deeper, unresolved issues: an economy still tethered to a volatile commodity; state institutions too weak to provide security or justice at scale; political parties built as electoral vehicles rather than policy platforms; and a foreign policy that reacts to pressure rather than shapes partnership.

If those structures remain essentially unchanged, then every election cycle will produce some version of the same script, with different actors playing slightly different roles.

What, then, does this foretell for 2027?

If the current trajectories hold if banditry and insurgency remain rampant, if hunger and unemployment continue to gnaw away at social stability, if northern grievances are left to fester, and if the opposition manages to cobble together a minimally coherent coalition 2027 could well resemble 2015 in one crucial respect: an incumbent facing a broad, emotionally charged, and regionally diverse rejection at

But there are also reasons to be cautious about neat historical parallels. The electorate has changed. A younger generation, radicalised by EndSARS and years of economic disappointment, is more sceptical of both establishment and "old opposition" figures. Trust in electoral opposition ligures. Hust in eccurion institutions has been damaged in new ways, feeding a dangerous belief that votes do not count. Social media amplifies both accountability and disinformation at speeds unimaginable a decade ago. All of this means that even if the ingredients look familiar, the eventual dish may taste very different.

The most sobering possibility is that while 2015 delivered alternation in power, 2027 might provide something more ambiguous: either change without deep reform, or deepening apathy masked by the rituals of an election. The real risk is not just that one party loses and another wins; it is that ordinary Nigerians, having seen the same patterns recur, quietly conclude that democracy itself is incapable of altering the fundamentals of their lives.

If 2015 was Nigeria's proof that incumbents can fall, 2027 may be the test of whether we can do more than rotate the faces at the top while repeating the same underlying mistakes. The patterns are already visible. What we make of them, in the quiet decisions of today and the loud choices of election day, will determine whether 2027 becomes a turning point or just another rhyme in a poem we are too tired, or too timid, to rewrite.

The pattern is familiar: individual ambitions temporarily subordinated to the larger work of defeating an incumbent.

Yet there is a critical difference. There is no Buhari-like figure who naturally commands a cross-regional, cross-class argue that the region is again bearing disproportionate costs-in blood, in disrupted education, and in disrupted agriculture - without seeing commensurate benefits in appointments, major infrastructure, or economic opportunities. 

India-Russia Relations: Putin's Visit To Deepen Defense And Energy Cooperation

India and Russia are expected to discuss the procurement of additional S-400 air defense systems, Su-57 fighter jets, and other defense equipment, the two countries aim to increase bilateral trade to \$100 billion by 2030 with a focus on expanding Indian exports to Russia, including pharmaceuticals, agriculture, and food products.

Russia has offered India small modular reactors for nuclear energy, and discussions are expected on increasing Russian crude oil supplies to India, the visit marks the 25th anniversary of the India-Russia strategic partnership, with both countries committed to deepening their cooperation in defense, energy, and trade.



Stade El Barid (Rabat)

Grand Stade d'Agadir / Adrar Stadium (Agadir)

The Grand Stade d'Agadir often called Adrar Stadium - is a relatively modern venue recognised for its coastal setting since been maintained and and contemporary facilities. The

cementing its status as a major located north of Marrakech city centre and was developed to offer both football and athletics capacity with modern auxiliary facilities, including a 5,000-seat auxiliary stadium and a well-equipped media centre. The venue was inaugurated in 2013 and completed in the 2010s and has upgraded for international events;



Grand Stade de Tanger / Ibn Battouta Stadium (Tangier)

The Agadir ground is slated to host several prominent group fixtures, a round-of-16 match and one of the quarter-finals, making it one of the tournament's knockoutstage venues.

Complexe Sportif de Fès (Fès)

The Complexe Sportif de Fès has its origins in planning from the 1990s with construction completed in the early 2000s; after years of domestic use it received staged improvements to bring facilities up to CAF standards. The stadium seats roughly 45,000 and blends traditional Moroccan architectural elements with modern spectator and broadcast facilities.

Fès will host a cluster of highinterest group matches - notably Nigeria's group fixtures.

Grand Stade de Marrakech (Marrakech)

Battouta Stadium (Tangier)

The Grand Stade de Tanger (Ibn Battouta Stadium) opened in 2011 and was designed as a large, modern bowl to serve northern Morocco: it takes its name from the famed explorer Ibn Battuta. The stadium seats around 68,000 and underwent works and periodic upgrades in the years after opening to refine hospitality and broadcast amenities. Tangier will be a principal northern hub for AFCON 2025, hosting multiple group games, a round-of-16 tie, a quarterfinal and a semi-final underlining its capacity and logistical importance for late-stage

Complexe Sportif Prince Moulay Abdellah (Rabat)

The Complexe Sportif Prince Moulay Abdellah is Rabat's flagship venue and was comprehensively redeveloped in the run-up to AFCON 2025. The historic ground has been rebuilt and significantly modernised Heritier Moulay El Hassan during 2023-2025 to meet (Rabat) FIFA/CAF standards, with the main stadium emerging as a football-only bowl after removal of its athletics track and extensive improvements to media, infrastructure.

For AFCON 2025 the Prince Moulay Abdellah will host Morocco's opening match against
